# PRESS RELEASE

## **EVOLUTION OF TURNOVER OF GREEK ENTERPRISES**

## MAY 2022

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of all enterprises and sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **May 2022**.

The current publication is a sequel of the relevant Press Releases on the Evolution of Turnover of the Enterprises that were under Suspension of Operation due to the pandemic of the corona virus disease 2019 (COVID-19), published by ELSTAT (<u>PR link</u>). However, due to the evolution of COVID-19 pandemic and the lifting of the confinement measures, tables and graphs with aggregated turnover data only for all enterprises and sectors of the economy will be presented.

The purpose served by this publication is to both monitor and present the evolution of the basic economic concept of interest (turnover from Administrative Sources), through which conclusions can be drawn about the status of the Greek economy and every sector of economic activity separately.

### More specifically,

**Concerning the enterprises and the activities of the economy as a whole**, the turnover in the first quarter 2022 amounted to 91,496,894<sup>1</sup> thousand euro, recording an increase of 38.4%<sup>1</sup> in comparison with the first quarter 2021, when the respective turnover was 66,112,030 thousand euro. The biggest increase in turnover in the first quarter 2022 compared with the first quarter 2021 was recorded from the enterprises of the section Arts, Entertainment and Recreation, per 315.1%, while the smallest increase in turnover per 5.3% was recorded from the enterprises of the section Information and Communication (Table 1).

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in May 2022 amounted to 30,559,498 thousand euro, recording an increase of 51.8% in comparison with May 2021, when the respective turnover was 20,127,791 thousand euro. The biggest increase in turnover in May 2022 compared with May 2021 was recorded from the enterprises of the section Accommodation and Food Service Activities per 242.0%, while the smallest increase in turnover in May 2022 compared with May 2021 was recorded from the enterprises of the section Human Health and Social Work Activities per 5.3% (Table 2).

<u>Note</u>:

Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis, while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises, data are available only on a quarterly basis.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2019.
- Administrative transactions files (tax, etc) of the reference years 2019, 2020, 2021 and 2022.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transactions files of the years 2019, 2020, 2021 and 2022.

Statistical classifications For the economic activities, the European statistical classification of economic activities <u>NACE Rev. 2</u> is used.

Reference Period	May 2022.
Statistical unit	The statistical unit is the legal unit (distinct TIN).
Comparability	The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2019 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u> ).
