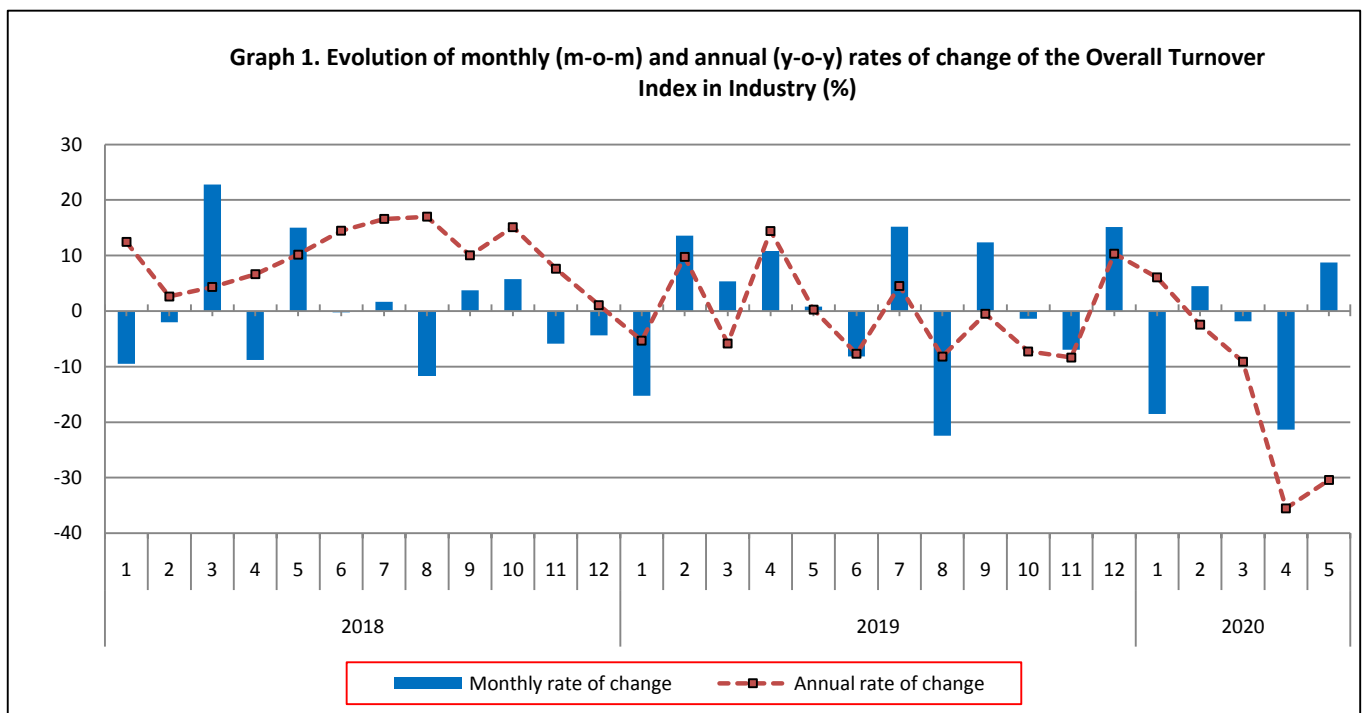
TURNOVER INDEX IN INDUSTRY: May 2020, y-o-y decrease of 30.4%

The Hellenic Statistical Authority announces the Turnover Index in Industry with base year 2015=100.0 for May 2020, on the basis of provisional data, which is as follows:

The Overall Turnover Index in Industry (both domestic and non-domestic market) in May 2020 recorded a decrease of 30.4% compared with the corresponding index of May 2019. The Overall Turnover Index in Industry in May 2019 increased by 0.3% compared with the corresponding index in May 2018 (Table 1).

The Overall Turnover Index in Industry in May 2020, compared with April 2020, recorded an increase of 8.7% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from June 2019 to May 2020 decreased by 7.9%, compared with the corresponding index of the 12-month period from June 2018 to May 2019. The average Overall Turnover Index in Industry for the 12-month period from June 2018 to May 2019 increased by 7.7% compared with the corresponding index of the 12-month period from June 2017 to May 2018 (Table 13).

Evolution of the Overall Turnover Index in Industry in May 2020

I. Annual changes of the Overall Turnover Index in Industry: May 2020/May 2019

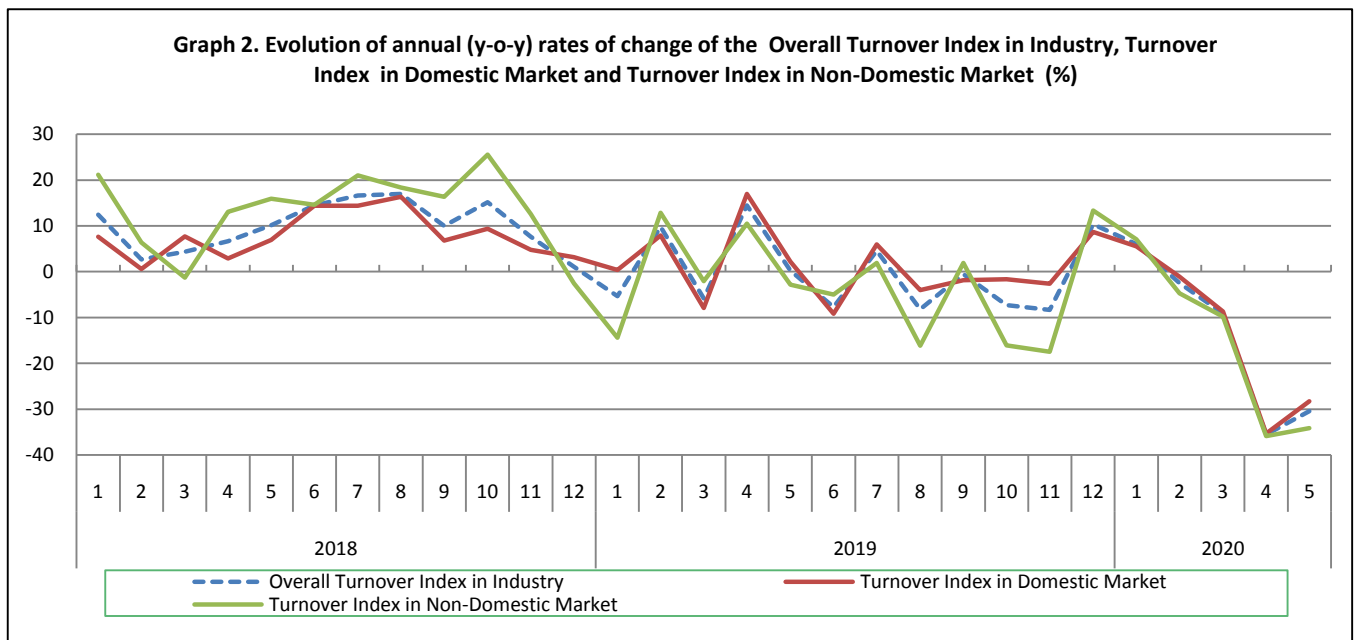
The 30.4% decrease in the Overall Turnover Index in Industry in May 2020, compared with the corresponding index in May 2019, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Mining and quarrying decreased by 23.5%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite - extraction of crude petroleum and natural gas - mining support service activities, other mining and quarrying products.
- The Turnover Index in Manufacturing decreased by 30.5%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, coke and refined petroleum products, other non-metallic mineral products, basic metals.

2. Changes in the sub-indices in domestic and non-domestic markets:

- The Turnover Index in Industry in domestic market decreased by 28.3% (Table 2).
- The Turnover Index in Industry in non-domestic market decreased by 34.1% (Table 3).



II. Annual changes of the Turnover Index in Industry in Domestic Market: May 2020/May 2019

The 28.3% decrease of the Turnover Index in Industry in domestic market in May 2020, compared with May 2019, is due to the following annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Mining and quarrying decreased by 31.7%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite - extraction of crude petroleum and natural gas - mining support service activities, other mining and quarrying products.
- The Turnover Index in Manufacturing decreased by 28.3%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, coke and refined petroleum products, other non-metallic mineral products, basic metals.

III. Annual changes of the Turnover Index in Industry in Non-Domestic Market: May 2020/May 2019

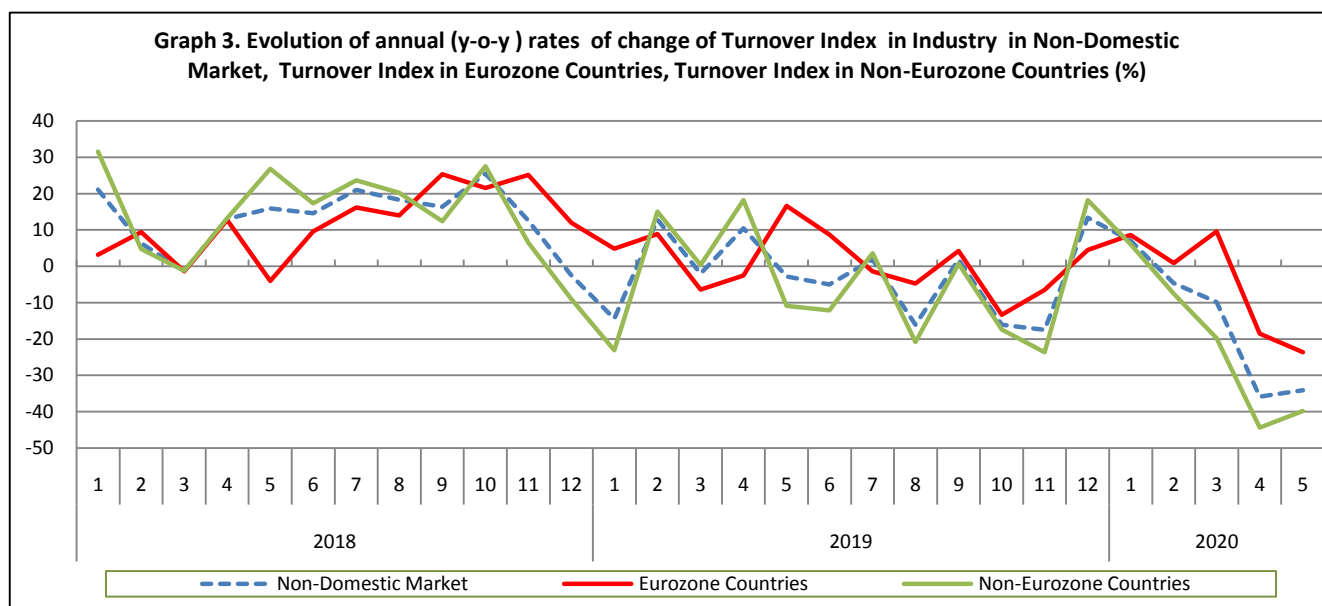
The 34.1% decrease of the Turnover Index in Industry in Non-Domestic market in May 2020, compared with May 2019, was due to the following:

1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Mining and quarrying decreased by 17.3%. The decrease was the result of the annual change of the sub-index in the following 2-digit division: other mining and quarrying products.
- The Turnover Index in Manufacturing decreased by 34.5%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: coke and refined petroleum products, other non-metallic mineral products, basic metals, electrical equipment.

2. Changes in the sub-indices in Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry in Eurozone countries decreased by 23.7% (Table 4).
- The Turnover Index in Industry in non-Eurozone countries decreased by 39.8% (Table 5).



IV. Monthly changes of the Overall Turnover Index in Industry: May 2020/ April 2020

The 8.7% increase of the Overall Turnover Index in Industry in May 2020, compared with the corresponding index in April 2020, was due to the following:

1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Mining and quarrying increased by 1.9%.
- The Turnover Index in Manufacturing increased by 8.8%.

2. Changes in the sub-indices in domestic and non-domestic market:

- The Turnover Index in Industry in domestic market increased by 13.6% (Table 7).
- The Turnover Index in Industry in non-domestic market increased by 0.7% (Table 8).

METHODOLOGICAL NOTES

Generally	The Industrial Turnover Index is an indicator of an enterprise's business cycle showing the monthly evolution of the market of goods and services in industry. The first compilation of the Turnover Index was completed by the Hellenic Statistical Authority in 2006, with base year 2000=100.0 and is compiled from 2000 onwards.
Purpose of the index	The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.
Legal Framework	The compilation and publication of the Turnover Index is based on the framework of the implementation of Council Regulation (EC) No 1165/1998 concerning short-term statistics (STS-R), as well as Regulation (EC) No 1158/2005 of the European Parliament and of the Council amending Council Regulation (EC) No 1165/1998. Furthermore, this index is governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council, by Commission Regulation (EC) No 656/2007 and by Regulation (EC) No 451/2008 of the Council.
Reference period	Month.
Base year	2015=100.0.
Revision	The latest revision of the Turnover Index in Industry (base year 2015=100.0) took place in the framework of Council Regulation (EC) No 1165/1998 concerning short-term statistics. In accordance with this regulation the index is revised every five years, in years ending in 0 or 5.
Statistical classifications	At the level of classes of economic activities, the statistical classification of economic activities NACE Rev. 2 of EU was used (Regulation No 1893/2006), while at the level of main industrial groupings, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with Commission Regulation No 656/2007.
Geographical coverage	The index covers the whole Country.
Coverage of economic activities	The Turnover Index in Industry is compiled for all activities listed in Sections B (mining and quarrying) and C (manufacturing) of the NACE Rev. 2 statistical classification.
Computation of the Index	The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level and two-level of economic activity) as well as at the level of Main Industrial Groupings (MIGs).
Data collection, processing and imputation in the context of the COVID-19 crisis	The compilation of the indices was mainly based on data collected by the enterprises (via web-based application, email), as well as data from administrative sources. For May 2020 there was no significant change in the data collection compared to previous reference months.
Publication of data	The Turnover Index in Industry (2015=100.0) is released since August 2019 with June 2019 as first reference month. Data with base year 2015=100.0 are available from January 2000 onwards.
