Building Activity Survey: March 2024

The Hellenic Statistical Authority (ELSTAT) announces the data of the Building Activity Survey for the month March 2024. More specifically:

The Total Building Activity (private-public) in Greece, in March 2024 which is calculated on the basis of the number of issued building permits, amounted to 3,756. This figure corresponds to 873,036 m² of surface and 3,285,556 m³ of volume, reflecting, respectively, a 39.8% increase in the number of building permits, a 34.8% increase in surface and an 11.2% increase in volume, compared with the corresponding month of 2023 (Table 1).

The building permits for the Private Building Activity issued in Greece in March 2024 amounted to 3,728. This figure corresponds to 864,988 m² of surface and 3,248,483 m³ of volume. In comparison with the same month of 2023 there is a 39.6% increase in the number of building permits, a 37.7% increase in surface and a 13.1% increase in volume (Table 2).

The building permits for the Public Building Activity issued in Greece in March 2024 amounted to 28. This figure corresponds to 8,048 m² of surface and 37,073 m³ of volume. Public Building Activity accounted for a 1.1% of the total building volume in March 2024.

In the last twelve months, from April 2023 until March 2024, Total Building Activity (private-public) in Greece, calculated on the basis of the number of issued building permits, amounted to 29,512. This figure corresponds to 6,780,660 m² of surface and 30,754,562 m³ of volume. In comparison with the corresponding period from April 2022 until March 2023, there is a 14.0% increase in the number of building permits, a 16.3% increase in surface and a 16.2% increase in volume (Table 3).

In the same period, from April 2023 untill March 2024, Private Building Activity in Greece recorded a 14.1% increase in the number of issued building permits, a 16.8% increase in surface and a 16.7% increase in volume, compared with the corresponding period from April 2022 to March 2023 (Table 4). During the same period, Public Building Activity accounted for a 2.2% of the total building volume.

During the period January - March 2024, Total Building Activity (private-public) in Greece recorded a 42.0% increase in the number of issued building permits, a 38.3% increase in surface and a 25.0% increase in volume, compared with the corresponding period of 2023 (Table 5). During the same period, January - March 2024, Private Building Activity in Greece recorded a 42.2% increase in the number of issued building permits, a 40.4% increase in surface and a 26.7% increase in volume, in comparison with the period January - March 2023 (Table 6).







Graph 1. Private Building Activity (volume), by Region (NUTS II), March 2023 and 2024


Graph 2. Private Building Activity (volume), by Region (NUTS II), April 2022 - March 2023 and April 2023 - March 2024

Graph 4. Annual Private Building Activity (2014 – 2023)




EXPLANATORY NOTES

Building Activity Survey The Building Activity Survey has been providing data on a monthly and yearly basis, since 1964. The purpose of this survey is to register the total number of building permits issued by the responsible administrative authorities, which are devolved to complete the questionnaire. The survey covers all the features of building activity, such as the type of building permit, the type of construction, the type and the characteristics of the building and its auxiliary spaces, as well as building usage, surface, volume and value.

Legal FrameworkThe survey is fully harmonized with the European legislation. The primary legislative act is Regulation (EU) No 2019/2152 of the
European Parliament and of the Council on European business statistics, as well as Commission Implementing Regulation (EU) No
2020/1197 laying down specifications and arrangements pursuant to Regulation (EU) No 2019/2152.

Reference Period March 1, 2024 to March 31, 2024.

Definitions Building Permit refers to all types of building permits. These are permits for new buildings or permits for additions, repair, renovation, demolition, legitimization, amendment and modification of a building.

The denotation of "built-property" is equal to "building".

Building is every permanent and independent structure, which has walls and a roof and consists of one or more rooms and other complementary spaces. Normally, buildings feature four walls. However, a construction open from one or even two sides will be considered a building, as long as it has a roof.

New building is any built-property raised on an uncovered site or in the place of an old building that has been demolished.

Building Addition is every construction that adds building volume (space) to an existing building, in terms of surface, height or both and creates a residence, a shop or both.

Building volume (the gross building volume) refers to the area that is included between the external surface of the external walls, the lowest level (the basement or the sub-basement, if it exists) and the roof of the building. If there is an open ground floor not enclosed within walls between the lower floor and the roof, its volume is taken into account. The relevant authorities calculate the volume of the building during the issuing of the building permit.

Surface of new-built property is considered to be the sum of each floor space along with the outer space of the outer walls.

General Remark Any delineation that may occur between the sum of sub totals and the totals is due to rounding.
