DEMOGRAPHIC EVENTS OF ENTERPRISES REGISTRATIONS AND BANKRUPTCIES 2ND QUARTER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on business demography in Greece and specifically on <u>Registrations</u> and <u>Bankruptcies</u>, for the 2nd quarter 2024.

More specifically, the number of registrations in all economic sections in the **2**nd **quarter 2024** amounted to 31,489, recording an increase of 17.1% in comparison with the 2nd quarter 2023, when the respective number was 26,897 and a decrease of 19.5% in comparison with the 1st quarter 2024, when the respective number was 39,128.

Among the sections of economic activity with the largest contribution to the total turnover, according to the data of the Statistical Business Register for the reference year 2021, the biggest increase in the number of registrations in the **2**nd **quarter 2024** compared with the 2nd quarter 2023, was recorded in section "Accommodation and Food Service Activities" (17.9%) and in section "Transportation and Storage" (16.0%), while the biggest decrease was recorded in section "Electricity, Gas, Steam and Air Conditioning Supply" (18.0%) and in section "Manufacturing" (5.7%) (Table 1).

The number of bankruptcies in all economic sections for the 2^{nd} quarter 2024 amounted to 7, while for the 2^{nd} quarter of 2023 is not disclosed for statistical confidentiality reasons regarding the protection of the identity of the enterprises.

Sections of Economic Activity by Large Geographical Area (NUTS 1) of Greece, 2nd quarter 2024 (Table 2)

The sections of economic activity with the biggest number of registrations by Large Geographical Area of Greare:

- Voreia Ellada: "Agriculture, Forestry and Fishing"(1), with 1,630 registrations out of 7,573 in total.
- **Kentriki Ellada**: "Agriculture, Forestry and Fishing"⁽¹⁾, with 2,271 registrations out of 7,427 in total.
- Attiki: "Professional, Scientific and Technical Activities" with 2,103 registrations out of 11,624 in total.
- Nissia Aigaiou Kriti: "Agriculture, Forestry and Fishing"(1), with 1,384 registrations out of 4,865 in total.

Sections of Economic Activity by category of Legal Form of enterprise, 2nd quarter 2024 (Table 3)

The sections of economic activity with the biggest number of registrations by category of Legal Form of enterprise are:

- **Sole Proprietorships:** "Agriculture, Forestry and Fishing"⁽¹⁾, with 5,663 registrations out of 20,795 in total.
- Partnerships: "Accommodation and Food Service Activities", with 1,280 registrations out of 5,452 in total.
- Capital Enterprises: "Real Estate Activities", with 128 registrations out of 457 in total.
- Other Legal Forms: "Real Estate Activities", with 825 registrations out of 4,785 in total.

¹ <u>Note</u>: The data recorded for the economic activity section Agriculture, Forestry and Fishing include farmers subjected to the special regime (of VAT), i.e. farmers who are registered in the tax registry of farmers, having both received subsidies of value less than 5,000 euro during the previous tax year and conducted during the previous tax year, sales of agricultural products of own production, as well as provision of agricultural services of value less than 15,000 euro, to any person.





Graph 1. Number of Registrations per week, 1st, 2nd, 3rd and 4th quarter 2023 and 1st, 2nd quarter 2024



METHODOLOGICAL NOTES

General Information

The compilation of the statistical data is made in accordance with the new European Regulation on Business Statistics, which entered into force on the 1st of January 2021 (Regulation (EU) 2019/2152 of the European Parliament and of the Council of 27th November 2019) and is among the key changes introduced by this Regulation for new and high-frequency official business statistics at European level.

The statistical data presented in this announcement refer to business demography and more specifically to the registrations and bankruptcies of enterprises, which are defined as follows:

<u>Registrations</u>: The number of entered legal units in the registration register at any time during the reference quarter, according to the respective administrative or legal procedure.

<u>Bankruptcies</u>: The number of legal units that have started the procedure of being declared bankrupt, by issuing a court declaration, at any time during the reference quarter (which is often provisional and does not always mean cessation of an activity).

Purpose

The purpose of the short-term business statistics, is to provide up-to-date and high frequency information on the evolution of business activity and, subsequently, of the economic climate - expectations.

Legal framework

Short-term business statistics are compiled in accordance with Regulation (EU) 2019/2152 of the European Parliament and of the Council of 27th November 2019, on European business statistics and Commission Implementing Regulation (EU) 2020/1197 of 30th July 2020, laying down technical specifications and arrangements pursuant to Regulation (EU) 2019/2152.

Compilation methodology

The statistical data have been compiled after processing quarterly data from administrative registers of enterprises, Specifically, information has been used for the date of registration in the register of legal units (Tax Identification Number - TIN), economic activity, geographical code, legal form and business status of the enterprise.

Statistical classifications

As regards the economic activities, the European statistical classification of economic activities <u>NACE Rev.2</u> is used. As regards the geographical representation, the European Nomenclature of territorial units for statistics, NUTS, is used.
