EVOLUTION OF TURNOVER OF ENTERPRISES IN
ACCOMMODATION AND FOOD SERVICE ACTIVITIES
MARCH AND 1st QUARTER 2021

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country. At the same time, under the recent circumstances, the monitoring and dedicated publication of the evolution of these economic activities has become imperative, given the direct and indirect adverse impact they have been subjected to, due to the pandemic of coronavirus disease 2019 (COVID-19).

The current publication is part of the Press Releases series published by ELSTAT ([PR link](#)), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **March and 1st quarter 2021**.

Similar publications have been planned and are released on a monthly basis, throughout the whole period during which the regular monitoring of the evolution of the turnover of enterprises providing Accommodation, Food and Beverage Service Activities remains relevant and warranted.

In particular, the Hellenic Statistical Authority (ELSTAT) announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation, Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2021.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Starting from the current press release, an updated framework for the determination of enterprises classified in Accommodation and Food and Beverage Service Activities divisions is used, which occurs from the linking at micro-data level of administrative transactions files of the reference years 2019, 2020 and 2021 and of the final Statistical Business Register, of the reference year 2018, that provides a standardized set of data, harmonized with European classifications.

Specifically,

For the total of enterprises in **Accommodation Activities**, the turnover in the first quarter 2021 amounted to 97,977,317 euro, recording a decrease of 59.2% in comparison with the first quarter 2020, when the respective turnover was 239,971,658 euro. The largest decrease in the turnover of the first quarter 2021 compared to the first quarter of 2020 was recorded in the Regional Unit Evrytania (93.9%) and the smallest decrease (9.3%) was recorded in the Regional Unit Kefallinia, while the respective largest increase (13.6%) was recorded in the Regional Unit Kea-Kythnos (Table 2a).

For the total of enterprises in **Food and Beverage Service Activities**, the turnover in the first quarter 2021 amounted to 460,584,614 euro, recording a decrease of 52.5% in comparison with the first quarter 2020, when the respective turnover was 970,366,988 euro. The largest decrease in the turnover of the first quarter 2021 compared to the first quarter of 2020 was recorded in the Regional Unit Erytania (85.5%) and the respective smallest decrease (6.9%) was recorded in the Regional Unit Karpathos, while the respective largest increase (13.7%) was recorded in the Regional Unit Kea-Kythnos (Table 3a).

For the enterprises in **Accommodation Activities obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2021 amounted to 30,582,380 euro, recording a decrease of 19.2% in comparison with March 2020, when the respective turnover was 37,856,603 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 1), the biggest decrease in the turnover in March 2021 compared with March 2020 was recorded in the Regional Unit Rethymno (69.1%) and the smallest decrease was recorded in the Region of Attiki (4.8%), while a respective increase (3.0%) was recorded in the Regional Unit Chania (Table 2b).

For the enterprises in **Food and Beverage Service Activities obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2021 amounted to 54,201,843 euro, recording a decrease of 18.3% in comparison with March 2020, when the respective turnover was 66,322,847 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 1), the biggest decrease in the turnover in March 2021 compared with March 2020 was recorded in the Regional Unit Thira (75.6%) and the smallest decrease was recorded in the Region of Attiki (13.4%), while a respective increase (3.0%) was recorded in the Regional Unit Chalkidiki (Table 3b).

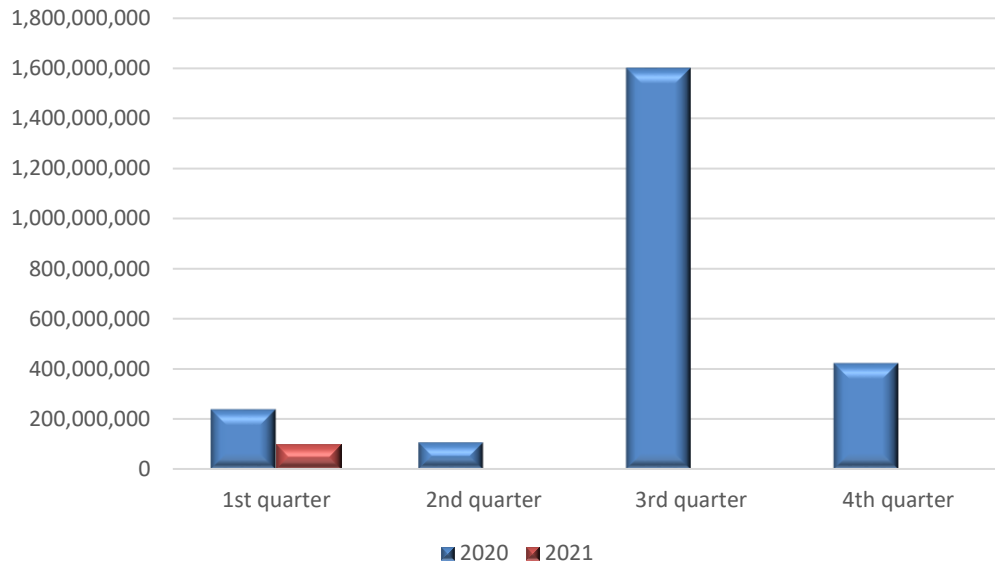

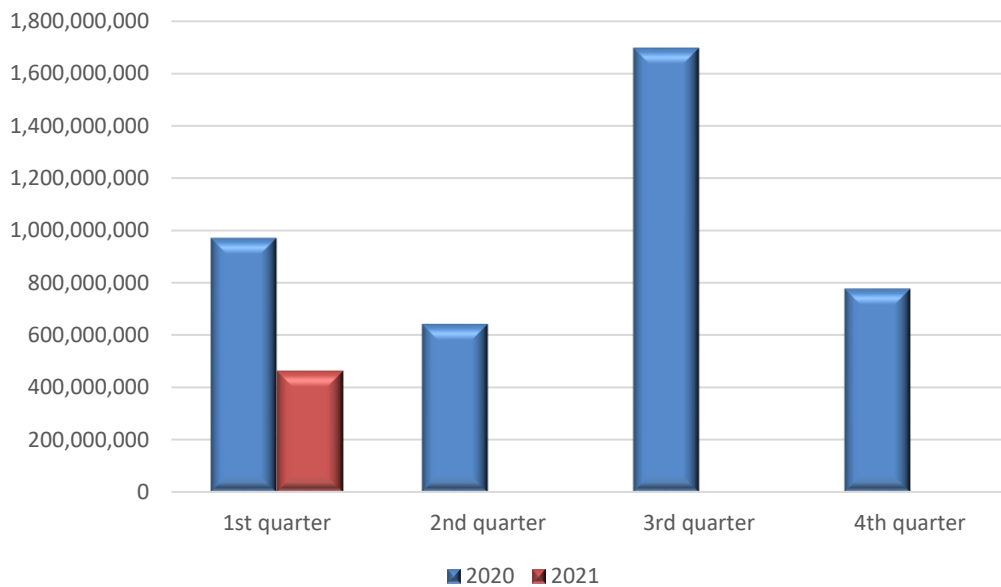

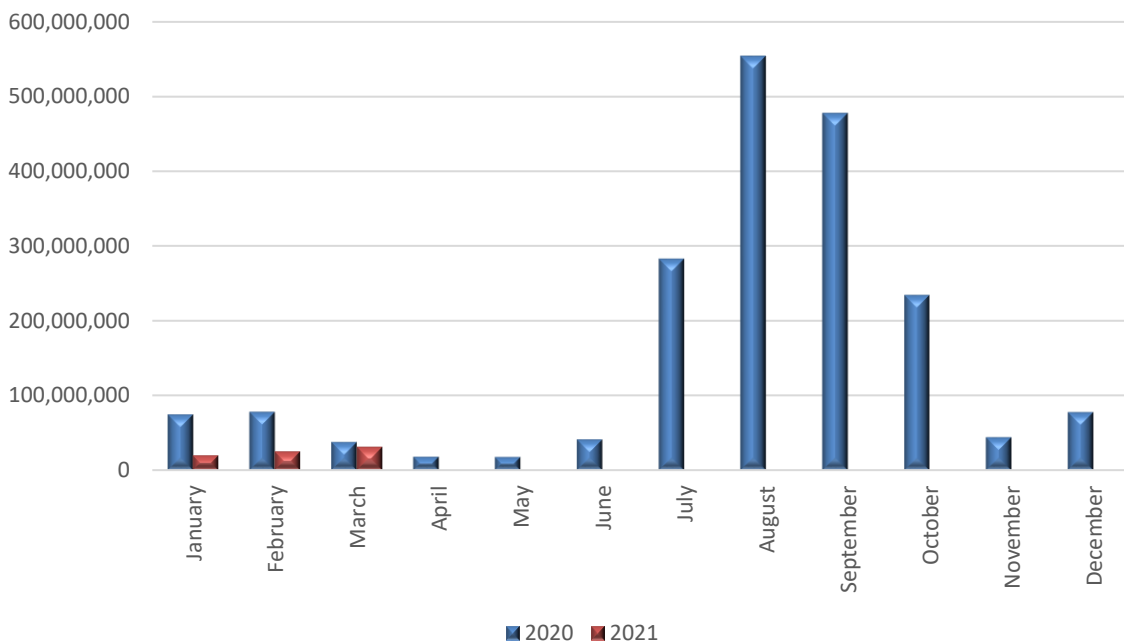
Graph 1: Turnover (in €) for the total of enterprises in the Accommodation division (55 of NACE Rev. 2 classification)



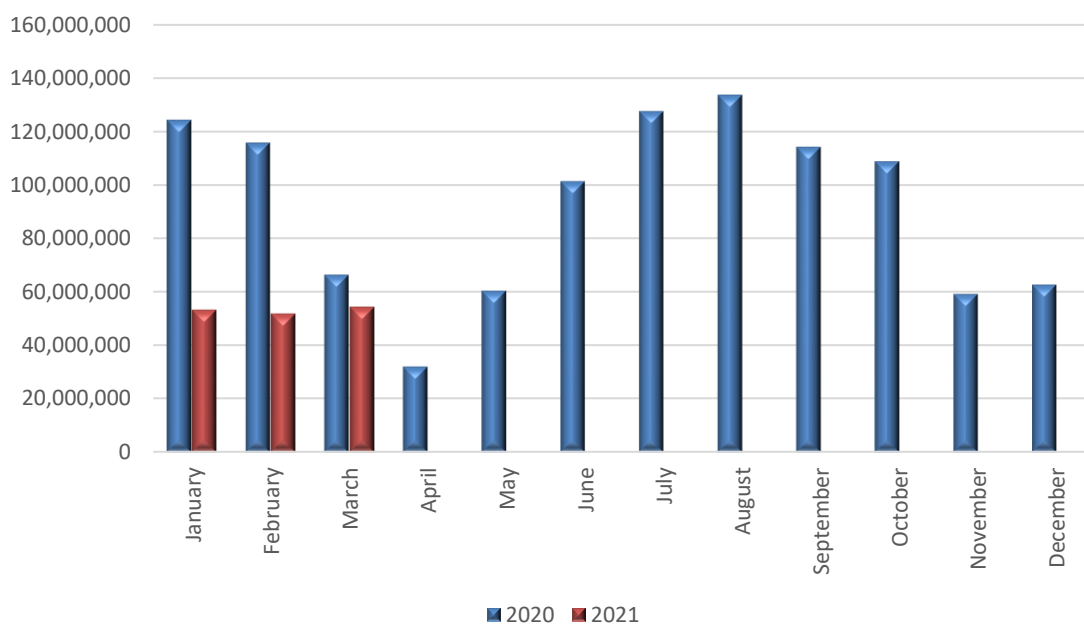
Graph 2: Turnover (in €) for the total of enterprises in the Food and Beverage Service Activities division (56 of NACE Rev. 2 classification)

- Administrative transactions files (tax, etc.) of the reference years 2019, 2020 and 2021.

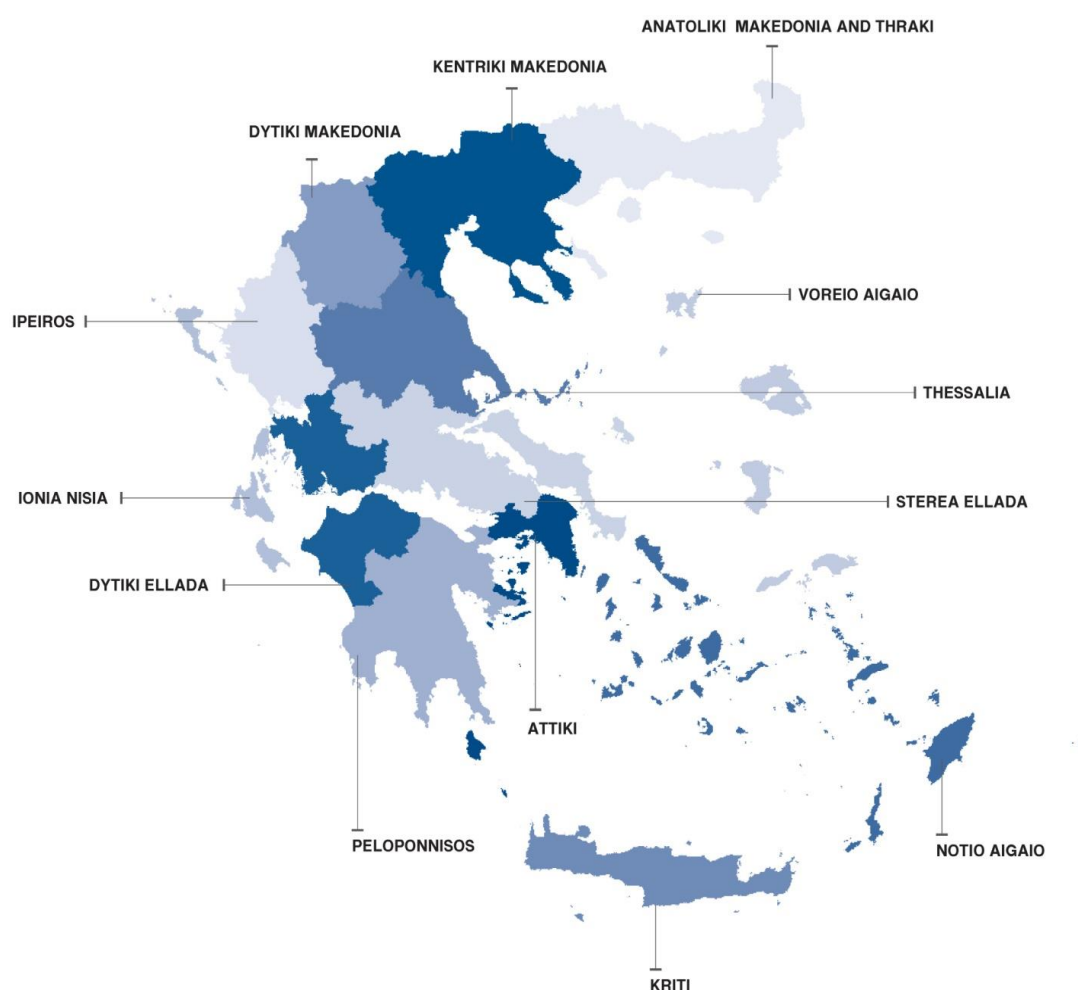
In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2018.
- Income data from administrative transaction files of the years 2019, 2020 and 2021.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications For the economic activities, the European statistical classification of economic activities NACE Rev.2 is used.
