EVOLUTION OF TURNOVER OF ENTERPRISES

NOVEMBER 2022

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for November 2022.

The current publication is a sequel of the relevant announcements on the Evolution of Turnover of the Enterprises that were under Suspension of Operation due to the pandemic of the corona virus disease 2019 (COVID-19), published by ELSTAT (link).

More specifically,

Concerning the enterprises and the activities of the economy as a whole, the turnover in the third quarter 2022 amounted to 133,266,230 thousand euro, recording an increase of 42.8% in comparison with the third quarter 2021, when the respective turnover was 93,341,622 thousand euro. The biggest increase in turnover in the third quarter 2022 compared with the third quarter 2021 was recorded from the enterprises of the section Manufacturing, per 44.2%, while the smallest increase was recorded from the enterprises of the section Human Health and Social Work Activities, per 3.1% (Table 1).

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in November 2022 amounted to 31,055,412 thousand euro, recording an increase of 20.5% in comparison with November 2021, when the respective turnover was 25,779,362 thousand euro. The biggest increase in turnover in November 2022 compared with November 2021 was recorded from the enterprises of the section Other Service Activities, per 33.4%, while the smallest increase was recorded from the enterprises of the section Public Administration and Defense; Compulsory Social Security per 9.0%. The biggest decrease in turnover was recorded from the enterprises of the section Human Health and Social Work Activities, per 14.5% (Table 2).

Note


Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis, while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises, data are available only on a quarterly basis.



METHODOLOGICAL NOTES

Generally

The current announcement provides statistical data on turnover for all enterprises and sectors of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2019.
- Administrative transactions files (tax, etc) of the reference years 2019, 2020, 2021 and 2022.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transactions files of the years 2019, 2020, 2021 and 2022.

Statistical classifications

For the economic activities, the European statistical classification of economic activities NACE Rev. 2 is used.

Reference Period

November 2022.

Statistical unit

The statistical unit is the legal unit (distinct TIN).

Comparability

The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2019 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
