## **COMMERCIAL TRANSACTIONS OF GREECE : June 2026**

( Provisional Data )

The total value of imports, in June 2026 amounted to 7,616.1 million euros (8,746.1 million dollars) in comparison with 7,154.2 million euros (8,214.7 million dollars) in June 2025, recording an increase, in euros, of 6.5%. The corresponding value excluding oil products in June 2026 recorded an increase of 264.7 million euros or 4.6% and the corresponding value excluding oil products and ships in June 2026 recorded an increase of 293.9 million euros or 5.1%, in comparison with June 2025 (Table 1).

The total value of exports, in June 2026 amounted to 5,000.3 million euros (5,776.7 million dollars) in comparison with 3,959.6 million euros (4,573.8 million dollars) in June 2025, recording an increase, in euros, of 26.3%. The corresponding value excluding oil products recorded in June 2026 an increase of 567.2 million euros or 18.4% and the corresponding value excluding oil products and ships in June 2026 recorded an increase of 557.3 million euros or 18.2%, in comparison with June 2025 (Table 1).

The deficit of the trade balance, in June 2026 amounted to 2,615.8 million euros (2,969.4 million dollars) in comparison with 3,194.6 million euros (3,640.9 million dollars) in June 2025, recording a drop, in euros, of 18.1%. The corresponding value of deficit excluding oil products in June 2026 recorded a drop of 302.5 million euros or 11.3% and the corresponding value excluding oil products and ships in June 2026 recorded a drop of 263.4 million euros or 10.0%, in comparison with June 2025 (Table 1).

The total value of imports, for the 6-month period from January to June 2026 amounted to 43,674.3 million euros (50,791.5 million dollars) in comparison with 41,007.2 million euros (44,698.9 million dollars) for the corresponding period of the year 2025, recording an increase, in euros, of 6.5%. The corresponding value excluding oil products recorded an increase of 736.9 million euros or 2.2% and the corresponding value excluding oil products and ships recorded an increase of 784.4 million euros or 2.4%, in comparison with the period from January to June 2025 (Table 5).

The total value of exports, for the 6-month period from January to June 2026 amounted to 27,633.7 million euros (32,319.3 million dollars) in comparison with 24,117.7 million euros (26,430.2 million dollars) for the corresponding period of the year 2025, recording an increase, in euros, of 14.6%. The corresponding value excluding oil products recorded an increase of 1,294.6 million euros or 6.9% and the corresponding value excluding oil products and ships recorded an increase of 1,256.2 million euros or 6.7%, in comparison with the period from January to June 2025 (Table 5).

The deficit of the trade balance, for the 6-month period from January to June 2026 amounted to 16,040.6 million euros (18,472.2 million dollars) in comparison with 16,889.5 million euros (18,268.7 million dollars) for the corresponding period of the year 2025, recording a drop, in euros, of 5.0%. The corresponding deficit excluding oil products recorded a drop of 557.7 million euros or 3.9% and the corresponding deficit excluding oil products and ships recorded a drop of 471.8 million euros or 3.4% (Table 5).

The monthly data of Intra-EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold<sup>(1)</sup>, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data <sup>(2)</sup>.

<sup>(1)</sup> By virtue of Union Regulations on the compilation of intra-Union trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Union transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by the Hellenic Statistical Authority on a yearly basis.

<sup>(2)</sup> It should be noted that, for every previous reference month featuring provisional data, the modifications presented in the external trade statistics with non-EU countries in this Announcement (including the months of April and May 2026) are due to the incorporation of data from the final customs declarations, which the Hellenic Statistical Authority (ELSTAT) regularly receives from the Independent Authority for Public Revenue (IAPR).

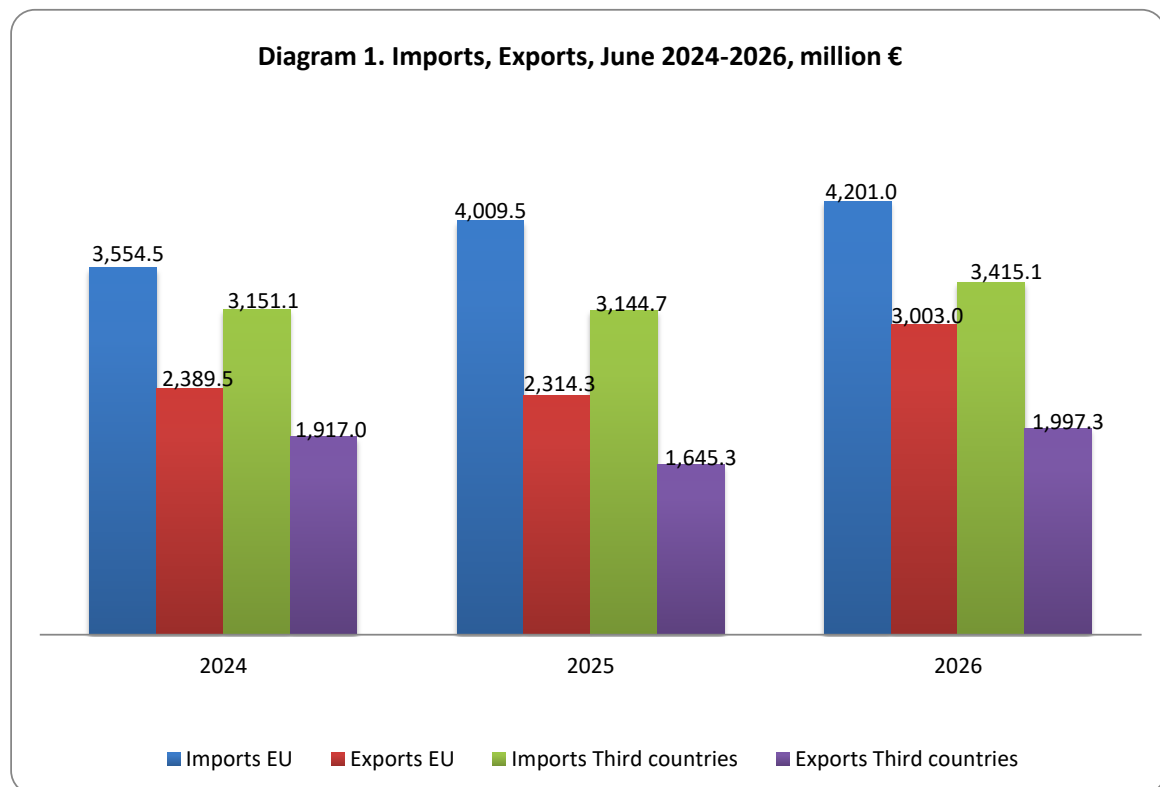

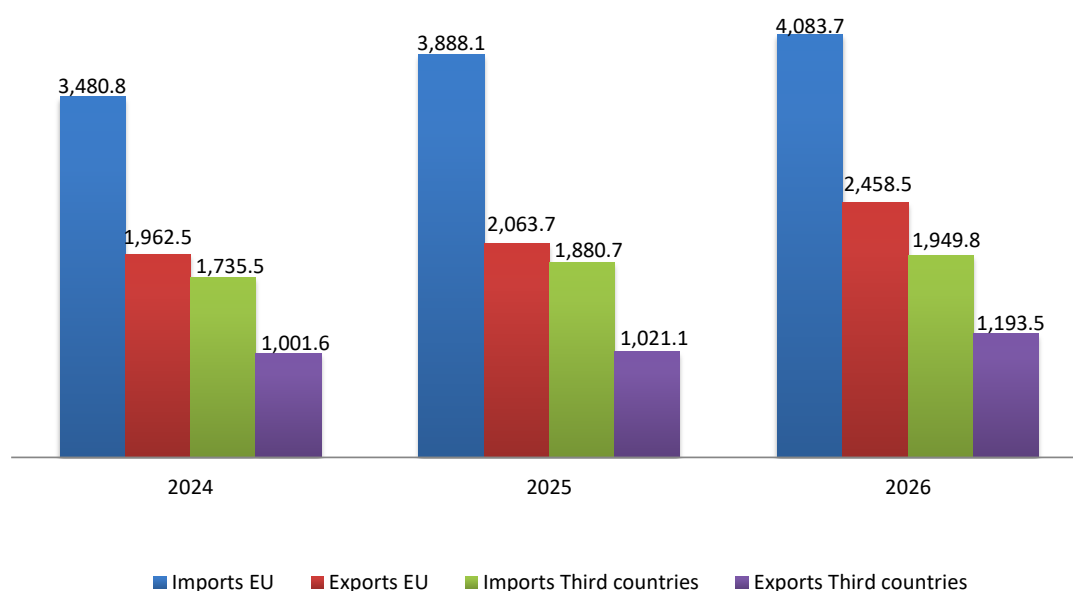

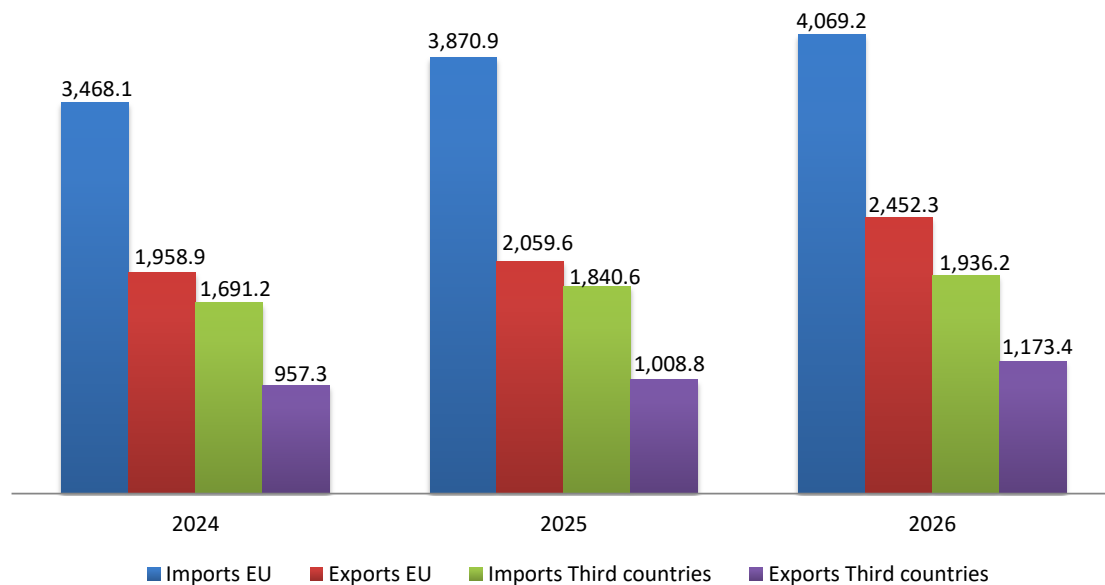

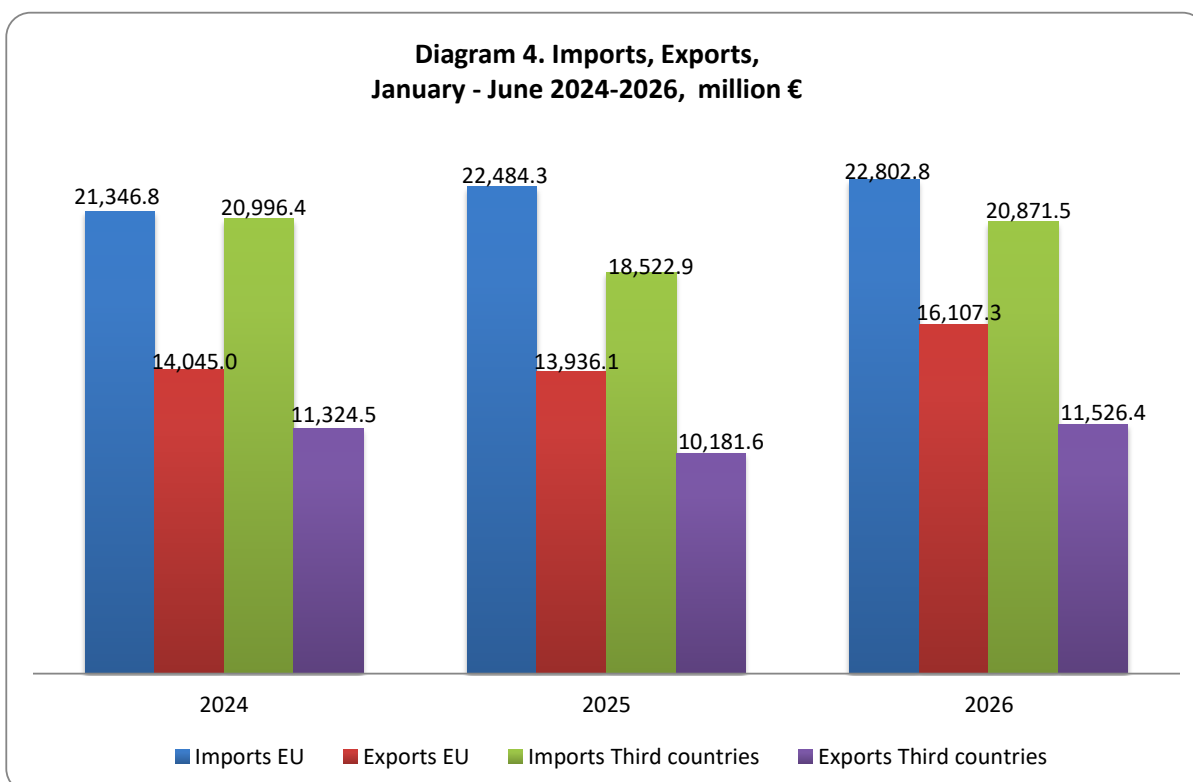

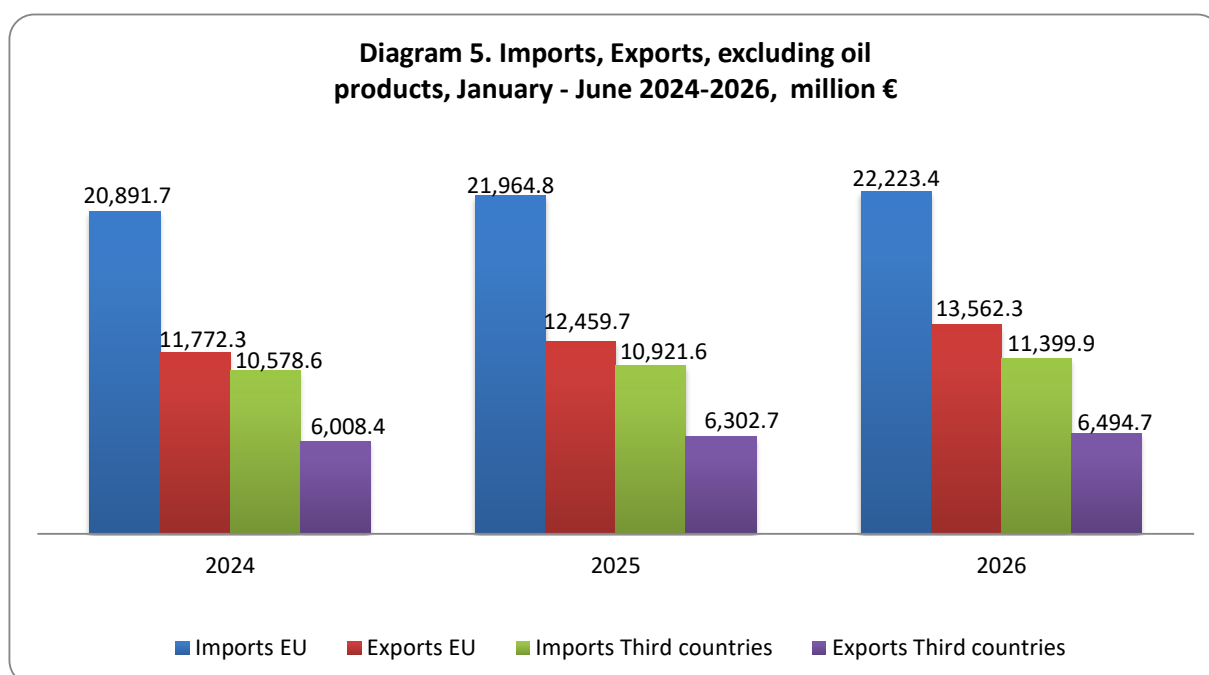

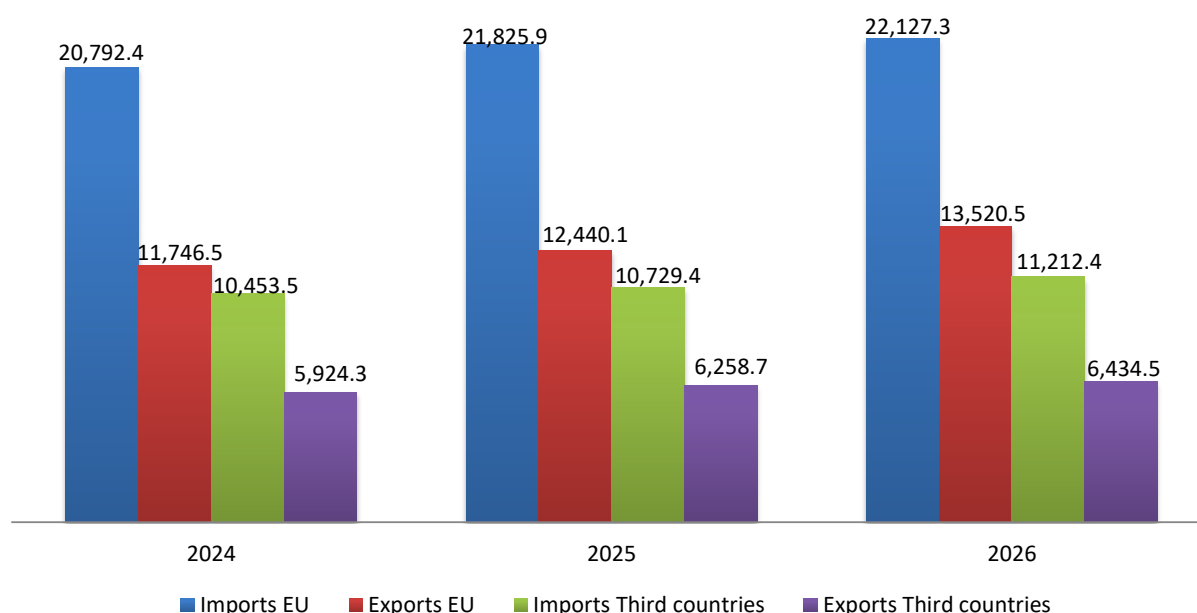

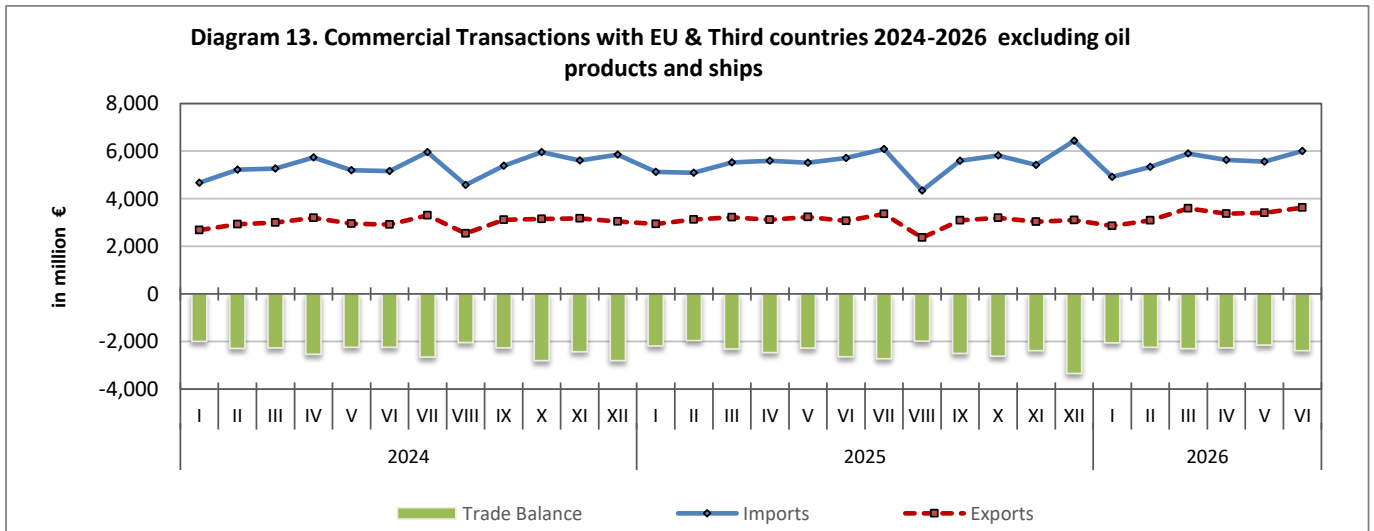
