**DEMOGRAPHIC EVENTS OF ENTERPRISES**  
**REGISTRATIONS AND BANKRUPTCIES**  
**4<sup>th</sup> QUARTER 2022**  
**ANNUAL DATA 2022**

The Hellenic Statistical Authority (ELSTAT) with this Press Release announces data on business demography in Greece and specifically on Registrations and Bankruptcies, for the **4<sup>th</sup> quarter 2022**.

Business demography statistics constitute, at European and international level, one of the most rapidly developing statistical domains and attract the interest of policy makers, institutional users and society, in general, as they are widely relevant through the information they provide.

In particular, the monitoring of registrations and bankruptcies on a quarterly basis provides up-to-date information on the evolution of business activity and subsequently of the economic climate.

More specifically, ELSTAT announces:

- Annual data on registrations, by section of economic activity of the Statistical Classification of Economic Activities (NACE Rev. 2) and on bankruptcies, for 2020, 2021 and 2022.
- Quarterly data on registrations, by section of economic activity of the Statistical Classification of Economic Activities (NACE Rev. 2), for the 3<sup>rd</sup> and 4<sup>th</sup> quarter 2021 and 2022.
- Quarterly data on registrations, by section of economic activity of the Statistical Classification of Economic Activities (NACE Rev. 2) and by Large Geographical Area (NUTS 1) / category of Legal Form of enterprise, for the 4<sup>th</sup> quarter 2022.
- Graphical representation of registrations per week, for the period 1<sup>st</sup> quarter 2021 - 4<sup>th</sup> quarter 2022.
- Quarterly data on bankruptcies, for the 4<sup>th</sup> quarter 2021 and 2022.

## Change in the number of registrations and bankruptcies

### Annual data (Table 1)

- The number of registrations in all economic sections in **2022** amounted to 105,565, recording a decrease of 4.0% in comparison with 2021, when the respective number was 109,961.

Among the sections of economic activity with the biggest contribution to the total turnover, according to the data of the Statistical Business Register for the reference year 2019 (Table 2), the biggest increase in the number of registrations in 2022 in comparison with 2021, was recorded in section “Transportation and Storage” (74.7%) and in section “Accommodation and Food Service Activities” (33.8%), while the respective biggest decrease was recorded in section “Electricity, Gas, Steam and Air Conditioning Supply” (27.0%) and in section “Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles” (5.0%).

- The number of bankruptcies for the years **2022** and 2021 are not disclosed for statistical confidentiality reasons regarding the protection of the identity of the enterprises.

### Quarterly data (Table 2)

- The number of registrations in all economic sections in the **4<sup>th</sup> quarter 2022** amounted to 30,316, recording a decrease of 12.1% in comparison with the 4<sup>th</sup> quarter 2021, when the respective number was 34,508 and an increase of 34.1% in comparison with the 3<sup>rd</sup> quarter 2022, when the respective number was 22,607.

Among the sections of economic activity with the largest contribution to the total turnover, according to the data of the Statistical Business Register for the reference year 2019, the biggest increase in the number of registrations in the **4<sup>th</sup> quarter 2022** compared with the 4<sup>th</sup> quarter 2021, was recorded in section “Transportation and Storage” (52.9%) and in section “Accommodation and Food Service Activities” (29.4%), while a decrease was recorded in section “Electricity, Gas, Steam and Air Conditioning Supply” (51.3%).

- The number of bankruptcies in all economic sections both in the **4<sup>th</sup> quarter of 2022** and in the 4<sup>th</sup> quarter 2021 amounted to 3.

### Sections of Economic Activity by Large Geographical Area (NUTS 1) of Greece, 4<sup>th</sup> quarter 2022 (Table 3)

The sections of economic activity with the biggest number of registrations by Large Geographical Area of Greece are:

- **Voreia Ellada:** “Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles”, with 1,243 registrations out of 6,683 in total.
- **Kentriki Ellada:** “Agriculture, Forestry and Fishing”<sup>(1)</sup>, with 2,871 registrations out of 7,518 in total.
- **Attiki:** “Professional, Scientific and Technical Activities” with 2,035 registrations out of 11,624 in total.
- **Nissia Aigaiou – Kriti:** “Agriculture, Forestry and Fishing”<sup>(1)</sup>, with 2,143 registrations out of 4,491 in total.

<sup>1</sup> *Note: The data recorded for the economic activity section Agriculture, Forestry and Fishing include farmers subjected to the special regime (of VAT), i.e. farmers who are registered in the tax registry of farmers, having both received subsidies of value less than 5,000 euro during the previous tax year and conducted during the previous tax year, sales of agricultural products of own production, as well as provision of agricultural services of value less than 15,000 euro, to any person.*

**Sections of Economic Activity by category of Legal Form of enterprise, 4<sup>th</sup> quarter 2022** (Table 4)

The sections of economic activity with the biggest number of registrations by category of Legal Form of enterprise are:

- **Sole Proprietorships:** “Agriculture, Forestry and Fishing”<sup>(1)</sup>, with 6,635 registrations out of 21,211 in total.
- **Partnerships:** “Wholesale and Retail Trade; Repair of Motor Vehicles and Motorcycles”, with 749 registrations out of 3,300 in total.
- **Capital Enterprises:** “Real Estate Activities”, with 122 registrations out of 551 in total.
- **Other Legal Forms:** “Real Estate Activities”, with 1,031 registrations out of 5,254 in total.

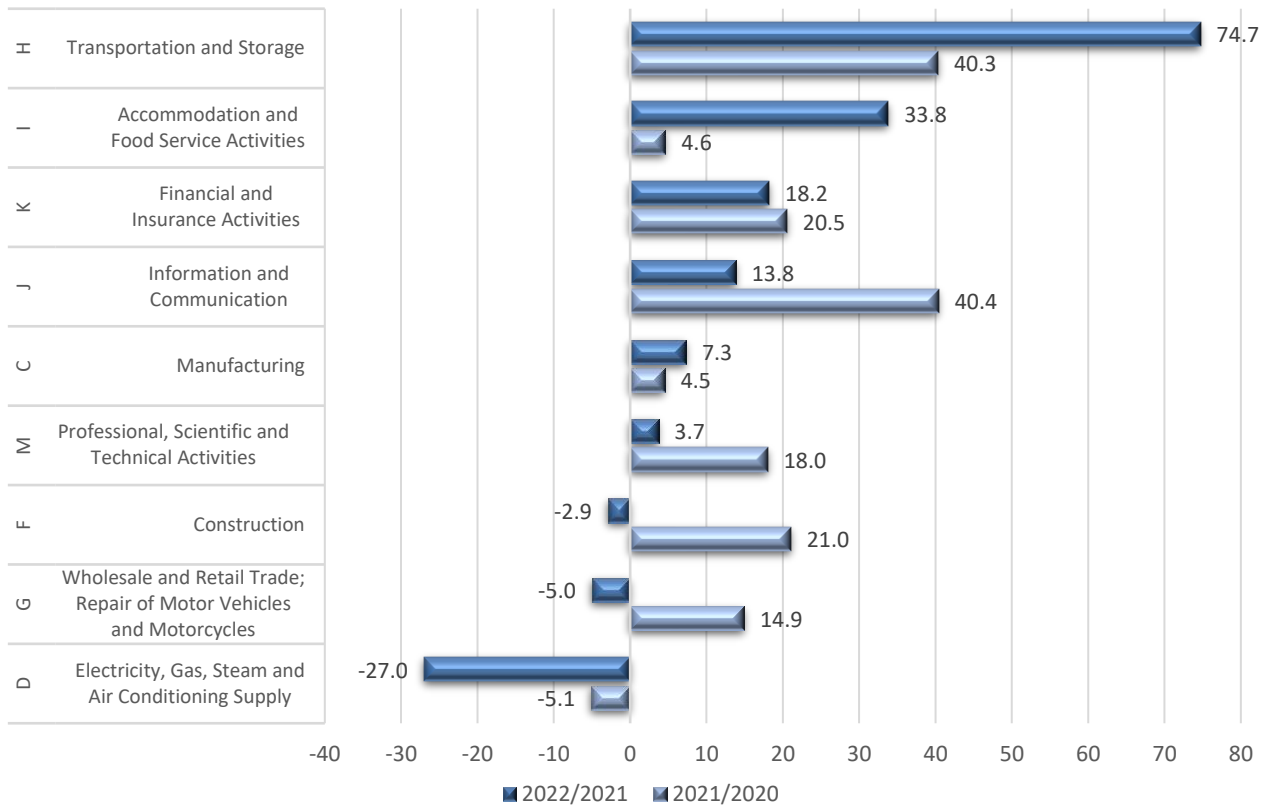

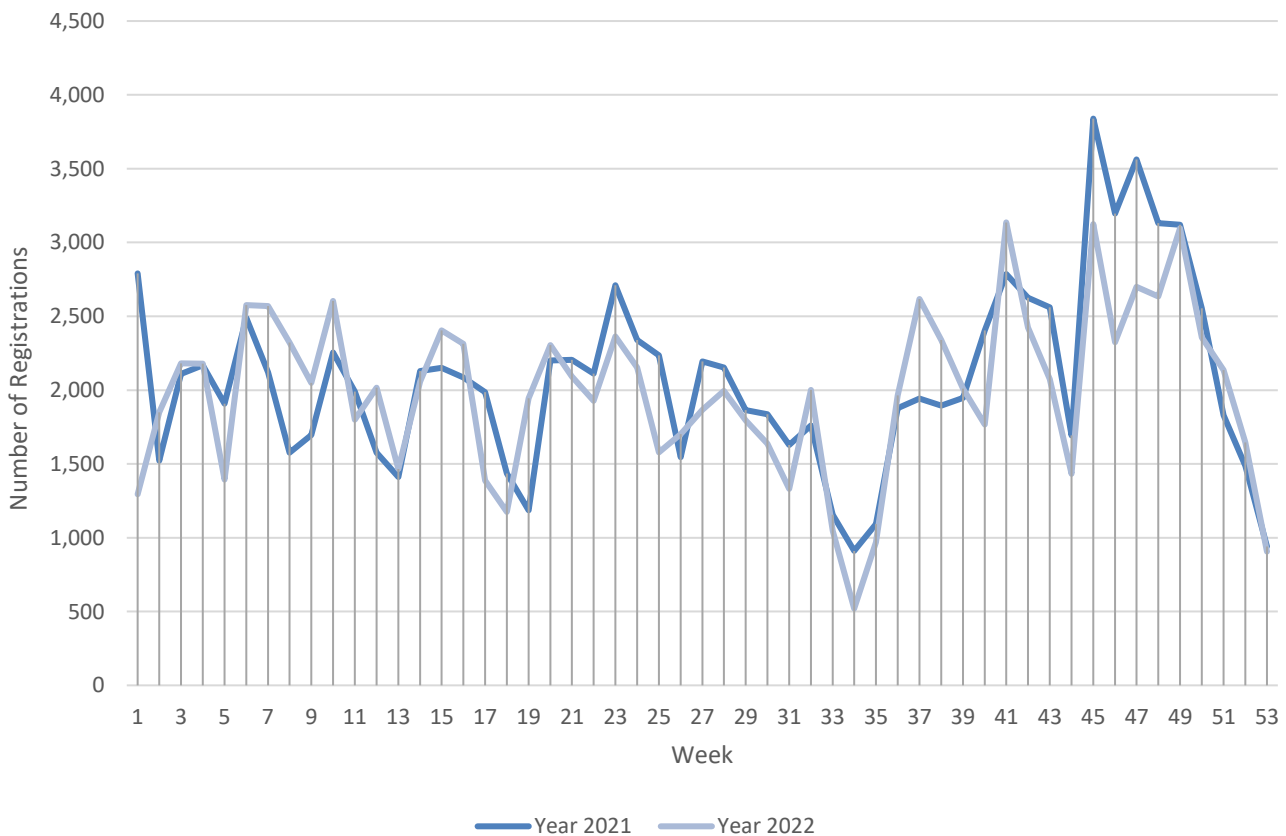

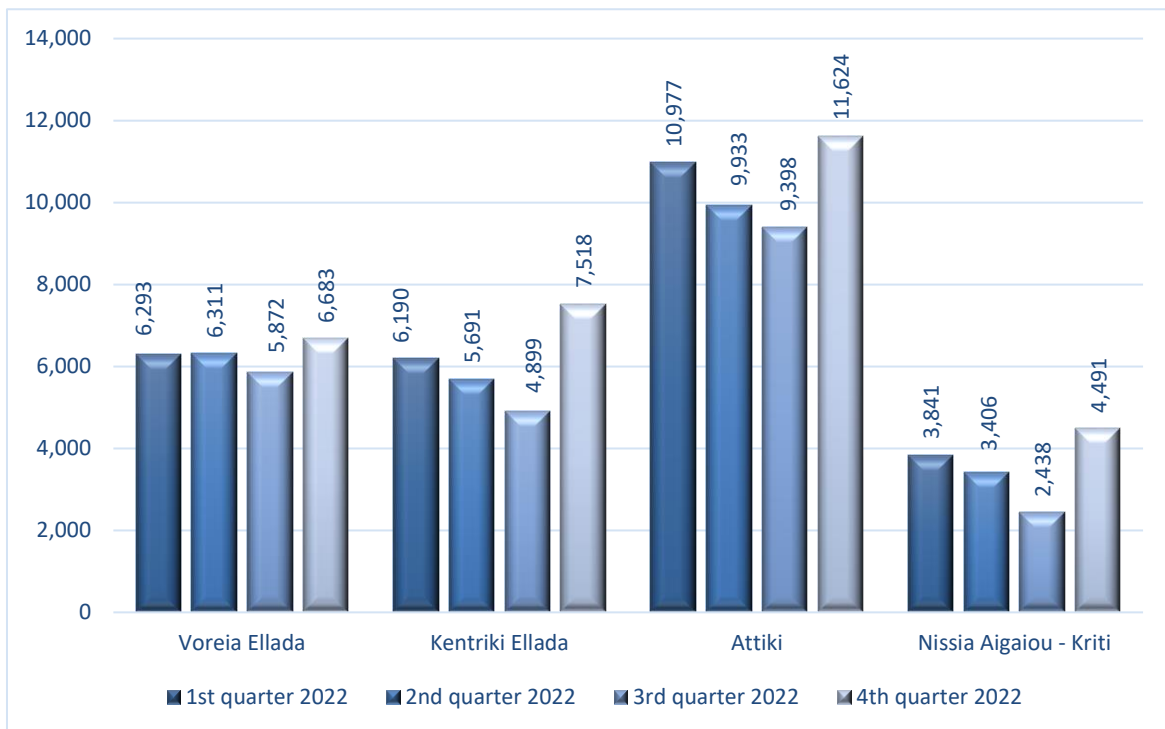

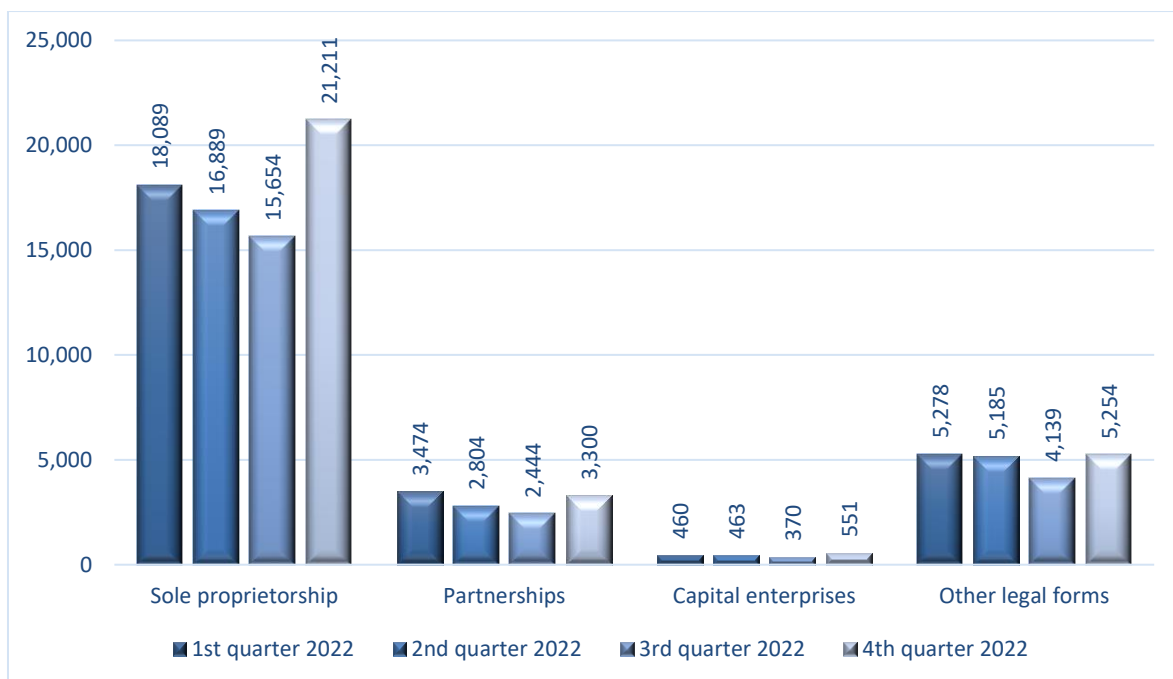

## METHODOLOGICAL NOTES

**General Information** The compilation of the statistical data is made in accordance with the new European Regulation on Business Statistics, which entered into force on the 1<sup>st</sup> of January 2021 ([Regulation \(EU\) 2019/2152 of the European Parliament and of the Council of 27<sup>th</sup> November 2019](#)) and is among the key changes introduced by this Regulation for new and high-frequency official business statistics at European level.

The statistical data presented in this announcement refer to business demography and more specifically to the registrations and bankruptcies of enterprises, which are defined as follows:

**Registrations:** The number of entered legal units in the registration register at any time during the reference quarter, according to the respective administrative or legal procedure.

**Bankruptcies:** The number of legal units that have started the procedure of being declared bankrupt, by issuing a court declaration, at any time during the reference quarter (which is often provisional and does not always mean cessation of an activity).

**Purpose** The purpose of the short-term business statistics, is to provide up-to-date and high frequency information on the evolution of business activity and, subsequently, of the economic climate - expectations.

**Legal framework** Short-term business statistics are compiled in accordance with [Regulation \(EU\) 2019/2152 of the European Parliament and of the Council of 27<sup>th</sup> November 2019](#), on European business statistics and [Commission Implementing Regulation \(EU\) 2020/1197 of 30<sup>th</sup> July 2020](#), laying down technical specifications and arrangements pursuant to Regulation (EU) 2019/2152.

**Compilation methodology** The statistical data have been compiled after processing quarterly data from administrative registers of enterprises. Specifically, information has been used for the date of registration in the register of legal units (Tax Identification Number - TIN), economic activity, geographical code, legal form and business status of the enterprise.

**Statistical classifications** As regards the economic activities, the European statistical classification of economic activities [NACE Rev.2](#) is used. As regards the geographical representation, the European Nomenclature of territorial units for statistics, NUTS, is used.
