EVOLUTION OF TURNOVER OF ENTERPRISES IN

ACCOMMODATION AND FOOD SERVICE ACTIVITIES

MARCH AND 1st QUARTER 2022

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country. At the same time, under the recent circumstances, the monitoring and dedicated publication of the evolution of these economic activities has become imperative, given the direct and indirect adverse impact they have been subjected to, due to the pandemic of coronavirus disease 2019 (COVID-19).

The current publication is part of the Press Releases series published by ELSTAT (PR link), since April 2020, incorporating the most recent data on turnover from Administrative Sources for March and 1st quarter 2022.

Similar publications have been planned and are released on a monthly basis, throughout the whole period during which the regular monitoring of the evolution of the turnover of enterprises providing Accommodation and Food and Beverage Service Activities remains relevant and warranted.

In particular, the Hellenic Statistical Authority (ELSTAT) announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2022.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Starting from the press release published in April 2022 (reference period February 2022), an updated framework for the determination of enterprises classified in Accommodation and Food and Beverage Service Activities divisions is used, which occurs from the linking at micro-data level of administrative transactions files of the reference years 2019, 2020, 2021 and 2022 and of the final Statistical Business Register, of the reference year 2019, that provides a standardized set of data, harmonized with European classifications.

Specifically,

For the total of enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification)**, the turnover in the first quarter 2022 amounted to 283,075,798 euro, recording an increase of 204.9% in comparison with the first quarter 2021, when the respective turnover was 92,855,293 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the largest increase in the turnover of the first quarter 2022 compared to the first quarter of 2021 was recorded in the Regional Unit Rodos (560.1%) and the smallest increase (66.7%) was recorded in the Regional Unit Kos (Table 2).

For the total of enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, the turnover in the first quarter 2022 amounted to 1,117,240,187 euro, recording an increase of 120.9% in comparison with the first quarter 2021, when the respective turnover was 505,773,774 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the largest increase in the turnover of the first quarter 2022 compared to the first quarter of 2021 was recorded in the Regional Unit Thira (350.2%) and the smallest increase (86.1%) was recorded in the Regional Unit Iraklio (Table 3).

For the enterprises in **Accommodation Activities (division 55 of NACE Rev.2 classification)**, **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2022 amounted to 91,897,549 euro, recording an increase of 240.7% in comparison with March 2021, when the respective turnover was 26,969,308 euro (Table 4).

For the enterprises in **Food and Beverage Service Activities (division 56 of NACE Rev.2 classification)**, **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in March 2022 amounted to 123,882,427 euro, recording an increase of 115.2% in comparison with March 2021, when the respective turnover was 57,555,388 euro (Table 4).

For the enterprises in Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of NACE Rev. 2 classification), obliged to double-entry bookkeeping, for which data are available on a monthly basis, the turnover in March 2022 amounted to 215,779,976 euro, recording an increase of 155.3% in comparison with March 2021, when the respective turnover was 84,524,696 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2021 greater than 1.0% (Table 1), the biggest increase in the turnover of March 2022 compared with March 2021 was recorded in the Regional Unit Zakynthos (435.8%) and the smallest increase was recorded in the Regional Unit Iraklio (120.9%) (Table 5).






Graph 1: Turnover (in thousand €) of the total of enterprises in the Accommodation Activities (division 55 of NACE Rev. 2 classification)




Graph 2: Turnover (in thousand €) of the total of enterprises in the Food and Beverage Service Activities (division 56 of NACE Rev. 2 classification)

METHODOLOGICAL NOTES

Generally

The statistical data presented in this Press Release have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2019.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021 and 2022.

In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2019.
- Income data from administrative transaction files of the years 2019, 2020, 2021 and 2022.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications

For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.
