



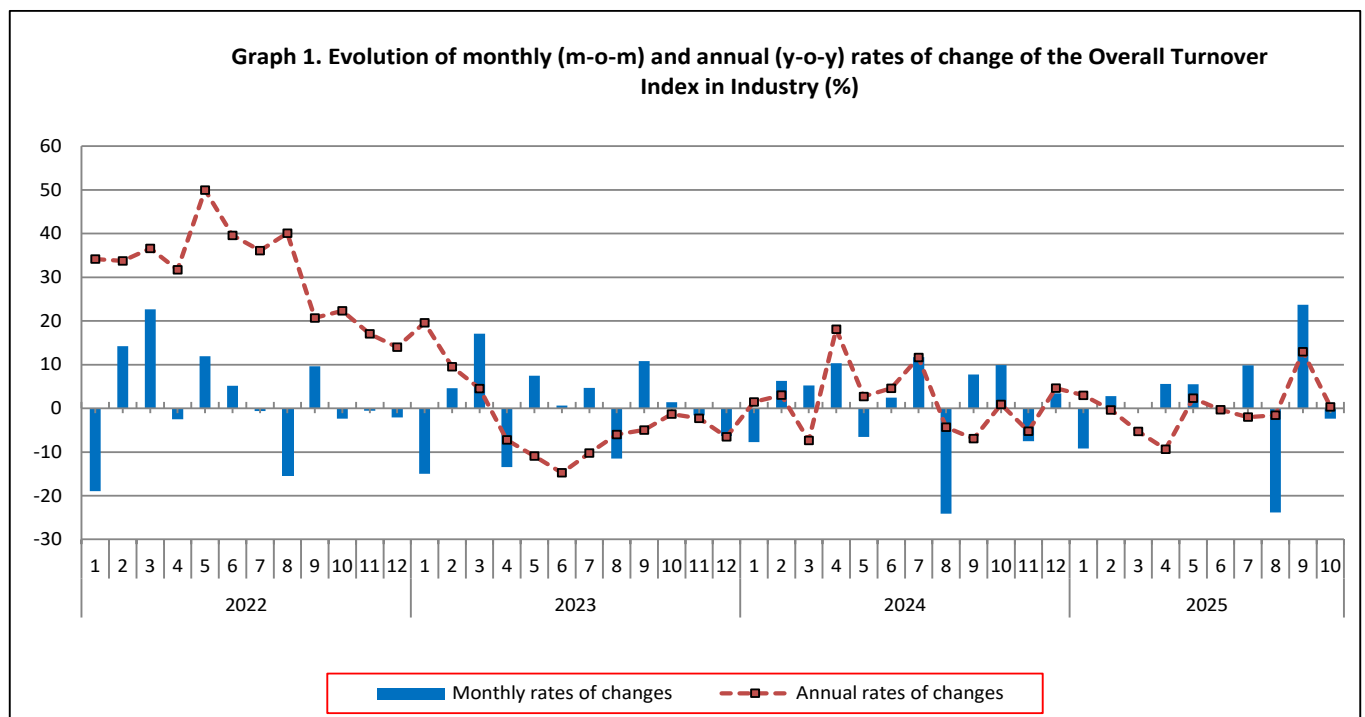
## TURNOVER INDEX IN INDUSTRY October 2025, y-o-y increase of 0.3%

The Hellenic Statistical Authority announces the Turnover Index in Industry with base year 2021=100.0 for October 2025, the evolution of which on the basis of provisional data, is as follows:

The Overall Turnover Index in Industry (both Domestic and Non-Domestic Market) in October 2025 recorded an increase of 0.3% compared with the corresponding index of October 2024. The Overall Turnover Index in Industry in October 2024 increased by 0.9% compared with the corresponding index in October 2023 (Table 1).

The Overall Turnover Index in Industry in October 2025, compared with September 2025, recorded a decrease of 2.4% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from November 2024 to October 2025 decreased by 0.3%, compared with the corresponding index of the 12-month period from November 2023 to October 2024. The average Overall Turnover Index in Industry for the 12-month period from November 2023 to October 2024 increased by 1.1% compared with the corresponding index of the 12-month period from November 2022 to October 2023 (Table 13).

## Evolution of the Overall Turnover Index in Industry in October 2025

### I. Annual changes of the Overall Turnover Index in Industry: October 2025 / October 2024

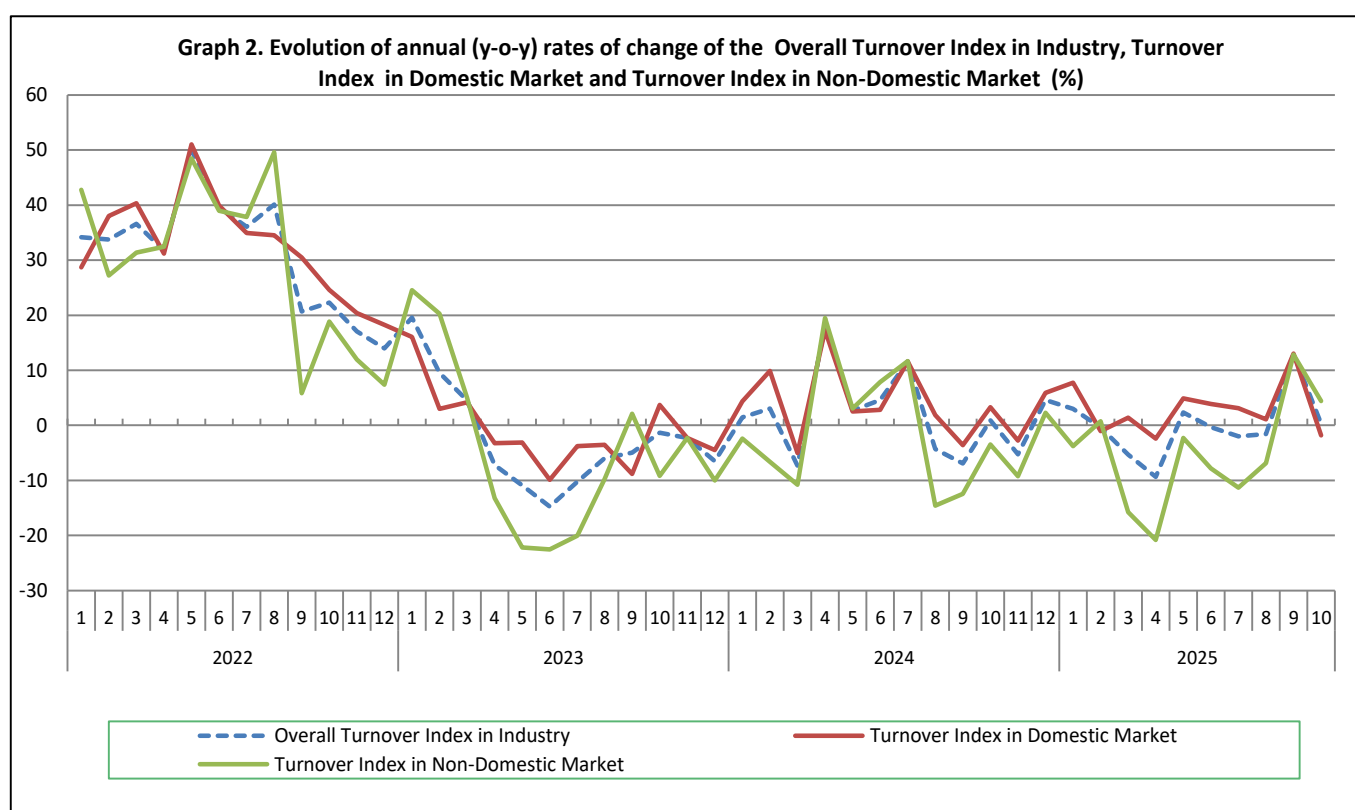
The 0.3% increase of the Overall Turnover Index in Industry in October 2025, compared with the corresponding index in October 2024, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Mining and quarrying increased by 5.6%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of metal ores, other mining and quarrying products.
- The Turnover Index in Manufacturing increased by 0.3%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: computers, electronic and optical products, electrical equipment, basic pharmaceutical products and pharmaceutical preparations, wearing apparel.

#### 2. Changes in the sub-indices in Domestic and Non-Domestic Markets:

- The Turnover Index in Industry in Non-Domestic Market increased by 4.4% (Table 3).
- The Turnover Index in Industry in Domestic Market decreased by 1.8% (Table 2).



### II. Annual changes of the Turnover Index in Industry in Domestic Market: October 2025 / October 2024

The 1.8% decrease of the Turnover Index in Industry in Domestic Market in October 2025, compared with October 2024, is due to the annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Manufacturing decreased by 2.0%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: other transport equipment, motor vehicles, trailers and semi-trailers, coke and refined petroleum products, beverages.
- The Turnover Index in Mining and quarrying increased by 14.5%. The increase was the result of the annual change of the sub-index in the following 2-digit division: other mining and quarrying products.

### III. Annual changes of the Turnover Index in Industry in Non-Domestic Market: October 2025 / October 2024

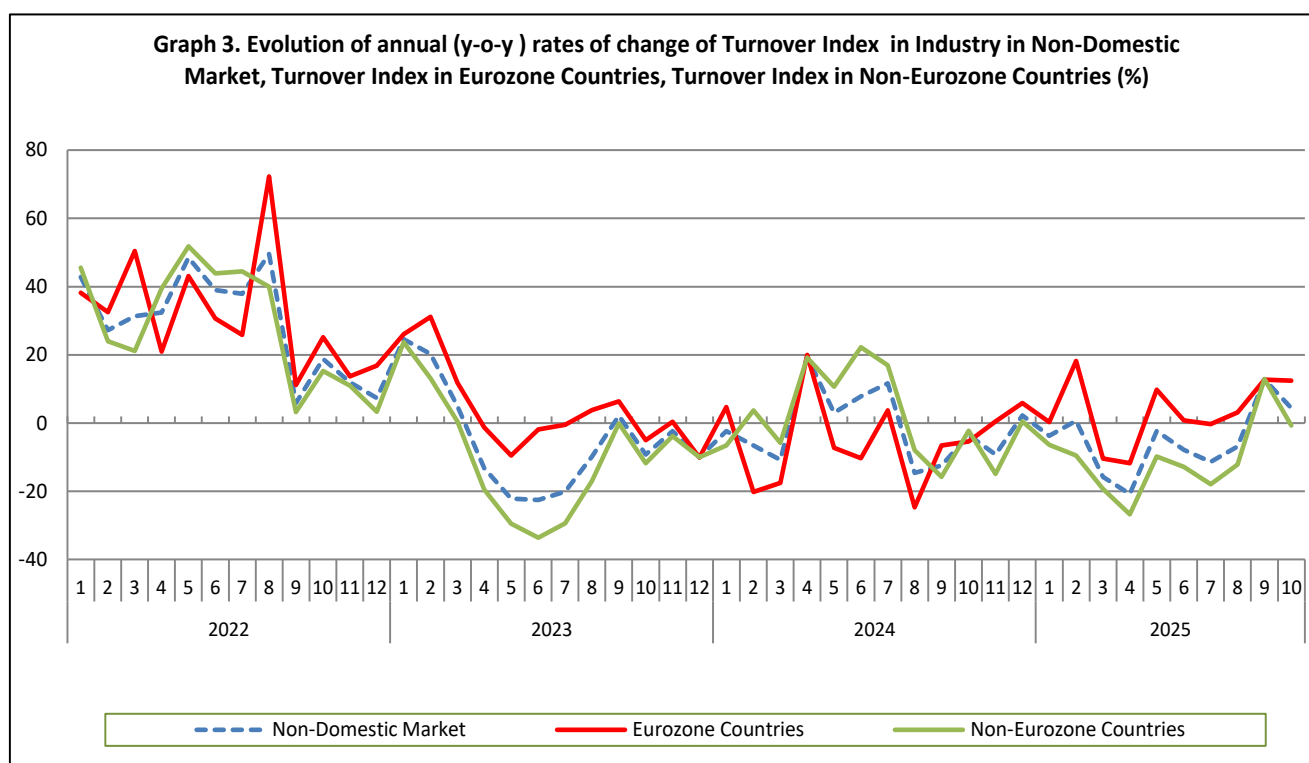
The 4.4% increase of the Turnover Index in Industry in Non-Domestic Market in October 2025, compared with October 2024, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Manufacturing increased by 4.6%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: computers, electronic and optical products, furniture, paper and paper products, machinery and equipment n.e.c.
- The Turnover Index in Mining and quarrying decreased by 5.0%. The decrease was mainly the result of the annual change of the sub-index in the following 2-digit division: other mining and quarrying products.

#### 2. Changes in the sub-indices in Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry in Eurozone countries increased by 12.4% (Table 4).
- The Turnover Index in Industry in Non-Eurozone countries decreased by 0.6% (Table 5).



### IV. Monthly changes of the Overall Turnover Index in Industry: October 2025 / September 2025

The 2.4% decrease of the Overall Turnover Index in Industry in October 2025, compared with the corresponding index in September 2025, was due to the following:

#### 1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Manufacturing decreased by 2.4%.
- The Turnover Index in Mining and quarrying decreased by 0.01%.

#### 2. Changes in the sub-indices in Domestic and Non-Domestic Market:

- The Turnover Index in Industry in Domestic Market decreased by 2.7% (Table 7).
- The Turnover Index in Industry in Non-Domestic Market decreased by 1.9% (Table 8).

## METHODOLOGICAL NOTES

<b>Generally</b>	The Industrial Turnover Index is an indicator of an enterprise's business cycle showing the monthly evolution of the market of goods and services in industry. The first compilation of the Turnover Index was completed by the Hellenic Statistical Authority in 2006, with base year 2000=100.0 and is compiled from 2000 onwards.
<b>Purpose of the index</b>	The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.
<b>Legal Framework</b>	The compilation and publication of the Turnover Index is based on the Regulation (EU) No 2019/2152 of the European Parliament and of the Council on European business statistics, as well as Commission Implementing Regulation (EU) No 2020/1197 laying down technical specifications and arrangements pursuant to Regulation (EU) No 2019/2152. Furthermore, the indices are governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council.
<b>Reference period</b>	Month.
<b>Base year</b>	2021=100.0.
<b>Revision</b>	Pursuant to the provisions of Council Regulation No 2019/2152 concerning the indices, they are updated, every five (5) years in years ending in 0 or 5, while, in the current revision 2021=100.0 due to the impact of the pandemic, they were revised with base year the year 2021.
<b>Statistical classifications</b>	At the level of classes of economic activities, the statistical classification of economic activities NACE Rev. 2 of EU was used (Regulation No 1893/2006), while at the level of main industrial groupings, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with Commission Regulation No 656/2007.
<b>Geographical coverage</b>	The index covers the whole Country.
<b>Coverage of economic activities</b>	The Turnover Index in Industry is compiled for all activities listed in Sections B (mining and quarrying) and C (manufacturing) of the NACE Rev. 2 statistical classification.
<b>Computation of the Index</b>	The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level and two-level of economic activity) as well as at the level of Main Industrial Groupings (MIGs).
<b>Publication of data</b>	The Turnover Index in Industry (2021=100.0) is released since December 2024 with October 2024 as first reference month. Data with base year 2021=100.0 are available from January 2000 onwards.
