SUPPLY & USE TABLES 2021 revision of Base Year & revision of years 2010-2020

SYMMETRIC INPUT – OUTPUT TABLES revision of Base Year & revision of years 2010, 2015 and 2020

The Hellenic Statistical Authority (ELSTAT) announces the Supply and Use Tables for year 2021, the revised Supply and Use Tables for years 2010-2020, as well as the revised Symmetric Input-Output Tables for years 2010, 2015 and 2020. These tables are compiled according to the European System of National and Regional Accounts ESA 2010 (Regulation (EU) No 549/2013 of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union – ESA 2010), as amended by Regulation (EU) 2023/734 of the European Parliament and of the Council and are consistent with the respective annual national figures.

It is noted that the results of the Benchmark Revision of Annual National Accounts with new base year 2020=100.0 and reference year 2021 have been incorporated in the Tables annuanced with this annuancement.

Gross Domestic Product (2nd estimate)

Supply-Use and Input-Output Tables provide detailed information for a given year on production activities, the supply and demand of goods and services, intermediate consumption, primary inputs and foreign trade.

Supply and Use Tables are matrices by product and industry showing the production processes and transactions for particular products or industries.

Symmetric Input-Output Tables are product-by-product or industry-by-industry matrices combining both Supply and Use into a single table with identical classification of products or industries, applied to both rows and columns.

These tables present:

- a) the structure of the costs of production and the value added that is generated in the production process;
- b) the flows of goods and services produced in the Greek territory; and
- c) the flows of goods and services with the rest of the world.

For the compilation of Supply-Use and Input-Output Tables, data are used from the tables compiled by the National Accounts Division of ELSTAT for the calculation of Gross Domestic Product and the macroeconomic variables.

The data sources used concern mainly:

- Surveys carried out by ELSTAT, like Structural Business Surveys (SBS), Household Budget Survey, Foreign Trade Statistics, Labor Force Survey, Labor Cost Survey, the census of population and buildings, Short Term Indicators for the volume and the prices etc.
- Data from the business register of ELSTAT
- Administrative sources, like the State Budget Outturn etc.
- Balance of Payments data from the Bank of Greece
- Other sources, like financial data of enterprises etc.

The data are presented using NACE Rev. 2 in 64 industries and under the CPA 2008 in 64 products.

The figures in the Supply-Use and Input-Output Tables are in current prices and the figures in the Symmetric Input – Output Table are in basic prices of the reference year.
