ACTIVITIES OF NOTARIES: Year 2023

The Hellenic Statistical Authority (ELSTAT) announces statistics on the activities of notaries for the year 2023. The data derive from the annual census survey on notaries which is conducted by ELSTAT on the basis of a standard statistical questionnaire filled in by the notaries all over Greece, with the cooperation of their Regional Associations. The total of notaries for the year 2023 was 2,654.

In 2023, the concluded notaries' deeds were 837,726 in comparison with 804,322 in 2022, recording an increase of 4.2%. On the basis of the available data for the period 2014 – 2023, an increase of 67.2% is recorded taking into account the conclusion of 837,726 deeds in 2023 compared with 500,992 deeds in 2014 (Tables 1, 2).

In the year 2023 compared to the year 2022, the following categories recorded the greater increase:

- "Real estate transactions", 122,123 deeds compared to 112,283
- "Auctions", 7,291 deeds compared to 5,760 and
- "Loans", 653 deeds compared to 485 (Tables 1, 2).

In the year 2023, the main notarial deeds drawn up concern the following categories:

- "Deeds of procuration" (207,848 deeds)
- "Real estate transactions" (122,123 deeds). It should be clarified that the data on real estate transactions refer to the relevant deeds concluded (a deed may relate to more than one real estate or share/s of immovable property).
- "Wills and testaments" (33,124 deeds) (Tables 1, 2).





EXPLANATORY NOTES

Survey on Notaries' activities The survey on Notaries' Activities is a census survey; it is conducted on a yearly basis, during the 1st semester of the year n for the data referring to the year n-1. The

survey collects information on the number of notarial deeds per year by type of deed. The collected data are broken down by Judicial Regions of Courts of Appeal. The competent persons for the completion of the annual statistical table of notarial deeds are the Notaries.

The main variables of the survey are the Judicial Region and the type of deeds, such as notices for seizure, protests, wills and testaments, real estate transactions, donations, parental grants, deeds of procuration, etc.

From reference year 2018, the following notarial deeds have been added: acknowledgement of paternity of child, registered partnerships, dissolution of registered partnerships, dissolution of marriages by mutual consent. It is noted that these are notarial deeds of dissolution of marriages by mutual consent which were carried out in the corresponding year, which are then required to be declared in the competent Registries.

- Legal basis The survey on the notaries' activities is conducted by virtue of the Greek Statistical Law 3832/2010, as in force, and the Joint Ministerial Decision 10498/B115/16.05.1963.
- Periodicity Annual
- **Definitions** Notaries are unsalaried public officials. They are appointed to existing places following a public competition; their main duty is to draft contracts, wills, memoranda of agreement etc. Their professional status is governed by the Notaries Code, and they are organized in professional associations of notaries. The geographical distribution of the deeds is according to the seat of the notaries who concluded the acts, aggregated by the regions of Courts of Appeal.

Type of notarial deeds:

- Notices of seizure
- Auctions: refers to the concluded auctions. Postponements, annulments, non-awarded auctions are included in "Other deeds".
- Wills and testaments
- Establishment/dissolution of companies
- Real estate transactions: a deed that refers to more than one transaction of immovable property or share/s of immovable property is counted as one transaction.
- Vehicles purchase and sales.
- Donations (in life, in prospect of death)
- Parental grants
- Loans deeds
- Procuration deeds
- Acknowledgement of paternity of child
- Dissolution of registered partnerships
- Dissolution of marriages by mutual consent
- Other deeds: lease contracts, statements in writing sworn, statements of legal capacity, approvals of private agreements, zone reservation contracts, distributions, exchanges, assignments, mergers, acceptance of inheritance, registered partnerships etc.
- **Methodology** Data are collected through a standard statistical table which is filled in by the Notaries.
