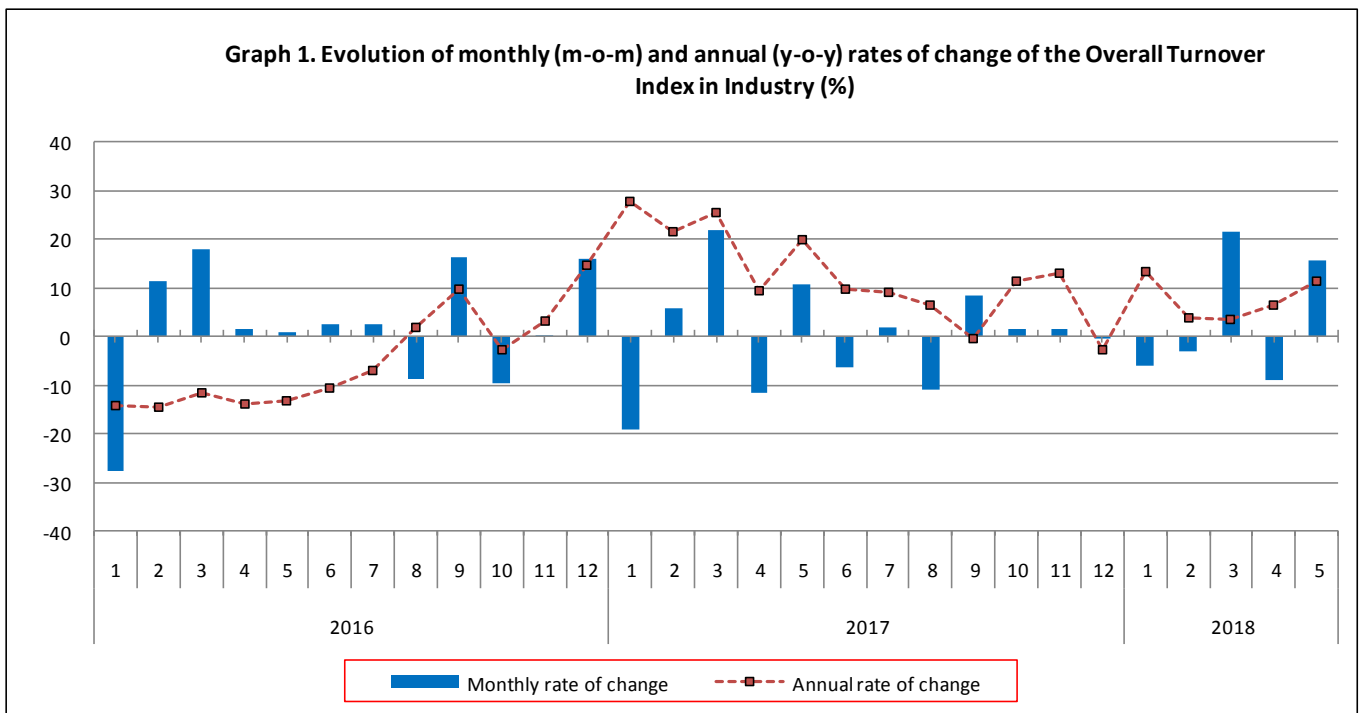
### TURNOVER INDEX IN INDUSTRY: May 2018, y-o-y increase of 11.4%

The evolution of the Turnover Index in Industry with base year 2010=100.0 for May 2018, on the basis of provisional data, is as follows:

The Overall Turnover Index in Industry (both domestic and non-domestic market) in May 2018 recorded an increase of 11.4% compared with the corresponding index of May 2017. In May 2017, the corresponding annual rate of change of the Overall Turnover Index in Industry was 20.1% (Table 1).

The Overall Turnover Index in Industry in May 2018, compared with April 2018, recorded an increase of 15.7% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from June 2017 to May 2018 increased by 6.9%, compared with the corresponding index of the 12-month period from June 2016 to May 2017. In May 2017, the corresponding annual rate of change of the Overall Turnover Index in Industry was 8.5% (Table 13).

## Evolution of the Overall Turnover Index in Industry

### I. Annual changes of the Overall Turnover Index in Industry: May 2018/May 2017

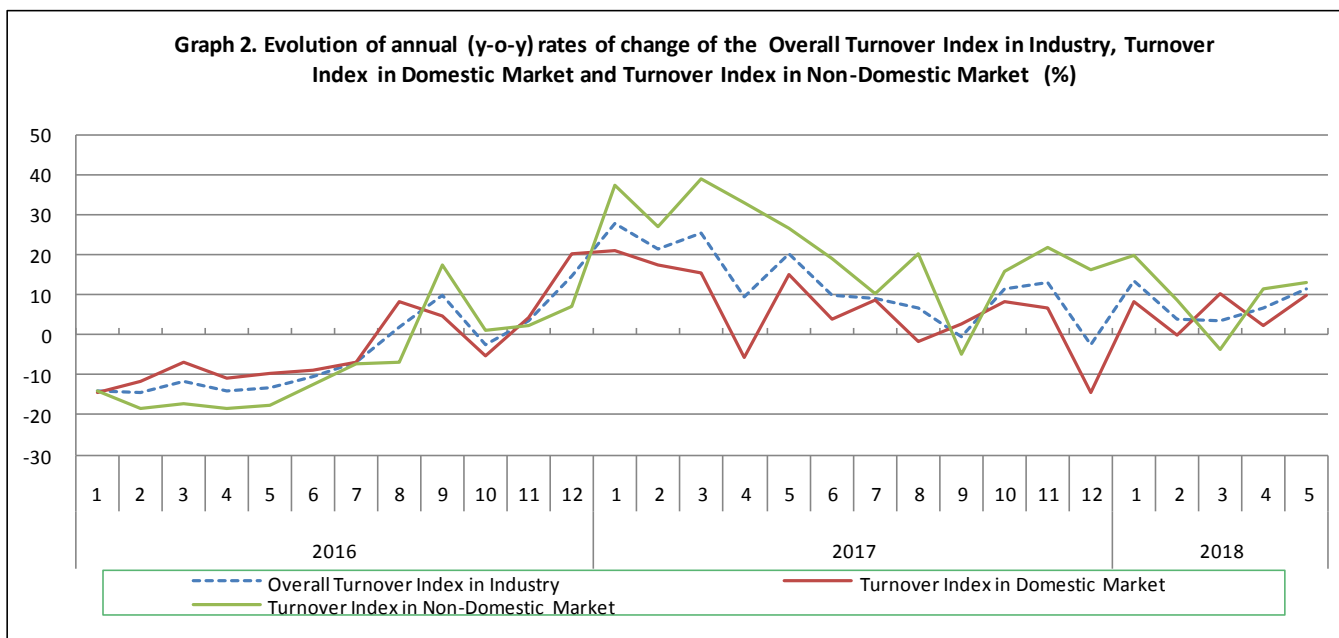
The 11.4% increase in the Overall Turnover Index in Industry in May 2018, compared with the corresponding index in May 2017, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Manufacturing increased by 11.6%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, paper and paper products, coke and refined petroleum products, basic pharmaceutical products and pharmaceutical preparations.
- The Turnover Index in Mining and quarrying decreased by 1.4%. The decrease was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite, other mining and quarrying products.

#### 2. Changes in the sub-indices of the domestic and non-domestic market:

- The Turnover Index in Industry for the domestic market increased by 10.0% (Table 2).
- The Turnover Index in Industry for the non-domestic market increased by 13.1% (Table 3).



### II. Annual changes of the Turnover Index in Industry in the Domestic Market: May 2018/May 2017

The 10.0% increase of the Turnover Index in Industry for the domestic market in May 2018, compared with May 2017, is due to the following annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Manufacturing increased by 10.2%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: beverages, tobacco products, paper and paper products, coke and refined petroleum products, furniture.
- The Turnover Index in Mining and quarrying decreased by 5.9%. The decrease was the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite, mining of metal ores.

### III. Annual changes of the Turnover Index in Industry in the Non-Domestic Market: May 2018/May 2017

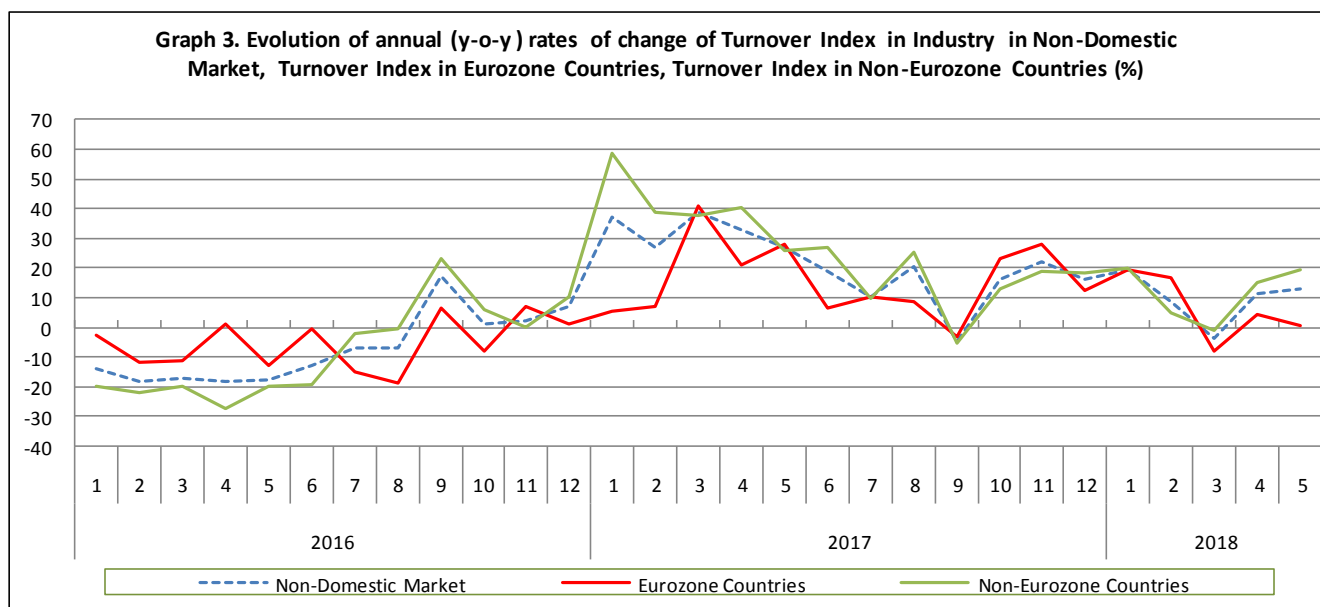
The 13.1% increase of the Turnover Index in Industry for the Non-Domestic market in May 2018, compared with May 2017, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Mining and quarrying increased by 1.0%. The increase was the result of the annual change of the sub-index in the following 2-digit division: mining of metal ores.
- The Turnover Index in Manufacturing increased by 13.4%. The increase was the result of the annual changes of the sub-indices in the following 2-digit divisions: paper and paper products, coke and refined petroleum products, basic pharmaceutical products and pharmaceutical preparations, basic metals.

#### 2. Changes in the sub-indices for Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry for Eurozone countries increased by 0.4% (Table 4).
- The Turnover Index in Industry for non-Eurozone countries increased by 19.4% (Table 5).



### IV. Monthly changes of the Overall Turnover Index in Industry: May 2018/ April 2018

The 15.7% increase of the Overall Turnover Index in Industry in May 2018, compared with the corresponding index in April 2018, was due to the following:

#### 1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Mining and quarrying increased by 13.0%.
- The Turnover Index in Manufacturing increased by 15.7%.

#### 2. Changes in the sub-indices of the domestic and non-domestic market:

- The Turnover Index in Industry for the domestic market increased by 24.4% (Table 7).
- The Turnover Index in Industry for the non-domestic market increased by 6.9% (Table 8).

## METHODOLOGICAL NOTES

<b>Generally</b>	The Turnover Index is compiled since January 2006.
<b>Purpose of the index</b>	The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced (without VAT) by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.
<b>Legal basis</b>	The compilation and publication of the Turnover Index is based on the framework of requirements of Council Regulation (EC) No 1165/98 concerning short-term statistics (STS-R), as well as Regulation (EC) No 1158/05 of the European Parliament and Council amending Council Regulation (EC) No 1165/98. Furthermore, this index is governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council, by Commission Regulation (EC) No 656/2007 and by Regulation (EC) No 451/2008 of the Council.
<b>Reference period</b>	Month.
<b>Base year</b>	2010=100.0.
<b>Revision</b>	The latest revision of the Turnover Index in Industry (base year 2010=100.0) took place in the framework of Council Regulation (EC) No 1165/98 concerning short-term statistics. In accordance with this regulation the index is revised every five years, in years ending in 0 or 5.
<b>Statistical classifications</b>	At the level of categories of economic activities, the classification of NACE Rev. 2 was used (Regulation No 1893/2006), while at the level of main industrial groups, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was used, in accordance with Commission Regulation No 656/2007. At product level, the Eurostat classification CPA 2008 was used, pursuant to Council Regulation No 451/2008.
<b>Geographical coverage</b>	The Index covers the whole Country.
<b>Coverage of economic activities</b>	The Turnover Index in Industry covers the whole country and is compiled for all activities listed in Sections C (mining and quarrying) and D (manufacturing) of the NACE Rev.2 classification.
<b>Computation of the Index</b>	The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level, two-level and one-level of economic activity) or at the level of Main Industrial Groupings (MIGs).
<b>Publication of data</b>	The Turnover Index in Industry (2010=100.0) is released since November 2014 with September 2014 as first reference month. Data with base year 2010=100.0 are available from January 2000 onwards.
