



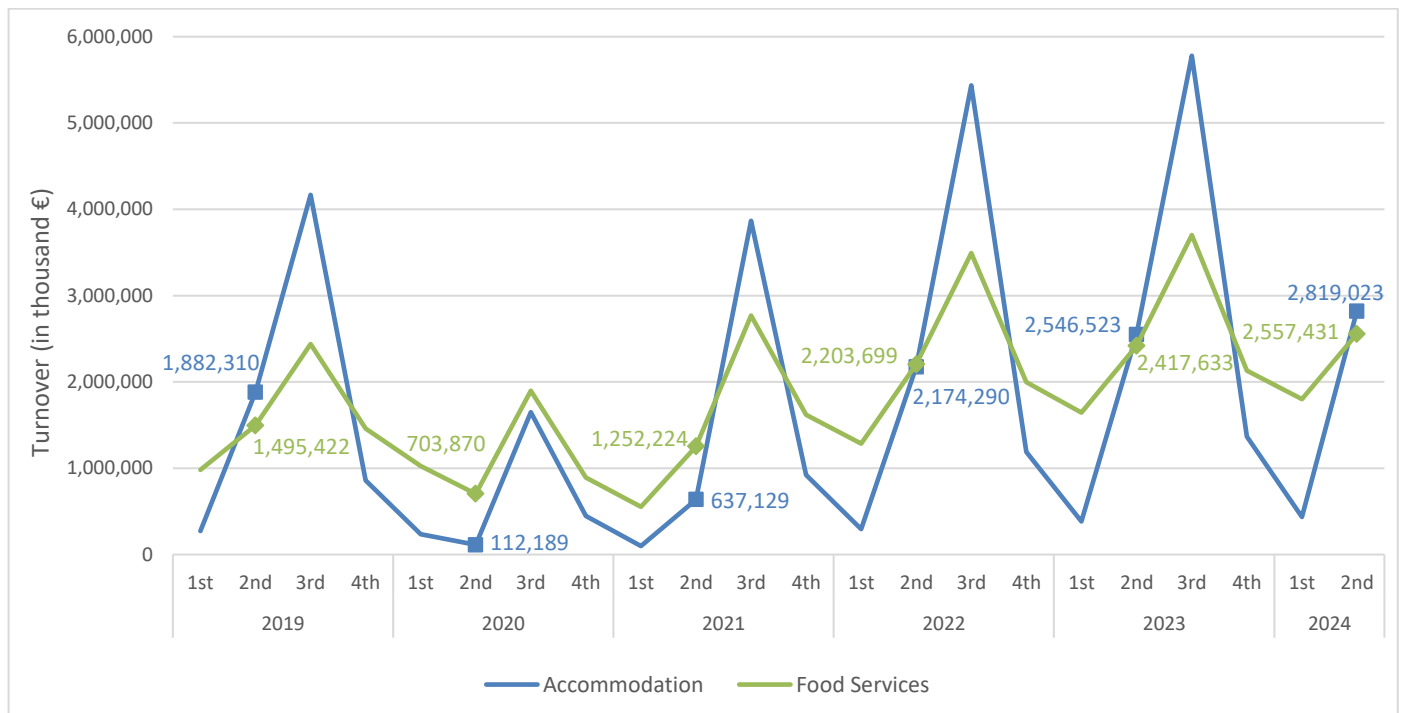
EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES JUNE, 2ND QUARTER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **June and 2nd quarter 2024**.

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in the second quarter 2024 amounted to 2,819,022,548 euro, recording an increase of 10.7% in comparison with the second quarter 2023, when the respective turnover was 2,546,523,445 euro (Graph 1, Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in the second quarter 2024 amounted to 2,557,431,370 euro, recording an increase of 5.8% in comparison with the second quarter 2023, when the respective turnover was 2,417,633,471 euro (Graph1, Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of the second quarter 2024 compared to the second quarter of 2023 was recorded in the Regional Unit Chalkidiki (20.4%) and the smallest increase (2.9%) was recorded in the Regional Unit Thessaloniki, while the biggest decrease was recorded in the Regional Unit Mykonos (12.1%) (Table 1).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of the second quarter 2024 compared to the second quarter of 2023 was recorded in the Regional Unit Chalkidiki (25.2%) and the smallest increase (0.5%) was recorded in the Regional Unit Ioannina, while the biggest decrease was recorded in the Regional Unit Mykonos (7.4%) (Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2024 amounted to 1,340,480,397 euro, recording an increase of 11.1% in comparison with June 2023, when the respective turnover was 1,206,973,143 euro (Table 3).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2024 amounted to 313,052,796 euro, recording an increase of 13.7% in comparison with June 2023, when the respective turnover was 275,328,134 euro (Table 3).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in June 2024 amounted to 1,653,533,193 euro, recording an increase of 11.6% in comparison with June 2023, when the respective turnover was 1,482,301,277 euro (Table 3). For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of June 2024 compared with June 2023 was recorded in the Regional Unit Kos (16.3%) and the smallest increase (1.5%) was recorded in the Regional Unit Thessaloniki (Table 4).

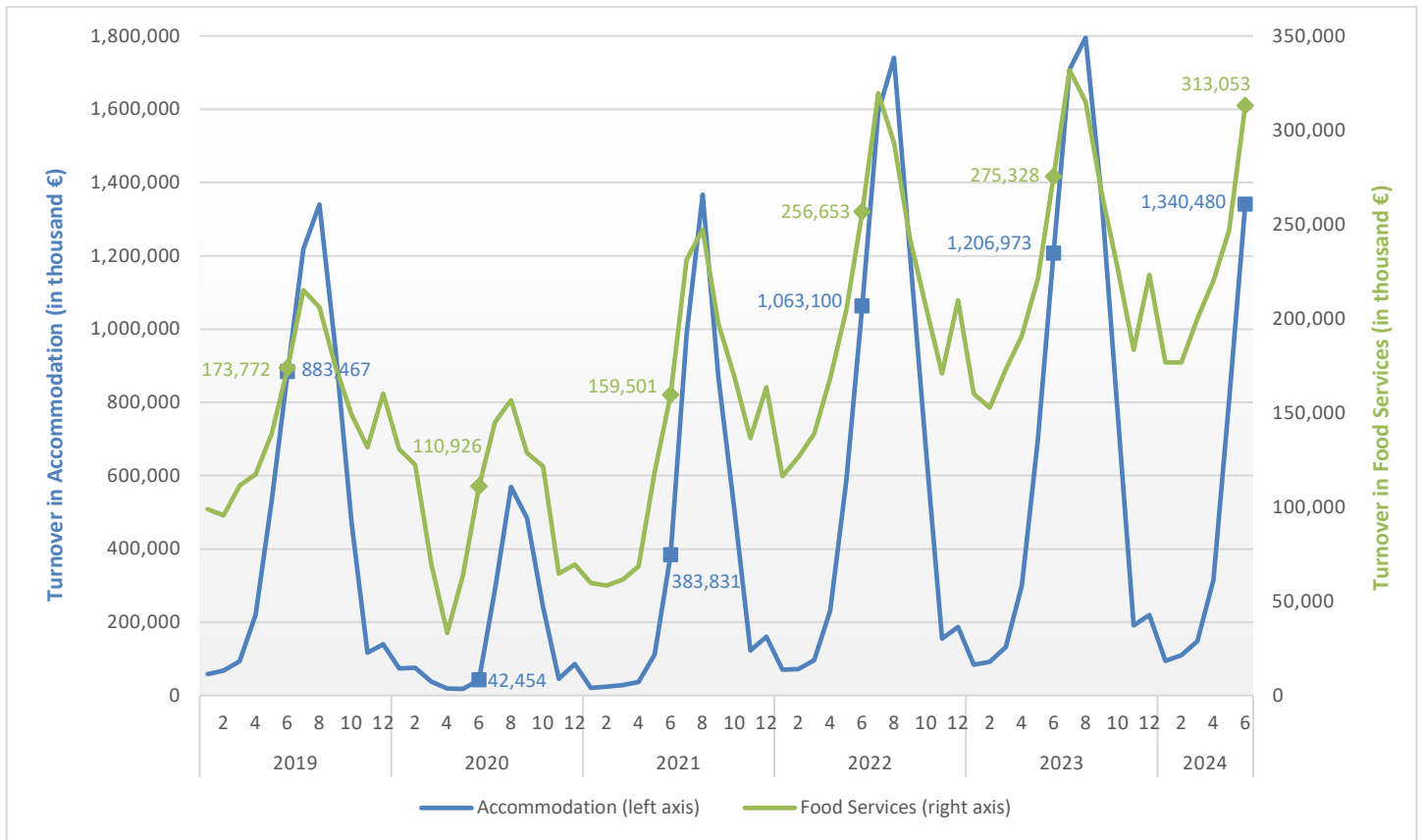

METHODOLOGICAL NOTES

Generally The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

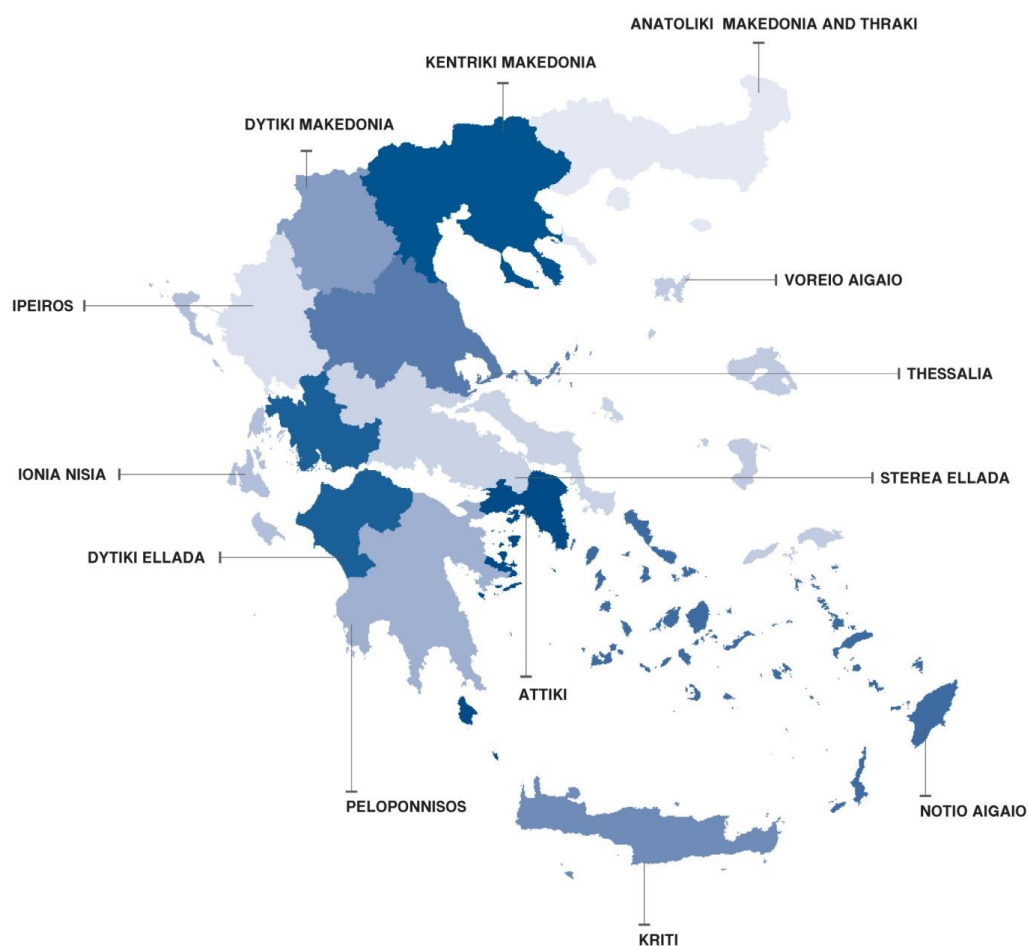
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transaction files of the years 2019 to 2024.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications For the economic activities the European statistical classification of economic activities [NACE Rev.2](#) is used.
