
## EVOLUTION OF TURNOVER OF ENTERPRISES IN ACCOMMODATION AND FOOD SERVICE ACTIVITIES SEPTEMBER, 3<sup>RD</sup> QUARTER 2024

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in the Accommodation and Food and Beverage Service Activities divisions, per Regional Unit, incorporating the most recent data on turnover from Administrative Sources for **September and 3<sup>rd</sup> quarter 2024.** 

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev. 2 classification), the turnover in the third quarter 2024 amounted to 6,177,866,375 euro, recording an increase of 6.9% in comparison with the third quarter 2023, when the respective turnover was 5,779,046,583 euro (Graph 1, Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), the turnover in the third quarter 2024 amounted to 3,708,863,769 euro, recording an increase of 0.2% in comparison with the third quarter 2023, when the respective turnover was 3,701,529,355 euro (Graph1, Table 2).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev. 2 classification), of the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of the third quarter 2024 compared to the third quarter of 2023 was recorded in the Regional Unit Rodos (17.4%) and the smallest increase (1.2%) was recorded in the Regional Unit Messinia, while the biggest decrease was recorded in the Regional Unit Mykonos (8.4%) (Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2024 amounted to 1,480,985,268 euro, recording an increase of 9.2% in comparison with September 2023, when the respective turnover was 1,356,560,795 euro (Table 3).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2024 amounted to 288,838,567 euro, recording an increase of 8.3% in comparison with September 2023, when the respective turnover was 266,787,992 euro (Table 3).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2024 amounted to 1,769,823,835 euro, recording an increase of 9.0% in comparison with September 2023, when the respective turnover was 1,623,348,787 euro (Table 3). For the Regional Units with a contribution to the total turnover of the year 2023 greater than 1.0% (Table 5), the biggest increase in the turnover of September 2024 compared with September 2023 was recorded in the Regional Unit Kerkyra (18.1%) and the smallest increase (4.3%) was recorded in the Regional Unit Thessaloniki (Table 4).



**Generally** The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:


- The final Statistical Business Register of ELSTAT of the reference year 2021.
- Administrative registers of enterprises, of the reference years 2022 and 2023.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2024.

In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2021.
- The economic activity class for the enterprises that started their activity after the reference year 2021 and have a significant turnover, from administrative registers of enterprises of the reference years 2022 and 2023.
- Income data from administrative transaction files of the years 2019 to 2024.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

**Statistical** For the economic activities the European statistical classification of economic activities <u>NACE Rev.2</u> is used. **classifications**
