COMMERCIAL TRANSACTIONS OF GREECE : July 2021

(Provisional Data)

The total value of imports-arrivals, in July 2021 amounted to 5,651.2 million euros (6,661.0 million dollars) in comparison with 4,570.3 million euros (5,223.2 million dollars) in July 2020, recording an increase, in euros, of **23.7%**. The corresponding value excluding oil products in July 2021 recorded an increase of 413.5 million euros or 11.1% and the corresponding value excluding oil products and ships in July 2021 recorded an increase of 421.1 million euros or 11.4%, in comparison with July 2020 (Table 1).

The total value of exports-dispatches, in July 2021 amounted to 3,530.2 million euros (4,185.6 million dollars) in comparison with 2,924.4 million euros (3,362.6 million dollars) in July 2020, recording an increase, in euros, of **20.7%**. The corresponding value excluding oil products recorded in July 2021 an increase of 251.4 million euros or 10.7% and the corresponding value excluding oil products and ships in July 2021 recorded an increase of 261.3 million euros or 11.2%, in comparison with July 2020 (Table 1).

The deficit of the trade balance, in July 2021 amounted to 2,121.0 million euros (2,475.4 million dollars) in comparison with 1,645.9 million euros (1,860.6 million dollars) in July 2020, recording an increase, in euros, of **28.9%**. The corresponding value of deficit excluding oil products in July 2021 recorded an increase of 162.1 million euros or 11.9% and the corresponding value excluding oil products and ships in July 2021 recorded an increase of 159.8 million euros or 11.7%, in comparison with July 2020 (Table 1).

The total value of imports-arrivals, for the 7-month period from January to July 2021 amounted to 34,504.7 million euros (41,309.8 million dollars) in comparison with 28,314.5 million euros (31,321.4 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **21.9%**. The corresponding value excluding oil products recorded an increase of 3,882.8 million euros or 17.1% and the corresponding value excluding oil products and ships recorded an increase of 3,906.2 million euros or 17.3%, in comparison with the period from January to July 2020 (Table 5).

The total value of exports-dispatches, for the 7-month period from January to July 2021 amounted to 22,116.9 million euros (26,644.4 million dollars) in comparison with 17,732.2 million euros (19,734.2 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **24.7%**. The corresponding value excluding oil products recorded an increase of 2,518.5 million euros or 18.1% and the corresponding value excluding oil products and ships recorded an increase of 2,505.9 million euros or 18.1%, in comparison with the period from January to July 2020 (Table 5).

The deficit of the trade balance, for the 7-month period from January to July 2021 amounted to 12,387.8 million euros (14,665.4 million dollars) in comparison with 10,582.3 million euros (11,587.2 million dollars) for the corresponding period of the year 2020, recording an increase, in euros, of **17.1%**. The corresponding deficit excluding oil products recorded an increase of 1,364.3 million euros or 15.5% and the corresponding deficit excluding oil products and ships recorded an increase of 1,400.3 million euros or 16.1% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

Diagram 1. Imports - Arrivals, Exports - Dispatches, July 2019-2021, million €

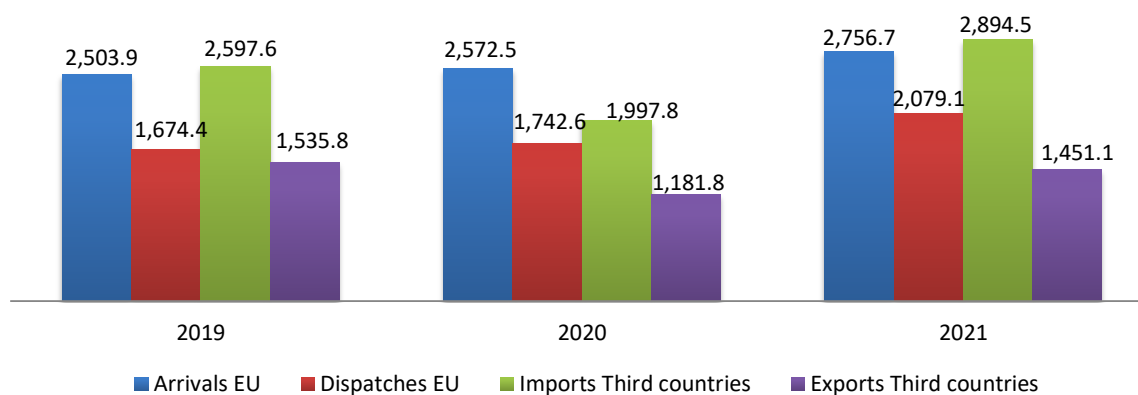

Diagram 2. Imports - Arrivals, Exports - Dispatches excluding oil products, July 2019-2021, million €

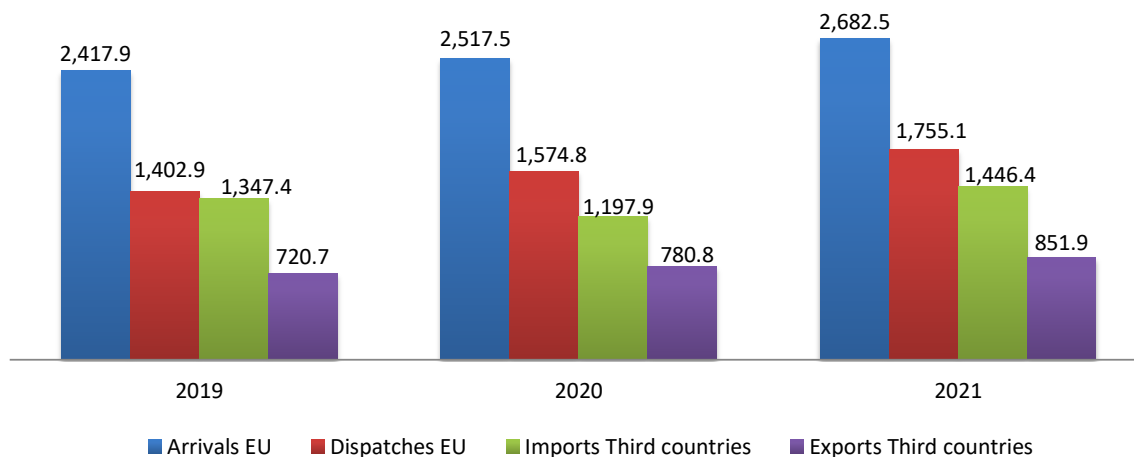

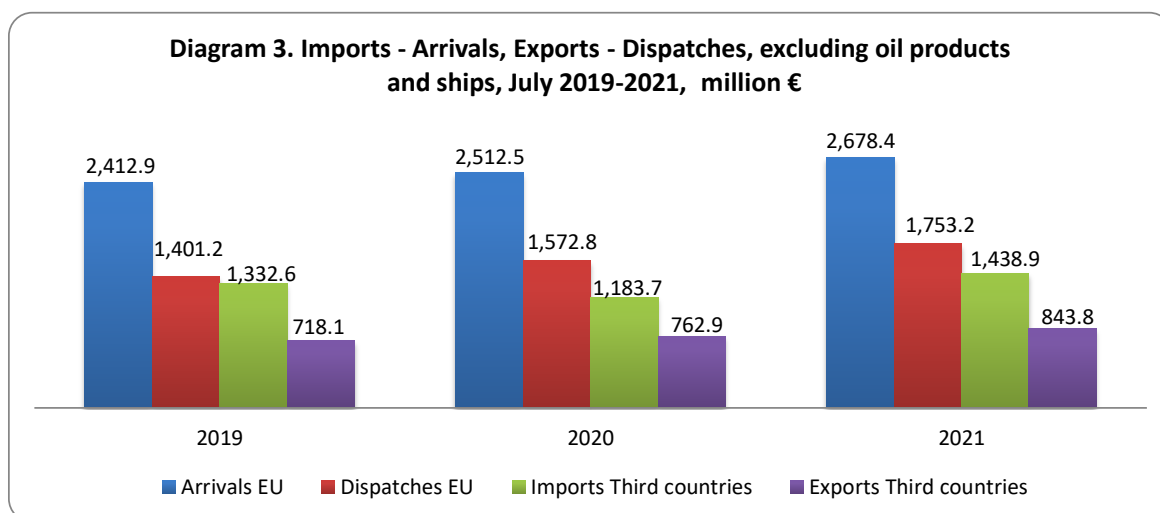

Diagram 4. Imports - Arrivals, Exports - Dispatches, January - July 2019-2021, million €

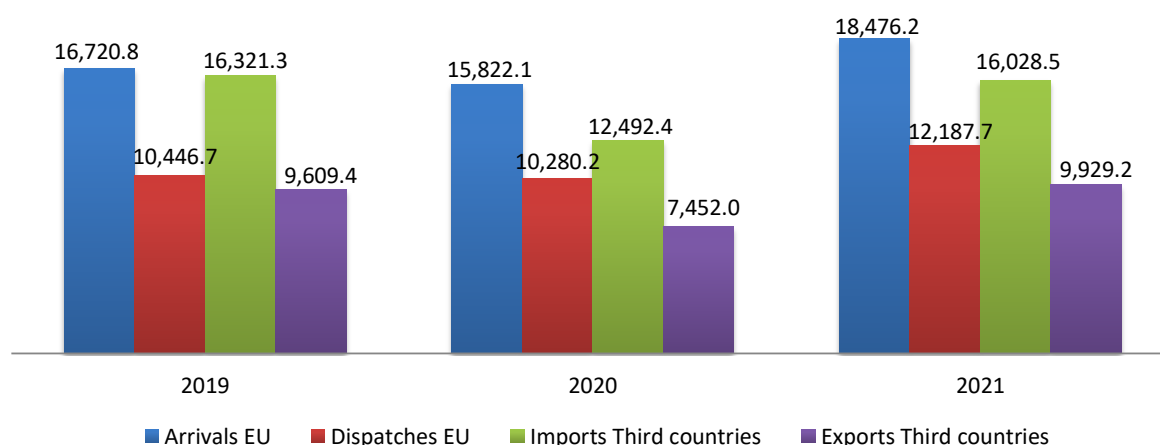

Diagram 5. Imports - Arrivals, Exports - Dispatches, excluding oil products, January - July 2019-2021, million €

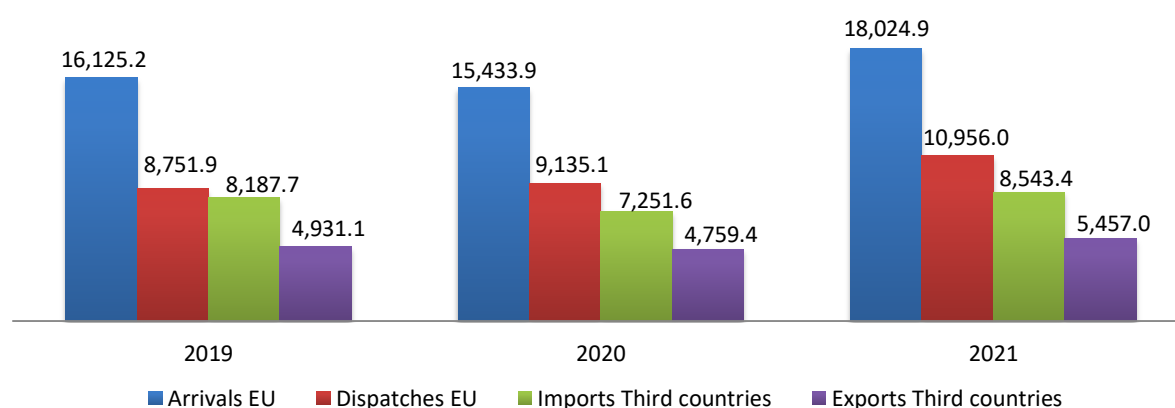

Diagram 6. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, January - July 2019-2021, million €

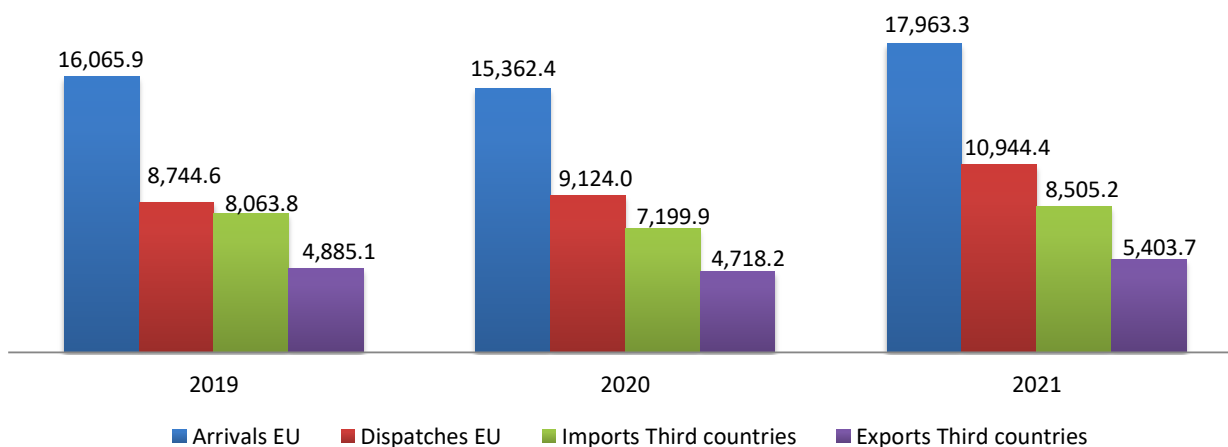

Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, July 2021

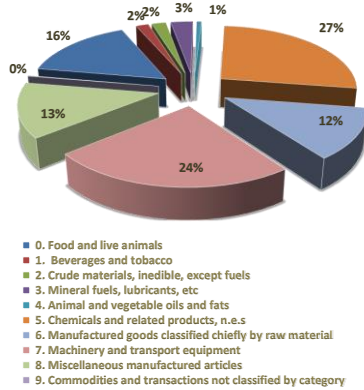


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, July 2021

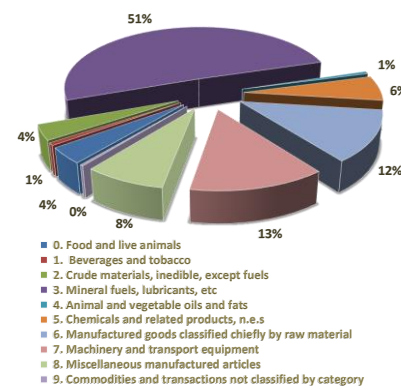


Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, July 2021

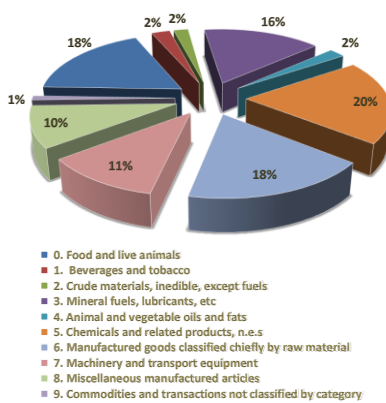


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, July 2021

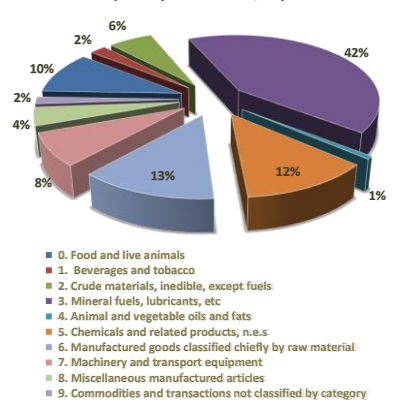


Diagram 9. Imports - Arrivals E.U. & Third countries by SITC sections, Jan. - July 2021, million €

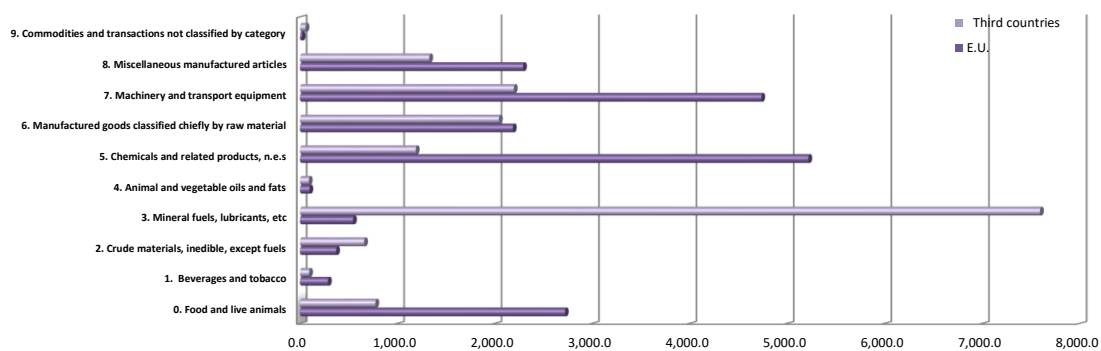


Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - July 2021, million €

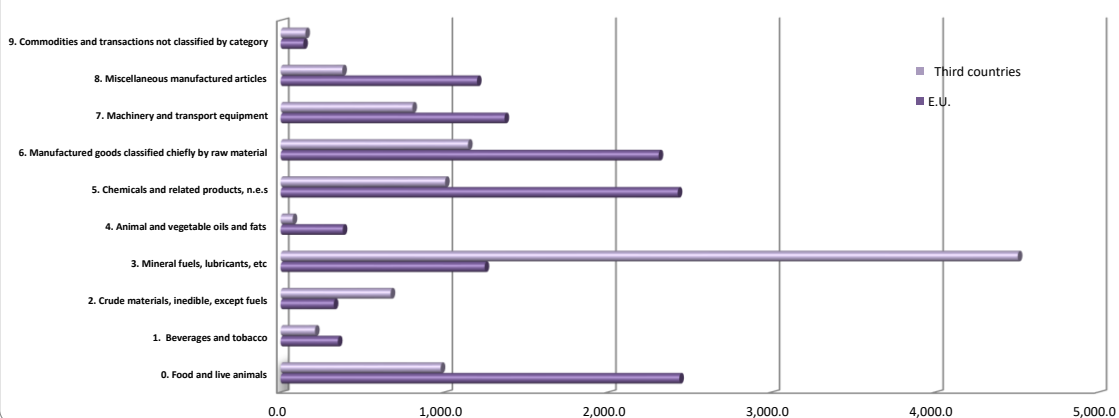

Diagram 11. Commercial Transactions with EU & Third countries 2019-2021

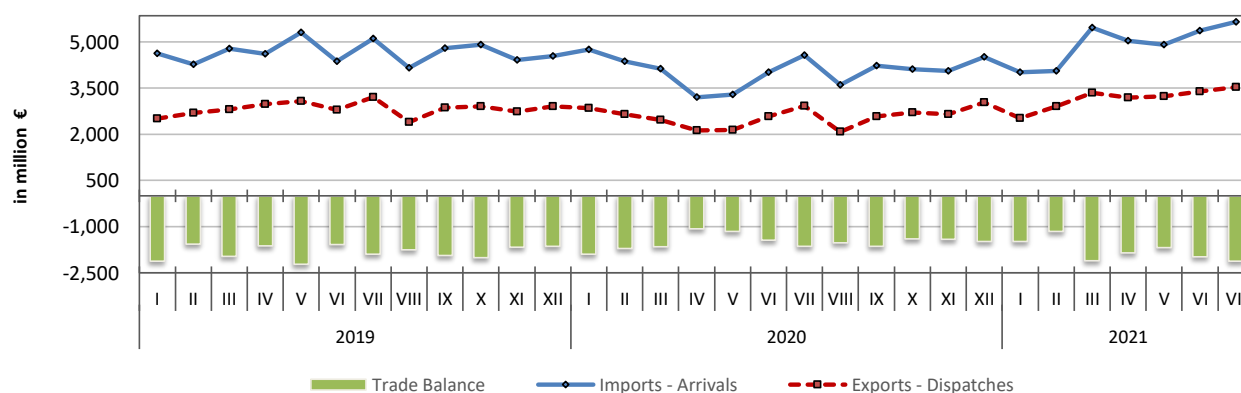

Diagram 12. Commercial Transactions with EU & Third countries 2019-2021 excluding oil products

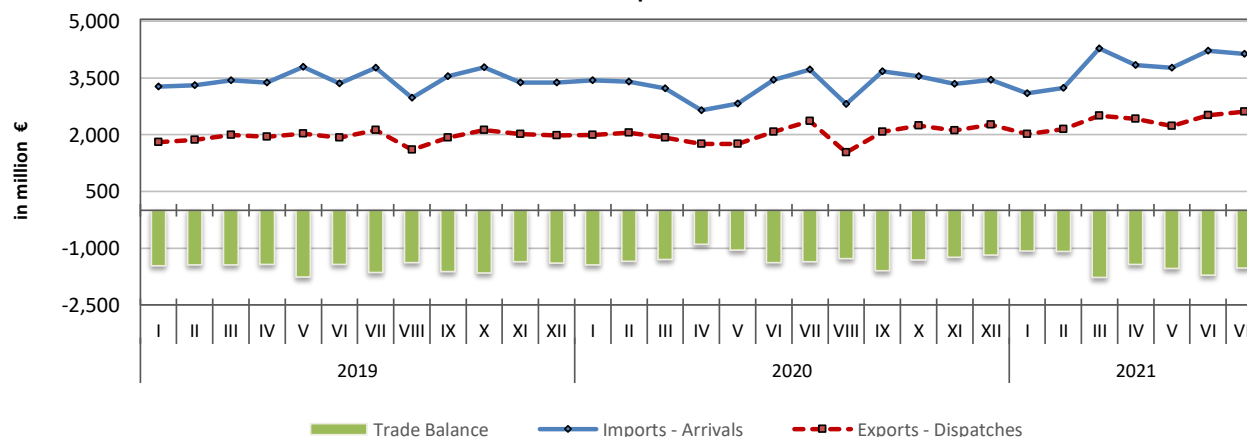


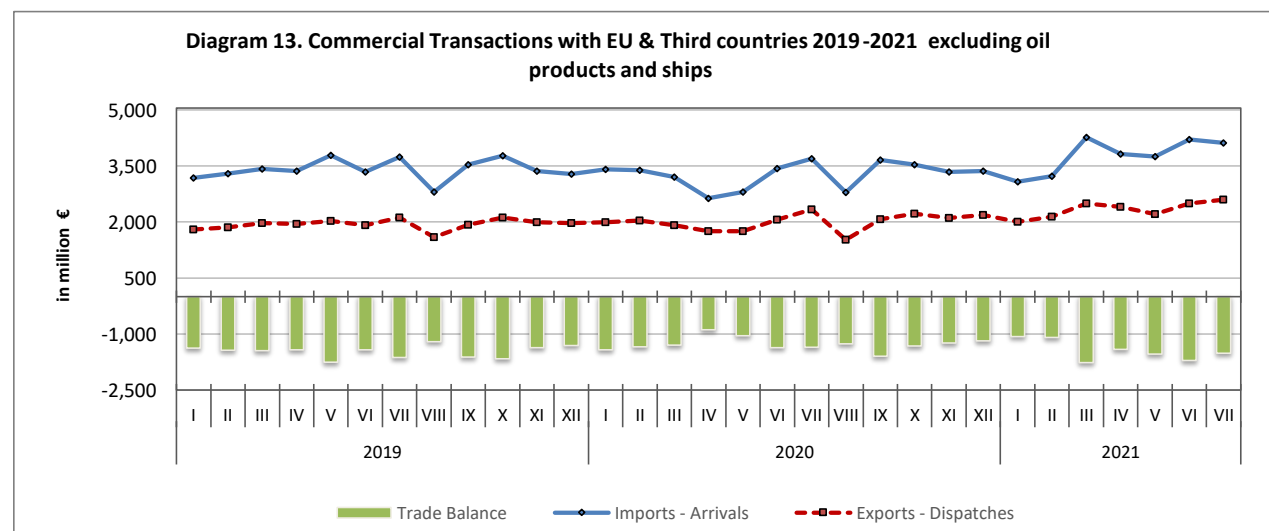
