LABOUR FORCE SURVEY: April 2022

The Hellenic Statistical Authority (ELSTAT) announces the seasonally adjusted estimates of employment and unemployment for April 2022.

- The **seasonally adjusted unemployment rate** in April 2022 amounted to **12.5**% compared to 17.2% in April 2021 and to the upwards revised 12.6% in March 2022.
- The **number of employed persons** amounted to 4,123,634 persons increasing by 403,552 persons as compared with April 2021 (+10.8%) and decreasing by 41,072 persons compared with March 2022 (-1.0%).
- The **number of unemployed persons** amounted to 587,595 decreasing by 182,482 persons as compared with April 2021 (-23.7%) and by 11,707 persons compared with March 2022 (-2.0%).
- The number of persons outside the labour force, i.e., persons under the age of 75, that neither work nor look for a job, amounted to 3,125,509, decreasing by 256,988 persons as compared with April 2021 (-7.6%) and increased by 51,662 persons compared with March 2022 (+1.7%).

Graph 1 shows the evolution of the above figures as of January 2009.

The monthly estimates are subject to revisions due to the updates of the seasonally adjusted series whenever new monthly data are added, as well as to the update of seasonal adjustment model with complete annual data. Users should also take into account that the first estimates of the most recent monthly unemployment rates are likely to be revised as they are produced on the basis of the survey data collected and processed at the time of the press release publication, which do not coincide with the finally collected and processed data. For this reason, the monthly estimates are revised when the final quarterly estimates are made available.

The new European Regulation (EU) 2019/1700 for social statistics, which entered into force on 1.1.2021, brought about changes in the data collection method as well as the method of producing the estimates of the survey. The LFS data produced from 2021 onwards were no longer comparable with those up to 2020 (a "break" in the time series). According to the provisions of the implementing Regulations (EC) 2019/2240 (Art. 10) and 2019/2241 (Art. 5), in order to produce break-free timeseries, the data from 2009 to 2020 were revised. In this Press Release, the estimates for the reference months from January 2009 to December 2020 incorporate the impact of the implementation of the Regulation (EU) 2019/1700. The changes brought about by the new Regulation, the changes in the calculation of the employment status as well as an outline of the revision process applied to produce the backward series are described in the Explanatory Notes.

The figures and the changes of the estimates as regards the persons employed, the unemployed and the persons outside the labour force, as well as the unemployment rate for April of the years 2017-2022 are presented in Table 1. The complete data series for employed, unemployed and persons outside the labour force as well as the unemployment rate are published on ELSTAT's webpage. Graph 2 depicts the percentage changes in relation to the corresponding month of the previous year.

The effect of seasonal adjustment on the estimates of Labour Force Survey

The characteristics surveyed by the Labour Force Survey (number of employed, unemployed, etc.) have large seasonal variation. For example, in Greece, employment normally increases during the summer months because of tourism (if there are no other countervailing factors).

Seasonal adjustment is a statistical technique that removes the seasonal component of a time series, making more visible the underlying trend in the change of a characteristic. Whenever new data are added, the monthly estimates are subject to revisions due to the update of the seasonally adjusted time series.

Graphs 3, 4 and 5 present the adjusted and unadjusted time series for employed and unemployed persons, and the unemployment rate as of 2017.

Revisions of monthly estimates

The monthly estimates for the number of employed and unemployed persons and the unemployment rate can be subject to revisions in the following months due to the updates to the seasonally adjusted series whenever new monthly data are added, to the inclusion of the most recent quarterly Labour Force Survey data, and the update of the seasonal adjustment model with complete annual data. In this press release the estimation of unemployment rate for the period February 2021 – March 2022 has been revised (compared to the estimation published in the previous press-release) as follows:

EXPLANATORY NOTES

Labour Force The Labour Force Survey has been conducted since 1981. Until 1997 the results were produced on an annual basis with reference to the second quarter of each year. From 1998 onwards it is a continuous quarterly survey. The main statistical objective of the Labour Force Survey is to divide the population of working age (15 years and over) into three mutually exclusive and exhaustive groups - persons in employment, unemployed persons, and persons outside the labour force. In addition, the Labour Force Survey collects information on demographic characteristics, on main job characteristics, on the existence and characteristics of a second job, on educational attainment, on participation in education, on previous working experience and on search of job.

The data presented in this Press release are revised compared to those published by Eurostat on 1st June 2022.

- Legislation The current survey is fully harmonized with European legislation. The basic act is Regulation (EC) No 2019/1700 of the European Parliament and of the Council establishing a common framework for European statistics relating to persons and households, which is in force since 1/1/2021 and replaced Regulation (EC) 577/98. Implementing Regulation (EU) 2019/2240 sets out the design and characteristics of the survey and Implementing Regulation (EU) 2019/2241 lays down the technical elements of the monthly unemployment data.
- Reference
PeriodThe sample of Labour Force Survey is equally allocated to the 4 (or 5) weeks of the month. Every selected
household is assigned to a specific week, the reference week, running from Monday to Sunday.
- **Coverage** For the monthly estimates, a sub-sample of the quarterly Labour Force survey's sample is used.
- **Definitions Employed**: comprise persons aged 15 to 89 (in completed years at the end of the reference week) who, during the reference week, were in one of the following categories:

a) persons who during the reference week worked for at least 1 hour for pay or profit, including contributing family workers

b) persons with a job or business who were temporarily not at work during the reference week but had an attachment to their job, where the following groups have a job attachment:

persons not at work due to holidays, working time arrangements, sick leave, maternity or paternity leave;
persons in job-related training;

- persons on parental leave, either receiving and/or being entitled to job-related income or benefits, or whose parental leave is expected to be 3 months or less;

- seasonal workers during the off-season, where they continue to regularly perform tasks and duties for the job or business, excluding fulfilment of legal or administrative obligations;

- persons temporarily not at work for other reasons where the expected duration of the absence is 3 months or less.

Note: contributing family workers, persons in own-use production work, voluntary workers, unpaid trainees and individuals involved in other forms of work are defined in the 19th International Conference of Labour Statisticians (ICLS) Resolution concerning statistics of work, employment and labour underutilisation, adopted on 11 October 2013.

Unemployed persons comprise persons aged 15 to 74 who were, during the reference week, (a) not employed, (b) currently available for work, and (c) actively seeking work, or found a job to start within a period of at most 3 months from the end of the reference week.

Persons outside the labour force comprise persons who were in one of the following categories: (a) aged below 15, (b) aged above 89, or (c) aged 15 to 89 and neither employed nor unemployed during the reference week, according to the definitions of employment and unemployment described above.

Economically active population (labour force) are persons either employed or unemployed.

Unemployment Rate is the ratio of unemployed divided by total labour force.

back-seriesThe entry into force of the new Regulation (EU) 2019/1700 as of 1.1.2021, as well as of the implementing
Regulations (EC) 2019/2240 and 2019/2241, brought about changes in the data collection method and in
the way of producing the estimates which were no longer comparable to those up to 2020 (under the old
Regulation). To achieve comparability, the time-series had to be recalculated in order to become "break-
free". To do this, the results of the Labour Force Survey for the period 2009 – 2020 were recalculated taking
into account the new definitions and questions introduced in the survey with the adoption of the new
Regulation.

At first, the impact of weighting was studied, and the new weighting procedure (calibration vs poststratification) was applied for all quarters. This procedure resulted in rather small differences in the estimated number of employed and more significant in the estimated number of unemployed. In a next step, all persons responding in a previous survey quarter were classified (where possible) as employed, unemployed or outside labour force, according to the new definitions. This procedure resulted in the following classification of the persons participating in the survey up to 2020:

Persons that report absence from a job during the reference week cannot always be classified according to IESS definitions, since they did not answer to the same questions when they were interviewed. The same holds for persons outside labour force.

The problem of the classification of these groups of persons was assessed by using correction factors. These correction factors were computed at an aggregated level based on the results of the survey of the first quarter of 2021.

The following 3 types of correction factors were computed for various combinations of sex, age group, professional status, and reason of absence from work.

 $CorrF1 = \frac{persons \ reporting \ absence \ from \ job \ and \ not \ employed}{all \ persons \ reporting \ absence \ from \ job}$

(that is, the percentage of persons that are classified as not employed over all persons that report absence from job, according to 2021 1st quarter results)

$$CorrF2 = \frac{persons reporting a casual job}{persons not having work and not being absent from a job}$$

(that is, the percentage of persons that report a small job over all persons that report not having a job, according to 2021 1st quarter results)

$$CorrF3 = \frac{persons reporting have a job from which they were absent and are unemployed}{persons reporting have a job from which they were absent and are not employed}$$

(that is, the percentage of persons that are finally classified as unemployed though they reported having a job over all persons that report absence from job and they are not employed, according to 2021 1st quarter results)

- Seasonal adjustment is a statistical technique that removes the seasonal component of a time series, making adjustment Beasonal adjustment is a statistical technique that removes the seasonal component of a time series, making JDemetra+ for seasonal adjustment. Seasonally adjusted series are produced by TRAMO&SEATS algorithm. It should be noted that due to seasonal adjustment the whole series with monthly estimates is recalculated every time a new month is added in time series. As a result, estimations for the previous months are often revised.
- Sampling The monthly results of Labour Force Survey are estimations that are based in a relatively small sample size and have large sampling errors. An indication of the magnitude of survey's sampling errors is that estimations of characteristics that refer to 10,000 persons at the total country are accompanied by a coefficient of variation of at least 15%. More accurate estimates and detailed analysis of the changes in employment can be based on the quarterly results of the survey.
- Methodology Labour Force Survey's estimates are produced by a suitable unbiased estimator which takes into account a) the probability of selection of every sampled household, b) the response rate in every primary sampling unit, c) the estimated population, for the corresponding month, allocated by NUTS II areas, gender and age group. For reasons of public health protection from the COVID-19 pandemic, data were collected mainly by way of telephone interviews.
