

COMMERCIAL TRANSACTIONS OF GREECE : April 2024

(Provisional Data)

The total value of imports, in April 2024 amounted to 7,480.0 million euros (8,000.0 million dollars) in comparison with 6,241.7 million euros (6,825.3 million dollars) in April 2023, recording an increase, in euros, of **19.8%**. The corresponding value excluding oil products in April 2024 recorded an increase of 970.2 million euros or 20.5% and the corresponding value excluding oil products and ships in April 2024 recorded an increase of 968.5 million euros or 20.6%, in comparison with April 2023 (Table 1).

The total value of exports, in April 2024 amounted to 4,467.1 million euros (4,806.5 million dollars) in comparison with 4,019.4 million euros (4,421.8 million dollars) in April 2023, recording an increase, in euros, of **11.1%**. The corresponding value excluding oil products recorded in April 2024 an increase of 463.1 million euros or 17.0% and the corresponding value excluding oil products and ships in April 2024 recorded an increase of 464.2 million euros or 17.1%, in comparison with April 2023 (Table 1).

The deficit of the trade balance, in April 2024 amounted to 3,012.9 million euros (3,193.5 million dollars) in comparison with 2,222.3 million euros (2,403.5 million dollars) in April 2023, recording an increase, in euros, of **35.6%**. The corresponding value of deficit excluding oil products in April 2024 recorded an increase of 507.1 million euros or 25.3% and the corresponding value excluding oil products and ships in April 2024 recorded an increase of 504.3 million euros or 25.5%, in comparison with April 2023 (Table 1).

The total value of imports, for the 4-month period from January to April 2024 amounted to 27,802.8 million euros (29,996.2 million dollars) in comparison with 27,429.2 million euros (29,490.0 million dollars) for the corresponding period of the year 2023, recording an increase, in euros, of **1.4%**. The corresponding value excluding oil products recorded an increase of 930.4 million euros or 4.7% and the corresponding value excluding oil products and ships recorded an increase of 918.1 million euros or 4.6%, in comparison with the period from January to April 2023 (Table 5).

The total value of exports, for the 4-month period from January to April 2024 amounted to 16,805.7 million euros (18,243.3 million dollars) in comparison with 17,872.0 million euros (19,329.2 million dollars) for the corresponding period of the year 2023, recording a drop, in euros, of **6.0%**. The corresponding value excluding oil products recorded a drop of 400.5 million euros or 3.3% and the corresponding value excluding oil products and ships recorded a drop of 350.2 million euros or 2.9%, in comparison with the period from January to April 2023 (Table 5).

The deficit of the trade balance, for the 4-month period from January to April 2024 amounted to 10,997.1 million euros (11,752.9 million dollars) in comparison with 9,557.2 million euros (10,160.8 million dollars) for the corresponding period of the year 2023, recording an increase, in euros, of **15.1%**. The corresponding deficit excluding oil products recorded an increase of 1,330.9 million euros or 17.3% and the corresponding deficit excluding oil products and ships recorded an increase of 1,268.3 million euros or 16.6% (Table 5).

The monthly data of Intra-EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-EU transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by Hellenic Statistical Authority on a yearly basis.

Diagram 1. Imports, Exports, April 2022-2024, million €

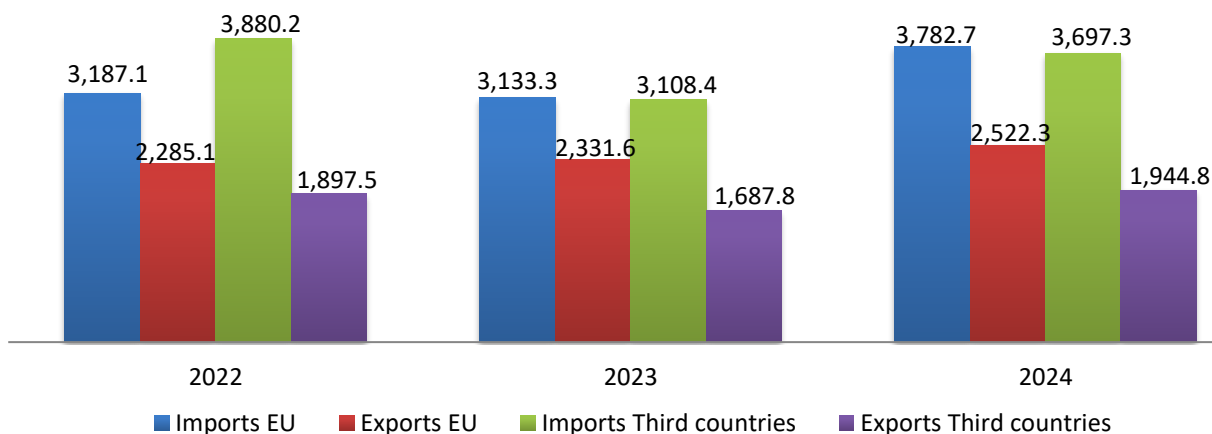

Diagram 2. Imports, Exports excluding oil products, April 2022-2024, million €

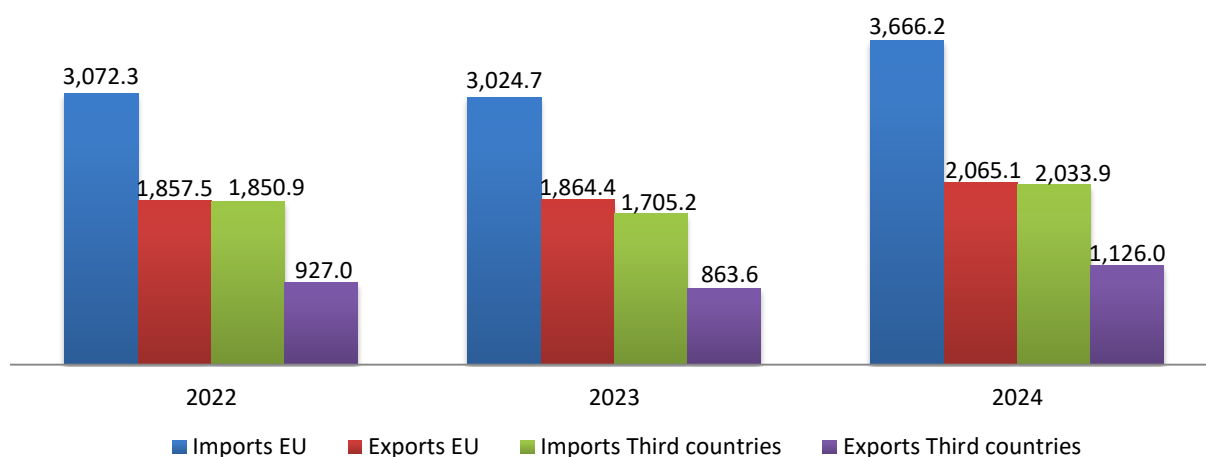

April 2022-2024, million €**

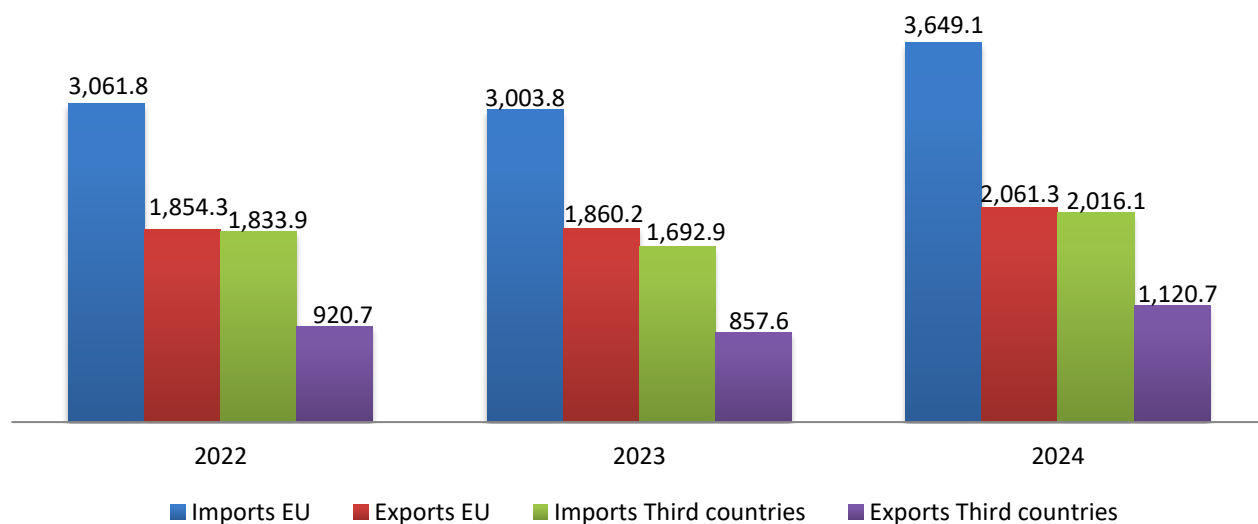

January - April 2022-2024, million €**

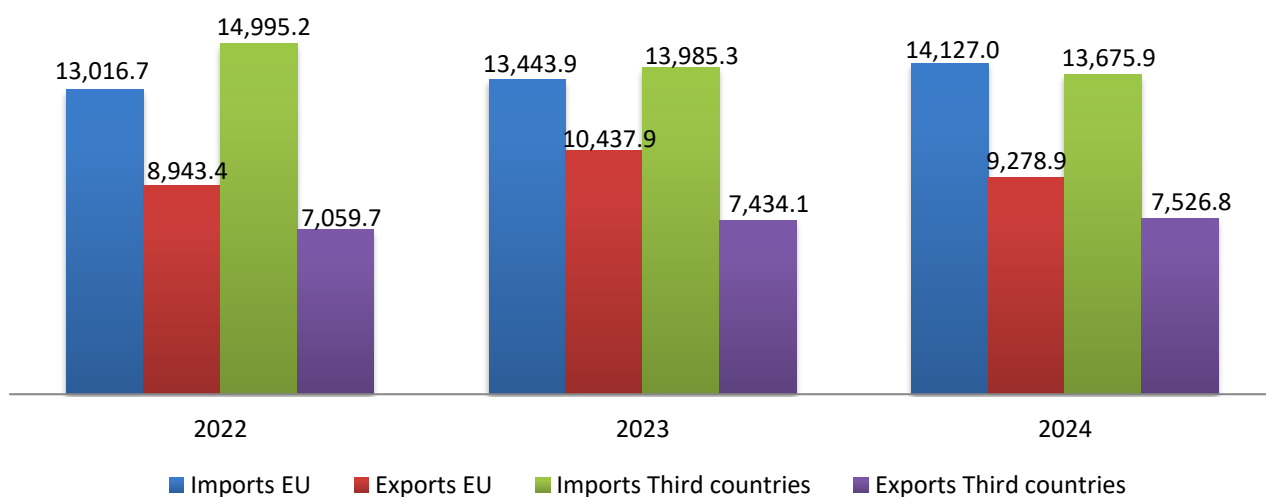

Diagram 5. Imports, Exports, excluding oil products, January - April 2022-2024, million €

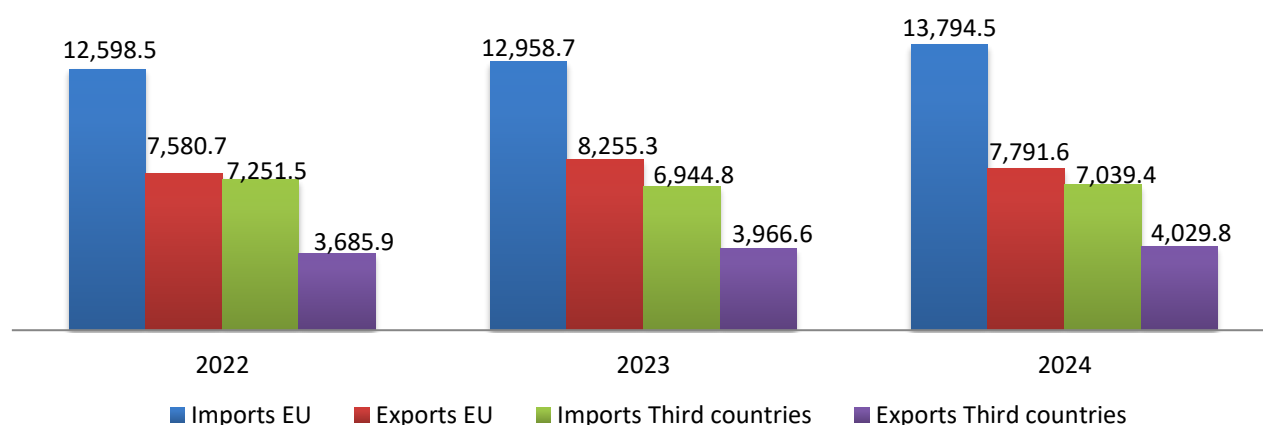

Diagram 6. Imports, Exports, excuding oil products and ships, January - April 2022-2024, million €

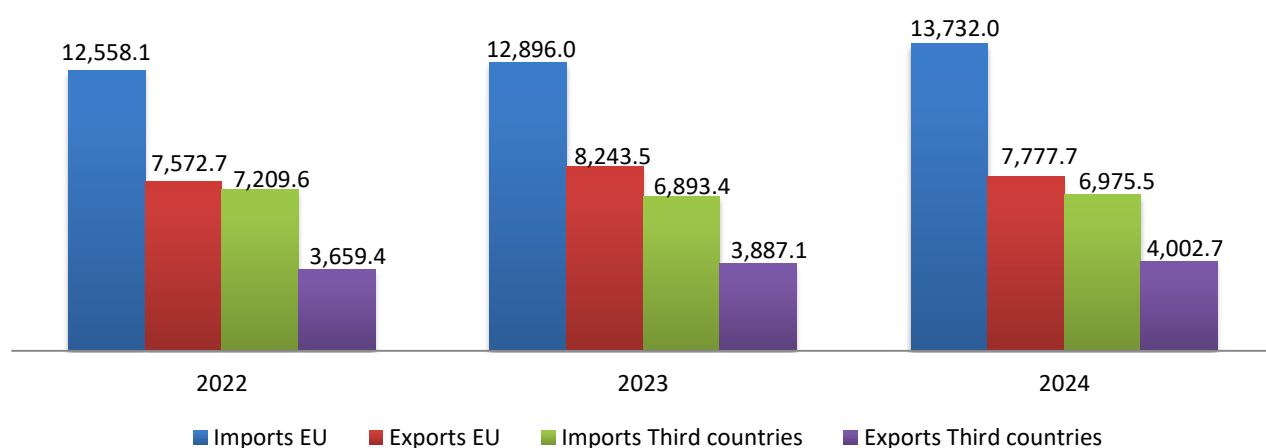

Diagram 7a. Percentage (%) distribution of E.U. imports by SITC sections, April 2024

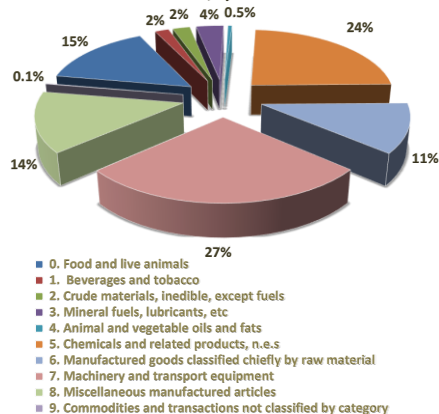


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, April 2024

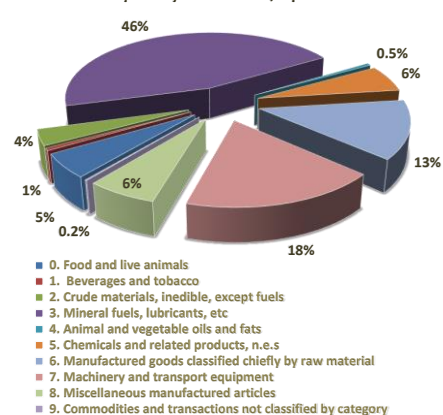


Diagram 8a. Percentage (%) distribution of E.U. exports by SITC sections, April 2024

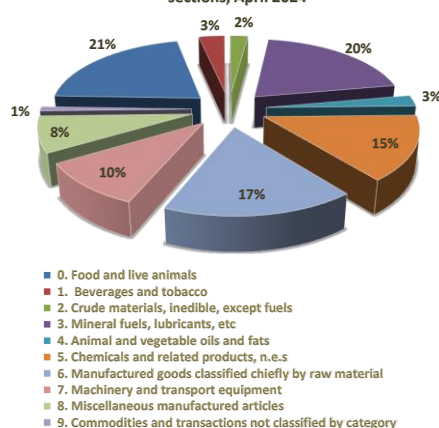


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, April 2024

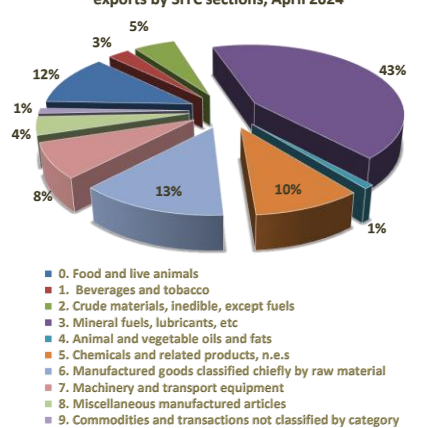


Diagram 9. Imports E.U. & Third countries by SITC sections, Jan. - Apr. 2024, million €

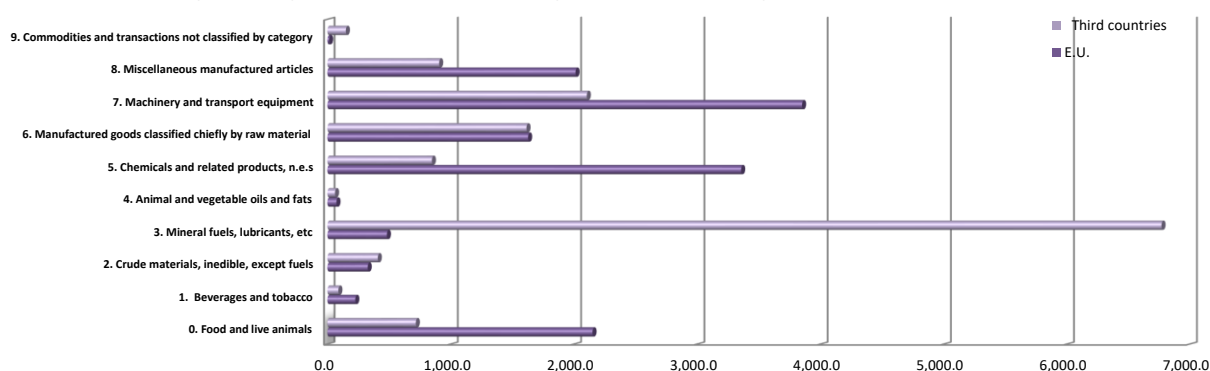


Diagram 10. Exports E.U. & Third countries by SITC sections, Jan. - Apr. 2024, million €

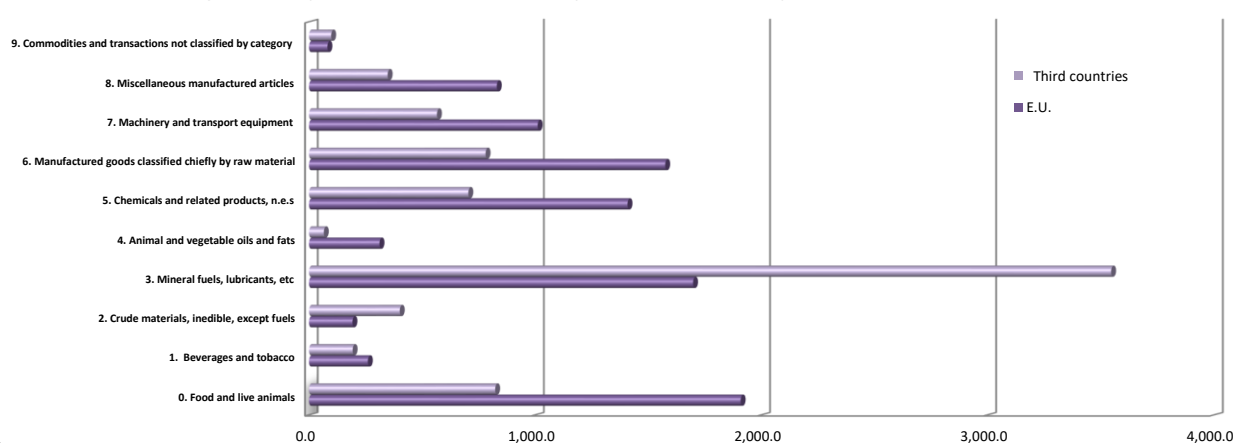

Commercial Transactions of Greece	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports, exports and their changes. This recording does not include the imports and exports of services.
Legal Framework	The survey is conducted for intra-Union trade and for trade with third countries in accordance with Regulations (EU) 2019/2152 and (EU) 2020/1197.
Reference Period	April 2024
Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	<p>INTRASTAT is the system for collecting Intra-Union statistical data (among the EU countries). It was implemented on January 1st, 1993.</p> <p>Import is considered every import of goods from a country of the EU.</p> <p>Export is considered every export of goods to a country of the EU.</p> <p>EXTRASTAT is the system for collecting external trade data with third countries (countries outside the EU).</p> <p>Import is considered every import of goods from a third country (outside the EU).</p> <p>Export is considered every export of goods to a third country (outside the EU).</p>
Methodology	<p>INTRASTAT: It is an exhaustive statistical survey. The parties responsible for providing statistical information through Intrastat System are the enterprises which perform intra-Union trade transactions and they have exceeded the applied statistical thresholds. In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Independent Authority of Public Revenue.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1,000 euros are registered.
