EVOLUTION OF TURNOVER OF ENTERPRISES IN

ACCOMMODATION AND FOOD SERVICE ACTIVITIES

DECEMBER AND 4th QUARTER 2021

ANNUAL DATA 2021

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country. At the same time, under the recent circumstances, the monitoring and dedicated publication of the evolution of these economic activities has become imperative, given the direct and indirect adverse impact they have been subjected to, due to the pandemic of coronavirus disease 2019 (COVID-19).

The current publication is part of the Press Releases series published by ELSTAT ([PR link](#)), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **December and 4th quarter 2021**.

Similar publications have been planned and are released on a monthly basis, throughout the whole period during which the regular monitoring of the evolution of the turnover of enterprises providing Accommodation, Food and Beverage Service Activities remains relevant and warranted.

In particular, the Hellenic Statistical Authority (ELSTAT) announces data on a monthly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation, Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2021.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities**, the turnover in 2021 amounted to 5,176,144,589 euro, recording an increase of 118.3% in comparison with 2020, when the respective turnover was 2,371,365,548 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0%, the biggest increase in turnover in 2021 compared with 2020 was recorded in the Regional Unit Mykonos (277.4%) and the smallest increase (64.6%) was recorded in the Region Attiki (Table 1).

For the total of enterprises in **Food and Beverage Service Activities**, the turnover in 2021 amounted to 5,136,822,479 euro, recording an increase of 25.8% in comparison with 2020, when the respective turnover was 4,084,227,880 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0%, the biggest increase in turnover in 2021 compared with 2020 was recorded in the Regional Unit Thira (161.5%) and the smallest increase (6.6%) was recorded in the Regional Units Etoloakarnania and Evia (Table 2).

For the total of enterprises in **Accommodation Activities**, the turnover in the fourth quarter 2021 amounted to 868,793,952 euro, recording an increase of 104.9% in comparison with the fourth quarter 2020, when the respective turnover was 423,954,467 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 1), the biggest increase in the turnover of the fourth quarter 2021 compared to the fourth quarter of 2020 was recorded in the Regional Unit Zakynthos (210.8%) and the smallest increase (56.8%) was recorded in the Regional Unit Kos (Table 1a).

For the total of enterprises in **Food and Beverage Service Activities**, the turnover in the fourth quarter 2021 amounted to 1,320,623,995 euro, recording an increase of 70.0% in comparison with the fourth quarter 2020, when the respective turnover was 776,795,990 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 2), the biggest increase in the turnover of the fourth quarter 2021 compared to the fourth quarter of 2020 was recorded in the Regional Unit Thira (189.2%) and the smallest increase (27.5%) was recorded in the Regional Unit Korinthia (Table 2a).

For the enterprises in **Accommodation Activities obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2021 amounted to 151,004,501 euro, recording an increase of 93.9% in comparison with December 2020, when the respective turnover was 77,885,478 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 1), the biggest increase in the turnover of December 2021 compared with December 2020 was recorded in the Regional Unit Lassithi (361.7%) and the smallest increase (69.1%) was recorded in the Regional Unit Chania (Table 1b).

For the enterprises in **Food and Beverage Service Activities obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in December 2021 amounted to 137,104,168 euro, recording an increase of 118.9% in comparison with December 2020, when the respective turnover was 62,626,204 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2020 greater than 1.0% (Table 2), the biggest increase in the turnover of December 2021 compared with December 2020 was recorded in the Regional Unit Magnissia (742.4%) and the smallest increase was recorded in the Regional Unit Iraklio (64.7%), while a decrease (39.4%) was recorded in the Regional Unit Chalkidiki (Table 2b).

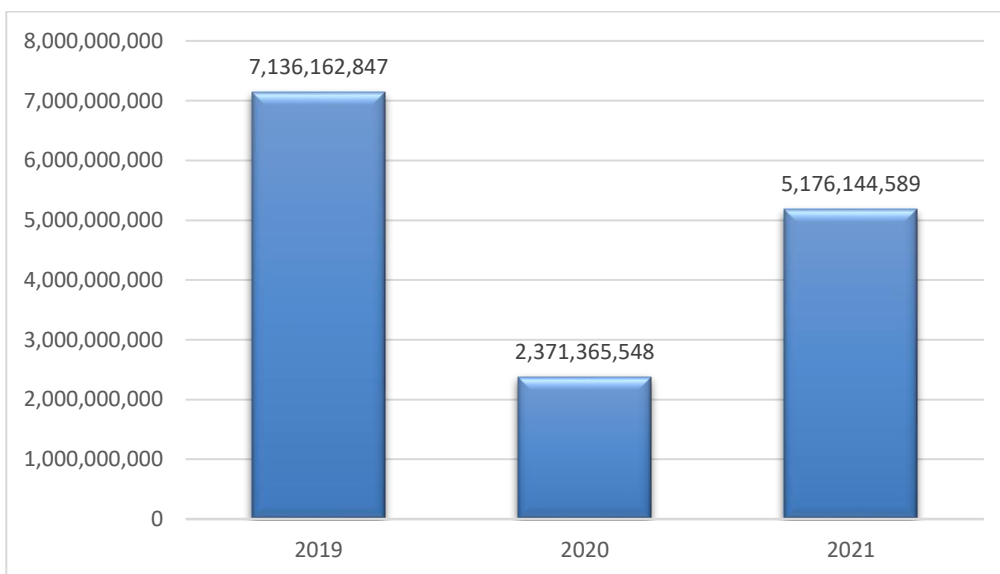

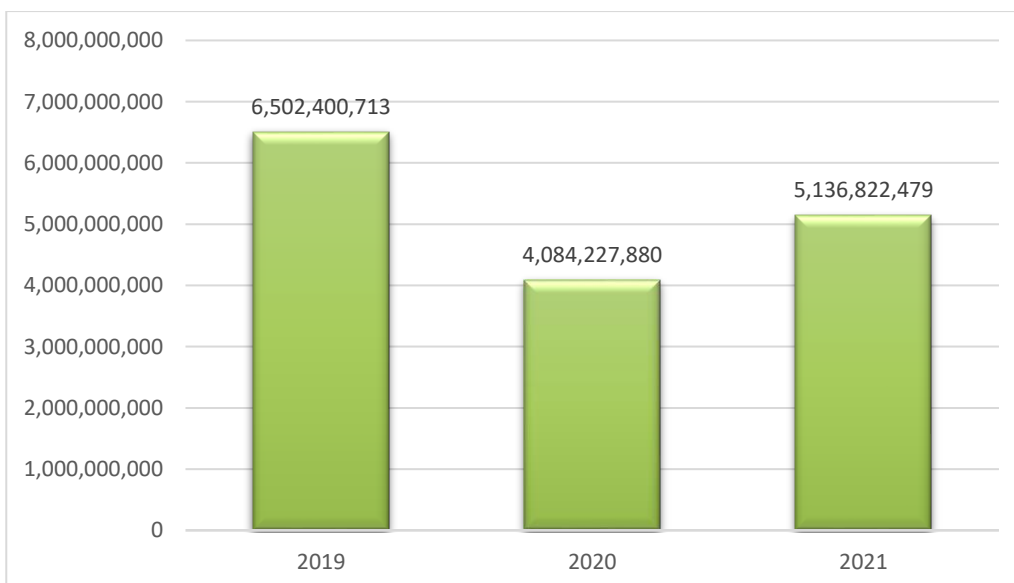

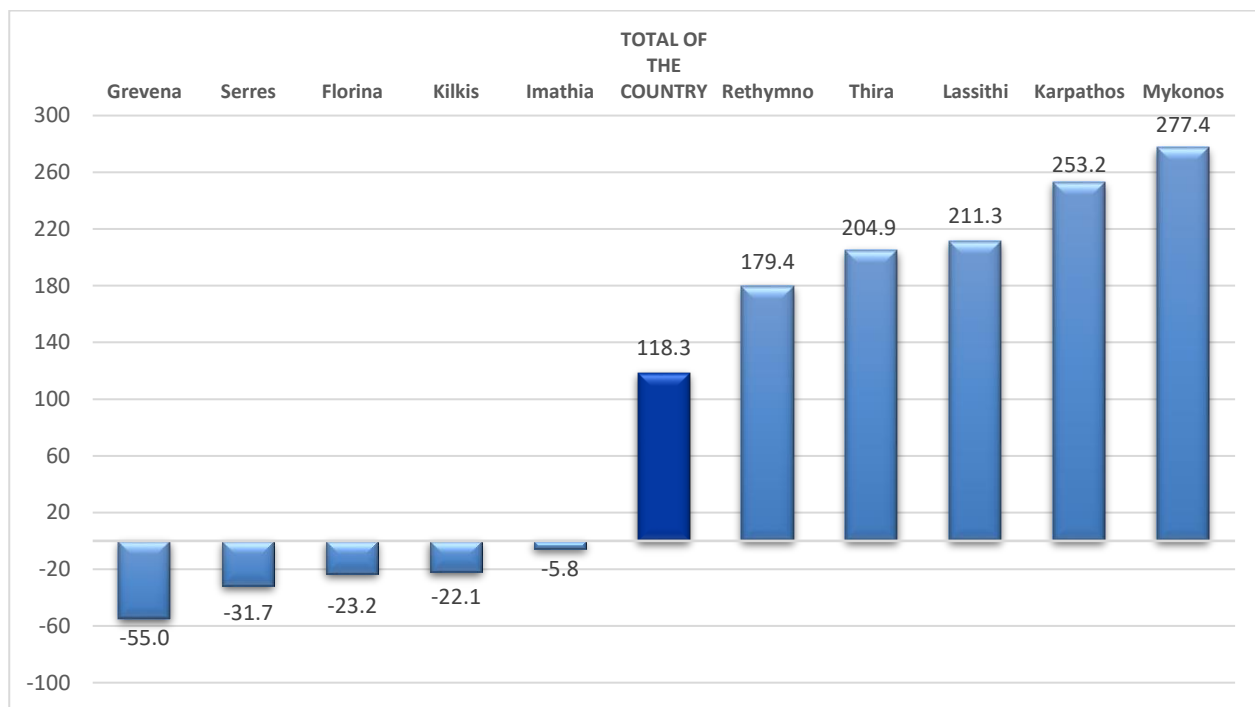
Graph 1: Annual turnover (in €) for the total of enterprises in the Accommodation division (55 of NACE Rev. 2 classification)



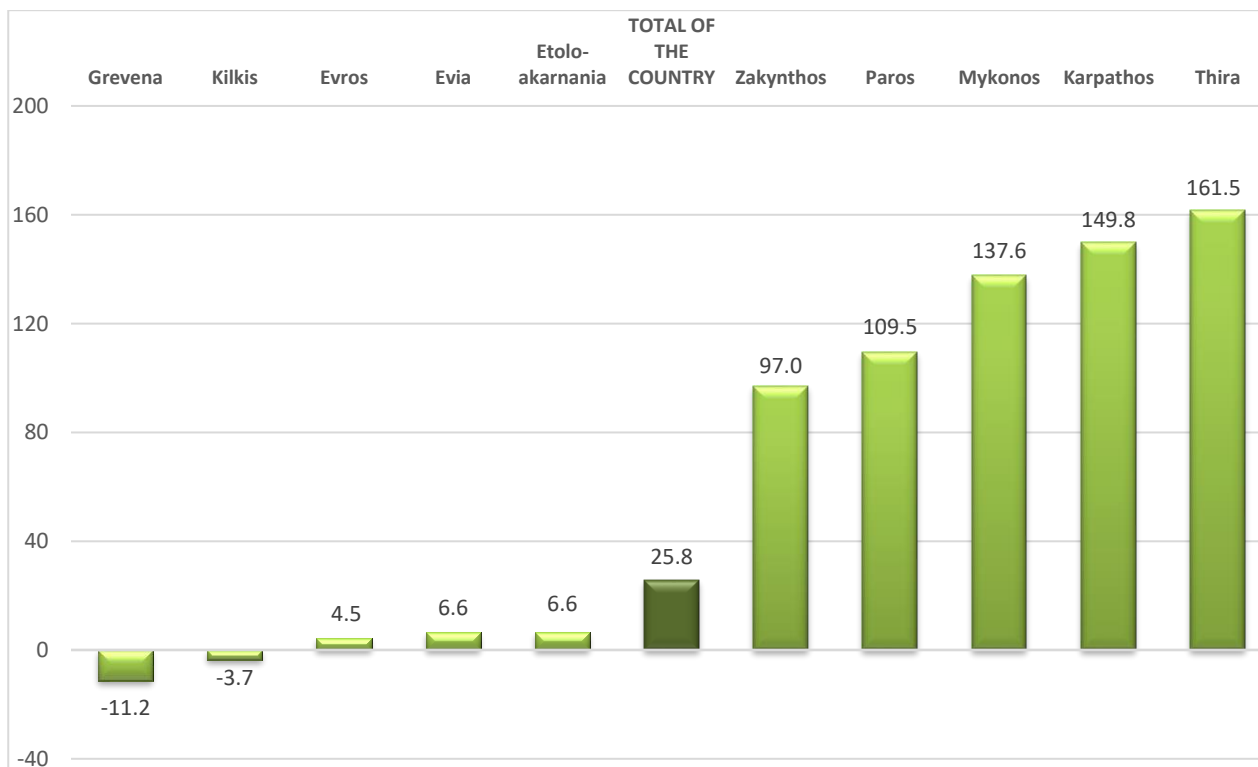
Graph 2: Annual turnover (in €) for the total of enterprises in the Food and Beverage Service Activities division (56 of NACE Rev. 2 classification)



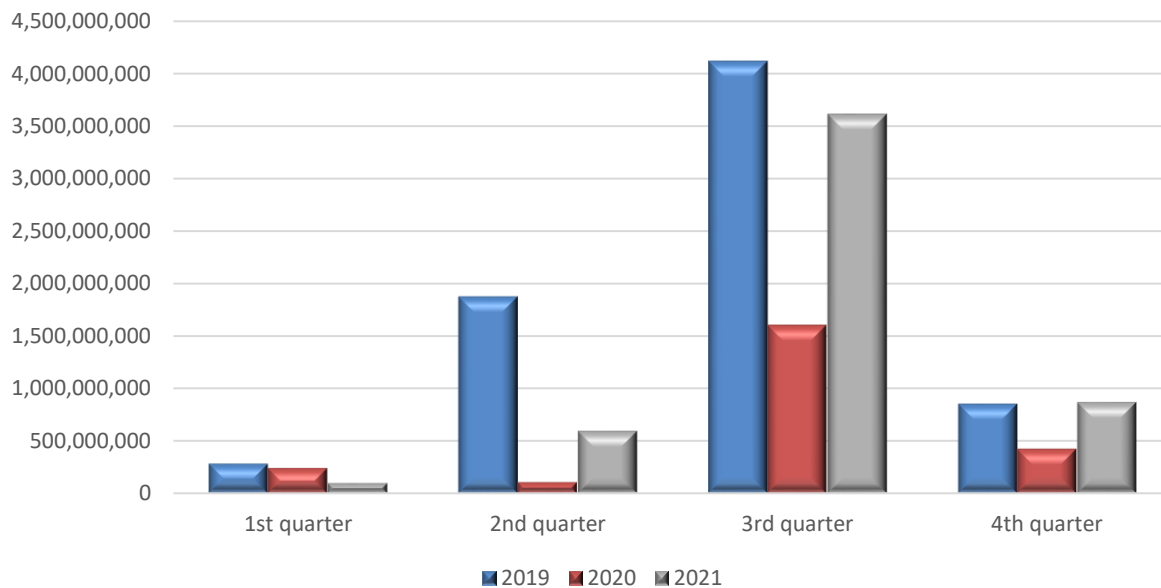

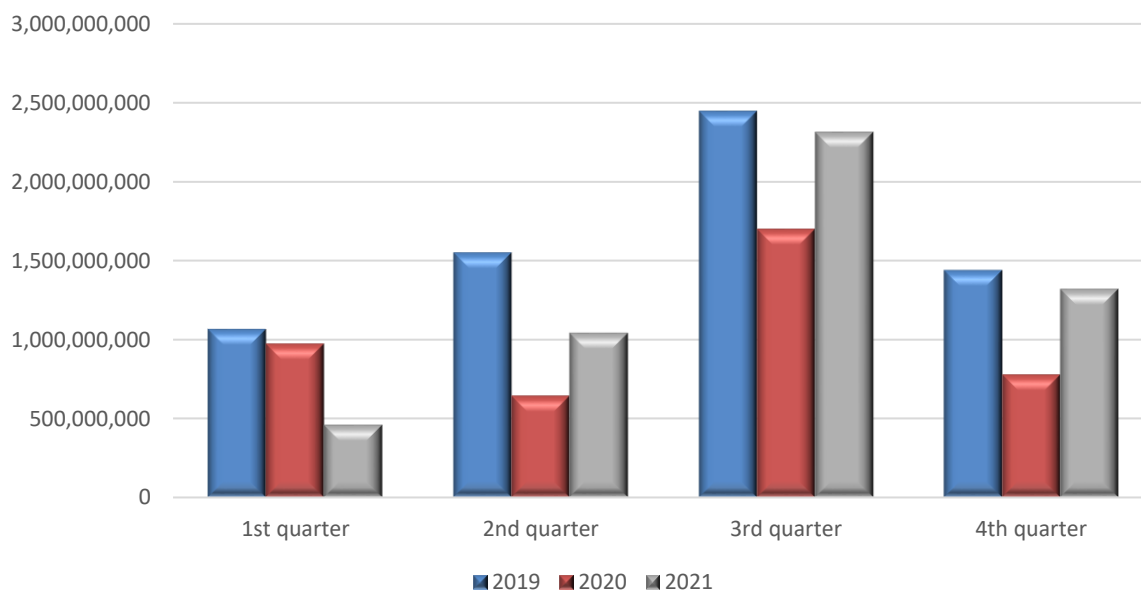

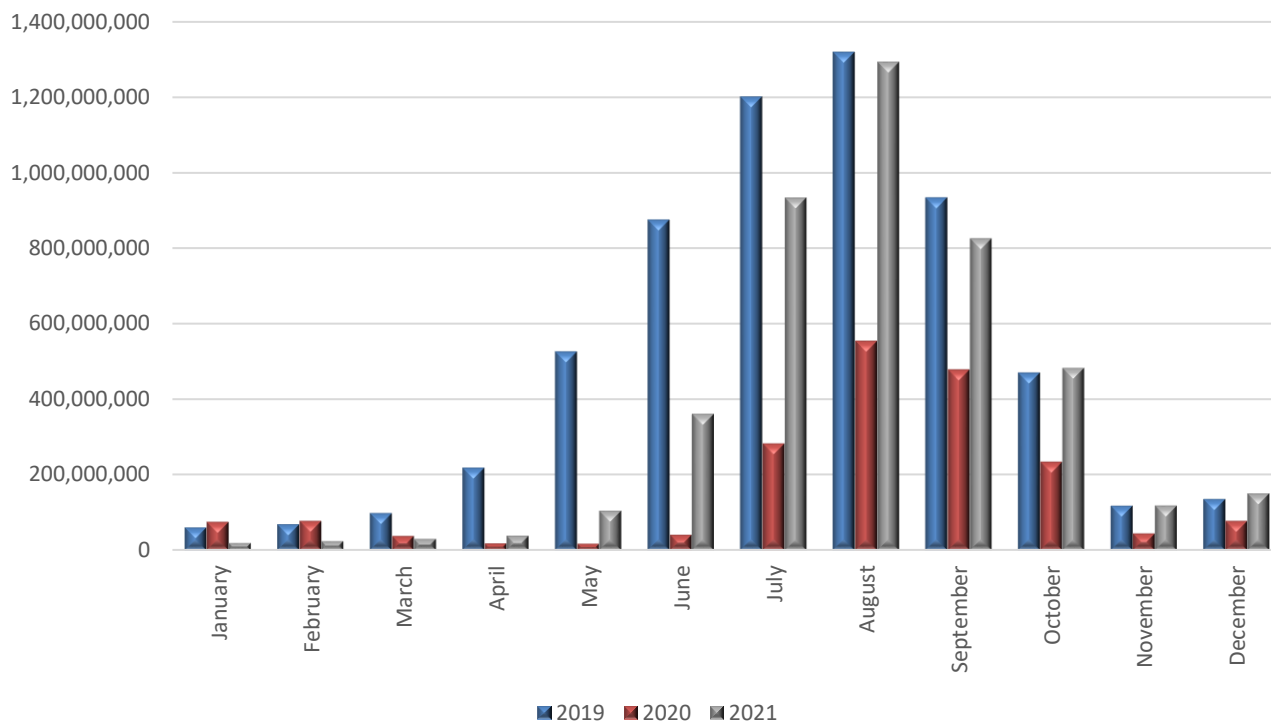
Graph 5: Turnover (in €) for the total of enterprises in the Accommodation division (55 of NACE Rev. 2 classification)



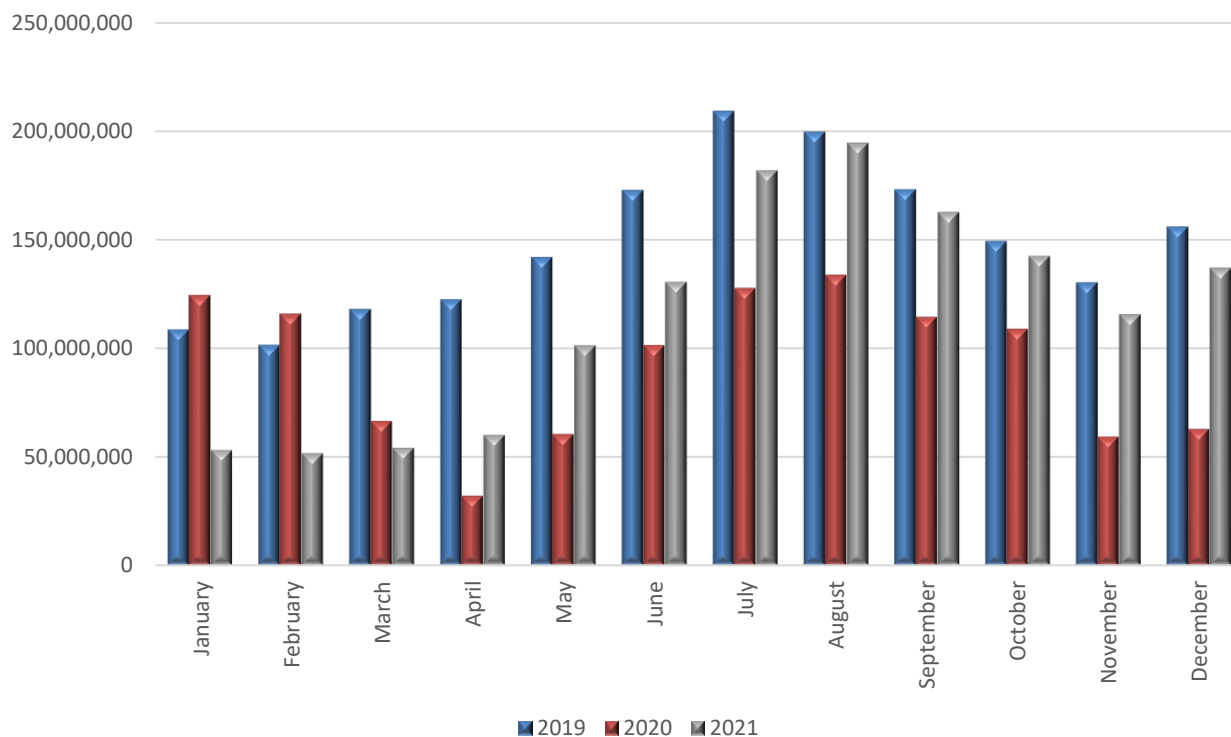
Graph 6: Turnover (in €) for the total of enterprises in the Food and Beverage Service Activities division (56 of NACE Rev. 2 classification)

Generally The statistical data presented in this Press Release have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2018.
- Administrative transactions files (tax etc) of the reference years 2019 2020 and 2021.

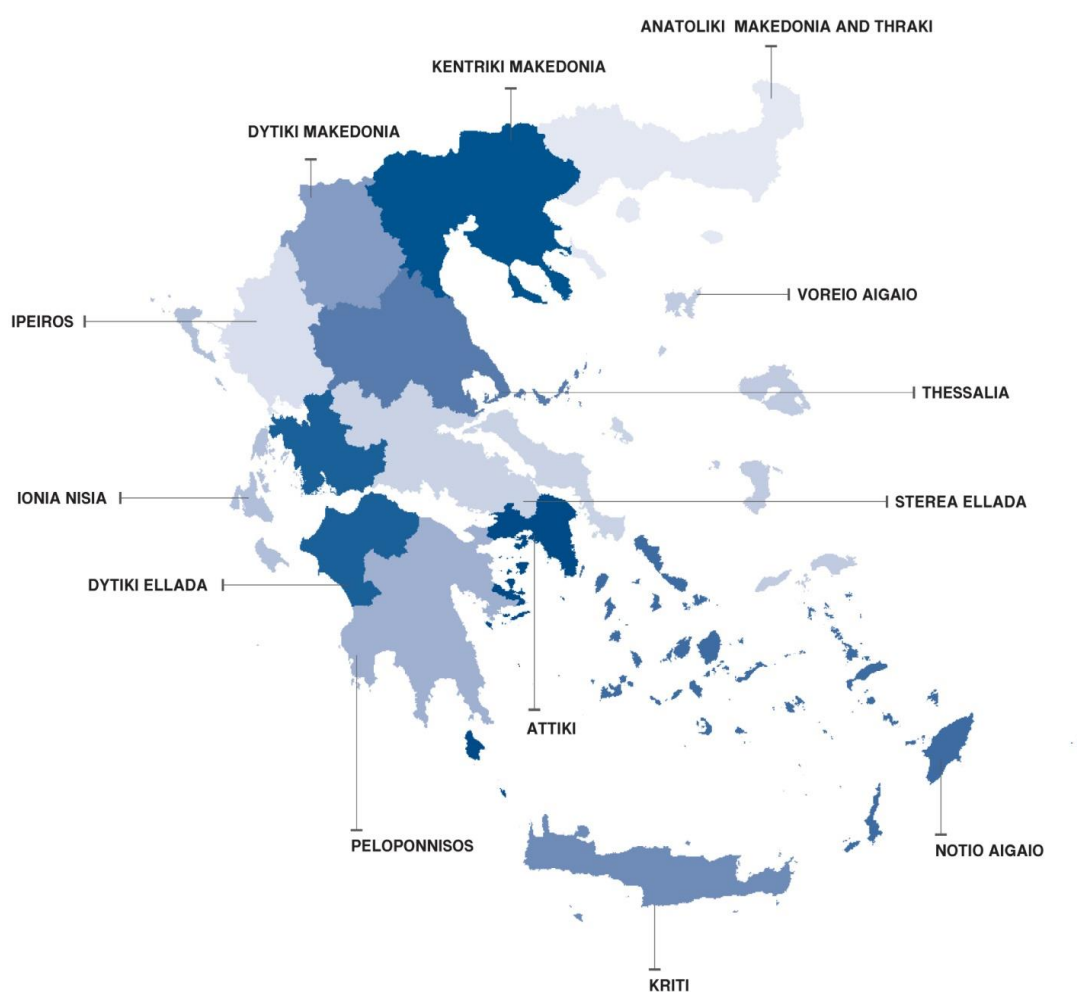
In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2018.
- Income data from administrative transaction files of the years 2019 2020 and 2021.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

Statistical classifications For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.
