## PRESS RELEASE

### Index of Number of Persons Employed in Retail Trade <sup>1</sup> (2000=100,0) Fourth quarter 2007

The National Statistical Service of Greece publishes the Index of Number of Persons Employed in Retail Trade for the 4<sup>th</sup> quarter 2007 as follows:

- The Index of Number of Persons Employed in Retail Trade in the 4<sup>th</sup> quarter 2007, as compared to the 4<sup>th</sup> quarter 2006 decreased by 0,7 %. A year earlier the annual rate of change was 2,6%
- The Index of Number of Persons Employed in Retail Trade in the 4<sup>th</sup> quarter 2007, as compared to the 3<sup>rd</sup> quarter 2007 increased by 0,9 % . A year earlier the quarterly rate of change was 2,6%.



<sup>1</sup> The index of number of persons employed in retail trade is a new index with base year :2000=100,0 covering the period from 2000 onwards.

The compilation and publication of this new index is based on the requirements of the Council Regulation (EC) No 1165/98 concerning short-term statistics.

The objective of the index of number of persons employed is to show the development of employment in retail trade.
