COMMERCIAL TRANSACTIONS OF GREECE: March 2011

(Provisional Data)

The total value of imports-arrivals, excluding oil products, in March 2011 amounted to 3016,7 million euros (4210,9 million dollars) in comparison with 3999,5 million euros (5410,6 million dollars) in March 2010, recording a drop of **24,6%** (Table 1).

The total value of exports-dispatches, excluding oil products, in March 2011 amounted to 1305,9 million euros (1833,7 million dollars) in comparison with 1311,7 million euros (1785,1 million dollars) in March 2010, recording a drop of **0,4%**. (Table 1).

The deficit of the trade balance, excluding oil products, in March 2011 amounted to 1710,8 million euros (2377,2 million dollars) in comparison with 2687,8 million euros (3625,5 million dollars) in March 2010 recording a drop of **36,4%**. (Table 1).

The total value of imports-arrivals, excluding oil products, for the 3-month period from January to March 2011 amounted to 8261,0 million euros (11274,3 million dollars) in comparison with 10162,1 million euros (13995,5 million dollars) for the corresponding period of 2010, recording a drop of **18,7%**. (Table 4).

The total value of exports-dispatches, excluding oil products, for the 3-month period from January to March 2011 amounted to 3651,5 million euros (5011,1 million dollars) in comparison with 3244,6 million euros (4492,1 million dollars) for the corresponding period of 2010, recording an increase of **12,5%**. (Table 4).

The deficit of the Trade Balance, excluding oil products, for the 3-month period from January to March 2011 amounted to 4609,5 million euros (6263,2 million dollars) in comparison with 6917,5 million euros (9503,4 million dollars) for the corresponding period of the year 2010, recording a drop of **33,4%**. (Table 4).

Since the value of ships has an important effect on the total value of imports, the above data are presented in table 1 excluding the value of ships.

For comparability of the external trade statistics **including oil products**, and following the intergration of the audited "incomplete customs declarations" concerning oil products, the data for January for the years 2009, 2010 and 2011 are provided in Table 4.

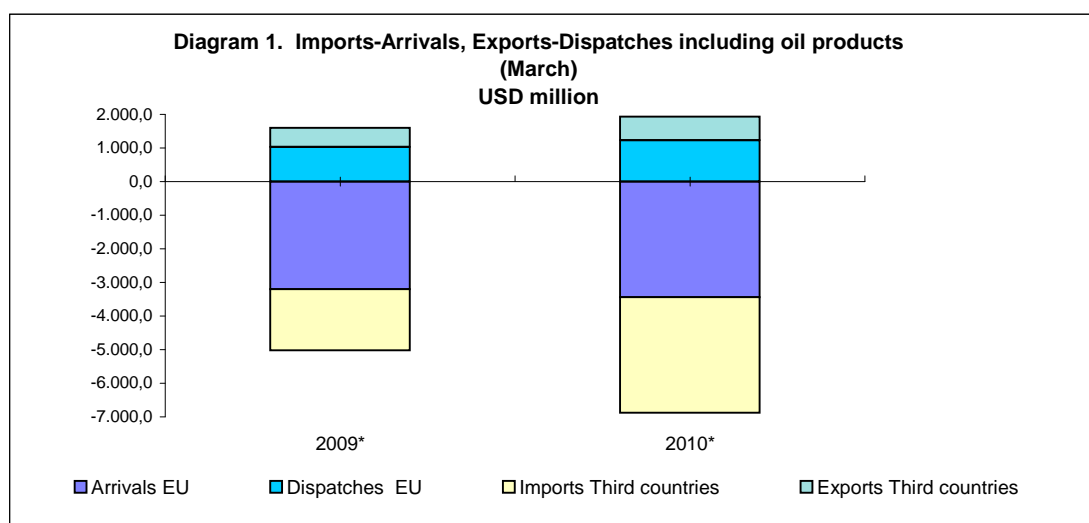

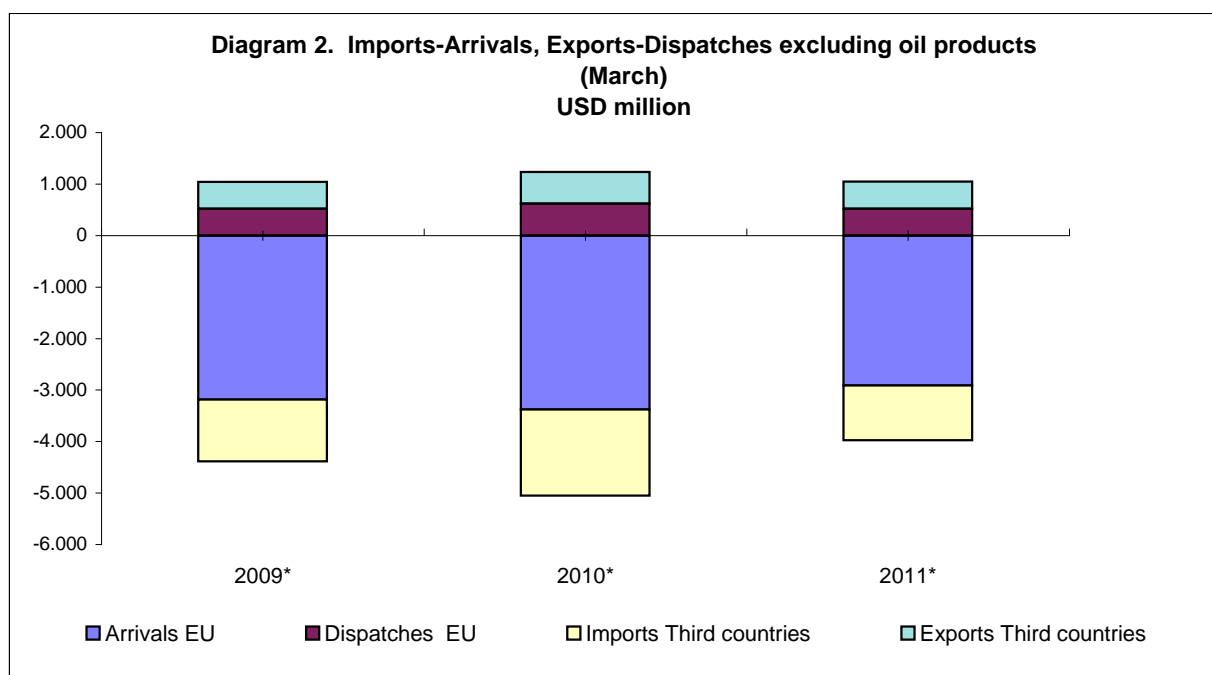

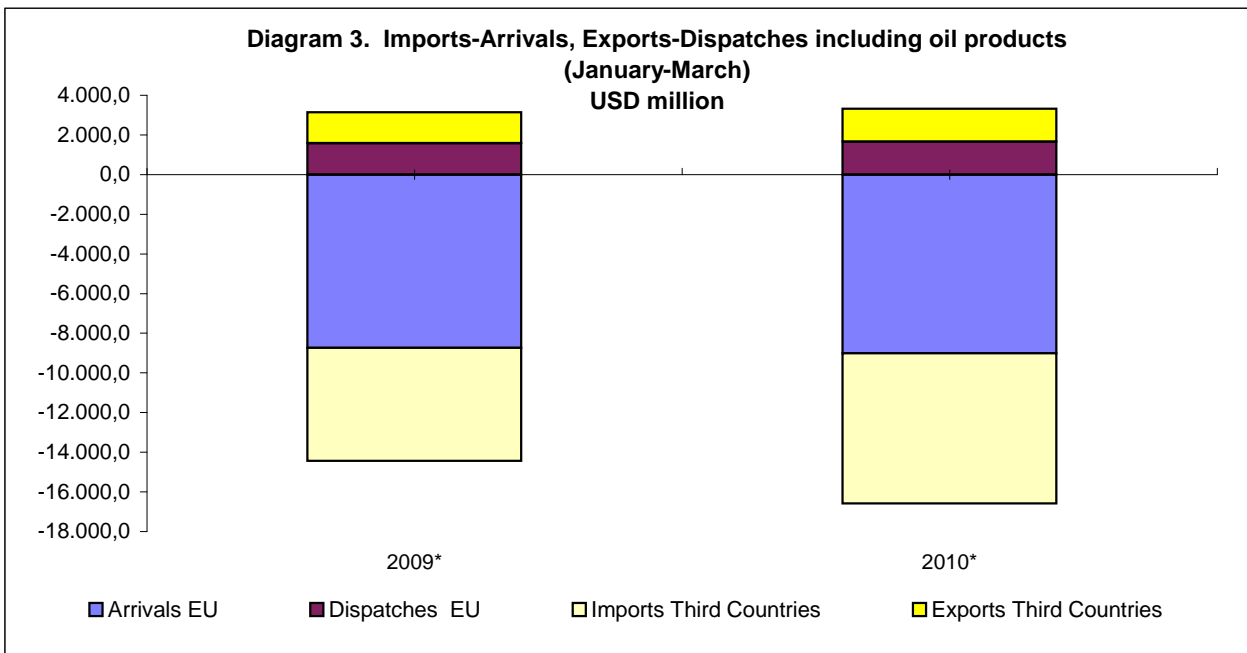

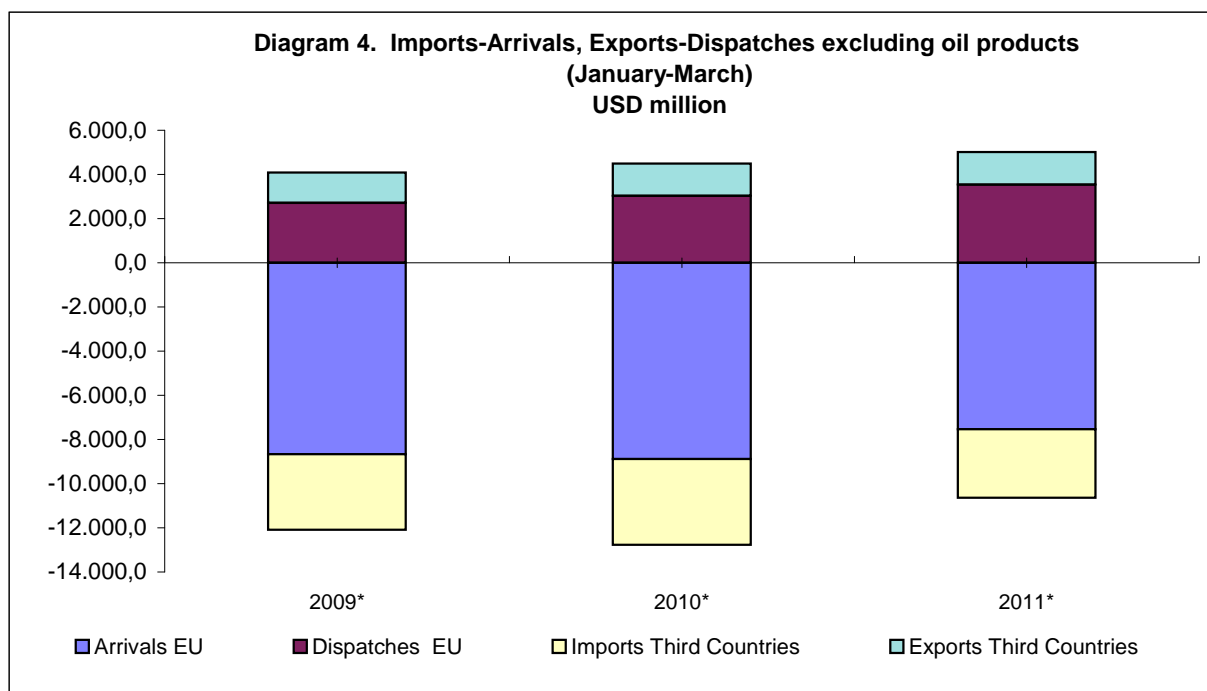

| Commercial Transactions of Greece | The Commercial Transactions of Greece are recorded on a monthly basis aiming at monitoring the total value of Imports-Arrivals, Exports-Dispatches as well as the changes on a percentage basis of the above-mentioned categories. Consequently, there are not included in them, the transactions of services and the non-registered transactions, which these two latter categories of transactions, along with the commercial transactions are taken into account in the compilation of the tables of the National Accounts. |

| Methodology | <p>INTRASTAT: It is an inventory statistical survey. The percentage of coverage ranges between 97 and 99%.</p> <p>The thresholds of adjustment for 2010 are the following: Arrivals: € 130,000.00 (98% coverage) Dispatches: € 90,000.00 (98% coverage)</p> <p>ELECTRONIC SUBMISSION: From 2003 onwards, the Intrastat form can be submitted electronically at the following links: http://eurostat.statistics.gr or www.statistics.gr. Nowadays, 80-85% of the forms is submitted electronically.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. All the transactions above the amount of 1.000 euros are registered. The Customs Authorities of the country collect the statistical data on trade filling in the Single Administrative Document (SAD). In the beginning of each month they send to the Hellenic Statistical Authority an electronic file with the statistical data of the previous month.</p> <p>Classification of goods: The goods are classified in compliance with the 8-digit Combined Nomenclature Code (CN/8) and the Standard International Trade Classification (SITC).</p> <p>The statistics of imports and exports for oil products are calculated according to the data derived from the customs declarations. The status of the audited incomplete customs declarations, for the years 2009 and 2010, has been integrated in the compilation of the external trade statistics. The corresponding declarations for the year 2011 have not been integrated yet, since they have not been finalized entirely, having as a result the lack of comparability of the external trade statistics data between the year 2011 and the years 2010 and 2009. However, the data for January for the years 2011, 2010, 2009 are comparable.</p> |
