COMMERCIAL TRANSACTIONS OF GREECE : August 2016

(Provisional Data)

The total value of imports-arrivals, in August 2016 amounted to 3110,9 million euros (3477,4 million dollars) in comparison with 2988,3 million euros (3318,8 million dollars) in August 2015, recording an increase, in euros, of **4,1%**. The corresponding change excluding oil products recorded an increase of 517,0 million euros or 27,1% (Table 1)⁽¹⁾.

The total value of exports-dispatches, in August 2016 amounted to 1912,9 million euros (2151,2 million dollars) in comparison with 1914,6 million euros (2139,0 million dollars) in August 2015, recording a drop, in euros, of **0,1%**. The corresponding change excluding oil products recorded an increase of 20,7 million euros or 1,7% (Table 1).

The deficit of the trade balance, in August 2016 amounted to 1198,0 million euros (1326,2 million dollars) in comparison with 1073,7 million euros (1179,8 million dollars) in August 2015, recording an increase, in euros, of **11,6%**. The corresponding change excluding oil products recorded an increase of 496,3 million euros or 73,6% (Table 1).

The total value of imports-arrivals, for the 8-month period from January to August 2016 amounted to 28340,1 million euros (31536,1 million dollars) in comparison with 28328,9 million euros (31403,0 million dollars) for the corresponding period of the year 2015, presenting no significant change. The corresponding change excluding oil products recorded an increase of 2215,8 million euros or **10,6%** (Table 5).

The total value of exports-dispatches, for the 8-month period from January to August 2016 amounted to 16179,6 million euros (18106,3 million dollars) in comparison with 17270,0 million euros (19264,4 million dollars) for the corresponding period of the year 2015, recording a drop, in euros, of **6,3%**. The corresponding change excluding oil products recorded a drop of 64,5 million euros or 0,5% (Table 5).

The deficit of the Trade Balance, for the 8-month period from January to August 2016 amounted to 12160,5 million euros (13429,8 million dollars) in comparison with 11058,9 million euros (12138,6 million dollars) for the corresponding period of the year 2015, recording an increase, in euros, of **10,0%**. The corresponding change excluding oil products recorded an increase of 2280,3 million euros or 26,0% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, (including the transactions below the statistical threshold ⁽¹⁾), on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises in the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

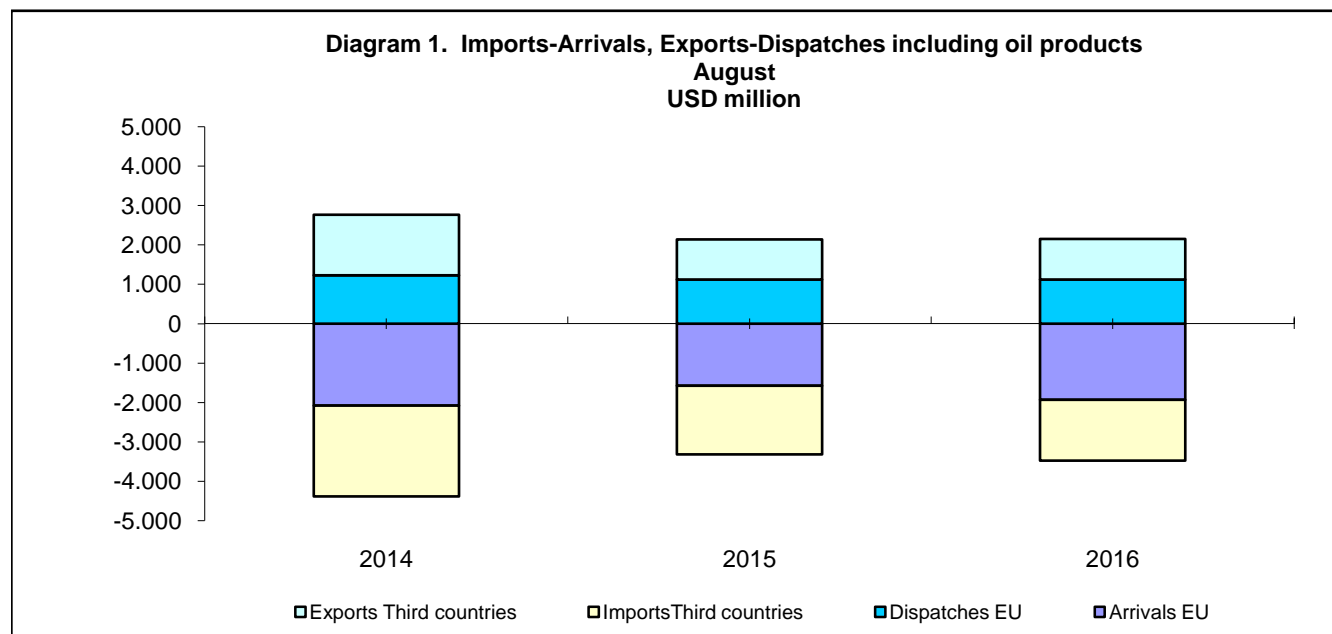

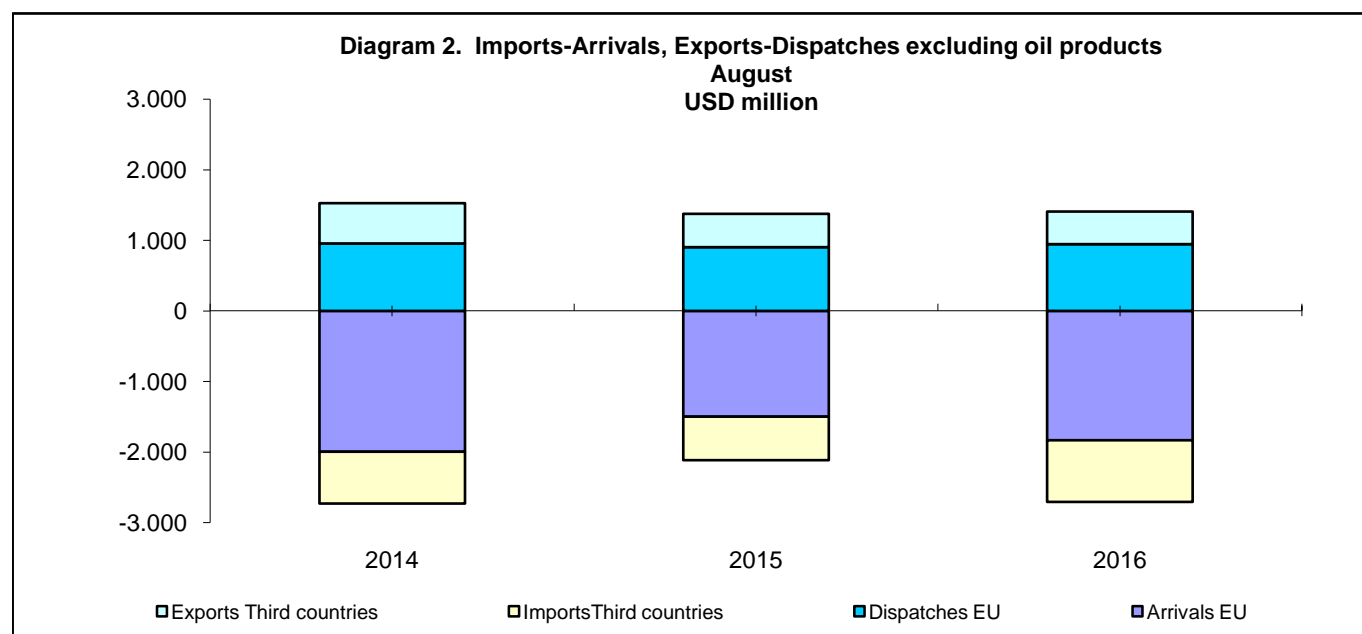

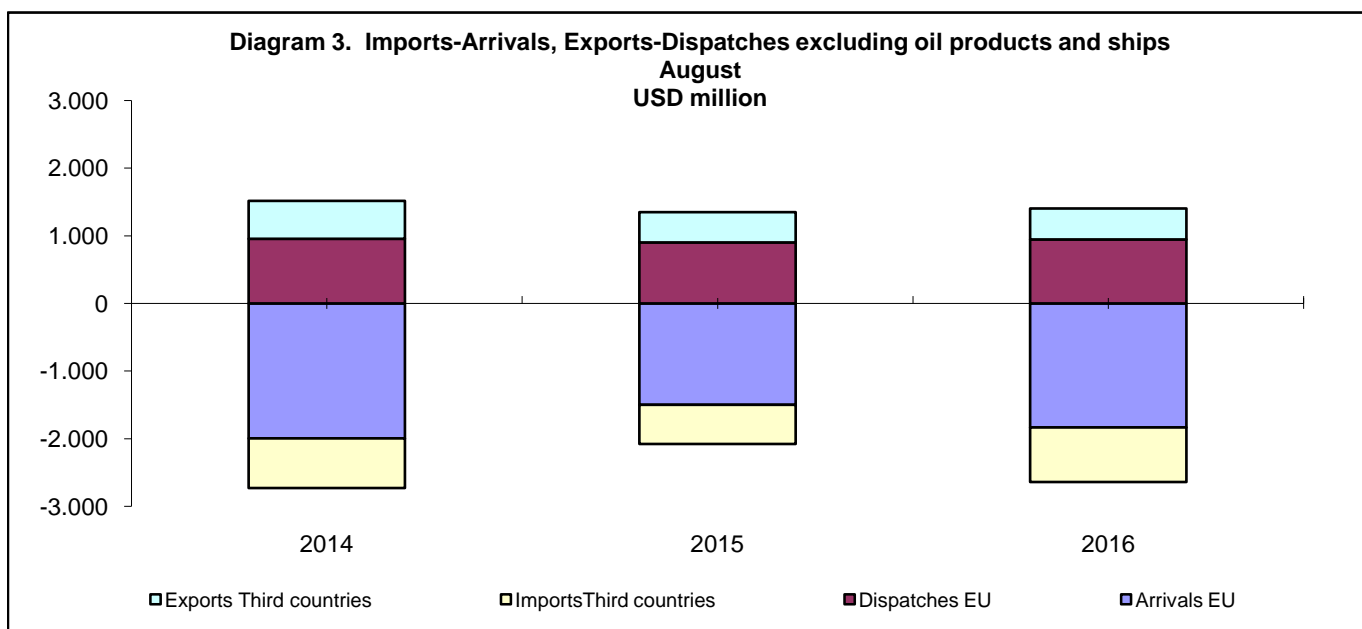

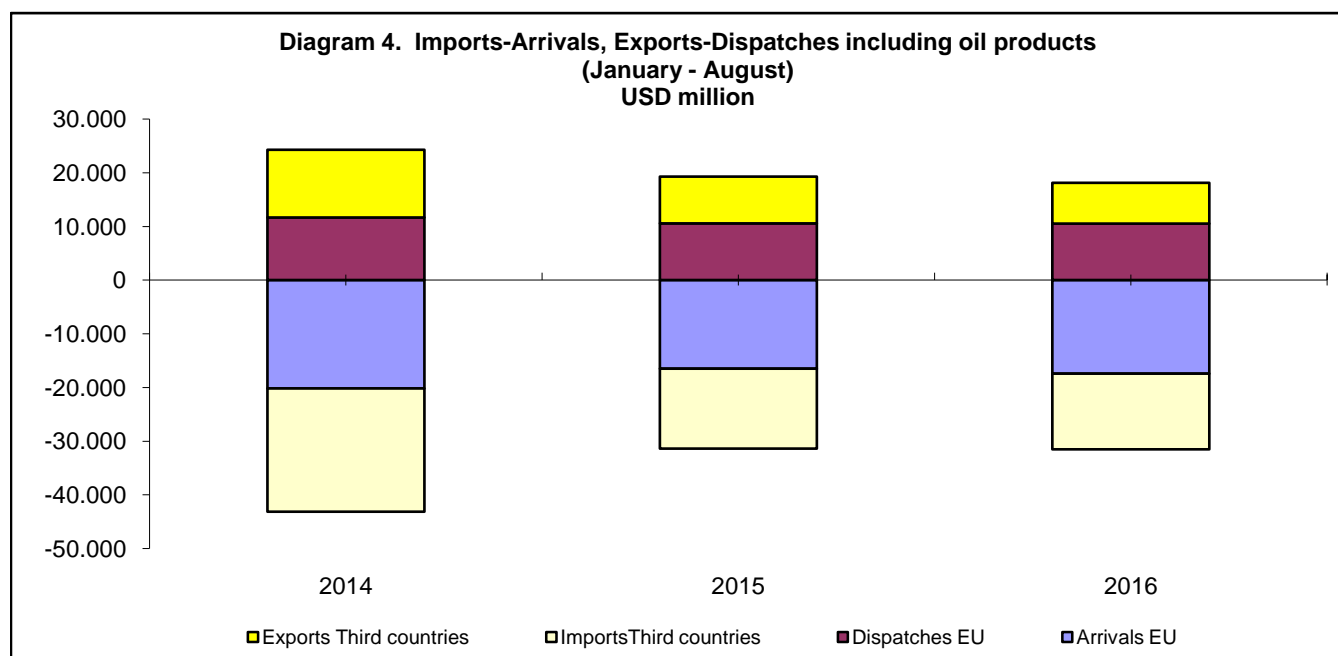

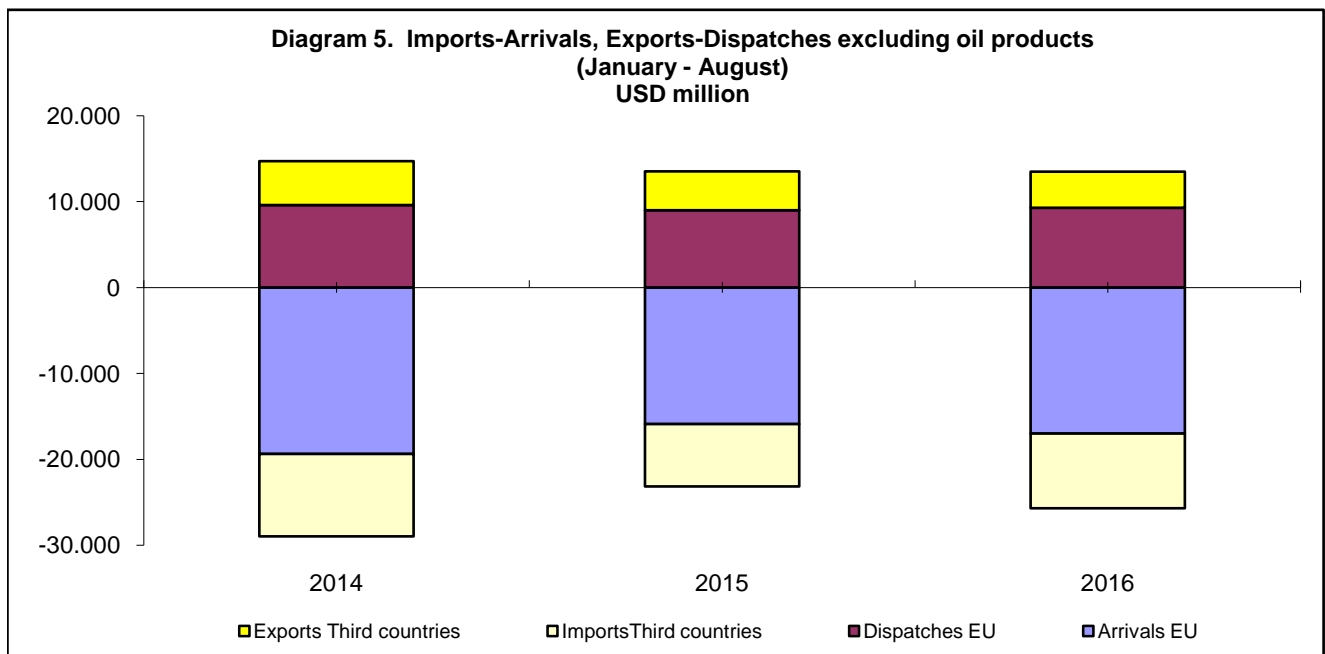

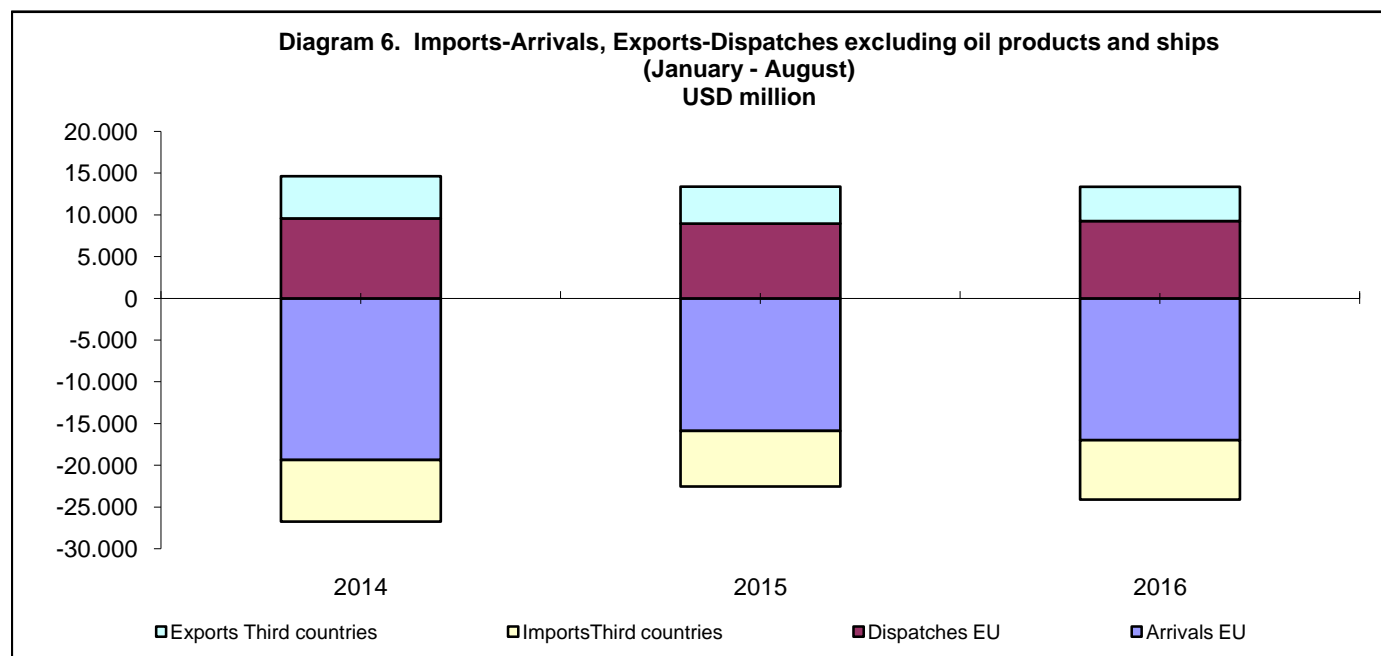
