The Hellenic Statistical Authority (ELSTAT) is publishing the quarterly Press Release presenting data on Short-Term Indices of Employment, Hours Worked and Gross Wages and Salaries in main sections of the economy for the 4th quarter 2017.

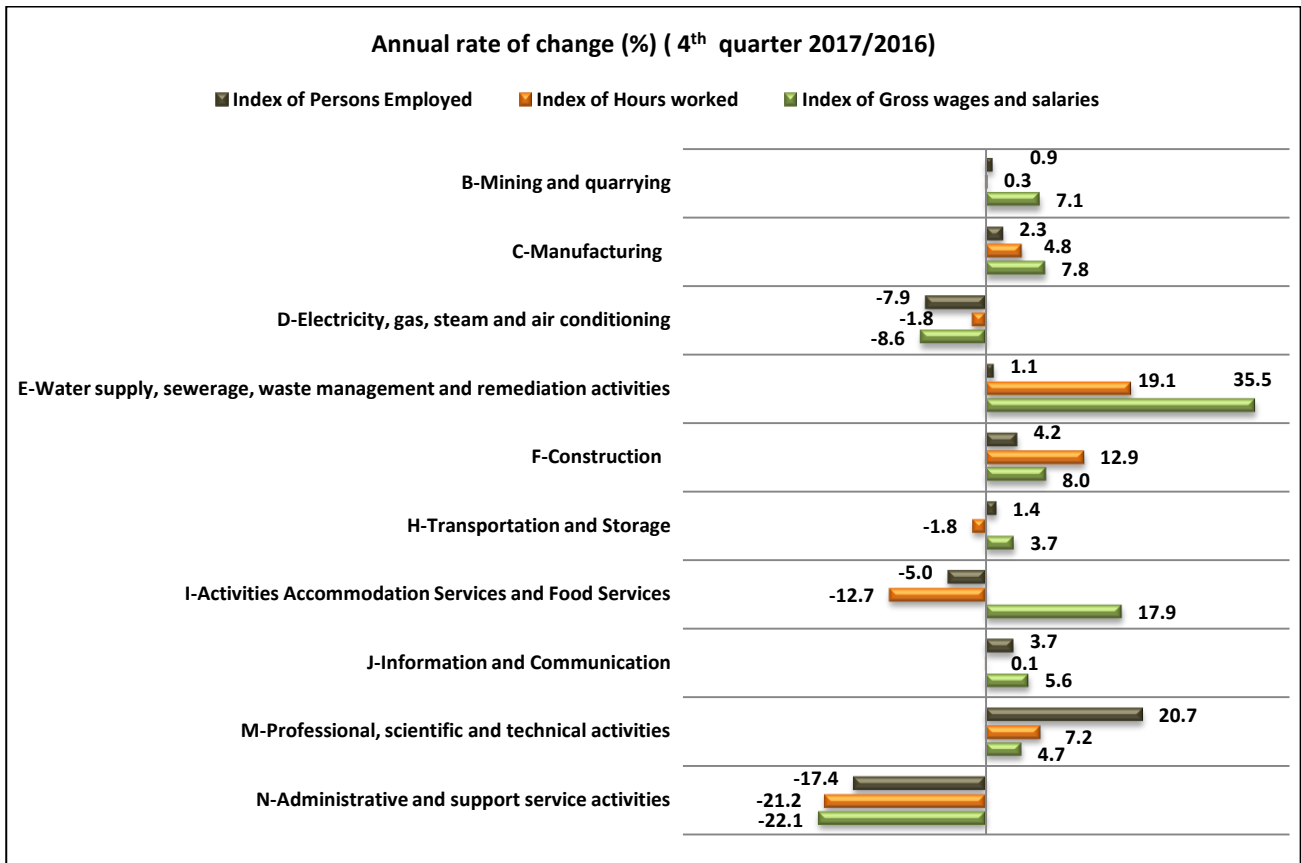

In the following table, the short-term Indices of Employment, Hours Worked and Gross Wages without any adjustment (seasonal or adjustment for the number of working days) are presented analytically in ten main sections¹ of the NACE Rev.2 classification of economic activities. Furthermore, data of the annual change of each index are presented.

In the Graphs 1 to 10 that follow the evolution over time of the Indices of Employment, Hours Worked and Gross Wages and Salaries broken down by NACE Rev.2 Section for the 4th quarter of the years 2010 up to 2017 is shown, as well as their annual changes.

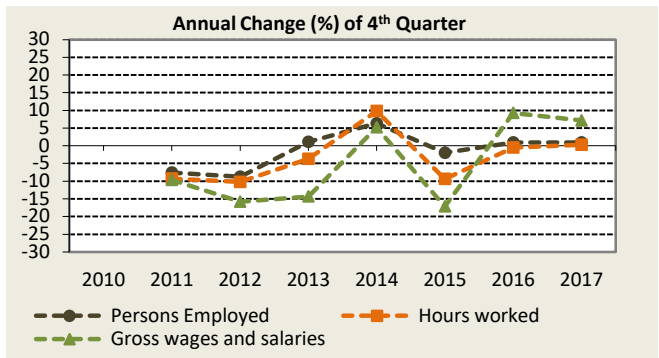

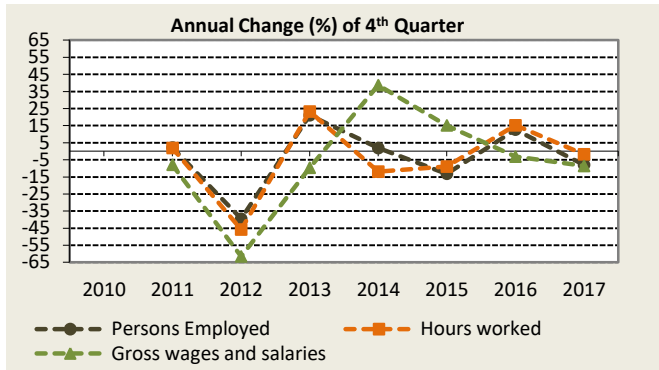
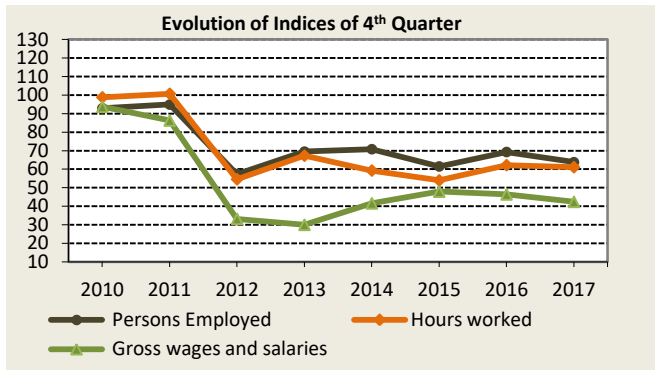
Graph 1: B-Mining and quarrying



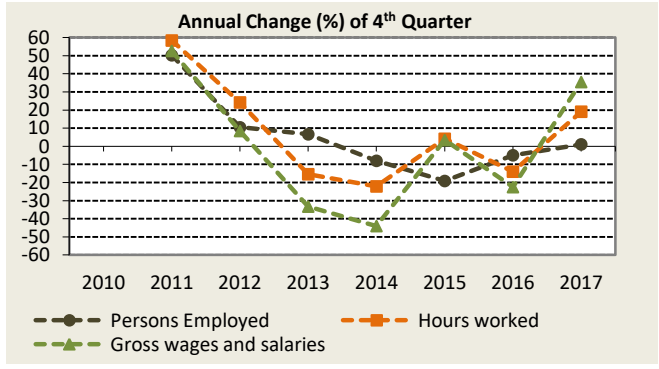
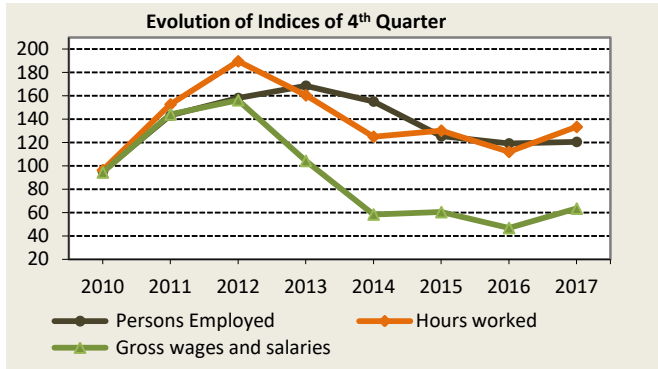
Graph 2: C-Manufacturing



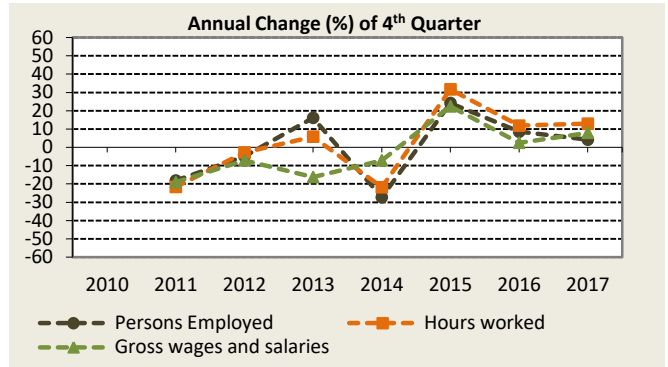
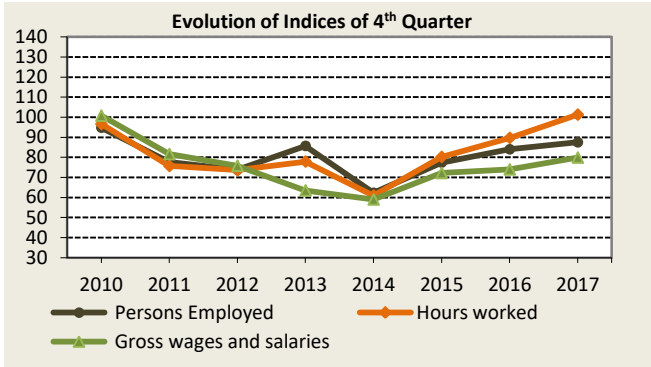
Graph 3: D-Electricity, gas, steam and air conditioning



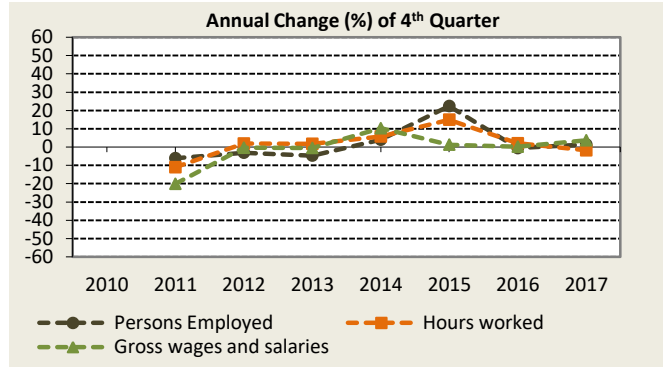
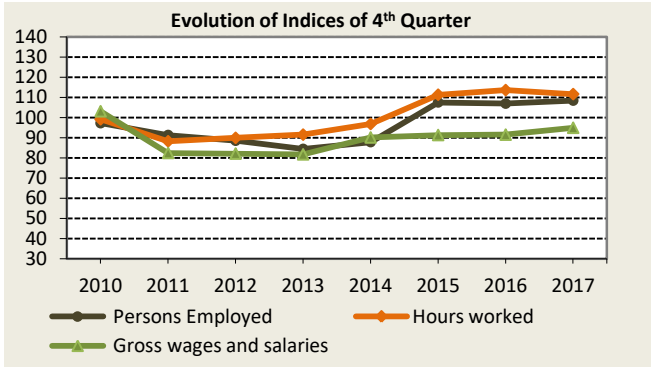
Graph 4: E-Water supply, sewerage, waste management and remediation activities



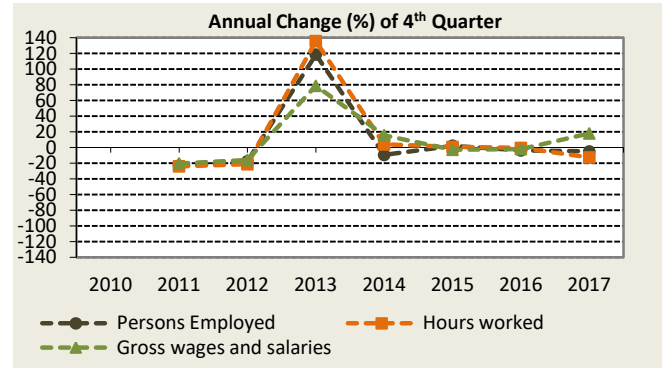
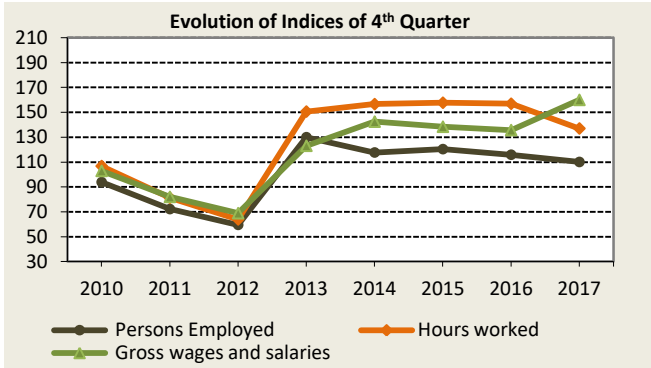
Graph 5: F-Construction



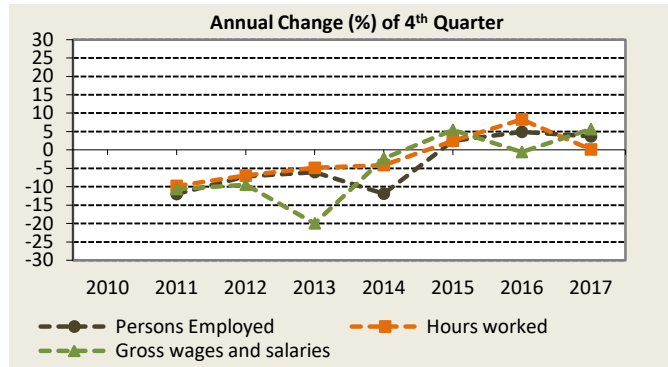
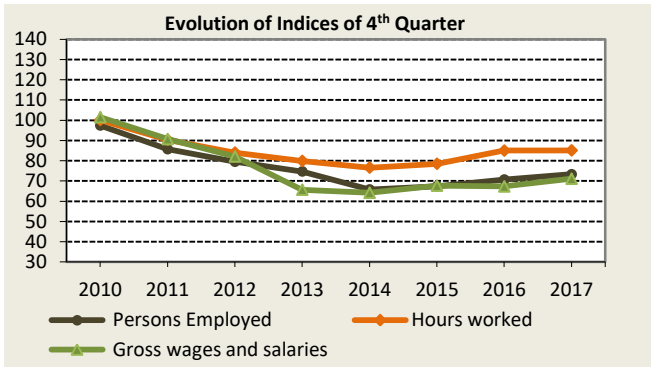
Graph 6: H-Transportation and Storage



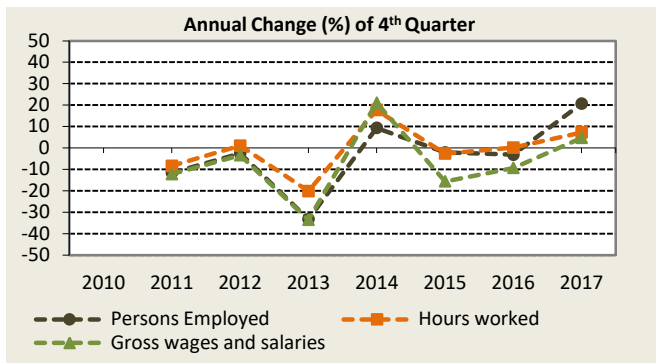
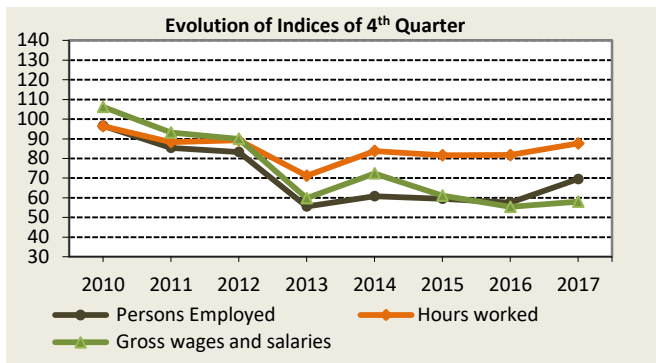
Graph 7: I-Activities Accommodation Services and Food Services



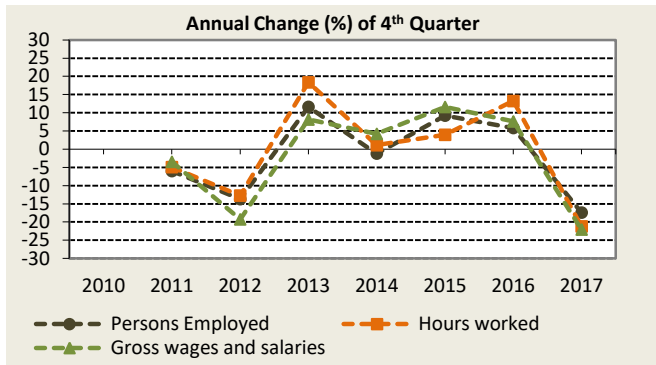
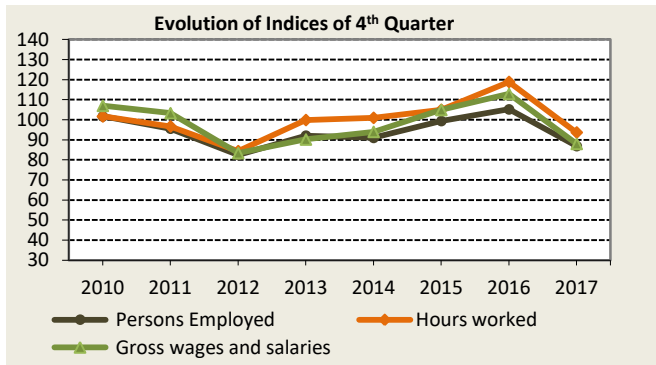
Graph 8: J-Information and Communication

METHODOLOGICAL NOTES

Generally	The Short-term Indices of Persons Employed, Hours worked and Gross wages and salaries are quarterly indices concerning the Sections of economic activity B to E (Industry), F (Construction), H to J and M to N (Other Services) of the European Economic classification NACE Rev.2, having 2010 as the base year (2010=100.00).																				
Purpose of the index	The purpose of the indices is the description in change of Persons Employed, Hours worked and Gross wages and salaries on a quarterly basis in sections of Economic activity B to E (Mining-quarrying and Industry), F (Construction), H to J and M to N (Other Services) of the European economic classification NACE Rev.2.																				
Legal Framework	The Council Regulation (EC) No.1165/98 concerning short-term statistics and on Council Regulation (EC) No.1503/2006 as regards definitions of variables, list of variables and frequency of data compilation.

Reference Period	Quarter.																				
Definitions	<p>As Number of Persons Employed is defined the total number of persons employed in the enterprise, irrespectively of their status (owners, partners and their family members) and the nature of their work (managers, sales persons and auxiliary staff) and irrespectively of whether they work temporarily or seasonally, full-time or part-time employment, with or without remuneration.</p> <p>As Hours Worked is defined the total number of hours actually worked in the enterprise during the reference quarter. Included are hours actually worked during normal working hours; hours worked in addition to those, with or without remuneration, time that is spent at the place of work on tasks such as preparing the site and time corresponding to short periods of rest at the work place. This variable excludes hours paid but not actually worked such as for annual leave, holidays and sickness leave.</p> <p>As Wages and salaries is defined the total remuneration, in cash or in kind, payable to all persons counted on the payroll, in return for work done.</p>
