## **PRESS RELEASE**

### **COMMERCIAL TRANSACTIONS OF GREECE : July 2020**

( Provisional Data )

The total value of imports-arrivals, in July 2020 amounted to 4,446.1 million euros (5,081.3 million dollars) in comparison with 5,091.9 million euros (5,695.1 million dollars) in July 2019, recording a drop, in euros, of **12.7%**. The corresponding value excluding oil products in July 2020 recorded a drop of 121.4 million euros or 3.2% and the corresponding value excluding oil products and ships in July 2020 recorded a drop of 121.1 million euros or 3.2%, in comparison with July 2019 (Table 1).

The total value of exports-dispatches, in July 2020 amounted to 2,884.5 million euros (3,316.6 million dollars) in comparison with 3,209.3 million euros (3,611.2 million dollars) in July 2019, recording a drop, in euros, of **10.1%**. The corresponding value excluding oil products recorded in July 2020 an increase of 195.7 million euros or 9.2% and the corresponding value excluding oil products and ships in July 2020 recorded an increase of 180.1 million euros or 8.5%, in comparison with July 2019 (Table 1).

The deficit of the trade balance, in July 2020 amounted to 1,561.6 million euros (1,764.7 million dollars) in comparison with 1,882.6 million euros (2,083.9 million dollars) in July 2019, recording a drop, in euros, of **17.1%**. The corresponding value of deficit excluding oil products in July 2020 recorded a drop of 317.1 million euros or 19.4% and the corresponding value excluding oil products and ships in July 2020 recorded a drop of 301.2 million euros or 18.6%, in comparison with July 2019 (Table 1).

The total value of imports-arrivals, for the 7-month period from January to July 2020 amounted to 28,099.1 million euros (31,079.1 million dollars) in comparison with 33,000.2 million euros (37,121.4 million dollars) for the corresponding period of the year 2019, recording a drop, in euros, of **14.9%**. The corresponding value excluding oil products recorded a drop of 1,727.9 million euros or 7.1% and the corresponding value excluding oil products and ships recorded a drop of 1,667.4 million euros or 6.9%, in comparison with the period from January to July 2019 (Table 5).

The total value of exports-dispatches, for the 7-month period from January to July 2020 amounted to 17,682.3 million euros (19,677.2 million dollars) in comparison with 20,055.2 million euros (22,692.8 million dollars) for the corresponding period of the year 2019, recording a drop, in euros, of **11.8%**. The corresponding value excluding oil products recorded an increase of 159.8 million euros or 1.2% and the corresponding value excluding oil products and ships recorded an increase of 162.4 million euros or 1.2%, in comparison with the period from January to July 2019 (Table 5).

The deficit of the trade balance, for the 7-month period from January to July 2020 amounted to 10,416.8 million euros (11,401.9 million dollars) in comparison with 12,945.0 million euros (14,428.6 million dollars) for the corresponding period of the year 2019, recording a drop, in euros, of **19.5%**. The corresponding deficit excluding oil products recorded a drop of 1,887.7 million euros or 17.8% and the corresponding deficit excluding oil products and ships recorded a drop of 1,829.8 million euros or 17.5% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold <sup>(1)</sup>, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

<sup>(1)</sup> By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

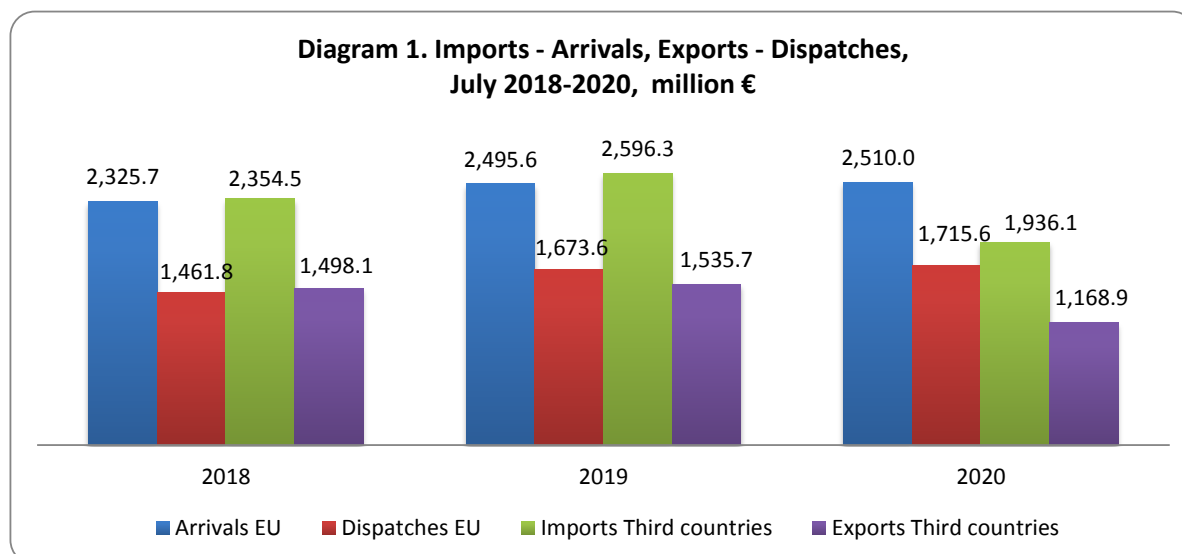

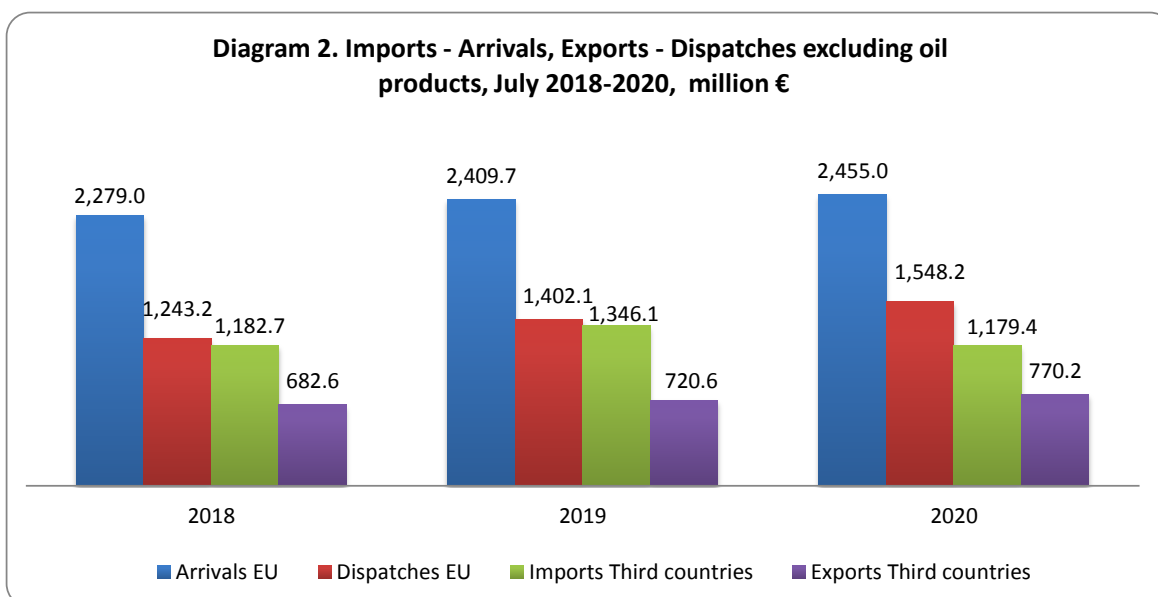

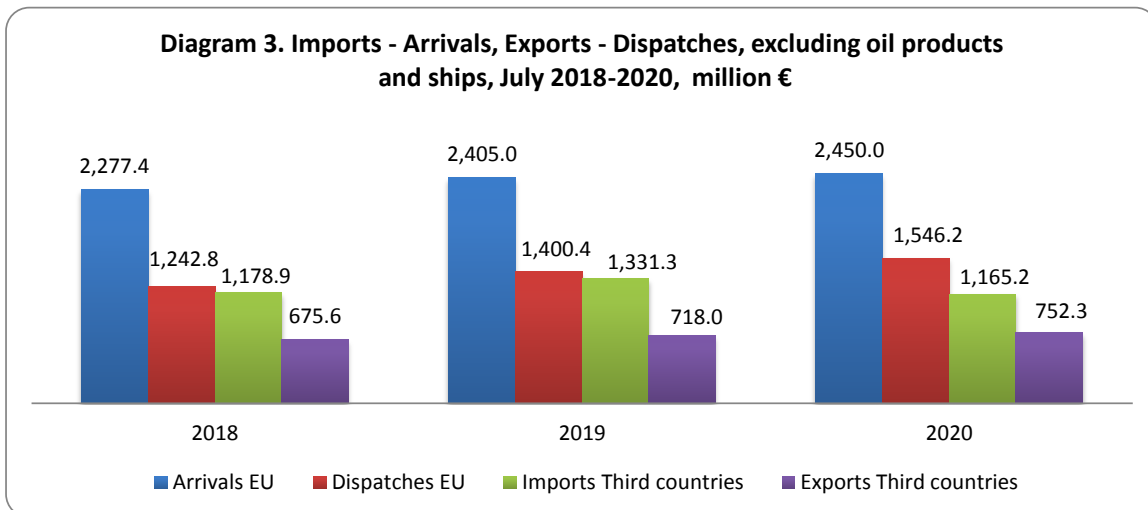

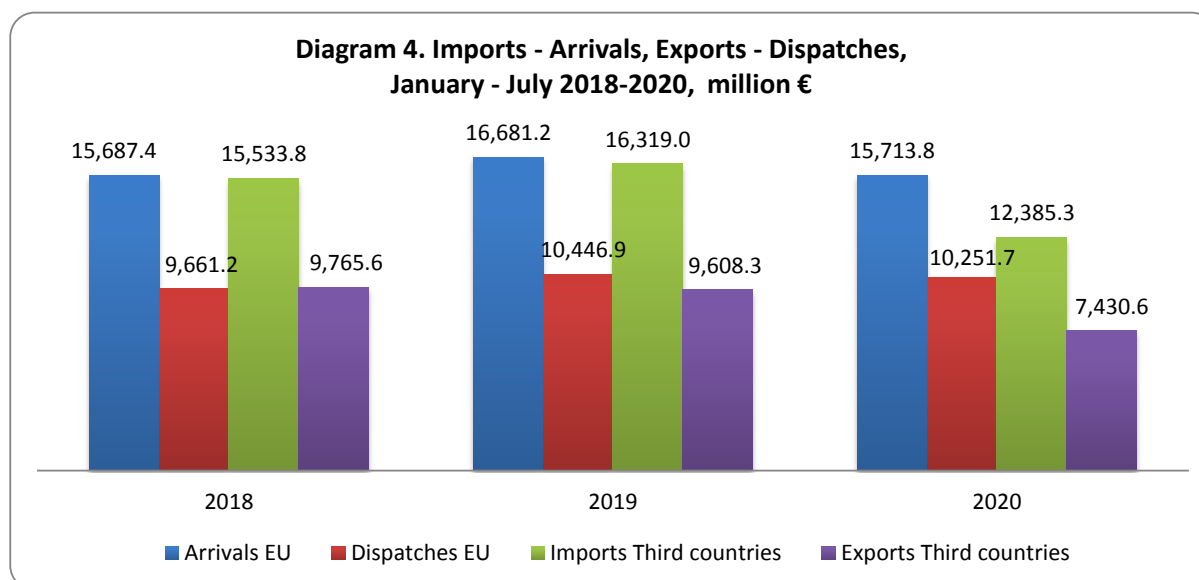

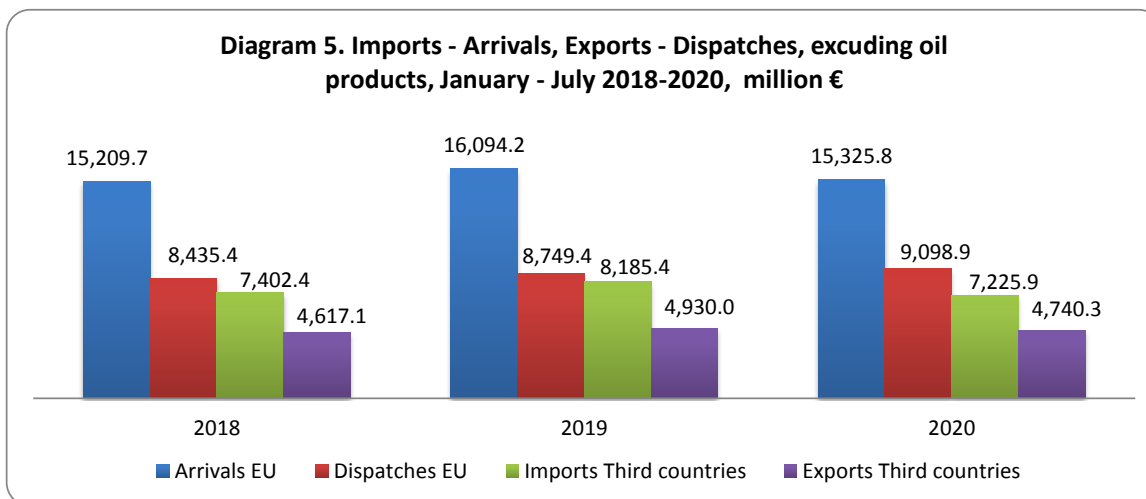

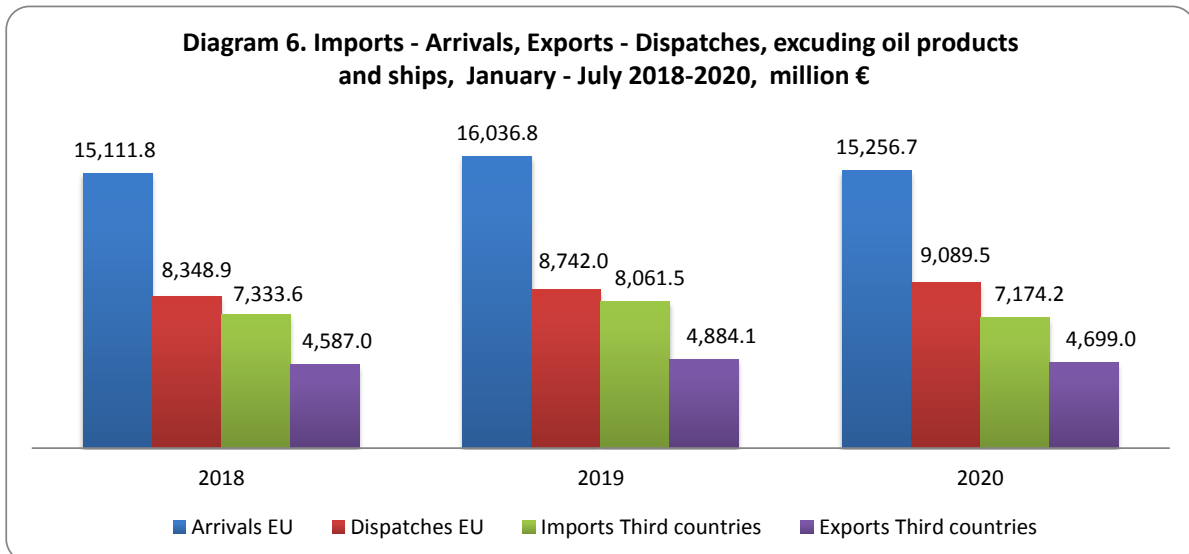

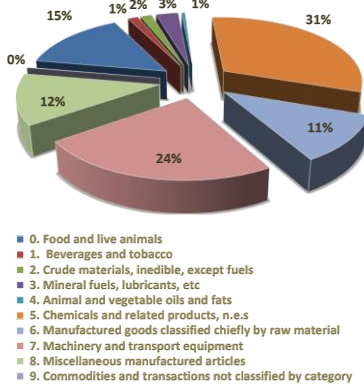

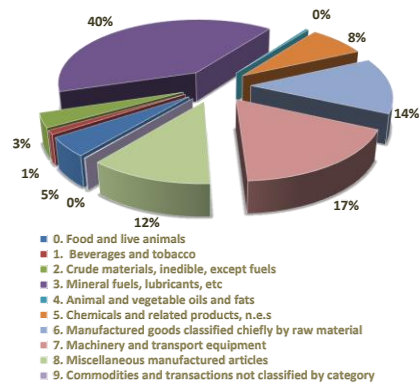

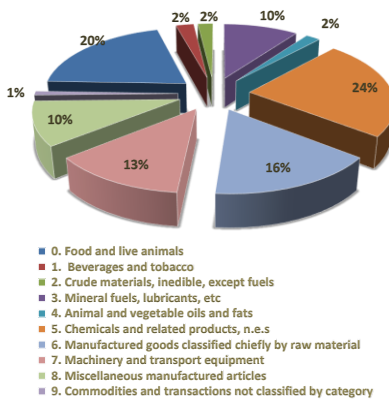
**Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, July 2020**



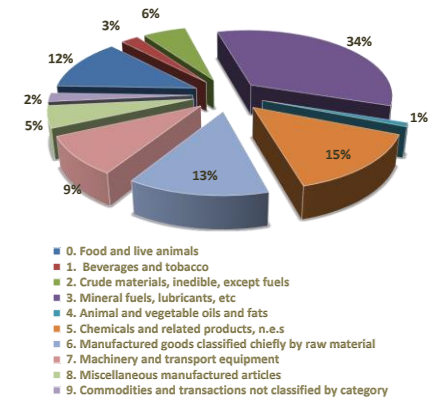
**Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, July 2020**



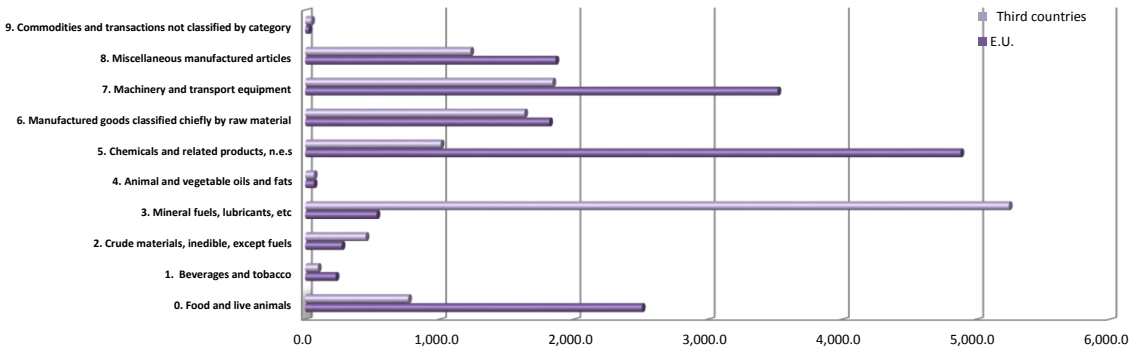
**Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, July 2020**



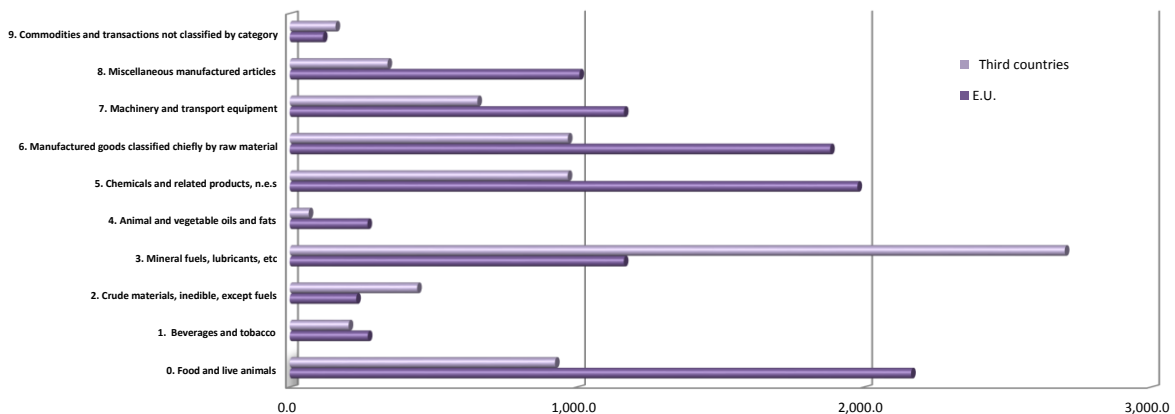
**Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, July 2020**

**Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - July 2020, million €**



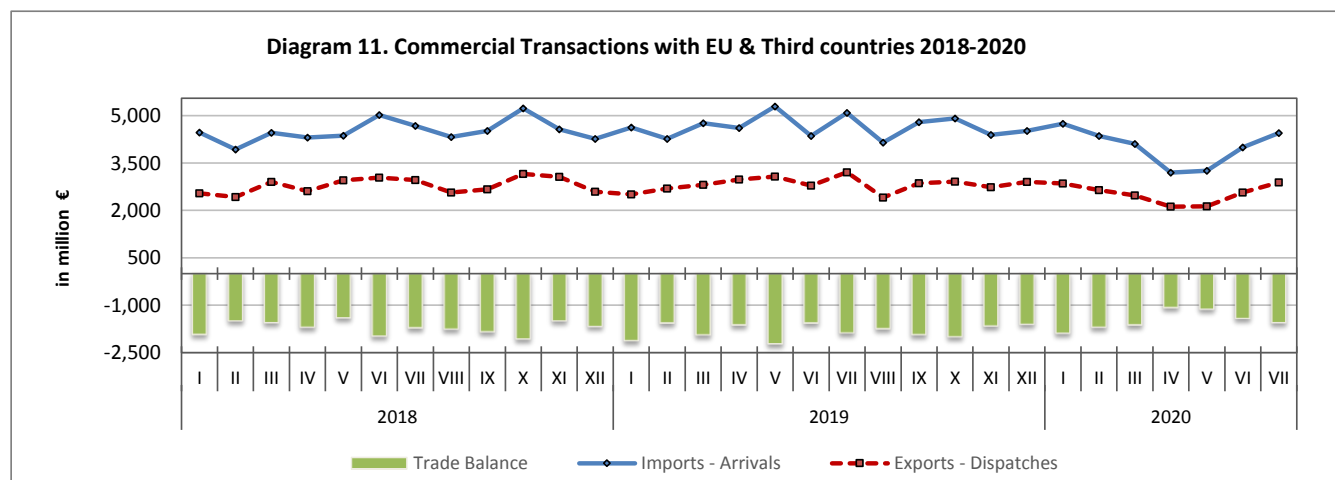

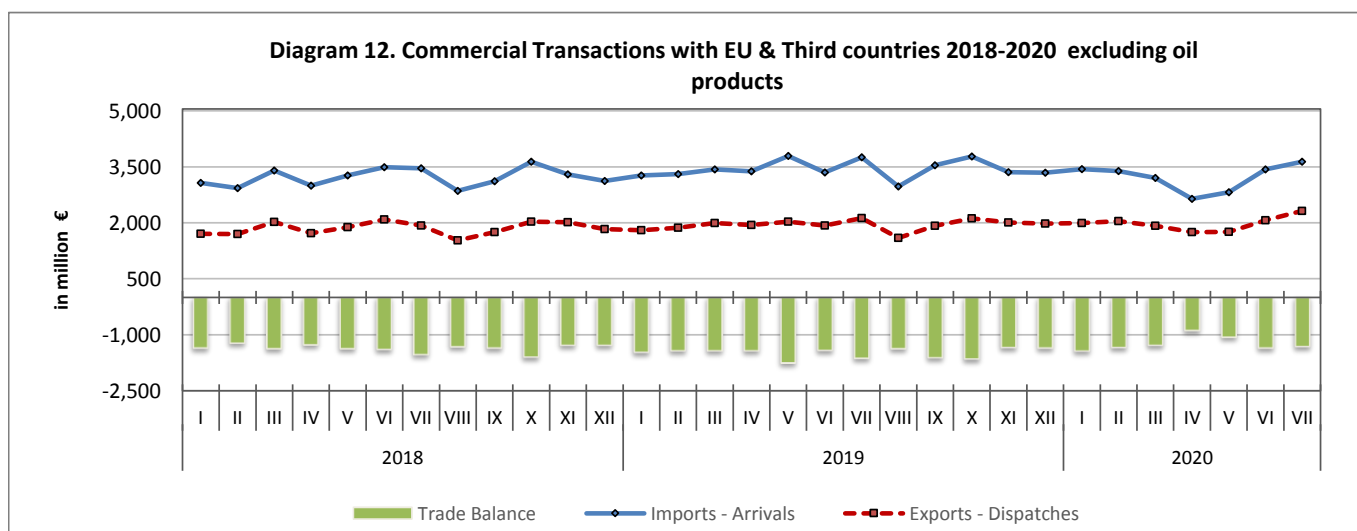

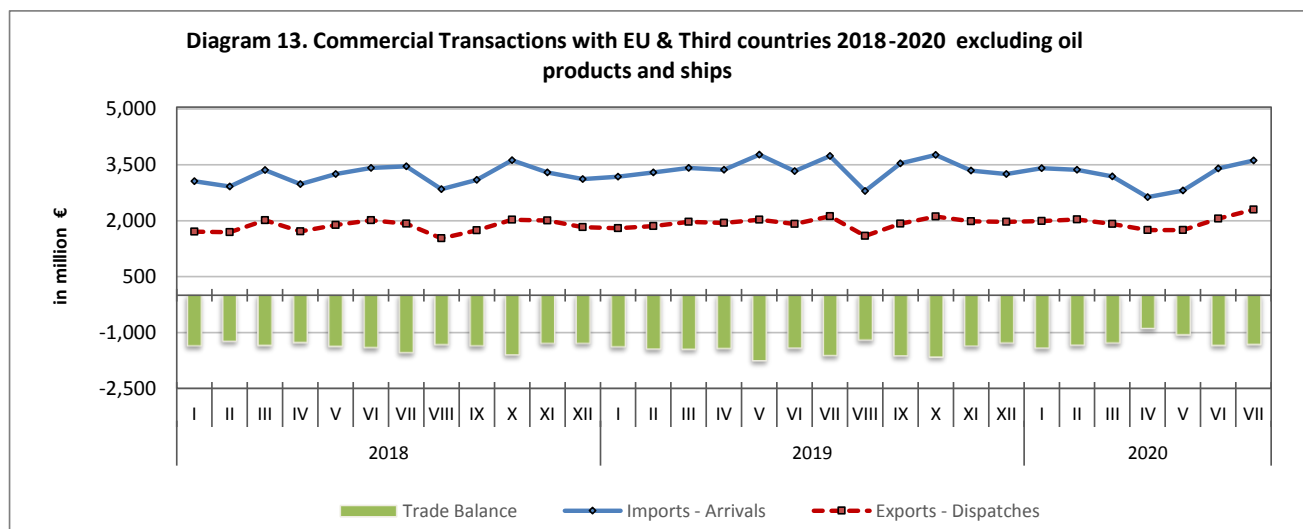

<b>Commercial Transactions of Greece</b>	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports/arrivals, exports/dispatches and their changes. This recording does not include the imports and exports of services; however the imports and exports of services together with the corresponding commercial transactions are taken into account for the compilation of National Accounts tables.
