

## **PRESS RELEASE**

### **COMMERCIAL TRANSACTIONS OF GREECE : June 2022**

( Provisional Data )

The total value of imports-arrivals, in June 2022 amounted to 8,262.5 million euros (8,703.8 million dollars) in comparison with 5,383.9 million euros (6,466.4 million dollars) in June 2021, recording an increase, in euros, of **53.5%**. The corresponding value excluding oil products in June 2022 recorded an increase of 1,080.9 million euros or 25.6% and the corresponding value excluding oil products and ships in June 2022 recorded an increase of 1,081.7 million euros or 25.7%, in comparison with June 2021 (Table 1).

The total value of exports-dispatches, in June 2022 amounted to 5,426.3 million euros (5,750.6 million dollars) in comparison with 3,396.0 million euros (4,103.4 million dollars) in June 2021, recording an increase, in euros, of **59.8%**. The corresponding value excluding oil products recorded in June 2022 an increase of 607.7 million euros or 24.1% and the corresponding value excluding oil products and ships in June 2022 recorded an increase of 606.1 million euros or 24.2%, in comparison with June 2021 (Table 1).

The deficit of the trade balance, in June 2022 amounted to 2,836.2 million euros (2,953.2 million dollars) in comparison with 1,987.9 million euros (2,363.0 million dollars) in June 2021, recording an increase, in euros, of **42.7%**. The corresponding value of deficit excluding oil products in June 2022 recorded an increase of 473.2 million euros or 27.8% and the corresponding value excluding oil products and ships in June 2022 recorded an increase of 475.6 million euros or 28.0%, in comparison with June 2021 (Table 1).

The total value of imports-arrivals, for the 6-month period from January to June 2022 amounted to 43,610.7 million euros (47,467.1 million dollars) in comparison with 28,864.6 million euros (34,662.1 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **51.1%**. The corresponding value excluding oil products recorded an increase of 7,662.2 million euros or 34.1% and the corresponding value excluding oil products and ships recorded an increase of 7,620.7 million euros or 34.1%, in comparison with the period from January to June 2021 (Table 5).

The total value of exports-dispatches, for the 6-month period from January to June 2022 amounted to 26,017.5 million euros (28,434.6 million dollars) in comparison with 18,614.7 million euros (22,492.4 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **39.8%**. The corresponding value excluding oil products recorded an increase of 3,326.1 million euros or 24.1% and the corresponding value excluding oil products and ships recorded an increase of 3,319.3 million euros or 24.1%, in comparison with the period from January to June 2021 (Table 5).

The deficit of the trade balance, for the 6-month period from January to June 2022 amounted to 17,593.2 million euros (19,032.5 million dollars) in comparison with 10,249.9 million euros (12,169.7 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **71.6%**. The corresponding deficit excluding oil products recorded an increase of 4,336.1 million euros or 50.3% and the corresponding deficit excluding oil products and ships recorded an increase of 4,301.4 million euros or 50.1% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold<sup>(1)</sup>, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

<sup>(1)</sup> By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

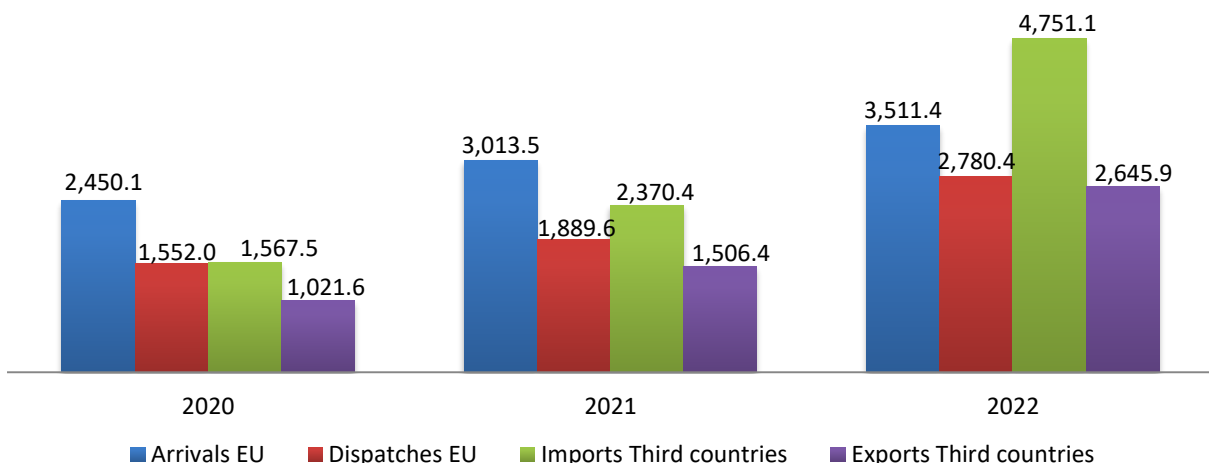

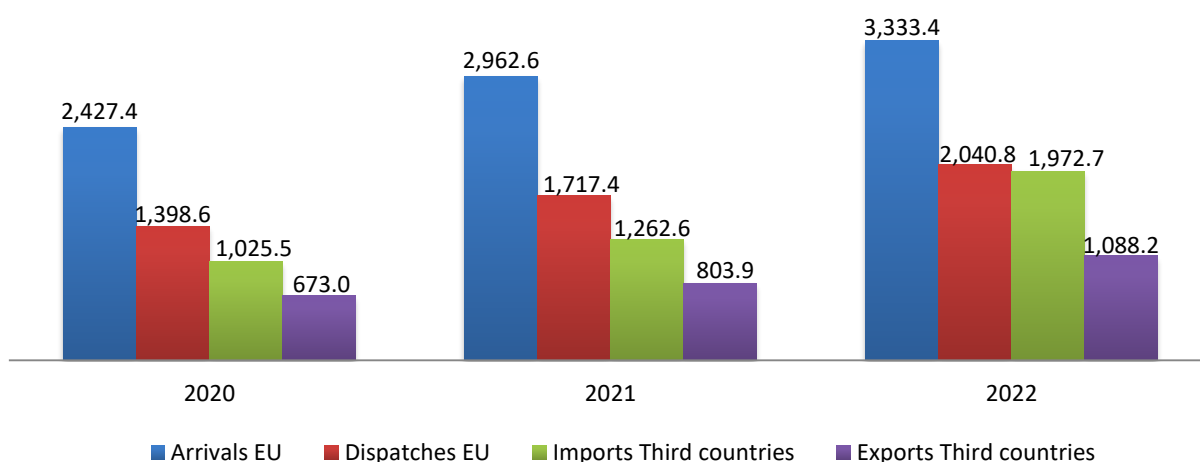

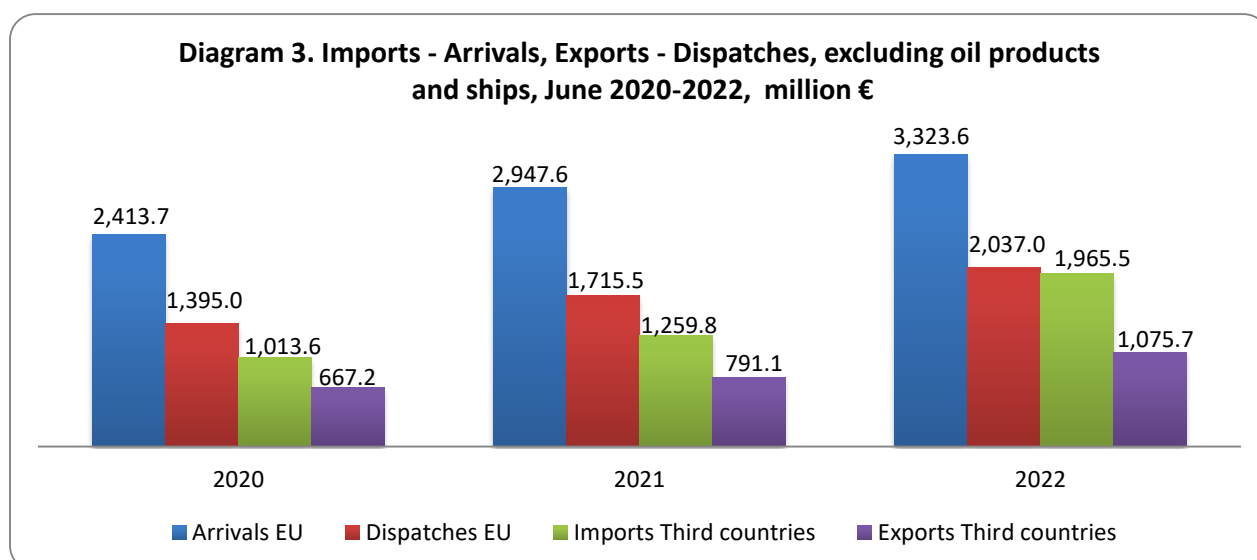

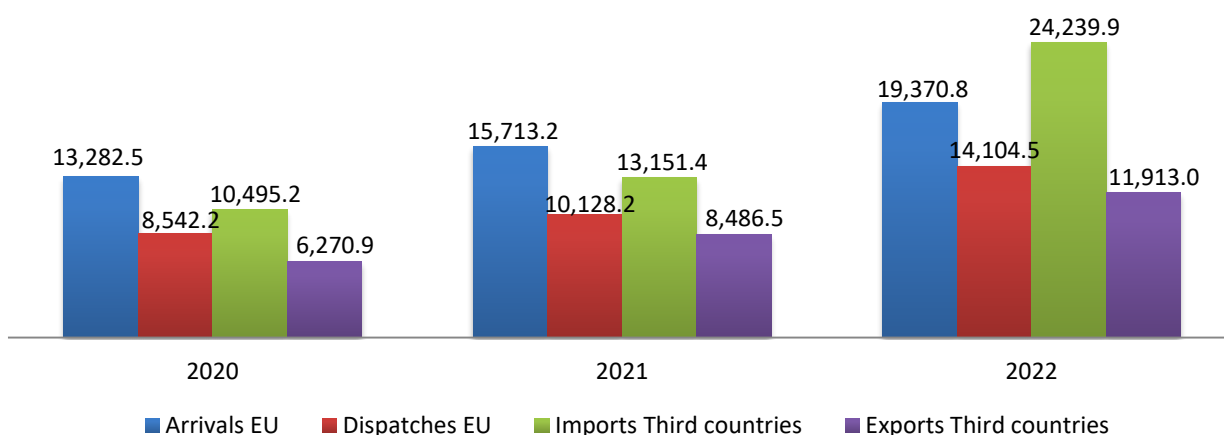

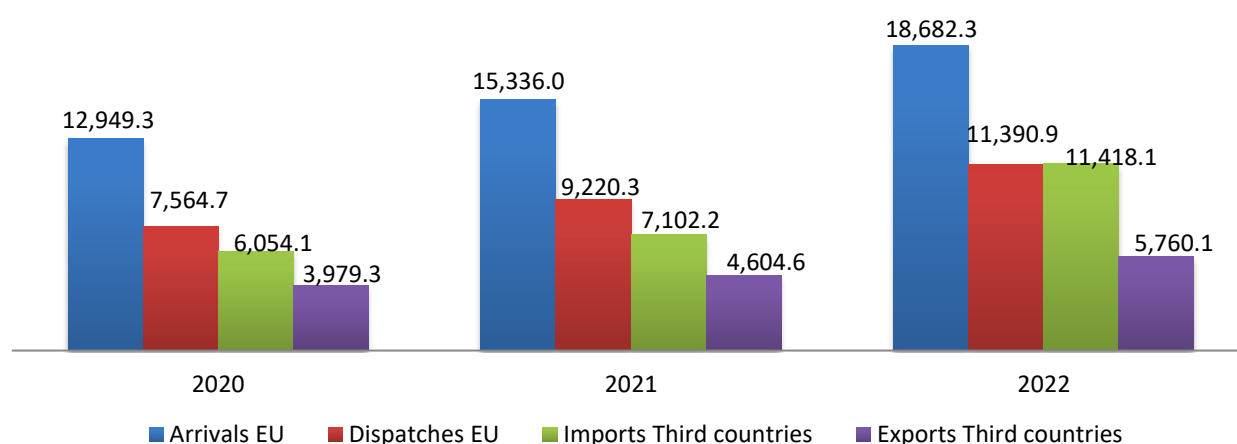

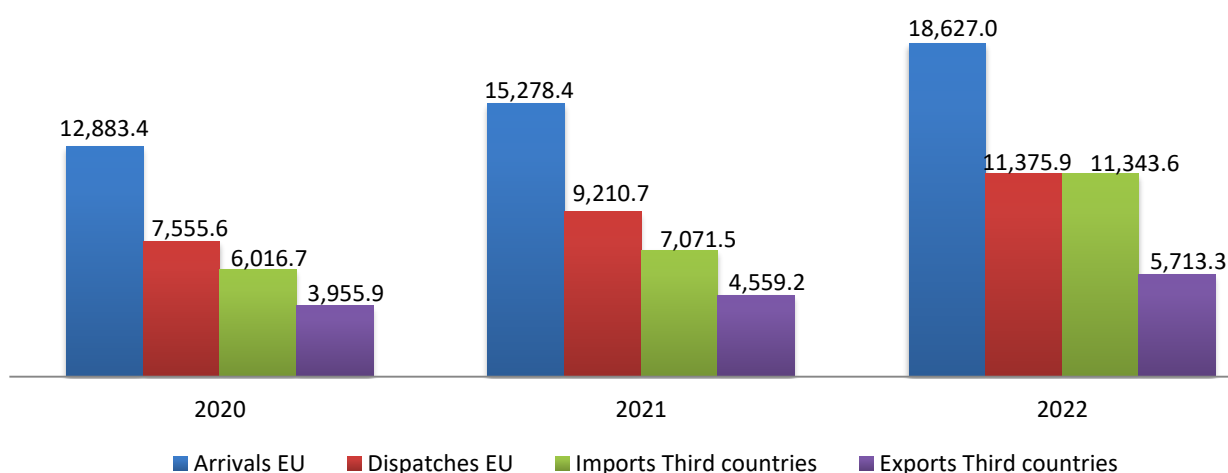

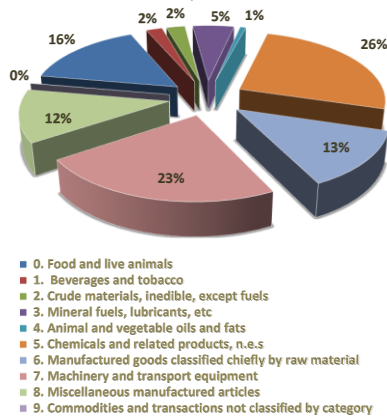

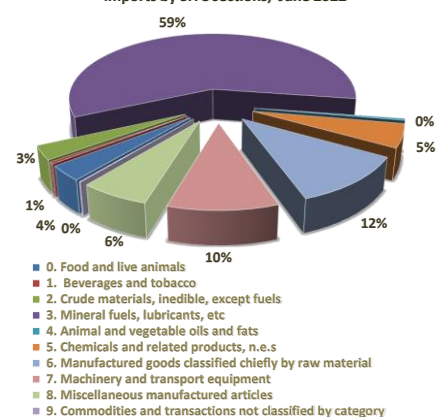

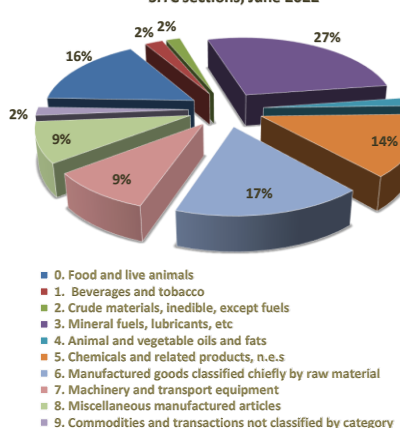
**Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, June 2022**



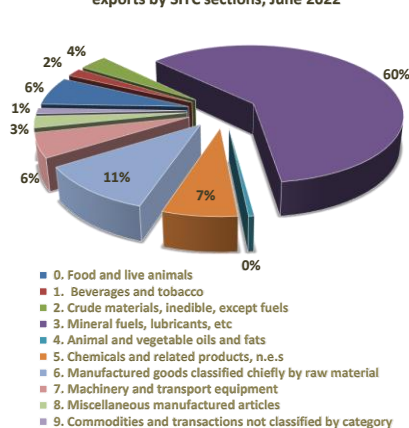
**Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, June 2022**



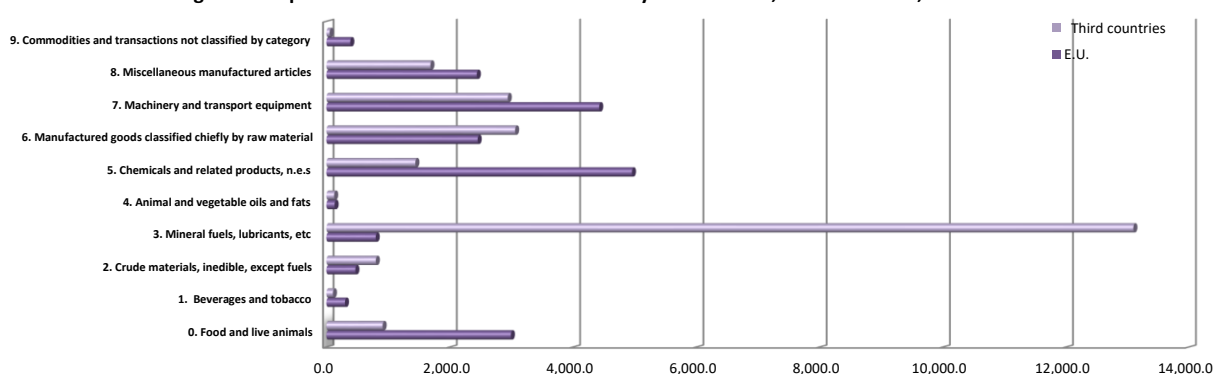
**Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, June 2022**



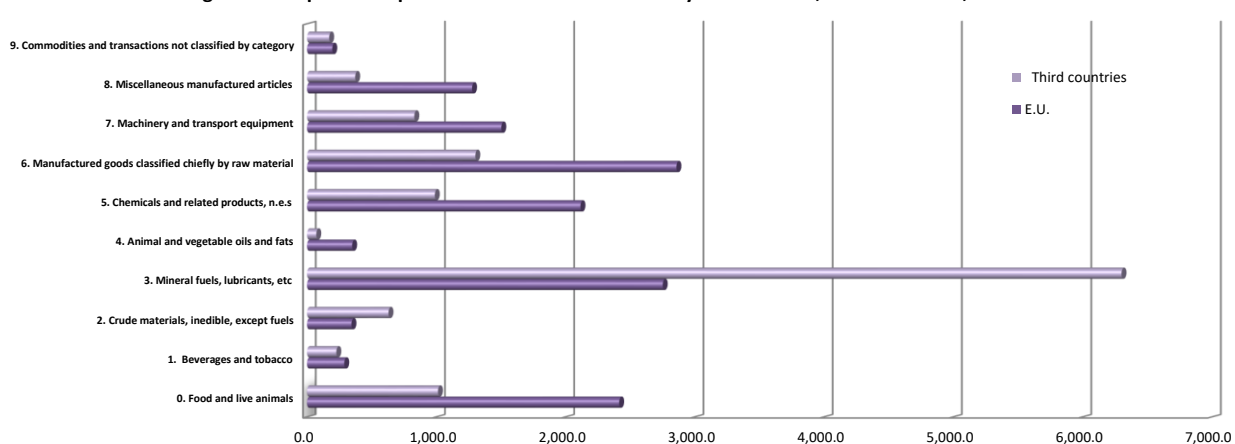
**Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, June 2022**

**Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - Jun. 2022, million €**



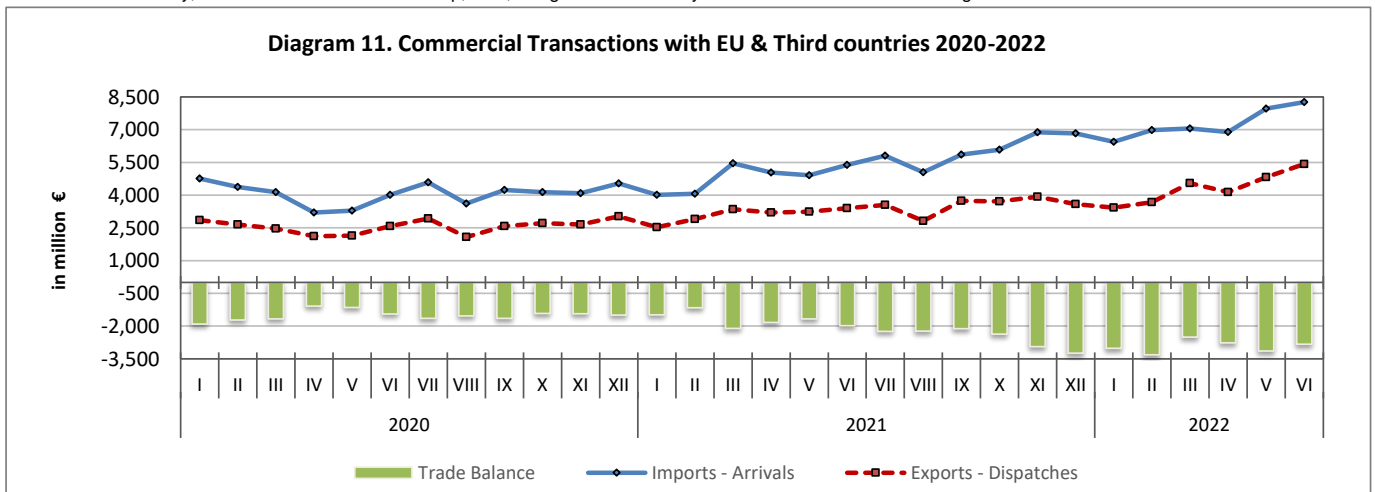

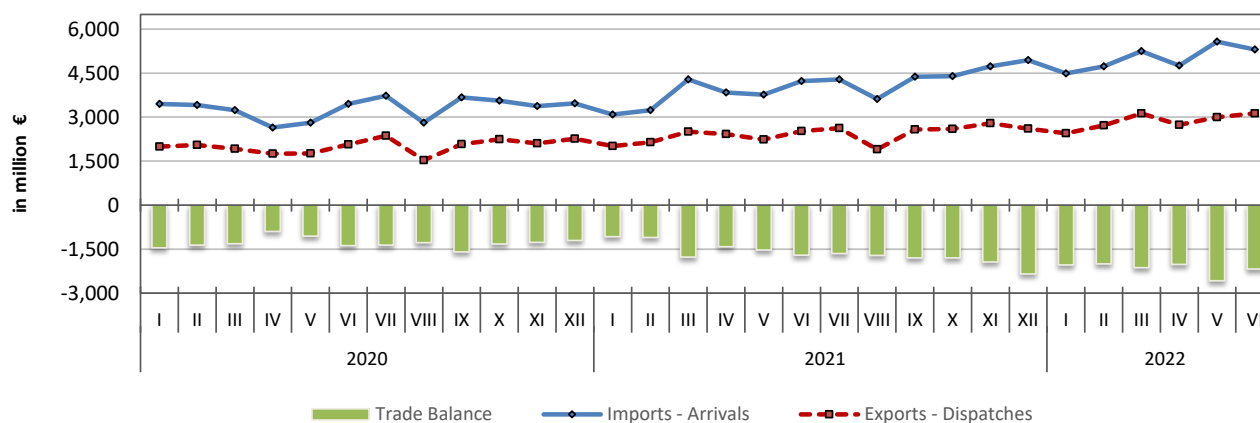

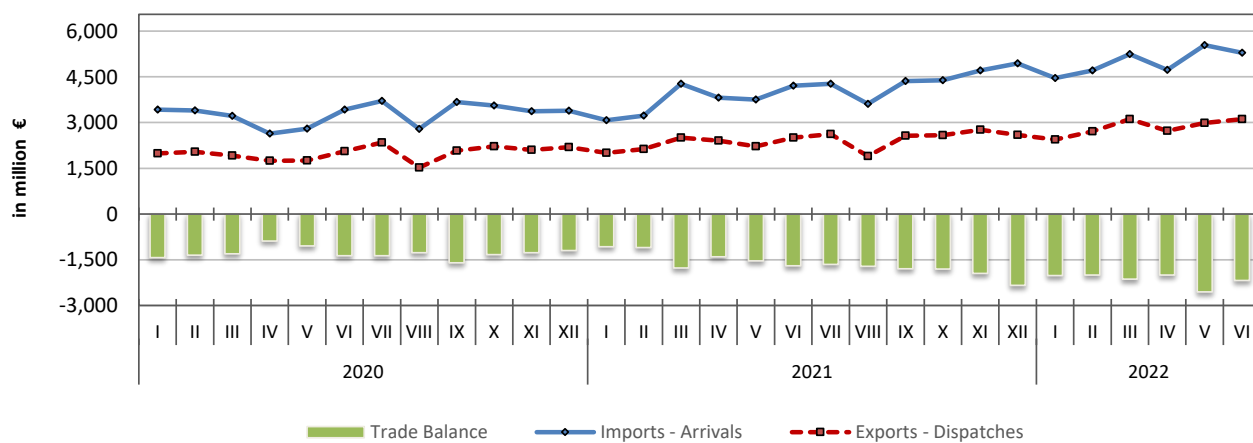

## EXPLANATORY NOTES

<b>Commercial Transactions of Greece</b>	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports/arrivals, exports/dispatches and their changes. This recording does not include the imports and exports of services; however the imports and exports of services together with the corresponding commercial transactions are taken into account for the compilation of National Accounts tables.
<b>Legal Framework</b>	The survey is conducted for intra-EU trade (Intrastat) and for trade with third countries (Extrastat) in accordance with Regulation (EU) 2152/2019 and (EU) 1197/2020.
<b>Reference Period</b>	<b>June 2022</b>
<b>Provision of Results</b>	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
<b>Definitions</b>	<p><b>INTRASTAT</b> is the system for collecting Intra EU statistical data (among the EU countries). It was implemented on January 1st, 1993.</p> <p><b>Arrival</b> is considered every import of goods from a country of the EU.</p> <p><b>Dispatch</b> is considered every export of goods to a country of the EU.</p> <p><b>EXTRASTAT</b> is the system for collecting external trade data with third countries (countries outside the EU).</p> <p><b>Import</b> is considered every import of goods from a third country (outside the EU).</p> <p><b>Export</b> is considered every export of goods to a third country (outside the EU).</p>
<b>Methodology</b>	<p><b>INTRASTAT:</b> It is an exhaustive statistical survey. The parties responsible for providing statistical information through Intrastat System are the enterprises which perform intra EU trade transactions and they have exceeded the applied statistical thresholds. The statistical thresholds are readjusted each year. The statistical thresholds for 2022 are the following:</p> <ul style="list-style-type: none"><li>• Arrivals: € 150,000.00 (95.0% coverage)</li><li>• Dispatches: € 90,000.00 (98.0% coverage)</li></ul> <p>The statistical data of Intra EU-Trade include also the transactions of the enterprises, which are not obliged to submit Intrastat data since the value of their transactions is below the applied statistical threshold. In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Ministry of Finance.</p> <p><b>ELECTRONIC SUBMISSION:</b> Intrastat declarations are submitted electronically via the following links: <a href="http://eurostat.statistics.gr">http://eurostat.statistics.gr</a> or <a href="http://www.statistics.gr">www.statistics.gr</a>.</p> <p><b>EXTRASTAT:</b> It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1,000 euros are registered. In the beginning of each month Customs Authorities transmit to the Hellenic Statistical Authority an electronic file with the customs data of statistical relevance of the previous month.</p> <p>The statistical data of imports and exports of goods with the Third Countries, are derived from the data transmitted by the Customs Authorities.</p> <p>Henceforth, the provisional data from the "incomplete customs declarations" - which concern mainly petroleum products - are incorporated in the monthly data on trade with third countries; the "incomplete customs declarations" data after having been completed will be replaced by the final data.</p> <p><b>IMPORTS AND EXPORTS OF SHIPS AND AIRCRAFTS:</b> In accordance with EU Regulations entered into force in 2010 (Regulations (EU) 96/2010, 113/2010) and in accordance with Regulations (EU) 2152/2019 and (EU) 1197/2020 entered into force in 2022, the EU Member States are obliged to record the transactions of special goods and movements and more specifically of vessels and aircrafts in line with the principle of economic ownership.</p> <p>"Economic ownership" means the right of a taxable person to claim the benefits associated with the use of a vessel or aircraft in the course of an economic activity by virtue of accepting the associated risks.</p> <p>For the compilation of statistics on imports/arrivals and exports/dispatches of ships are used Intrastat data, data from administrative sources (Customs, Ministry of Marine and Island Policy), as well as data from national and international commercial databases based on the estimation model of the Bank of Greece for the Greek shipping (see Press Release on Balance of Payments published by the Bank of Greece on 20.11.2018).</p> <p>The compilation of statistics on imports/arrivals and exports/dispatches of aircrafts is based on Intrastat data and data from administrative sources (Customs, Hellenic Civil Aviation Authority).</p> <p><b>Classification of goods:</b> The goods are classified in compliance with the 8-digit Combined Nomenclature Code (CN/8) and the Standard International Trade Classification (SITC).</p>

## EXPLANATORY NOTES

**International Trade in Goods data of the United Kingdom** Under the withdrawal agreement endorsed by the European Parliament on 29 January 2020, the United Kingdom from 1st January 2021 is not part of the European Union's customs and tax territory and trade flows between the United Kingdom and the EU are considered transactions with a Third Country. The imports and exports of the bilateral trade with the United Kingdom are included in the corresponding trade figures with the Third Countries, given that the United Kingdom is now considered a non-EU country.
