## EVOLUTION OF TURNOVER OF ENTERPRISES MAY 2025

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **May 2025**.

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in May 2025 amounted to 33,020,528 thousand euro, recording an increase of 5.4% in comparison with May 2024, when the respective turnover was 31,336,365 thousand euro (Graph 1, Table 1).

The biggest increase in turnover in May 2025 compared with May 2024 was recorded from the enterprises of the section Mining and Quarrying, per 46.0%, while the biggest decrease was recorded from the enterprises of the section Other Service Activities, per 1.7% (Table 1).

	<ul> <li>The final Statistical Business Register of ELSTAT, of the reference year 2022.</li> <li>Administrative transactions files (tax, etc) of the reference years 2019 to 2025.</li> </ul>	
	In particular, the following primary data have been used per source:	
	- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2022.	
	- Income data from administrative transactions files of the reference years 2019 to 2025.	
Statistical classifications	For the economic activities, the European statistical classification of economic activities <u>NACE Rev. 2</u> is used.	
Reference Period	May 2025.	
Statistical unit	The statistical unit is the legal unit (distinct TIN).	
Comparability	The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2022 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u> ).
