Year 2024: 2.1%

(2nd estimate in volume terms)

& revision of years 2022-2023

The Hellenic Statistical Authority (ELSTAT) announces the 2nd estimate of the Annual National Accounts for the year 2024 (provisional data) and the revised data for the years 2022-2023 according to the European System of National and Regional Accounts ESA 2010 (Regulation (EU) No 549/2013 of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union - ESA 2010), as amended by Regulation (EU) 2023/734 of the European Parliament and of the Council.

According to the revised data the Gross Domestic Product (GDP) of the year 2024 in volume terms increased by 2.1% in comparison with the year 2023, against an increase of 2.3% that was announced for the first estimate in March 2025.

The revision of GDP for the year 2024 compared to the first estimate announced in March 2025, which was the sum of the four quarters of the year, is mainly due to the incorporation of the Household Budget Survey 2024 data, and the update of General Government data on public final consumption, subsidies and taxes on products. It is also noted that the data for the year 2022 were revised, mainly due to the incorporation of the Structural Business Statistics (SBS) results. This provides a more accurate allocation of components within the supply and use tables, as well as a re-balancing of the system. The figures published in October 2024 were estimates, based on the relevant economic indicators and the preliminary supply and use tables. Accordingly, the components for the years 2023 and 2024 were also revised.

More analytically, the revision of the Annual National Accounts data was based on the utilization of new and incorporation of updated information, from various sources, such as:


- Incorporation of the results of the Structural Business Surveys for the year 2022.
- Updated estimates for the final consumption expenditure of households based on the results of the Household Budget Survey (HBS) for the years 2022 and 2023 and incorporation of updated data for year 2024.
- Integration of the Statistical Business Register of ELSTAT for the year 2022.
- Incorporation of updated International Trade in Goods data for years 2023-2024.
- Updated Balance of Payments (BoP) data of Bank of Greece (BoG), for years 2023-2024.
- Integration of General Government updated data for years 2022-2024.
- Integration of updated data for Non-Profit Institutions Serving Households (NPISHs) using administrative tax data, for years 2022-2024.
- Updated data for Agriculture, Forestry and Fishing industries for years 2022-2024.
- Incorporation of updated Short-Term Indicators for years 2023-2024.
- Integration of updated employment data for years 2022-2024.

The final consumption expenditure of the year 2024 in volume terms increased by 1.3% in comparison with the year 2023. The imports of goods and services of the year 2024 in volume terms increased by 4.8% in comparison with the year 2023. The exports of goods and services of the year 2024 in volume terms increased by 1.0% in comparison with the year 2023.

According to the revised data the Gross Domestic Product (GDP) of the year 2024 at current prices increased by 5.4% in comparison with the year 2023.

The final consumption expenditure of the year 2024 at current prices increased by 3.7% in comparison with the year 2023. The imports of goods and services of the year 2024 at current prices increased by 3.3% in comparison with the year 2023. The exports of goods and services of the year 2024 at current prices increased by 1.2% in comparison with the year 2023.
