




EVOLUTION OF TURNOVER OF ENTERPRISES MARCH, 1st QUARTER 2025

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **March and 1**st **quarter 2025**.

Concerning the enterprises and the activities of the economy as a whole, the turnover in the first quarter 2025 amounted to 105,579,832 thousand euro, recording an increase of 2.4% in comparison with the first quarter 2024, when the respective turnover was 103,124,658 thousand euro (Graph 1, Table 1).

The biggest increase in turnover in the first quarter 2025 compared with the first quarter 2024 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 28.2%, while the biggest decrease in turnover was recorded from the enterprises of the section Public Administration and Defense; Compulsory Social Security, per 5.7% (Table 1).

Tel.: +30 213 135 2022, 2308, 2310 E-mail: data.dissem@statistics.gr For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in March 2025 amounted to 30,438,155 thousand euro, recording an increase of 2.4% in comparison with March 2024, when the respective turnover was 29,720,024 thousand euro. The biggest increase in turnover in March 2025 compared with March 2024 was recorded from the enterprises of the section Mining and Quarrying, per 38.5%, while the biggest decrease was recorded from the enterprises of the section Public Administration and Defense; Compulsory Social Security, per 13.5% (Table 2).

Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis, while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises, data are available only on a quarterly basis.

^{**} Extraordinary transactions were recorded in the data. Therefore, they are not published as they are not comparable.



METHODOLOGICAL NOTES

Generally

The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2022.
- Administrative transactions files (tax, etc) of the reference years 2019 to 2025.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2022.
- Income data from administrative transactions files of the reference years 2019 to 2025.

Statistical classifications

For the economic activities, the European statistical classification of economic activities NACE Rev. 2 is used.

Reference Period

March and 1st quarter 2025.

Statistical unit

The statistical unit is the legal unit (distinct TIN).

Comparability

The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2022 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
