## **PRESS RELEASE**

### **Price Indices of Work Categories and Construction Costs Indices of New Residential Buildings<sup>1,2,3,4</sup> (2005=100.0)**

**2<sup>nd</sup> Quarter 2009**

The Construction Price Indices aim at providing information on the development of prices of work categories (producer prices) and of overall costs (material and labour costs) in the construction industry of New Residential Buildings.

#### **Price Index of work categories (PPI in construction)**

The Price Index of Work Categories (PPI) in the 2<sup>nd</sup> quarter of 2009 as compared to the 2<sup>nd</sup> quarter of 2008, recorded a fall of 0.3%. A year earlier the index was increased by 4.4%.

That index in the 2<sup>nd</sup> quarter of 2009, as compared to the 1<sup>st</sup> quarter of 2009 remained unchanged. A year earlier, the index was increased by 1.5%.

<sup>1</sup> The Work Categories Price Indices and the Construction Costs Indices, in the construction industry of new residential buildings, are published quarterly.

<sup>2</sup> The Price Index of Work Categories expresses the price change paid to the contractors or subcontractors of the various departments in the construction process of new residential buildings.

<sup>3</sup> The Construction Costs Index shows the development of costs incurred by the contractor or subcontractor to carry out the construction process for residential buildings, as a construction input price index.

<sup>4</sup> The above indices were compiled and released for the first time, in 1981 based in 1980. Afterwards, the indices were revised based in 1990,2000 and lately in 2005. With the latest revision, the Price Indices of Work Categories and Construction Costs Indices, comply to the requirements of the Council Regulation (EC) 1165/98 "on short term statistics", and of the Commission Regulation (EC) 588/2001 as regards "the definition of variables".

## **Construction Cost Index**

The Construction Cost Index in the 2<sup>nd</sup> quarter of 2009 as compared to the 2<sup>nd</sup> quarter of 2008 pointed a fall of 0.6%. A year earlier the index was increased by 5.2%.

That index in the 2<sup>nd</sup> quarter of 2009, as compared to the 1<sup>st</sup> quarter of 2009 remained unchanged. A year earlier, the index was increased by 2.5%.

The Construction Cost Index from the 1<sup>st</sup> quarter of 2009 to the 2<sup>nd</sup> quarter of 2009, remained unchanged due to the steadiness of the component costs indices, as following:

- The Material Cost Index remained unchanged.
- The Labour Cost Index remained unchanged.

It is noted that the Material Costs Index is released monthly by a separate Press Release.
