COMMERCIAL TRANSACTIONS OF GREECE : April 2016

(Provisional Data)

The total value of imports-arrivals, in April 2016 amounted to 4162,4 million euros (4705,9 million dollars) in comparison with 3887,3 million euros (4177,7 million dollars) in April 2015, recording an increase, in euros, of **7,1%**. The corresponding change excluding oil products recorded an increase of 738,7 million euros or 26,5% (Table 1)⁽¹⁾.

The total value of exports-dispatches, in April 2016 amounted to 2104,8 million euros (2393,8 million dollars) in comparison with 2187,2 million euros (2364,8 million dollars) in April 2015, recording a drop, in euros, of **3,8%**. The corresponding change excluding oil products recorded an increase of 34,3 million euros or 2,2% (Table 1).

The deficit of the trade balance, in April 2016 amounted to 2057,6 million euros (2312,1 million dollars) in comparison with 1700,1 million euros (1812,9 million dollars) in April 2015, recording an increase, in euros, of **21,0%**. The corresponding change excluding oil products recorded an increase of 704,4 million euros or 57,7% (Table 1).

The total value of imports-arrivals, for the 4-month period from January to April 2016 amounted to 14348,3 million euros (15905,6 million dollars) in comparison with 14898,4 million euros (16499,2 million dollars) for the corresponding period of the year 2015 recording a drop, in euros, of **3,7%**. The corresponding change excluding oil products recorded an increase of 1048,9 million euros or 9,6% (Table 5).

The total value of exports-dispatches, for the 4-month period from January to April 2016 amounted to 7831,1 million euros (8726,2 million dollars) in comparison with 8469,5 million euros (9446,3 million dollars) for the corresponding period of the year 2015, recording a drop, in euros, of **7,5%**. The corresponding change excluding oil products recorded an increase of 32,2 million euros or 0,5% (Table 5).

The deficit of the Trade Balance, for the 4-month period from January to April 2016 amounted to 6517,2 million euros (7179,4 million dollars) in comparison with 6428,9 million euros (7052,9 million dollars) for the corresponding period of the year 2015, recording an increase, in euros, of **1,4%**. The corresponding change excluding oil products recorded an increase of 1016,7 million euros or 20,8% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, (including the transactions below the statistical threshold⁽²⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises in the Ministry of Finance. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ The relatively significant increase in imports of third countries recorded in table 3 reflects at a great extent imports of ships from third countries

⁽²⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

USD million**



USD million







USD million**



USD million**



Transactions referring to services are not included, while they are taken into account for the compilation of the National Accounts tables, along with the commercial transactions.
