4.1 Data description

Manufacturing statistics is part of the Structural Business Statistics (SBS) and cover Annex II of these statistics. More specifically, the Industrial Survey is conducted since 1958 on a yearly basis.

The survey results are used both at national and international level for monitoring the activity of the enterprises in the sector of manufacturing and for identifying the contribution of this sector to the national income.

The purpose of the survey is to collect data on the main economic figures of manufacturing enterprises. The collected data refer to the enterprise as a whole.

Information on the basic variables of the survey can be found in section 4.4 and the legal framework of the survey is analysed in section 7.1

4.2 Classification system

The results of the survey are broken down according to the following classifications:

1. 4-digit level of economic activity of Nace Rev.2.
2. 2-digit level of regional breakdown of NUTS.

4.3 Sector coverage

The survey covers the economic activities 10-39, at 2 digit level of Nace rev2. The Nace codes are listed below:

8. Confidentiality

8.1 Confidentiality policy

The issues concerning the observance of statistical confidentiality by the Hellenic Statistical Authority (ELSTAT) are arranged by articles 7, 8 and 9 of the Law 3832/2010 as in force, by Articles 8, 10 and 11(2) of the Regulation on Statistical Obligations of the agencies of the Hellenic Statistical System and by Articles 10 and 15 of the Regulation on the Operation and Administration of ELSTAT.

More precisely:

ELSTAT disseminates the statistics in compliance with the statistical principles of the European Statistics Code of Practice and in particular with the principle of statistical confidentiality.

8.2 Confidentiality – data treatment

- ELSTAT protects and does not disseminate data it has obtained or it has access to, which enable the direct or indirect identification of the statistical units that have provided them by the disclosure of individual information directly received for statistical purposes or indirectly supplied from administrative or other sources. ELSTAT takes all appropriate preventive measures so as to render impossible the identification of individual statistical units by technical or other means that might reasonably be used by a third party. Statistical data that could potentially enable the identification of the statistical unit are disseminated by ELSTAT if and only if:
 - a) these data have been treated, as it is specifically set out in the Regulation on Statistical Obligations of the agencies of the Hellenic Statistical System (ELSS), in such a way that their dissemination does not prejudice statistical confidentiality or
 - b) the statistical unit has given its consent, without any reservations, for the disclosure of data.
- The confidential data that are transmitted by ELSS agencies to ELSTAT are used exclusively for statistical purposes and the only persons who have the right to have access to these data are the personnel engaged in this task and appointed by an act of the President of ELSTAT.
- ELSTAT may grant researchers conducting statistical analyses for scientific purposes access to data that enable the indirect identification of the statistical units concerned. The access is granted provided the following conditions are satisfied:
 - a) an appropriate request together with a detailed research proposal in conformity with current

scientific standards have been submitted;

b) the research proposal indicates in sufficient detail the set of data to be accessed, the methods of analyzing them, and the time needed for the research;

c) a contract specifying the conditions for access, the obligations of the researchers, the measures for respecting the confidentiality of statistical data and the sanctions in case of breach of these obligations has been signed by the individual researcher, by his/her institution, or by the organization commissioning the research, as the case may be, and by ELSTAT.

- Issues referring to the observance of statistical confidentiality are examined by the Statistical Confidentiality Committee (SCC) operating in ELSTAT. The responsibilities of this Committee are to make recommendations to the President of ELSTAT on:
 - the level of detail at which statistical data can be disseminated, so as the identification, either directly or indirectly, of the surveyed statistical unit is not possible;
 - the anonymization criteria for the microdata provided to users;
 - the granting to researchers access to confidential data for scientific purposes.
- The staff of ELSTAT, under any employment status, as well as the temporary survey workers who are employed for the collection of statistical data in statistical surveys conducted by ELSTAT, who acquire access by any means to confidential data, are bound by the principle of confidentiality and must use these data exclusively for the statistical purposes of ELSTAT. After the termination of their term of office, they are not allowed to use these data for any purpose.
- Violation of data confidentiality and/or statistical confidentiality by any civil servant or employee of ELSTAT constitutes the disciplinary offence of violation of duty and may be punished with the penalty of final dismissal.

ELSTAT, by its decision, may impose a penalty amounting from ten thousand (10,000) up to two hundred thousand (200,000) euro to anyone who violates the confidentiality of data and/or statistical confidentiality. The penalty is always imposed after the hearing of the defense of the person liable for the breach, depending on the gravity and the repercussions of the violation. Any relapse constitutes an aggravating factor for the assessment of the administrative sanction.

As regards the annual industrial survey, the data quality is ensured through all the stages of the compilation of statistics by means of the following steps:

1. Training of the statistical interviewers
2. Adjustment of the questionnaire, where possible, to the National General Accounting Framework, aiming at facilitating the enterprise to fill in the questionnaire.
3. Analytical and thorough checks of every questionnaire as regards the attached documentation
4. Cross-checks of variables in relation with the previous year on the basis of primary data
5. Implementation of all the correction rules and relevant standards which are laid down by Eurostat.

13.2 Quality assessment

Additional checks are carried out before the finalisation of data, such as consistency checks and comparisons with other surveys, etc.

Upon reception of the survey results of all Member States, Eurostat carries out the final quality checks and grants its approval for the publication of the data.

15. Accuracy and reliability

15.1 Overall accuracy

The survey is conducted exhaustively on all the enterprises employing 10 persons and over. In case of non-response, the relevant data are imputed. The imputations are very precise due to the big number of enterprises.

The data on the basic variables of the enterprises employing less than 10 employees are imputed on the basis of the relevant data of the corresponding variables of manufacturing enterprises employing 10-19 employees deriving from the Business Register of ELSTAT.

15.2 Sampling error

15.3 Non-sampling error

15.3.1 Coverage error

A coverage error occurs when specific members of the target population cannot be included in the sample. Coverage error results from gaps between the sampling frame and the total population.

15.3.1.1 Over-coverage – rate

1. In case the turnover coming from the secondary activity of the enterprise (usually more than 30%) is bigger than that of the manufacturing activity, the Register is updated with this change.
2. In case the number of employees is getting smaller in the course of time and the enterprise has less than 10 employees, this specific enterprise is put out of the “population” of the survey.

15.3.1.2 Common units – proportion

Not applicable; the survey is a census survey.

15.3.2 Measurement error

This kind of errors is eliminated by giving clear guidelines for the completion of the questionnaire.

In case of incomplete filling in of questionnaires, the responsible of the enterprises (accountant) is contacted in order to get more clarifications on the questionnaire.

15.3.3 Non response error

In case of non-response, the following steps are made:

- A letter is sent to the enterprise that has not responded
- The competent employee of the Accounting section of the enterprises is contacted over the telephone, more than once.

15.3.4 Processing error

Quantitative checks are carried out on the data base, in order to correct any mistakes during data entry. No other processing errors are identified because logical checks and cross-checks with administrative data (tax returns transmitted by the enterprises) are carried out.

15.3.5 Model assumption error

The data of the enterprises employing less than 10 persons are imputed. Any error that may occur from this estimation is the fact that not all the sectors are represented at 4-digit and 3-digit level of Nace Rev.2.

21.2 Frequency of data collection

The frequency of data collection is annual.

21.3 Data collection

At a first stage, the survey questionnaire is sent by post to the enterprise, accompanied by a letter describing the survey process and urging the respondents to cooperate.

15-20% of the enterprises respond to the questionnaire.

At a second stage, statistical interviewers are appointed in order to contact with the enterprises aiming at collecting the questionnaires.

The employees of the competent Section of ELSTAT contact with the “big” enterprises or with those who deny cooperating with the statistical interviewers, in order to collect the questionnaire.

21.4 Data validation

The primary data are checked in terms of quality by means of comparisons with tax documents.

Subsequently, thorough checks are carried out on all the material:

1. Logical checks among the variables, per questionnaire
2. Cross-checks on the data of the same enterprise as regards the corresponding data of previous years
3. Checks per variable for identifying any deviations from the data of the previous year
4. Use of an edit tool provided by Eurostat for identifying any warnings

The tables are compiled in accordance with EU Regulations 250/2009 and 251/2009 which lay down the description and the sets of variables to be collected by Member States for meeting the needs of Eurostat.
