



PRESS RELEASE

SURVEY ON CULTURAL ACTIVITIES, 2015

The Hellenic Statistical Authority (ELSTAT) announces, for the first time, a press release presenting the data of the Survey on Cultural Activities for the period 2005-2015.

Five (5) concise tables and the relevant graphs are presented below, illustrating some of the data collected by the survey during the last decade. All the findings of the survey are presented more analytically in the tables which are posted on the portal of ELSTAT.

On the basis of the available data deriving from the latest survey conducted in 2015, it is observed that:

- 19 properties of archaeological interest were expropriated by the Directorate of Expropriations and Property of the Ministry of Culture and Sports and the relevant compensation paid amounted to 2.070.622 euro, recording an increase in comparison with 2014 (Table 1, Graph 1).
- The receipts of the Archaeological Receipts Fund, in 2015, amounted to 4.783.193 euro, recording an increase in comparison with the corresponding receipts in 2014 (Table 2, Graph 2).
- The subsidies granted to cultural entities, such as museums, art galleries, theatre, film and classical dance associations, municipal and regional theatres, etc. fell to 27.723.841 euro in 2015, thus recording a decrease in comparison with the subsidies given in 2014 (Table 3, Graph 3).
- In 2015, the teaching personnel of vocational theatre, dance, film and music schools and conservatoires amounted to 7.276 persons, the number of students to 51.777 and the number of graduates, obtaining a diploma or relevant degree, to 2.039. In comparison with the corresponding data in 2014, a decrease is observed as regards the teaching personnel and the number of students, while an increase is recorded in the number of graduates (Table 4, Graph 4).
- In 2015, the Ministry of Culture and Sports supported the organisation of 19 pan-hellenic and local conferences and 3 international conferences, recording an increase in comparison with the conferences supported in 2014 (Table 5, Graph 5).

Graph 1. Expropriated Properties of Archeological Interest and Compensation Paid (2005-2015)




Graph 2. Receipts¹ of the Archaeological Receipts Fund (2005-2015)





Graph 3. Subsidies granted to cultural entities (2005-2015)





Graph 4. Teaching personnel, Students and Graduates of vocational theatre, dance, film and music schools and conservatoires (2005- 2015)



EXPLANATORY NOTES

Survey on Cultural Activities The Survey on Cultural Activities is an annual census survey, presenting the activities of several units of the Ministry of Culture and Sports, such as the Directorate of Expropriations and Property, the Directorate of Letters, the Archaeological Receipts Fund, the Directorate of Theatre and Dance and the Directorate of Music and Visual Arts. The survey is conducted since 1970.

Legal framework The survey is conducted by virtue of the Law 3832/2010, as amended and in force.

Periodicity Annual

Methodology It is a census survey, carried out on a yearly basis. The data are collected from the Directorate of Expropriations and Property, the Directorate of Letters, the Archaeological Receipts Fund, the Directorate of Theatre and Dance and the Directorate of Music and Visual Arts.

The most important activities recorded by the survey are as follows: the expropriations of property of archaeological interest and the relevant compensation paid, the receipts of the Archaeological Receipts Fund, the subsidies given to cultural entities, the number of teaching personnel, students and graduates of the vocational theatre and dance schools, vocational film and music schools and conservatoires, as well as the conferences supported by the Ministry (pan-hellenic, local and international conferences), given the fact that the Ministry of Culture and Sports supports the organisation of national and international conferences on Culture, Arts and Science.
