**PRESS RELEASE**

The Hellenic Statistical Authority (ELSTAT) publishes on its website **the statistical Register of General Government Entities** according to **ESA 2010** with reference months **September 2017** and **December 2017** and also the statistical **Register of General Government Entities** according to **ESA 2010** with reference months **March 2018, June 2018 and September 2018**.

The compilation and regular updating of the statistical Register of General Government Entities constitutes an obligation of all Member States of the European Union for the proper delineation of the institutional sector of General Government, **as specified by the European System of Accounts – ESA** on the basis of specific criteria. The new Regulation ESA 2010 (**EU Regulation 549/2013**) entered into force on 1 September 2014.

**The statistical Register of General Government Entities is compiled and used by ELSTAT exclusively for statistical purposes**, namely to conduct the annual and quarterly surveys of General Government Entities, which are necessary for the compilation of quarterly and annual government finance statistics by ELSTAT, as well as, the compilation of statistical tables for the purposes of Excessive Deficit Procedure (EDP) .

The responsibility for the proper maintenance of the statistical Register of General Government Entities lies with ELSTAT. It is noted that this Register is not a register of all the entities that are supervised and controlled by the government, nor is it the register of all entities funded by the public sector through the regular State Budget or the Public Investment Programme.

The maintenance of the statistical Register of General Government Entities is an ongoing task. In this context, ELSTAT continues to examine on a regular basis the classification of entities supervised by the General Government, taking into account the changes made under the administrative reform and the new or updated economic data of these entities, according to the rules of ESA2010. As a result, there is inclusion of new entities that according to ESA2010 classification criteria are classified within General Government, as well as deletion of entities that are either abolished, or are incorporated into other entities, or alternatively cease to fulfil the criteria for being classified within the General Government sector.

As regards the sub-sector of Local Government – S.1313, the works for the classification of the agencies (Legal Entities of Private Law) have not yet been completed for the total of the agencies, the completion of the classification requires the submission, by the relevant agencies, of their financial data to the database of the Ministry of Interior, as provided from the Ministerial Decision, No 2816/30.01.2018(B'350) that replaces the Ministerial Decisions No 74712 and 74713/29-12-2010(B'2043).
