COMMERCIAL TRANSACTIONS OF GREECE : February 2024

(Provisional Data)

The total value of imports, in February 2024 amounted to 6,997.8 million euros (7,531.0 million dollars) in comparison with 6,746.7 million euros (7,207.2 million dollars) in February 2023, recording an increase, in euros, of **3.7%**. The corresponding value excluding oil products in February 2024 recorded an increase of 389.1 million euros or 8.1% and the corresponding value excluding oil products and ships in February 2024 recorded an increase of 407.8 million euros or 8.6%, in comparison with February 2023 (Table 1).

The total value of exports, in February 2024 amounted to 3,963.9 million euros (4,291.8 million dollars) in comparison with 4,482.8 million euros (4,817.6 million dollars) in February 2023, recording a drop, in euros, of **11.6%**. The corresponding value excluding oil products recorded in February 2024 a drop of 54.4 million euros or 1.8% and the corresponding value excluding oil products and ships in February 2024 recorded a drop of 11.2 million euros or 0.4%, in comparison with February 2023 (Table 1).

The deficit of the trade balance, in February 2024 amounted to 3,033.9 million euros (3,239.2 million dollars) in comparison with 2,263.9 million euros (2,389.6 million dollars) in February 2023, recording an increase, in euros, of **34.0%**. The corresponding value of deficit excluding oil products in February 2024 recorded an increase of 443.5 million euros or 24.1% and the corresponding value excluding oil products and ships in February 2024 recorded an increase of 418.9 million euros or 22.7%, in comparison with February 2023 (Table 1).

The total value of imports, for the 2-month period from January to February 2024 amounted to 13,584.3 million euros (14,691.8 million dollars) in comparison with 13,737.7 million euros (14,713.1 million dollars) for the corresponding period of the year 2023, recording a drop, in euros, of **1.1%**. The corresponding value excluding oil products recorded an increase of 234.1 million euros or 2.4% and the corresponding value excluding oil products and ships recorded an increase of 235.6 million euros or 2.5%, in comparison with the period from January to February 2023 (Table 5).

The total value of exports, for the 2-month period from January to February 2024 amounted to 7,970.0 million euros (8,673.3 million dollars) in comparison with 8,996.5 million euros (9,693.1 million dollars) for the corresponding period of the year 2023, recording a drop, in euros, of **11.4%**. The corresponding value excluding oil products recorded a drop of 307.5 million euros or 5.2% and the corresponding value excluding oil products and ships recorded a drop of 259.2 million euros or 4.4%, in comparison with the period from January to February 2023 (Table 5).

The deficit of the trade balance, for the 2-month period from January to February 2024 amounted to 5,614.3 million euros (6,018.5 million dollars) in comparison with 4,741.2 million euros (5,020.0 million dollars) for the corresponding period of the year 2023, recording an increase, in euros, of **18.4%**. The corresponding deficit excluding oil products recorded an increase of 541.6 million euros or 14.6% and the corresponding deficit excluding oil products and ships recorded an increase of 494.8 million euros or 13.3% (Table 5).

The monthly data of Intra-Union transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-Union trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Union transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

Diagram 1. Imports, Exports, February 2022-2024, million €

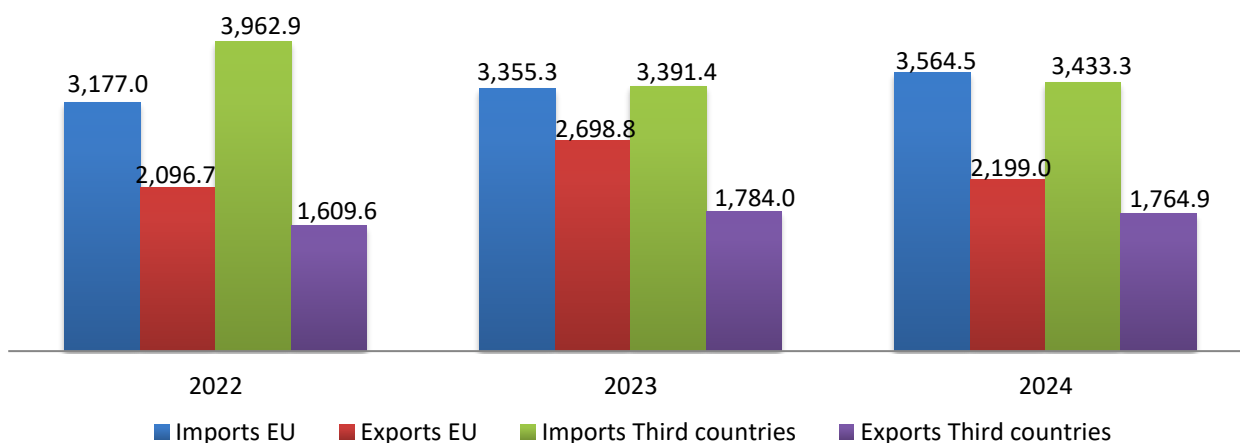

Diagram 2. Imports, Exports excluding oil products, February 2022-2024, million €

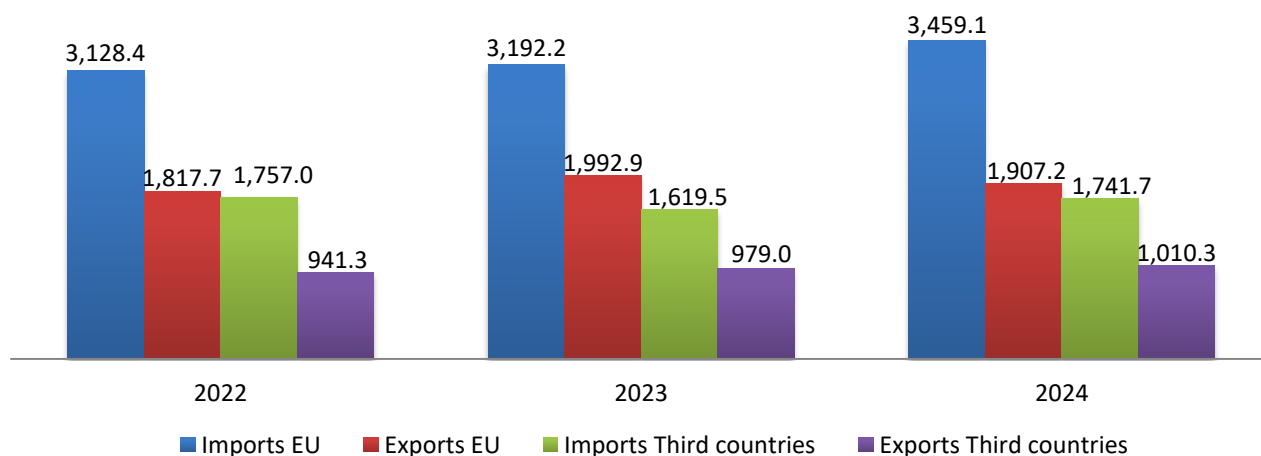

February 2022-2024, million €**

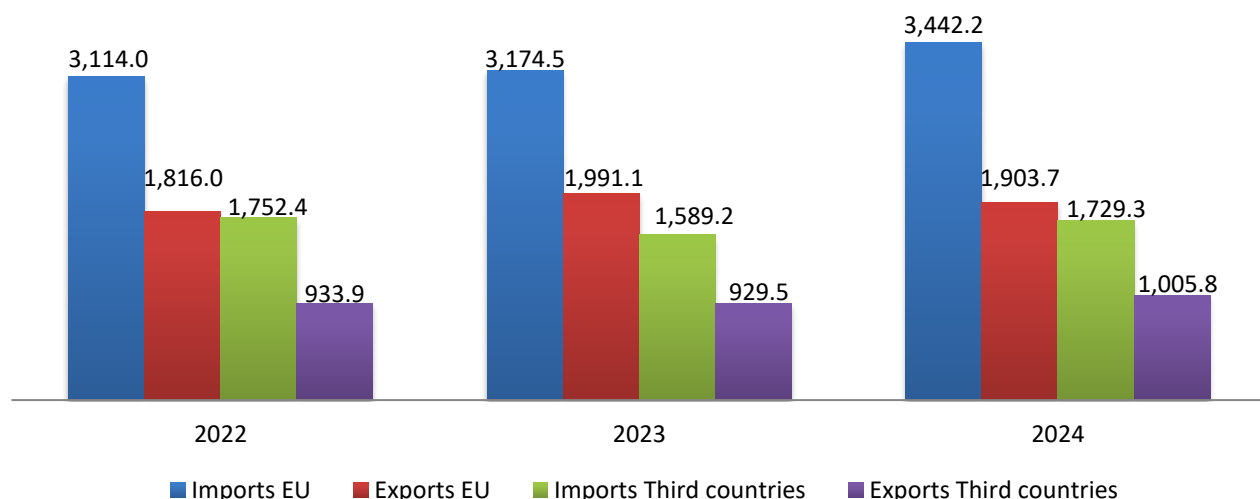

January - February 2022-2024, million €**

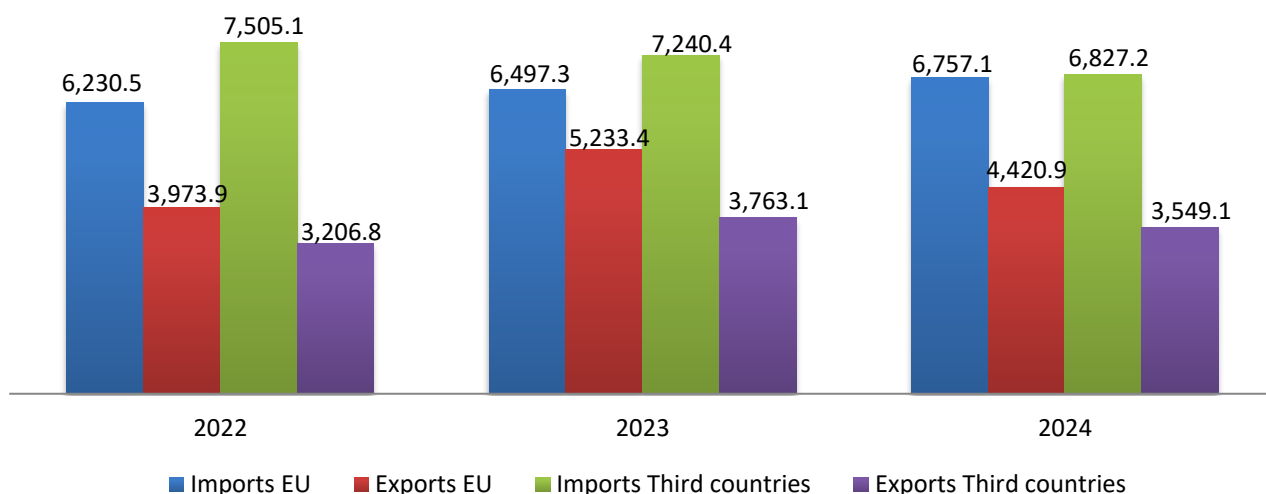

Diagram 5. Imports, Exports, excluding oil products, January - February 2022-2024, million €

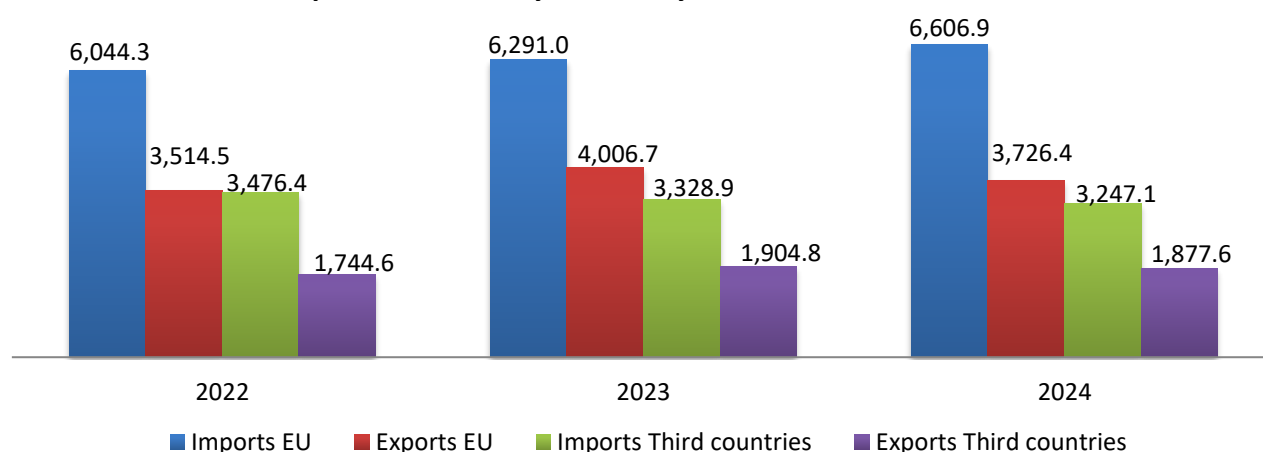

Diagram 6. Imports, Exports, excluding oil products and ships, January - February 2022-2024, million €

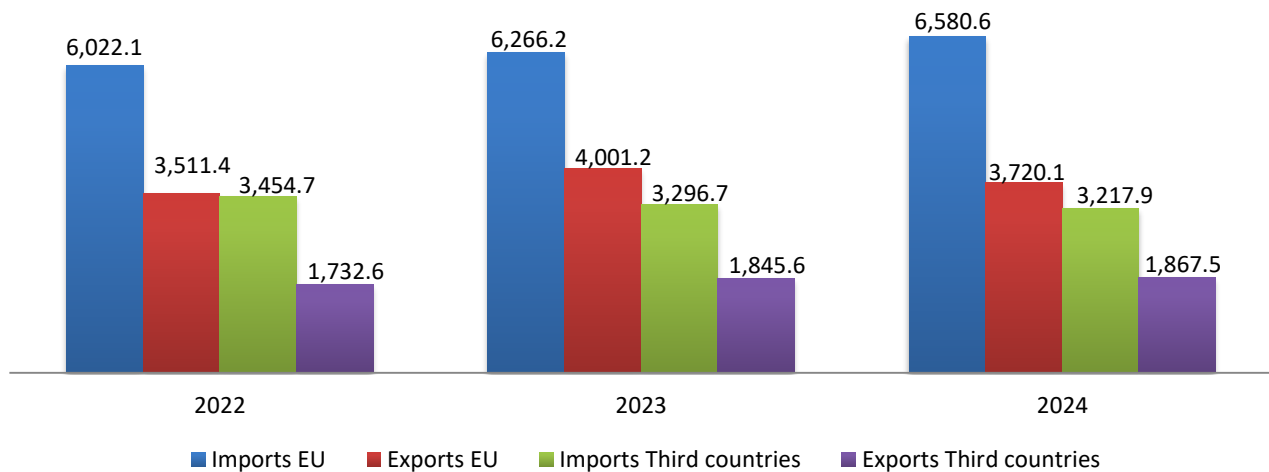

Diagram 7a. Percentage (%) distribution of E.U. imports by SITC sections, February 2024

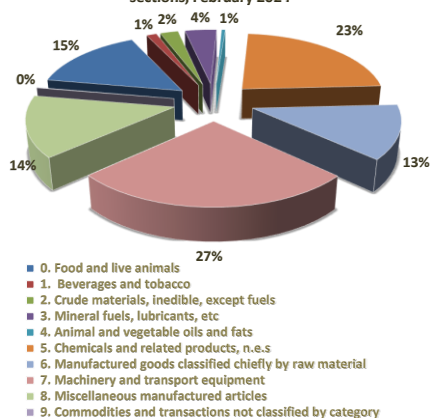


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, February 2024

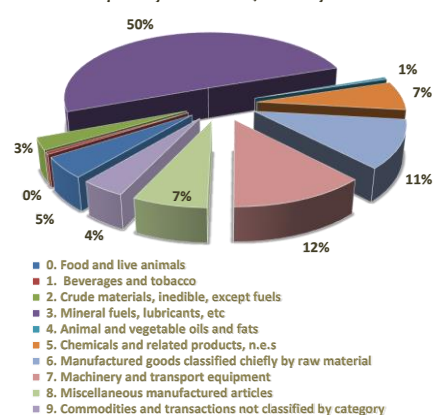


Diagram 8a. Percentage (%) distribution of E.U. exports by SITC sections, February 2024

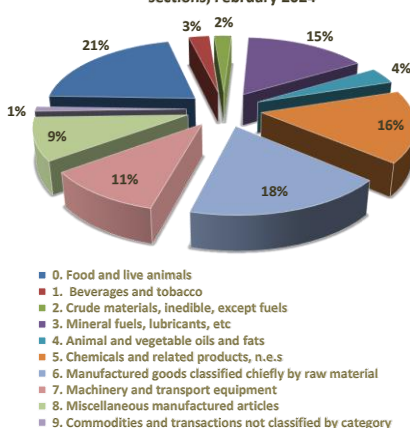


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, February 2024

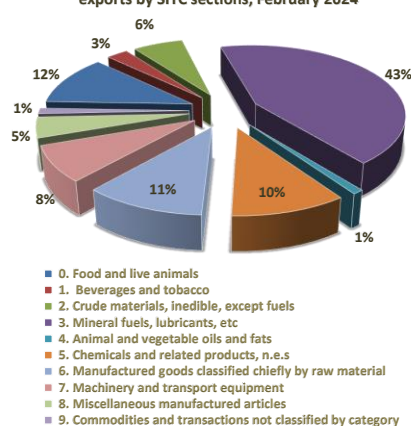


Diagram 9. Imports E.U. & Third countries by SITC sections, Jan. - Feb. 2024, million €

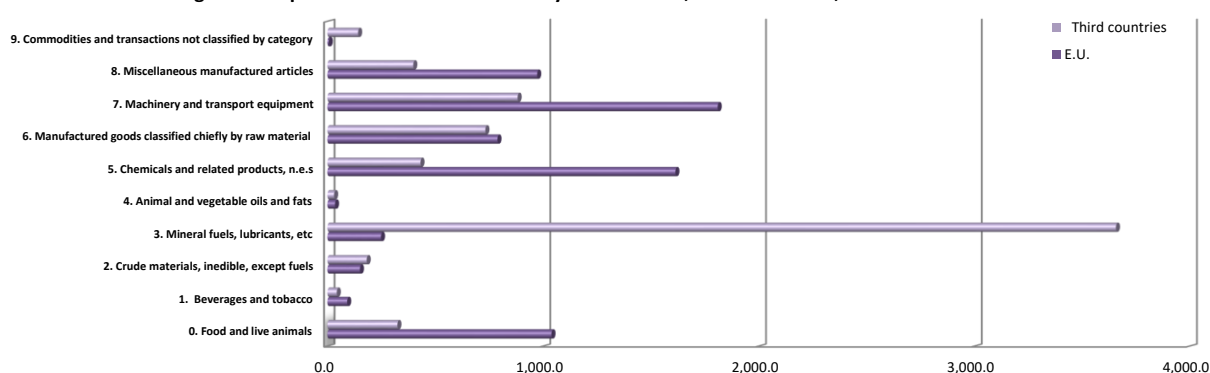


Diagram 10. Exports E.U. & Third countries by SITC sections, Jan. - Feb. 2024, million €

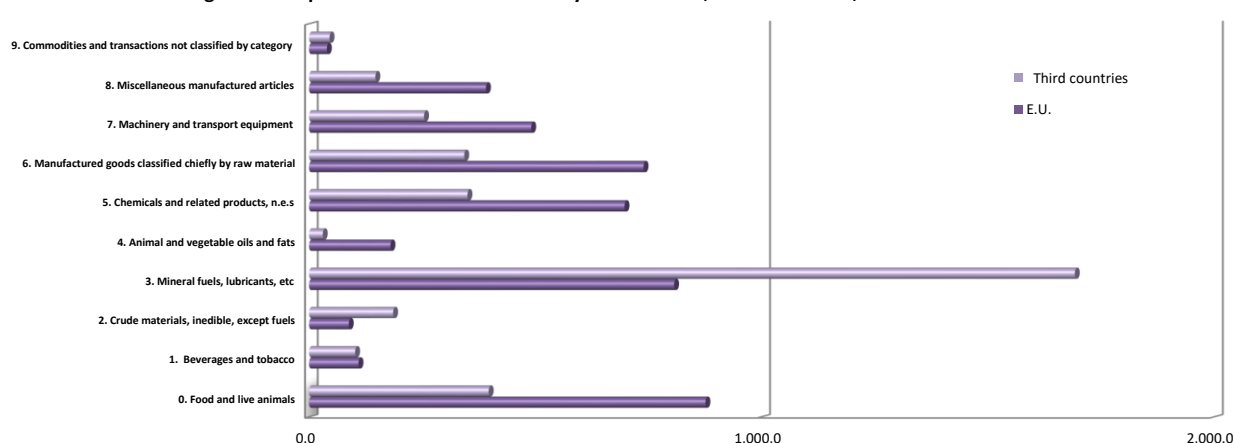

Commercial Transactions of Greece	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports, exports and their changes. This recording does not include the imports and exports of services.
Legal Framework	The survey is conducted for intra-Union trade and for trade with third countries in accordance with Regulation (EU) 2152/2019 and (EU) 1197/2020.
Reference Period	February 2024
Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	<p>INTRASTAT is the system for collecting Intra-Union statistical data (among the EU countries).
