Import Price Index in Industry¹

April 2007

The Import Price Index (MPI) in April 2007 as compared to April 2006 recorded a rise of 0,8%. A year earlier, the annual rate of change of the MPI was 7,4%.

The MPI in April 2007 as compared to March 2007 recorded a rise of 1,2%. A year earlier, the MPI was increased by 0,6%.

In the twelve-month period May 2006 – April 2007 the annual average rate of change of the MPI was 1,9%. A year earlier, the annual average rate of change of the MPI was 8,6%.

¹The Import Price Index (MPI) in Industry is a new price index released from October 2005, as first reference month, based in 2000=100,0. The MPI index is split up to partial indices of Eurozone and non-Eurozone, according to the country of consignment of the imported goods, forming two groups of Eurozone and non-Eurozone markets. The compilation and publication of the new index is based on the framework of requirements of the amendment Regulation (EC) No 1158/05 of the European Parliament and Council, amending Council Regulation (EC) No 1165/98 concerning short-term statistics.

The data series of the MPI starts from 1995, while the distinguished series of Eurozone and non-Eurozone, complying to the above Regulation, starts from January 2004 onwards.

Monthly rates²

Import Prices in total industry in April 2007, as compared to the previous month March 2007,

increased by 1,2% due to the monthly changes of the Main Industrial Groupings prices, as

following:

□ Intermediate goods prices grew by 0,7%.

□ Capital goods prices grew by 0,1%.

□ Durable consumer goods prices grew by 0,1%.

□ Non-Durable consumer goods prices grew by 0,1%.

□ Prices in Energy grew by 4,6%.

Annual rates³

Import Prices in total industry in April 2007, as compared to April 2006, increased by 0,8% due to

the annual changes of the Main Industrial Groupings prices, as following:

□ Intermediate goods prices grew by 8,0%.

□ Capital goods prices grew by 0,8%.

□ Durable consumer goods prices grew by 0,1%.

□ Non-Durable consumer goods prices grew by 1,6%.

□ Prices in Energy fell by 7,6%.
