4. Statistical presentation

4.1 Data description

The purpose of the Surveys on Secondary Education as regards Lower Secondary Schools, General Upper Secondary Schools, Vocational Upper Secondary Schools (EPAL), Vocational Schools (EPAS), Ecclesiastical Lower Secondary Schools and General Ecclesiastical Upper Secondary Schools, which are conducted through the questionnaire Form " Σ E-3", " Σ E-4" and " Σ E-6", is to collect and tabulate data on the number of private and public school units, by day and evening schools, on the teaching and other personnel employed in these units, as well as on the number of pupils by gender, class and year of birth, as well on foreign pupils by gender and citizenship, at the end of the school year.

4.2 Classification system

UNESCO's International Standard Classification of Education (ISCED)

Lower Secondary Schools, Ecclesiastical Lower Secondary Schools: ISCED-level 2

General Upper Secondary Schools, Vocational Upper Secondary Schools (EPAL), Vocational Schools (EPAS), General Ecclesiastical Upper Secondary Schools: ISCED-level 3

4.3 Sector coverage

All the school units of all the Lower Secondary Schools, General Upper Secondary Schools, EPAL, EPAS, Ecclesiastical Lower Secondary Schools and General Ecclesiastical Upper Secondary Schools of Greece.

4.4 Statistical concepts and definitions

Secondary Education encompasses: a) general, b) vocational and c) ecclesiastical education.

General Education includes Lower Secondary Schools and General Upper Secondary Schools.

Enrollment in lower secondary schools is obligatory for all pupils who have completed primary school and attendance lasts for three (3) years. Enrollment does not involve any examinations.

All pupils who have graduated from lower secondary schools can be enrolled in general upper secondary schools without any examinations. Attendance to general upper secondary schools is not obligatory and it lasts three (3) years as regards day schools and four (4) years as regards evening schools.

The Secondary Vocational Education is provided in: the Vocational Upper Secondary Schools (EPAL) and in the Vocational Schools (EPAS) which are supervised by the Ministry of Education and Religious Affairs and in the Vocational Schools (EPAS) which are supervised by the Ministry of Rural Development and Food, by the Ministry of Labour, Social Security and Welfare, by the Ministry of Education and by the Ministry of Tourism.

Attendance in Vocational Upper Secondary Schools (EPAL) lasts for three (3) years as regards day schools and four (4) years as regards evening schools.

Attendance in Vocational Schools (EPAS) lasts for two (2) years, since there are only day schools.

The Secondary Ecclesiastical Education is provided in the Ecclesiastical Lower Secondary Schools and in the General Ecclesiastical Upper Secondary Schools.

4.5 Statistical unit

School units of all the Lower Secondary Schools, General Upper Secondary Schools, EPAL, EPAS, Ecclesiastical Lower Secondary Schools and General Ecclesiastical Upper Secondary Schools.

4.6 Statistical population

The surveys are census surveys and refer to all the school units of Greece.

4.7 Reference area

Greece, total, Region (NUTS 2) and Department (NUTS 3).

4.8 Time coverage

From the school year 1954/1955 to the school year 2012/2013.

4.9 Base period

The Surveys on Secondary Education are governed by Joint Ministerial Decision No 13534/7-5-1962 (Government Gazette 174/18-5-1962, issue B) on the "Statistical work program of the Statistical Service of the Ministry of National Education and Religious Affairs".

At European level, the survey is governed by Commission Regulation (EU) No 88/2011 of 2 February 2011 implementing Regulation (EC) No 452/2008 of the European Parliament and of the Council concerning the production and development of statistics on education and lifelong learning, as regards statistics on education and training systems.

7.2 Data sharing

The survey results are transmitted to Eurostat through the joint UOE questionnaire (UNESCO OECD, Eurostat) and Eurostat, in its turn, transmits the data to UNESCO and OECD.

8. Confidentiality <u>Top</u>

8.1 Confidentiality policy

The issues concerning the observance of statistical confidentiality by the Hellenic Statistical Authority (ELSTAT) are arranged by articles 7, 8 and 9 of the Law 3832/2010 as in force, by Articles 8, 10 and 11(2) of the Regulation on Statistical Obligations of the agencies of the Hellenic Statistical System and by Articles 10 and 15 of the Regulation on the Operation and Administration of ELSTAT.

More precisely:

ELSTAT disseminates the statistics in compliance with the statistical principles of the European Statistics Code of Practice and in particular with the principle of statistical confidentiality.

8.2 Confidentiality - data treatment

- >ELSTAT protects and does not disseminate data it has obtained or it has access to, which enable the direct or indirect identification of the statistical units that have provided them by the disclosure of individual information directly received for statistical purposes or indirectly supplied from administrative or other sources. ELSTAT takes all appropriate preventive measures so as to render impossible the identification of individual statistical units by technical or other means that might reasonably be used by a third party. Statistical data that could potentially enable the identification of the statistical unit are disseminated by ELSTAT if and only if:
 - a) these data have been treated, as it is specifically set out in the Regulation on Statistical Obligations of the agencies of the Hellenic Statistical System (ELSS), in such a way that their dissemination does not prejudice statistical confidentiality or
 - b) the statistical unit has given its consent, without any reservations, for the disclosure of data.
- The confidential data that are transmitted by ELSS agencies to ELSTAT are used exclusively for statistical purposes and the only persons who have the right to have access to these data are the personnel engaged in this task and appointed by an act of the President of ELSTAT.
- >ELSTAT may grant researchers conducting statistical analyses for scientific purposes access to data that enable the indirect identification of the statistical units concerned. The access is granted provided the following conditions are satisfied:
 - a) an appropriate request together with a detailed research proposal in conformity with current scientific standards have been submitted;
 - b) the research proposal indicates in sufficient detail the set of data to be accessed, the methods of analyzing them, and the time needed for the research;
 - c) a contract specifying the conditions for access, the obligations of the researchers, the measures for respecting the confidentiality of statistical data and the sanctions in case of breach of these obligations has been signed by the individual researcher, by his/her institution, or by the organization commissioning the research, as the case may be, and by ELSTAT.
- Issues referring to the observance of statistical confidentiality are examined by the Statistical Confidentiality Committee (SCC) operating in ELSTAT. The responsibilities of this Committee are to make recommendations to the President of ELSTAT on:
- the level of detail at which statistical data can be disseminated, so as the identification, either directly or indirectly, of the surveyed statistical unit is not possible;
- the anonymization criteria for the microdata provided to users;
- the granting to researchers access to confidential data for scientific purposes.

- The staff of ELSTAT, under any employment status, as well as the temporary survey workers who are employed for the collection of statistical data in statistical surveys conducted by ELSTAT, who acquire access by any means to confidential data, are bound by the principle of confidentiality and must use these data exclusively for the statistical purposes of ELSTAT. After the termination of their term of office, they are not allowed to use these data for any purpose.
- ➤ Violation of data confidentiality and/or statistical confidentiality by any civil servant or employee of ELSTAT constitutes the disciplinary offence of violation of duty and may be punished with the penalty of final dismissal.
- >ELSTAT, by its decision, may impose a penalty amounting from ten thousand (10,000) up to two hundred thousand (200,000) euros to anyone who violates the confidentiality of data and/or statistical confidentiality. The penalty is always imposed after the hearing of the defense of the person liable for the breach, depending on the gravity and the repercussions of the violation. Any relapse constitutes an aggravating factor for the assessment of the administrative sanction.

9. Release policy

9.1 Release calendar

In September each year, ELSTAT publishes its 12-month release calendar, which outlines the release dates (Press Releases) for all statistics that are planned for next year.

13. Quality management

13.1 Quality assurance

During data processing, the data are also compared, mainly, with data from the previous school year, in order to detect any deviations. In case such deviations are identified, further clarifications are asked from the

School Units of Secondary Education, the Divisions of Secondary Education and the Ministry of Education and Religious Affairs and any errors are duly corrected. The quality of the surveys is also ensured by adhering to the provisions of the European Statistics Code of Practice.

13.2 Quality assessment

The questionnaires are filled in by the School Units of Secondary Education and then the Divisions of Secondary Education transmit the completed questionnaires to the Education Statistics Section where they are checked for completeness and correctness and are then compared with the corresponding questionnaires of the previous school year. After the completion of checks and comparisons, any errors are duly corrected, thus ensuring the production of high quality results. The errors or omissions which are detected are taken into consideration in order to carry out further checks in the survey of the following year.

14. Relevance <u>Top</u>

14.1 User needs

The main national users are government agencies, such as the Ministry of Education and Religious Affairs, the Ministry of Interior, Local Government, as well as university teachers, students, researches, the press, etc. At international level, the main user is Eurostat, as well as other international organizations (Unesco, OECD, etc.).

Users' needs are recorded in the publication "Information Bulletin" which is published by the Division of Statistical Information and Publications/Library Section every semester.

14.2 User satisfaction

14.3 Completeness

The variables are collected in compliance with European Regulations and also on the basis of users' needs. The variables are collected pursuant to Commission Regulation (EC) No. 88/2-2-2011 implementing Regulation (EC) No 452/2008 of the European Parliament and of the Council concerning the production and development of statistics on education and lifelong learning, as regards statistics on education and training systems. Completeness is considered satisfactory.

15. Accuracy and reliability

<u>Top</u>

15.1 Overall accuracy

Overall accuracy is considered satisfactory, since the surveys are census surveys and there is full coverage. Any non-sampling errors are identified by means of appropriate checking and are duly corrected, in cooperation with the Divisions of Secondary Education supervising the corresponding school units.

15.2 Sampling error

No sampling errors because surveys are census surveys. The registers are updated before the beginning of the school year, taking into consideration any changes in secondary education, as these are reflected in the relevant legislation. The registers is compared with the registers of the Ministry of Education and Religious Affairs for the school year when the surveys are conducted, therefore there is full coverage.

15.3 Non-sampling error

There are not any non-sampling errors because the survey is a census survey and it is conducted through the Divisions of Secondary Education which supervise the school units. Any non-sampling errors (non-response or processing errors) are identified by means of appropriate checking and are duly corrected, in cooperation with the Informatics Division of ELSTAT and the Divisions of Secondary Education of the Ministry of Education and Religious Affairs which supervise the corresponding school units.

15.3.1 Coverage error

The coverage errors are minimized because the register of the surveys is updated on a yearly basis in cooperation with the Ministry of Education and Religious Affairs and the Divisions of Secondary Education which supervise the corresponding school units, though which the surveys are conducted.

15.3.1.1 Over-coverage - rate

No coverage of school units that not belong to the surveys.

15.3.1.2 Common units - proportion

Not applicable.

15.3.2 Measurement error

The questionnaires, which are filled in by the teachers, include checks between questions –tables. They are then checked by the Divisions of Secondary Education and the Regional Statistical Offices of ELSTAT, and finally, once collected they are checked and codified by the Section of Education Statistics of ELSTAT. At this stage, the data are compared with the corresponding data of the survey of the previous year. The above procedure minimizes any measurement errors.

15.3.3 Non response error

The surveyed school units respond to the survey and fill in the questionnaires. In case there are missing values for some variables, ELSTAT staff contacts with the school unit or the supervising Division of Secondary Education.

15.3.4 Processing error

Once collected, the questionnaires are subject to quality, logical and computational checks. Then, the Informatics Division procedes with data entry and afterwards the Education Statistics Section carries out further checks in order to compile the tables of the survey. The above procedure minimizes processing errors

The data are collected by means of the questionnaire Σ E-3, Σ E-4 and Σ E-6 which include aggregate numerical data on each school unit (EPAL, EPAS, Ecclesiastical Lower Secondary Schools and of General Ecclesiastical Upper Secondary Schools) referring to general characteristics, teaching and other (specialized, administrative, auxiliary) personnel and its pupils. The register of ELSTAT includes fields for: the code number of each school unit, its name, the geographical code, capacity, type (private, public), postal address, postal code, telephone number and e-mail address. The school units are registered by supervising Division of Primary Education. The register is updated on a yearly basis, on the basis of changes (mergers, abolishment or creation of new school units) carried out by the Ministry of Education and Religious Affairs.

21.2 Frequency of data collection

Data are collected once a year, at the end of every school year.

21.3 Data collection

The Section of Education Statistics sends the questionnaires Σ E-3, Σ E-4 and Σ E-6, through the Divisions of Secondary Education, to the school units under their supervision and to the school units (EPAS) under the supervision of the Ministry of Rural Development and Food, the Ministry of Labour, Social Security and Welfare, the Ministry of Education and the Ministry of Tourism and then the filled in questionnaires are collected from these school units.

21.4 Data validation

The data are validated by means of a series of checks. The control of the questionnaires encompasses completeness, accuracy and logical checks at the level of the Division of Secondary Education, electronic and quality checks. The main variables are compared with variables from other statistical sources. Primary data are cross-checked with the corresponding data of the previous year.

21.5 Data compilation

The data after having been collected undergo logical checks, are codified, are entered the electronic data base, are tabulated and finally they are published. No imputation, weighting or calibration, etc is applied for the compilation of data.

21.5.1 Imputation - rate

21.6 Adjustment

Not necessary.

21.6.1 Seasonal adjustment

No seasonal adjustment methods or tools are implemented for eliminating any impacts on account of seasonality.
