<b>Survey on Tertiary Education (Universities)</b>	<p>Tertiary Education consists of two main parallel sectors:</p> <p>a) Universities, including:</p> <ul style="list-style-type: none"> <li>• all the Universities,</li> <li>• Polytechnic Schools and</li> <li>• the Athens School of Fine Arts and</li> </ul> <p>b) Technical Sector which encompasses:</p> <ul style="list-style-type: none"> <li>• the Technological Educational Institutes (TEI) and</li> <li>• the Higher School of Pedagogic and Technical Education (ASPATE).</li> </ul> <p>Tertiary Ecclesiastical Education includes the Higher Ecclesiastical Academies.</p> <p>Tertiary Vocational Education includes the Merchant Marine Academies (AEN), as well as the Higher Schools for Services and the Artistic Schools.</p>

<b>Reference period</b>	<p>The data of the survey refer to the beginning of academic year, yet for comparability reasons the data of the beginning of the previous academic year are also stated.</p>
<b>Methodology and coverage</b>	<p>The survey is an annual census survey and is conducted through special questionnaires, namely the forms ΣΕ-11. The survey is conducted by the Hellenic Statistical Authority on all the Universities of Greece.</p>
