As **adequate** will be considered the installations which cover the household's needs.

As **inadequate** will be considered the installations which are in bad condition, dangerous or frequently out of order. The same answer must be given in cases that the water is non-drinkable, there is a low water pressure, low voltage as well as for dwellings in places with low water supply or low voltage.

For installations (electrical or plumbing/water), which are permanently out of order, the answer is «My dwelling does not have this installment ».

HOUSING ADEQUACY

1. GENERALLY

The responsible person of the household with regard to the household fills in this questionnaire with the only exception the questions, 9 and 10, which are filled in by the responsible person personally.

2. GUIDELINES FOR THE COMPLETION OF THE QUESTIONNAIRE

Question 1

The question records the responsible person's view who in his answer have to take into account the other household members' view about shortage of space in the dwelling.

Question 2

Electrical installations are the wires, contacts, sockets and other permanent electrical installations.

Question 3

As fixed heating facilities will be considered central heating or similar. If the rooms of a dwelling are warmed by the same heating system without regard to the source of energy then this dwelling has central heating.

Other kinds of heating system (if settled) are the stoves with stovepipe, fireplaces, air-conditioning etc. Fan heaters, electrical stoves, and in general portable radiators are not included.

Question 4

The dwelling could be comfortably warm either because of enough fixed or portable heating equipment or is equipped with sufficient insulation against the cold.

Question 6

On the contrary with question 4 there is the possibility a dwelling to be comfortably cool during the summer months even if there is not air-conditioning system due to sufficient insulation and/or the area the dwelling is located.

Question 7

The question must record the spontaneous answer of the interviewee. However, the opinion of the respondent member could have been formed regarding the rent (if the dwelling is rented), the shortage of space, the neighbourhood, the distance of his/her job etc.

Question 8

The question records the measure of difficulty or the satisfaction of the respondent from the accessibility he/she has from his dwelling to several services such as banks, public transport, health care etc.

Questions 9-10

The responsible person for the household answers the following questions with regard to him/her personally.

If the respondent has changed dwelling during the last two years must mention the main of the reasons which obliged him to change dwelling.
