COLUMN 2: It aims at measuring the child's health in general and not past or temporary health problems that will last less than 6 months.

COLUMN 3: As obligatory education program is considered the demotiko and gymnasium.

COLUMN 4: As childcare program at school is considered childcare, in the morning, usually, from 7a.m. until lessons start and until 4p.m. This program does not exist in all schools. Private and public schools are included.

COLUMN 5: As childcare program outside school is considered childcare in especially adjusted places, at day-care center, during the day.

COLUMN 6: Concerning childcare by professionals or friends/relatives either at their place or at children's' home who are getting paid for taking care of the children.

COLUMN 7: Concerning childcare by grand-parents, other household members (parents are excluded), other relatives, friends or neighbors taking care of the children for free.

E. LIVING ARRANGEMENTS AND CONDITIONS OF CHILDREN IN SEPARATED AND BLENDED FAMILIES

FOR THE INTERVIEWER:

Children are individuals 0-17 years old at the time of interview.

Group E1: children (0-17 years old) who are not household members and whose parent lives inside the household apart from children who live away from home for educational or health reasons.

It includes:

- Children whose mother is a household member, but they are living with the father outside the household.
- Children whose father is a household member -but they are living with the mother outside the household.
- Children who have one or both parents inside the household, but they live outside the household (e.g., with grandparents).

It excludes:

- Children who are household members.
- Children who passed away.
- Children whose parents are household members, and the child lives away from home for educational or health reasons e.g., is in boarding school.

COLUMNS 1 and 2: In column (1) the s/n of the household member who is parent of at least one child that is not a household members is recorded and then, in column (2), the s/n of the child who is not a household member with parent in column (1) is recorded.

Attention: When both parents of the child who is not a household member live in the interviewed household, the S/n of the parent with lower personal number should be used to correspond with child(ren) S/n.

COLUMN 4: If several modes of transport are used, then it is suggested to refer to the notion of means of transport that is "normally used" or the transport "usually used". In cases when the parent does not have any contact with the child then the minutes reported must be '0'.

COLUMN 5: Information on the frequency and not on the length or quality of the time spent should be collected.

Group E2: children (0-17 years old), irrespectively of living in the household

FOR THE INTERVIEWER:

ATTENTION

Columns (3) and (4) include only:

A) children 0-17 years old of Group E1, as well as

B) children 0-17 years old who are household members but have parent outside the household.

B), more specifically:

Includes:

- Children whose mother is not a household member and father who is a household member.
- Children whose father is not a household member and mother who is a household member.
- Children living with one of the parents, but they do not know the other one.

Excludes

- Children who are household members and whose both parents live inside.
- Children who are household members and are living with one of the parents (either mother or father) and the other parent has died.
- Children living with grandparents, uncle/aunt, or other relatives but do not know or do not have the father and mother living in the household

Columns (5) and (6) refer to all children 0-17 years old, irrespectively from the fact that they live in the household or not, of the fact that one or both of their parents are household members and of any other condition. That means, that columns (5) and (6) also refer to children not surveyed in Group E1, as well as not surveyed in columns (3) and (4).

COLUMN 2: a) For children who are household members the s/n of the household members as in Part A is recorded and b) for children who are not household members s/n of column (2), in Group E1 is recorded.

COLUMN 3: If the child spends only the school holidays then the average number per month should be provided.

COLUMN 4: The question's aims to get information on the legal child custody (the legal right to make decisions about the child arrangement, even if in practice it could be different. The question does not collect information on the child's usual place of residence or who takes care of the child.

COLUMN 5: The answer depends on the age of the child, e.g. 1 year old children will not need their own room.

COLUMN 6: Non-physical contact such as talking on the phone or on social media is excluded. Physical contact does not have to be at home only, it could be in the park, in the cinema, in the school, in the house of the partner, etc. Interested on frequency and not on the length or quality of the time spent.

If the child has two parents in the household the time spend with each of the parents should be taken into account. If one of the parents spends more time with the child than the other parent, then the answers from parent who spends more time should be considered.
