Quarterly Non-Financial Accounts of General Government

3rd Quarter 2012

The Hellenic Statistical Authority (ELSTAT) with the present press release announces the quarterly non-financial accounts of General Government for the third quarter of 2012 (Table 1 & Table 2). The quarterly non-financial accounts of General Government provide information on the aggregates constituting General Government revenue (taxes, social contributions, capital transfers, etc) and expenditure (compensation of employees, intermediate consumption, social benefits, interest payments, etc).

The quarterly non-financial accounts of General Government from the first quarter of 2010 onwards have been compiled by ELSTAT based mainly on direct data sources. The data are compiled in full consistency with the European System of Accounts (ESA95). It should be noted that the methods used to compile data on a quarterly basis are consistent with the methods used to compile the annual data, which are published in the context of the Excessive Deficit Procedure Notifications, in April and in October of each year.

The increase of the deficit of the General Government in the third quarter of 2012 is mainly due to the capital transfers (D99) of the General Government during this quarter carried out in the framework of the program of state aid to specific banks (6.9 billions euro). It should be noted that the relevant data are provisional and are subject to revision at the time of completion of the valuation of the opening balance sheets of the banks under liquidation currently being carried out by the authorized liquidators for each bank.

It is noted that in the analytical tables (tables 1 and 2 bellow) have been calculated for the first time as a separate transaction the social transfers in kind from the General Government towards households (table 1, transaction D631M). In the previously published data this transaction was included under social benefits other than social transfers in kind (table 1, transaction D62). This reclassification has not impact in the deficit of the General Government (table 2, transaction B9) but has an impact on the level of General Government final consumption (table 1, transactions P3, P31, P32).
