## BUILDING ACTIVITY

MARCH 2009

The General Secretariat of the National Statistical Service of Greece publishes provisional data on the Building Activity, on the basis of the building permits issued from the Greek Town-Planning Offices during March 2009.

**DECREASE OF THE TOTAL BUILDING ACTIVITY (PRIVATE-PUBLIC) DURING JANUARY - MARCH 2009  
IN COMPARISON WITH THE SAME PERIOD OF 2008**

During the period January - March 2009, the magnitude of the total Building Activity (private-public), in the whole Country, measured on the basis of building permits issued, amounted to 13.062 building permits, which correspond to 3.109,5 thousand m<sup>2</sup> of surface and 12.159,1 thousand m<sup>3</sup> of volume, as compared to 14.216 building permits that were issued during the same period of 2008 and corresponded to 3.760,9 thousand m<sup>2</sup> of surface and 14.295,9 thousand m<sup>3</sup> of volume. Thus, there was a decrease in the number of building permits by 8,1%, in surface by 17,3% and in volume by 14,9%. The percentage contribution of the Public Building Activity in the total building volume, for the above period of 2009, is 3,2%.

In March 2009 the magnitude of the total Building Activity (private-public), in the whole Country, amounted to 4.719 building permits, which correspond to 1.204,9 thousand m<sup>2</sup> of surface and 4.601,8 thousand m<sup>3</sup> of volume, as compared to 3.962 building permits that were issued during the same month of 2008 and corresponded to, 947,8 thousand m<sup>2</sup> of surface and 3.552,6 thousand m<sup>3</sup> of volume. Thus, there was an increase in the number of building permits by 19,1%, in surface by 27,1% and in volume by 29,5%.

The magnitude of the Public Building Activity in March 2009, in the whole Country, amounted to 33 building permits, which correspond to 27,7 thousand m<sup>2</sup> of surface and 105,7 thousand m<sup>3</sup> of volume, as compared to 24 building permits that were issued during the same month of 2008 and corresponded to 10,8 thousand m<sup>2</sup> of surface and 39,4 thousand m<sup>3</sup> of volume. The percentage contribution of the Public Building Activity in the total building activity, in March 2009, is 2,3%.

#### DECREASE OF THE PRIVATE BUILDING ACTIVITY DURING JANUARY - MARCH 2009 IN COMPARISON WITH THE SAME PERIOD OF 2008

As concerns the Private Building Activity in the whole Country, during the period January - March 2009, there was a decrease in the number of building permits by 8,1%, in surface by 18,7% and in volume by 16,3%, as compared to the same period of 2008.


The building volume in the region of Attiki, during January - March 2009, has come up to 3.219,7 thousand m<sup>3</sup>, as compared to 3.204,6 thousand m<sup>3</sup>, of the same period of 2008 (increase by 0,5%).

The building volume in rest of the Country, during January - March 2009, has come up to 8.544,4 thousand m<sup>3</sup>, as compared to 10.857,6 thousand m<sup>3</sup>, of the same period of 2008 (decrease by 21,3%).

Rate of change (%) of building volume, by Region, for the period January - March, between 2008 and 2009




In March 2009 the magnitude of the Private Building Activity, in the whole Country, amounted to 4.686 building permits, which correspond to 1.177,2 thousand m<sup>2</sup> of surface and 4.496,2 thousand m<sup>3</sup> of volume, as compared to 3.938 building permits that were issued during March 2008 and corresponded to 937,0 thousand m<sup>2</sup> of surface and 3.513,2 thousand m<sup>3</sup>

of volume. Thus, there was an increase in the number of building permits by 19%, in surface by 25,6% and in volume by 28%.

**Private Building Activity, by Region, for the month of March of 2008 and 2009**



Summary metadata: The data above refer to the authorized building activity (public and private).

Specifically, the above results refer to data on building permits totally issued by the competent authorities. Such data are collected through a special monthly survey, the Building Permits Survey. The data are collected from administrative sources (Town Planning Offices). External engineers, simultaneously with the issue of a building permit, fill in the relevant questionnaire, properly designed for the survey.

A building permit is an authorization to start work on a building project. Thus, a building permit is the final stage of planning and building authorizations, prior to the start of work.

The legal basis of the survey is the Law 2396/96 (concerning the access of the General Secretariat of the National Statistical Service of Greece to administrative sources and archives and the regulation of issues regarding census surveys and statistical works) and the following STS Regulations:

- Council Regulation (EC) No 1165/98 (concerning short-term statistics)
- Regulation (EC) of the European Parliament and of the Council No 1158/05 (amending Council Regulation (EC) No 1165/98).
