The General Secretariat of the National Statistical Service of Greece publishes provisional data on the Building Activity, on the basis of the building permits issued from the Greek Town-Planning Offices during December 2008.

**DECREASE OF THE TOTAL BUILDING ACTIVITY (PRIVATE-PUBLIC) DURING JANUARY - DECEMBER 2008
IN COMPARISON WITH THE SAME PERIOD OF 2007**

During the period January - December 2008, the magnitude of the total Building Activity (private-public), in the whole Country, measured on the basis of building permits issued, amounted to 65.474 building permits, which correspond to 16.894,4 thousand m² of surface and 65.925,8 thousand m³ of volume, as compared to 77.423 building permits that were issued during the same period of 2007 and corresponded to 20.575,1 thousand m² of surface and 79.490,9 thousand m³ of volume. Thus, there was a decrease in the number of building permits by 15,4%, in surface by 17,9% and in volume by 17,1%. The percentage contribution of the Public Building Activity in the total building volume, for the above period of 2008, is 1,7%.

In December 2008 the magnitude of the total Building Activity (private-public), in the whole Country, amounted to 5.153 building permits, which correspond to 1.352,2 thousand m² of surface and 5.694,3 thousand m³ of volume, as compared to 5.410 building permits that where issued during the same month of 2007 and corresponded to 1.588,2 thousand m² of surface and 6.540,6 thousand m³ of volume. Thus, there was a decrease in the number of building permits by 4,8%, in surface by 14,9% and in volume by 12,9%.

The magnitude of the Public Building Activity in December 2008, in the whole Country, amounted to 29 building permits, which correspond to 37,7 thousand m² of surface and 152,3 thousand m³ of volume, as compared to 35 building permits that where issued during the same month of 2007 and corresponded to 33,5 thousand m² of surface and 190,7 thousand m³ of volume. The percentage contribution of the Public Building Activity in the total building activity, in December 2008, is 2,7%.

DECREASE OF THE PRIVATE BUILDING ACTIVITY DURING JANUARY - DECEMBER 2008 IN COMPARISON WITH THE SAME PERIOD OF 2007

As concerns the Private Building Activity in the whole Country, during the period January - December 2008, there was a decrease in the number of building permits by 15,6%, in surface by 18,1% and in volume by 17,1%, as compared to the same period of 2007.


The building volume in the region of Attiki, during January - December 2008, has come up to 15.515,3 thousand m³, as compared to 20.439,9 thousand m³, of the same period of 2007 (decrease by 24,1%).

The building volume in the rest of the Country, during January - December 2008, has come up to 49.284,4 thousand m³, as compared to 57.766,5 thousand m³, of the same period of 2007 (decrease by 14,7%).

between 2007 and 2008




In December 2008 the magnitude of the Private Building Activity, in the whole Country, amounted to 5.124 building permits, which correspond to 1.314,6 thousand m² of surface and 5.542,0 thousand m³ of volume, as compared to 5.375 building permits that were issued during December 2007 and corresponded to 1.554,8 thousand m² of surface and 6.349,9 thousand m³ of volume. Thus, there was a decrease in the number of building permits by 4,7%, in surface 15,4% and in volume by 12,7%.

Summary metadata: The data above refer to the authorized building activity (public and private).

Specifically, the above results refer to data on building permits totally issued by the competent authorities. Such data are collected through a special monthly survey, the Building Permits Survey. The data are collected from administrative sources (Town Planning Offices). External engineers, simultaneously with the issue of a building permit, fill in the relevant questionnaire, properly designed for the survey.

A building permit is an authorization to start work on a building project. Thus, a building permit is the final stage of planning and building authorizations, prior to the start of work.

The legal basis of the survey is the Law 2396/96 (concerning the access of the General Secretariat of the National Statistical Service of Greece to administrative sources and archives and the regulation of issues regarding census surveys and statistical works) and the following STS Regulations:

- Council Regulation (EC) No 1165/98 (concerning short-term statistics)
- Regulation (EC) of the European Parliament and of the Council No 1158/05 (amending Council Regulation (EC) No 1165/98).
