ANNUAL NATIONAL ACCOUNTS Year 2015 (2nd estimate) & revision of years 2013-2014

The Hellenic Statistical Authority (ELSTAT) announces the 2nd estimate of the Annual National Accounts for the year 2015 (provisional data) and revised data for the years 2013-2014 according to the European System of National and Regional Accounts ESA 2010 (Regulation (EU) No 549/2013 of the European Parliament and of the Council on the European System of National and Regional Accounts in the European Union - ESA 2010).

The revision of the Annual National Accounts data was based on the utilization of new and incorporation of updated information, from various sources, such as:

- Structural Business Statistics results for the year 2013,
- updated estimations for the consumption expenditure of households based on the results of the Household Budget Survey (HBS) for the years 2013-2014 and incorporation of new estimations for the year 2015,
- Balance of Payments data and external trade data for the years 2013-2015,
- General Government data for the years 2013-2015,
- Non Profit Institutions Serving Households (NPISH's) data for the years 2013-2015,
- employment data for the years 2013-2015,
- short term indices 2013-2015.

Specifically, for the year 2015, the revision is mainly due to the incorporation of Household Budget Survey (HBS) results of year 2015, as well as, of short term indices for the evolution of water transport industry and also to the incorporation of ELSTAT's external trade data for the evolution of ships imports.

According to the revised data the Gross Domestic Product (GDP) of the year 2015 at current prices decreased by 1.3% in comparison with the year 2014, against a decrease of 0.9% that was announced for the first estimate in March 2016.

The final consumption expenditure of the year 2015 at current prices decreased by 1.9% in comparison with the year 2014, against a decrease of 0.9% that was announced for the first estimate in March 2016.

The imports of goods and services of the year 2015 at current prices decreased by 10.2% in comparison with the year 2014, against a decrease of 14.8% that was announced for the first estimate in March 2016.

The exports of goods and services of the year 2015 at current prices decreased by 3.0% in comparison with the year 2014, against a decrease of 8.7% that was announced for the first estimate in March 2016.
