SURVEY ON EPHORATES OF ANTIQUITIES: 2018

The Hellenic Statistical Authority (ELSTAT) announces the data of the Survey on Ephorates of Antiquities for the year 2018. The Survey on Ephorates of Antiquities is an annual, census survey and presents the activities of 55 Ephorates of Antiquities, 9 Offices of Modern Monuments and Technical Works, as well as of 8 Special Regional Operational Units, which belong to the Ministry of Culture and Sports.

The survey helps collecting data on a lot of activities, the most important being: the excavations that were carried out, by type and the relevant funding, the monuments and archaeological finds revealed, the declaration of archaeological sites, the exhibitions of archaeological finds, illicit trade and deliveries of antiquities, donations of archaeological objects, licenses to export antiquities, expenditure of projects (completed or under way) concerning monuments, archaeological sites and museums and maintenance of archaeological finds.

Five (5) concise tables and the relevant graphs are presented below, illustrating some of the data collected by the survey during the last years.







Graph 2. Declaration of Archaeological Sites, Traditional Settlements and Listed Monuments, 2008-2018





b. Museums and Other Buildings





Graph 4. Indication of archaeological locations and antiquities delivered, 2008-2018




EXPLANATORY NOTES

Antiquities

Survey on Ephorates of The Survey on Ephorates of Antiquities is carried out since 1970, collecting data from the Ephorates of Antiquities, the Offices of Modern Monuments and Technical Works and the Special Regional Operational Units of Greece which all belong to the Ministry of Culture and Sports.

Legal framework The survey is conducted by virtue of the Law 3832/2010, as amended and in force.

Periodicity Annual.

Methodology

It is a census survey, carried out by means of questionnaires transmitted electronically, which are completed by the Ephorates of Antiquities, the Offices of Modern Monuments and Technical Works and the Special Regional Operational Units of the Ministry of Culture and Sports.
