
# TURNOVER INDEX IN INDUSTRY: April 2022, y-o-y increase of 33.3%

The Hellenic Statistical Authority announces the Turnover Index in Industry with base year 2015=100.0 for April 2022, the evolution of which on the basis of provisional data, is as follows:

The Overall Turnover Index in Industry (both Domestic and Non-Domestic Market) in April 2022 recorded an increase of 33.3% compared with the corresponding index of April 2021. The Overall Turnover Index in Industry in April 2021 increased by 53.0% compared with the corresponding index in April 2020 (Table 1).

The Overall Turnover Index in Industry in April 2022, compared with March 2022, recorded a decrease of 2.6% (Table 6).

The average Overall Turnover Index in Industry for the 12-month period from May 2021 to April 2022 increased by 33.3%, compared with the corresponding index of the 12-month period from May 2020 to April 2021. The average Overall Turnover Index in Industry for the 12-month period from May 2020 to April 2021 decreased by 5.1% compared with the corresponding index of the 12-month period from May 2019 to April 2020 (Table 13).

### **Evolution of the Overall Turnover Index in Industry in April 2022**

#### I. Annual changes of the Overall Turnover Index in Industry: April 2022/ April 2021


The 33.3% increase in the Overall Turnover Index in Industry in April 2022, compared with the corresponding index in April 2021, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 1):

- The Turnover Index in Manufacturing increased by 34.1%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: coke and refined petroleum products, basic metals, chemicals and chemical products, food.
- The Turnover Index in Mining and quarrying decreased by 24.3%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities, other mining and quarrying products.

#### 2. Changes in the sub-indices in Domestic and Non-Domestic Markets:

- The Turnover Index in Industry in Domestic Market increased by 33.4% (Table 2).
- The Turnover Index in Industry in Non-Domestic Market increased by 33.3% (Table 3).



## II. Annual changes of the Turnover Index in Industry in Domestic Market: April 2022/ April 2021

The 33.4% increase of the Turnover Index in Industry in Domestic Market in April 2022, compared with April 2021, is due to the annual changes in the sub-indices of the following industrial sections (Table 2):

- The Turnover Index in Manufacturing increased by 33.5%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: coke and refined petroleum products, basic metals, food, chemicals and chemical products.
- The Turnover Index in Mining and quarrying increased by 15.8%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities, mining of metal ores.

### III. Annual changes of the Turnover Index in Industry in Non-Domestic Market: April 2022/ April 2021


The 33.3% increase of the Turnover Index in Industry in Non-Domestic Market in April 2022, compared with April 2021, was due to the following:

#### 1. Changes in the sub-indices of the industrial sections (Table 3):

- The Turnover Index in Manufacturing increased by 35.0%. The increase was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: coke and refined petroleum products, basic metals, food.
- The Turnover Index in Mining and quarrying decreased by 43.9%. The decrease was mainly the result of the annual changes of the sub-indices in the following 2-digit divisions: mining of coal and lignite extraction of crude petroleum and natural gas mining support service activities, other mining and quarrying products.

#### 2. Changes in the sub-indices in Eurozone and Non-Eurozone countries:

- The Turnover Index in Industry in Non-Eurozone countries increased by 39.8% (Table 5).
- The Turnover Index in Industry in Eurozone countries increased by 22.5% (Table 4).



## Monthly changes of the Overall Turnover Index in Industry: April 2022/ March 2022

The 2.6% decrease of the Overall Turnover Index in Industry in April 2022, compared with the corresponding index in March 2022, was due to the following:

#### 1. Changes in the sub-indices of industrial sections (Table 6):

- The Turnover Index in Mining and quarrying decreased by 9.3%.
- The Turnover Index in Manufacturing decreased by 2.6%.

## 2. Changes in the sub-indices in Domestic and Non-Domestic Market:

- The Turnover Index in Industry in Domestic Market decreased by 2.7% (Table 7).
- The Turnover Index in Industry in Non-Domestic Market decreased by 2.5% (Table 8).

#### METHODOLOGICAL NOTES

Generally

The Industrial Turnover Index is an indicator of an enterprise's business cycle showing the monthly evolution of the market of goods and services in industry. The first compilation of the Turnover Index was completed by the Hellenic Statistical Authority in 2006, with base year 2000=100.0 and is compiled from 2000 onwards.

Purpose of the index

The purpose of this index is to measure the monthly activity of the industrial sector in terms of value. Turnover comprises the totals invoiced by the observation units during the reference period and corresponds to the market sales of goods or services supplied to third parties. The purposes and the characteristics of the Turnover Index apply, as well, to the indices for the distinction between domestic and non-domestic turnover.

**Legal Framework** 

The compilation and publication of the Turnover Index is based on the framework of the implementation of Council Regulation (EC) No 1165/1998 concerning short-term statistics (STS-R), as well as Regulation (EC) No 1158/2005 of the European Parliament and of the Council amending Council Regulation (EC) No 1165/1998. Furthermore, this index is governed by Regulation (EC) No 1893/2006 of the European Parliament and of the Council, by Commission Regulation (EC) No 656/2007, by Regulation (EC) No 451/2008 of the Council, by Regulation (EU) No 2019/2152 of the European Parliament and of the Council on European business statistics, as well as Commission Implementing Regulation (EU) No 2020/1197 laying down technical specifications and arrangements pursuant to Regulation (EU) No 2019/2152.

Revision The latest revision of the Turnover Index in Industry (base year 2015=100.0) took place in the framework

of Council Regulation (EC) No 1165/1998 concerning short-term statistics. In accordance with this

regulation the index is revised every five years, in years ending in 0 or 5.

Statistical classifications At the level of classes of economic activities, the statistical classification of economic activities NACE Rev.

2 of EU was used (Regulation No 1893/2006), while at the level of main industrial groupings, the allocation of two-digit and three-digit NACE Rev. 2 headings to categories of aggregate classification was

used, in accordance with Commission Regulation No 656/2007.

Geographical coverage The index covers the whole Country.

The Turnover Index in Industry is compiled for all activities listed in Sections B (mining and quarrying) and Coverage of economic activities

C (manufacturing) of the NACE Rev. 2 statistical classification.

Computation of the Index The Turnover Index in Industry is a fixed base index. This index is calculated at a first stage at the four-

> digit level of economic activity and subsequently, with the implementation of appropriate weighting coefficients, the index is calculated at higher levels (three-level and two-level of economic activity) as

well as at the level of Main Industrial Groupings (MIGs).

**Publication of data** The Turnover Index in Industry (2015=100.0) is released since August 2019 with June 2019 as first

reference month. Data with base year 2015=100.0 are available from January 2000 onwards.
