COMMERCIAL TRANSACTIONS OF GREECE : October 2022

(Provisional Data)

The total value of imports-arrivals, in October 2022 amounted to 8,806.3 million euros (8,626.9 million dollars) in comparison with 6,083.9 million euros (7,037.5 million dollars) in October 2021, recording an increase, in euros, of **44.7%**. The corresponding value excluding oil products in October 2022 recorded an increase of 1,000.1 million euros or 22.7% and the corresponding value excluding oil products and ships in October 2022 recorded an increase of 840.1 million euros or 19.1%, in comparison with October 2021 (Table 1).

The total value of exports-dispatches, in October 2022 amounted to 4,755.4 million euros (4,686.5 million dollars) in comparison with 3,707.6 million euros (4,314.2 million dollars) in October 2021, recording an increase, in euros, of **28.3%**. The corresponding value excluding oil products recorded in October 2022 an increase of 346.4 million euros or 13.4% and the corresponding value excluding oil products and ships in October 2022 recorded an increase of 349.1 million euros or 13.5%, in comparison with October 2021 (Table 1).

The deficit of the trade balance, in October 2022 amounted to 4,050.9 million euros (3,940.4 million dollars) in comparison with 2,376.3 million euros (2,723.3 million dollars) in October 2021, recording an increase, in euros, of **70.5%**. The corresponding value of deficit excluding oil products in October 2022 recorded an increase of 653.7 million euros or 36.1% and the corresponding value excluding oil products and ships in October 2022 recorded an increase of 491.0 million euros or 27.1%, in comparison with October 2021 (Table 1).

The total value of imports-arrivals, for the 10-month period from January to October 2022 amounted to 76,705.4 million euros (80,484.0 million dollars) in comparison with 51,674.8 million euros (61,359.7 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **48.4%**. The corresponding value excluding oil products recorded an increase of 11,678.0 million euros or 29.8% and the corresponding value excluding oil products and ships recorded an increase of 11,434.7 million euros or 29.3%, in comparison with the period from January to October 2021 (Table 5).

The total value of exports-dispatches, for the 10-month period from January to October 2022 amounted to 45,343.9 million euros (47,841.9 million dollars) in comparison with 32,459.0 million euros (38,792.8 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **39.7%**. The corresponding value excluding oil products recorded an increase of 5,354.0 million euros or 22.7% and the corresponding value excluding oil products and ships recorded an increase of 5,350.8 million euros or 22.8%, in comparison with the period from January to October 2021 (Table 5).

The deficit of the trade balance, for the 10-month period from January to October 2022 amounted to 31,361.5 million euros (32,642.1 million dollars) in comparison with 19,215.8 million euros (22,566.9 million dollars) for the corresponding period of the year 2021, recording an increase, in euros, of **63.2%**. The corresponding deficit excluding oil products recorded an increase of 6,324.0 million euros or 40.6% and the corresponding deficit excluding oil products and ships recorded an increase of 6,083.9 million euros or 39.1% (Table 5).

The monthly data of Intra EU transactions, have been adjusted to the total trade transactions with EU countries, including the transactions below the statistical threshold⁽¹⁾, on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that are submitted by the enterprises to the Independent Authority of Public Revenue. Accordingly, the provisional data from the "incomplete customs declarations" have been incorporated in the monthly data on trade with third countries and, after having been completed, they will be replaced by the final data.

⁽¹⁾ By virtue of EU Regulations on the compilation of intra-EU trade statistics, Member States set out a "statistical exemption threshold". On the basis of the exemption threshold, the enterprises whose transactions are below the statistical threshold are exempted from the obligation to submit data on their intra-Community transactions (Intrastat declaration). The aim is to reduce the burden on enterprises. The statistical exemption threshold, valid for each year, is specified and released by ELSTAT on a yearly basis.

Diagram 1. Imports - Arrivals, Exports - Dispatches, October 2020-2022, million €

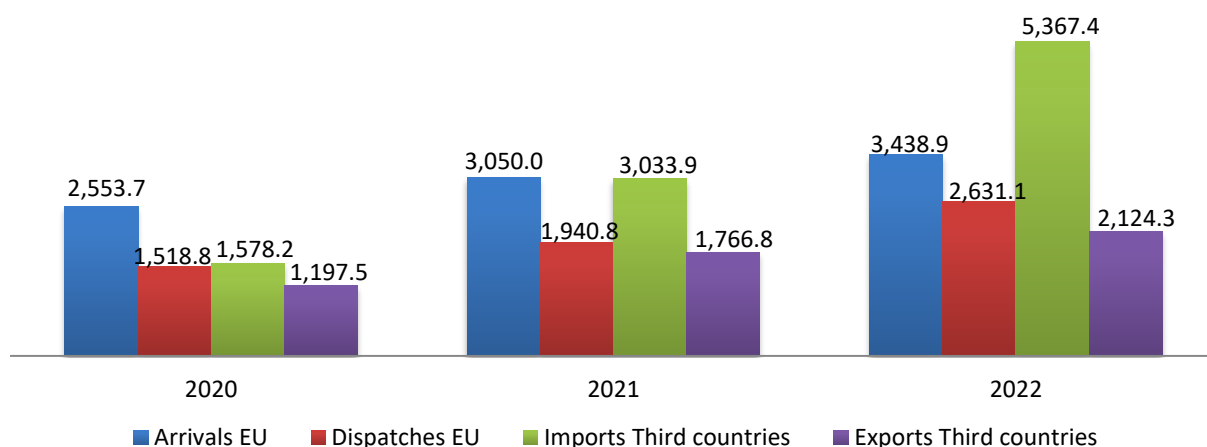

Diagram 2. Imports - Arrivals, Exports - Dispatches excluding oil products, October 2020-2022, million €

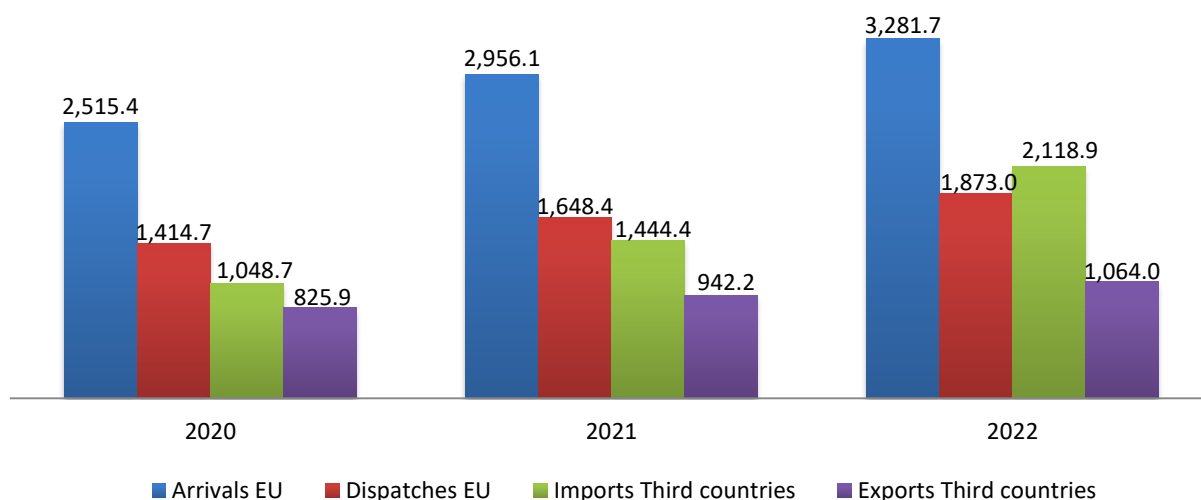

Diagram 3. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, October 2020-2022, million €

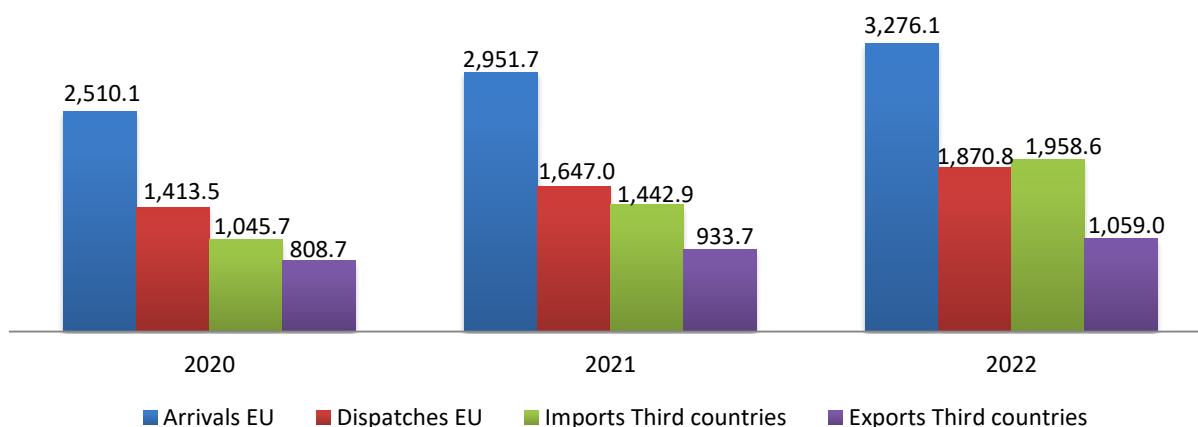

Diagram 4. Imports - Arrivals, Exports - Dispatches, January - October 2020-2022, million €

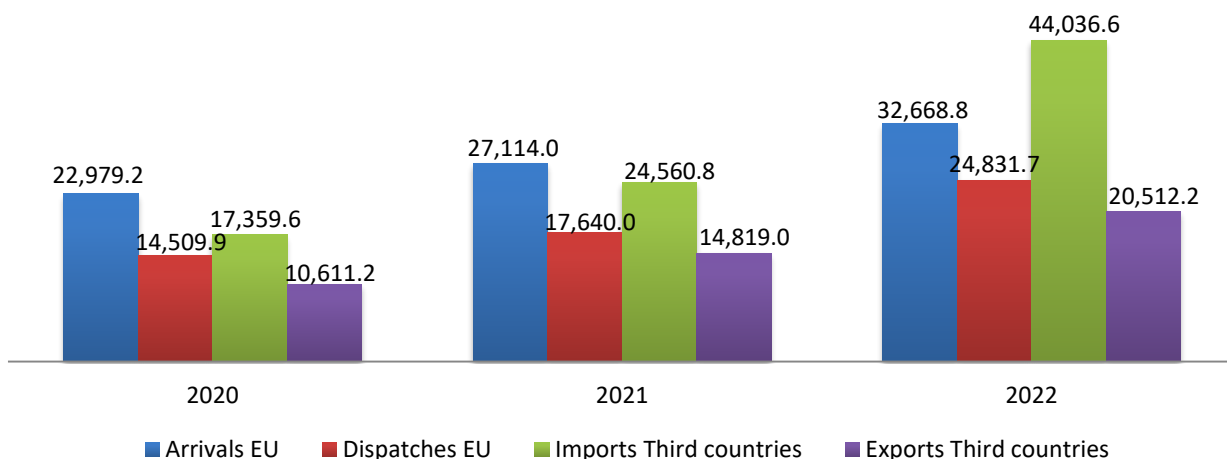

Diagram 5. Imports - Arrivals, Exports - Dispatches, excluding oil products, January - October 2020-2022, million €

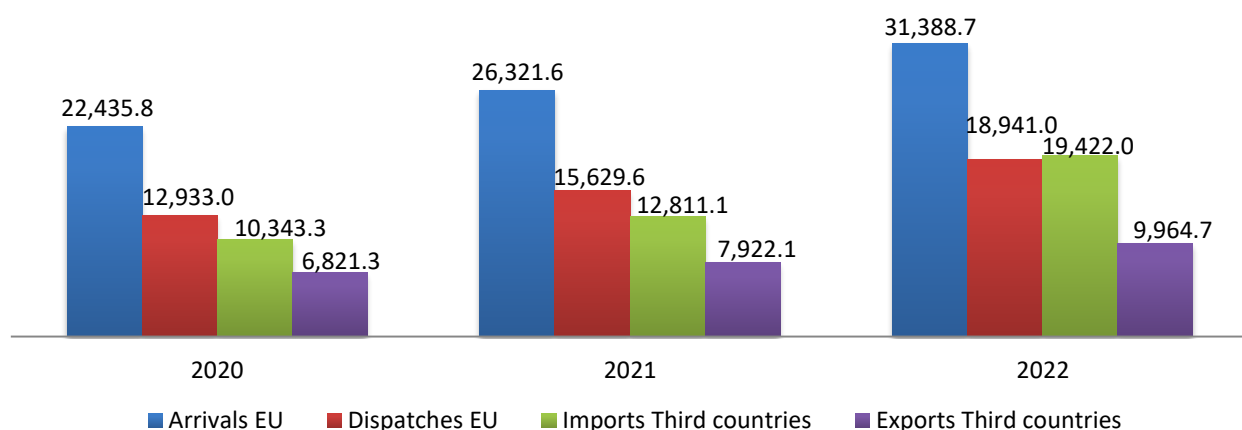

Diagram 6. Imports - Arrivals, Exports - Dispatches, excluding oil products and ships, January - October 2020-2022, million €

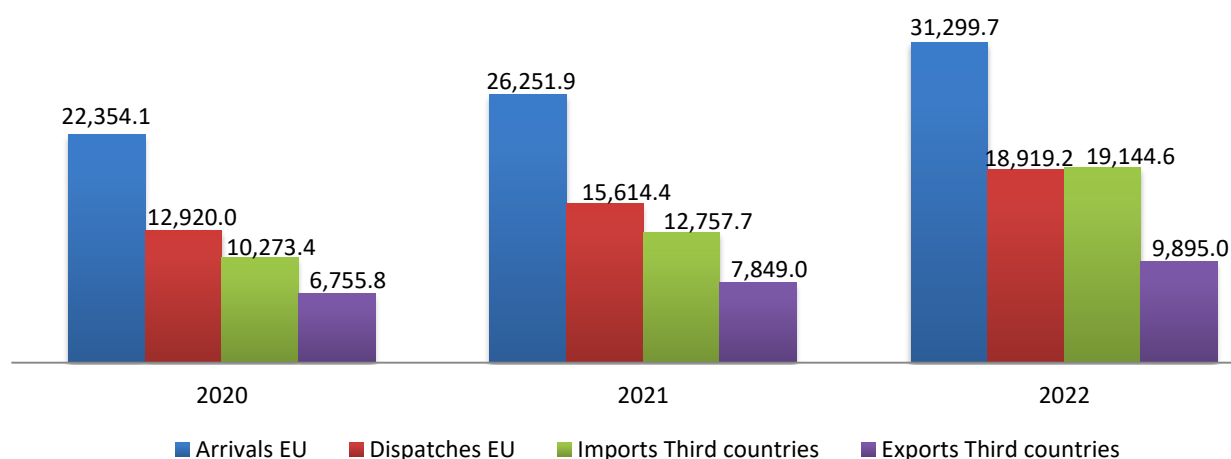

Diagram 7a. Percentage (%) distribution of E.U. arrivals by SITC sections, October 2022

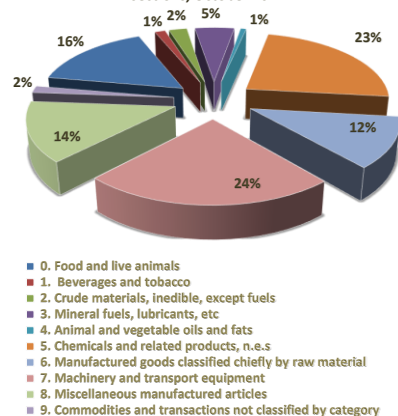


Diagram 7b. Percentage (%) distribution of Third countries imports by SITC sections, October 2022

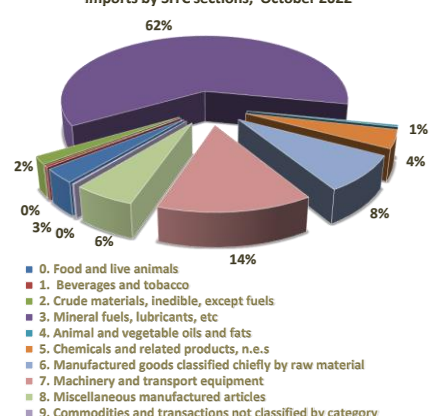


Diagram 8a. Percentage (%) distribution of E.U. dispatches by SITC sections, October 2022

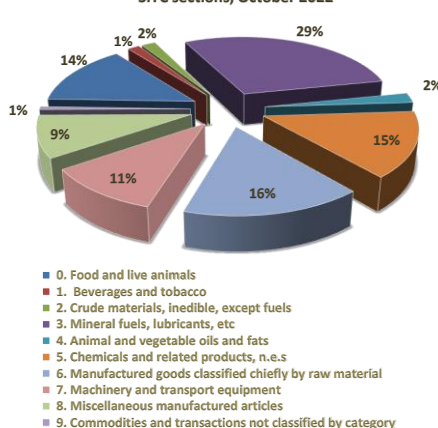


Diagram 8b. Percentage (%) distribution of Third countries exports by SITC sections, October 2022

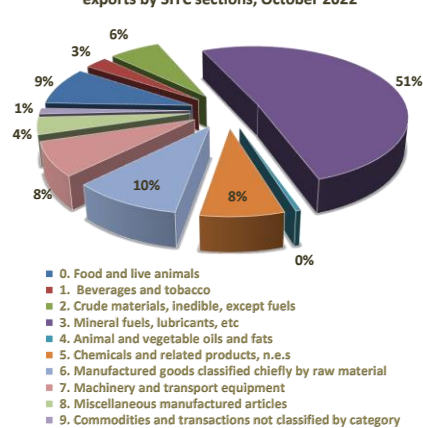


Diagram 9. Imports - Arrivals E.U. & Third countries by SITC sections, Jan. - Oct. 2022, million €

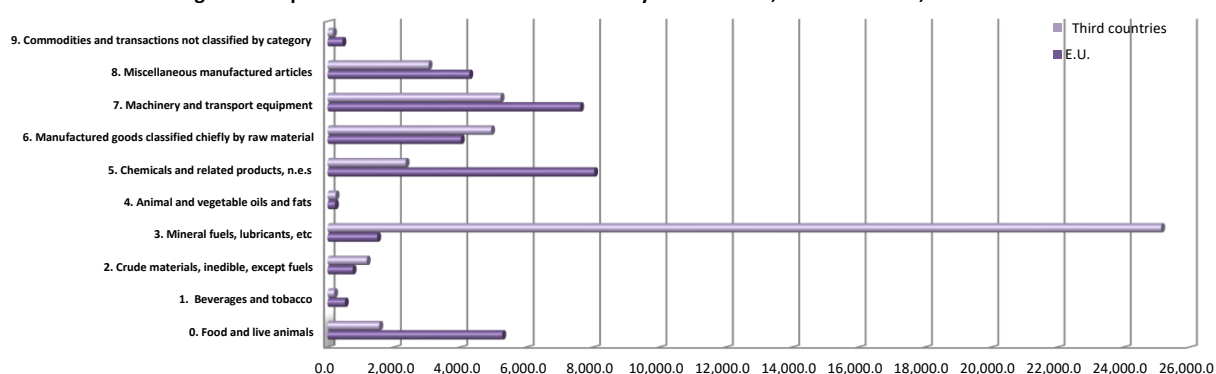


Diagram 10. Exports - Dispatches E.U. & Third countries by SITC sections, Jan. - Oct. 2022, million €

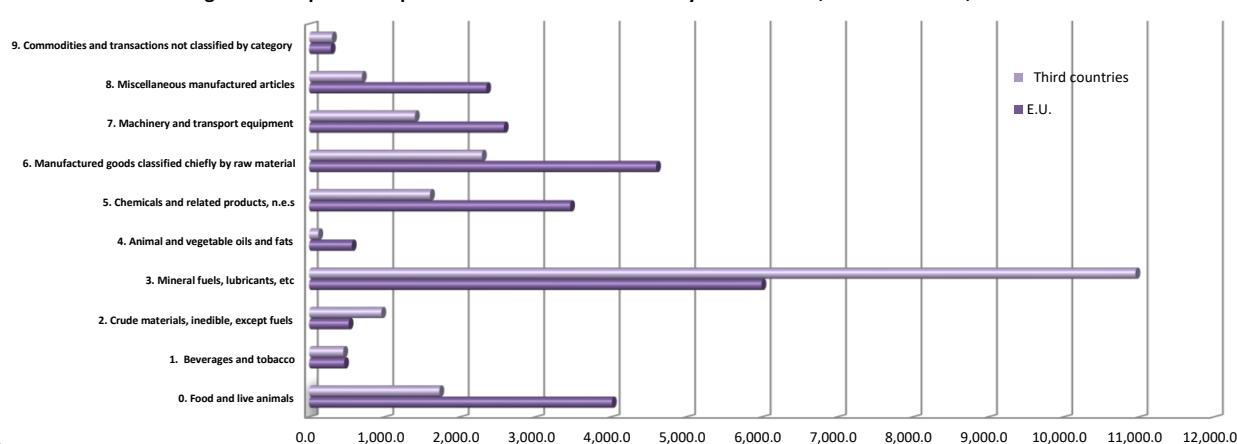

Diagram 11. Commercial Transactions with EU & Third countries 2020-2022

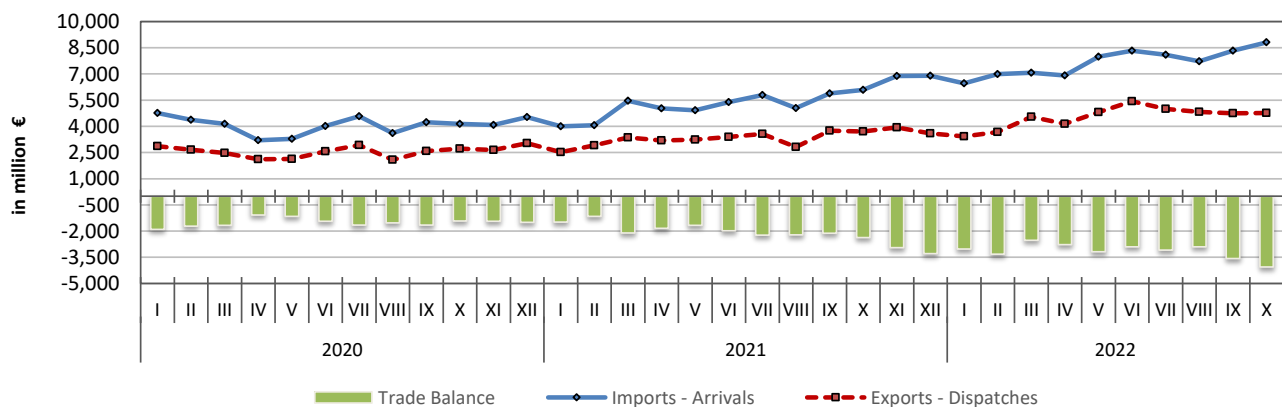

Diagram 12. Commercial Transactions with EU & Third countries 2020-2022 excluding oil products

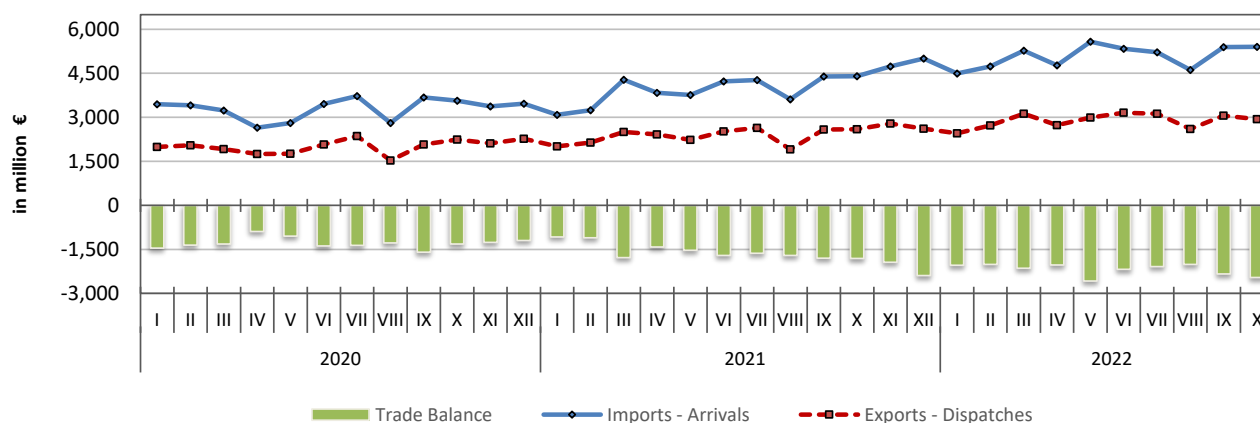

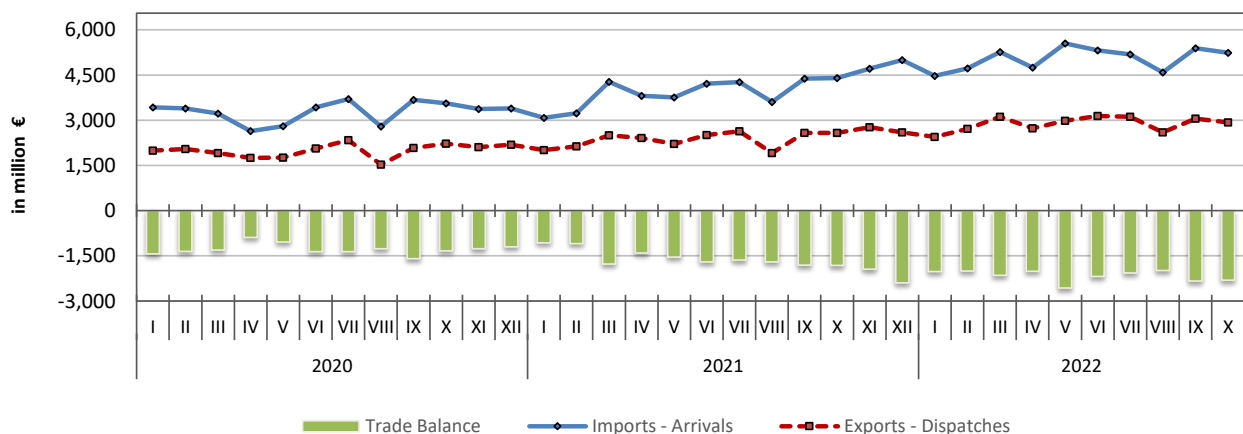

Commercial Transactions of Greece	The Commercial Transactions are recorded on a monthly basis aiming at monitoring the total value of imports/arrivals, exports/dispatches and their changes. This recording does not include the imports and exports of services; however the imports and exports of services together with the corresponding commercial transactions are taken into account for the compilation of National Accounts tables.
Legal Framework	The survey is conducted for intra-EU trade (Intrastat) and for trade with third countries (Extrastat) in accordance with Regulation (EU) 2152/2019 and (EU) 1197/2020.
Reference Period	October 2022
Provision of Results	38 days after the end of the reference month (provisional data). The provisional data are revised and disseminated on a monthly basis for all the previous months until the finalization of the yearly data, which takes place ten months after the end of the reference year.
Definitions	<p>INTRASTAT is the system for collecting Intra EU statistical data (among the EU countries). In compliance with the obligations provided in the EU Regulations regarding the compilation of external trade statistics, these transactions are calculated on the basis of the Recapitulative Statements of Intra-EU Deliveries and Acquisitions that all the enterprises are obliged to submit to the Independent Authority of Public Revenue.</p> <p>ELECTRONIC SUBMISSION: Intrastat declarations are submitted electronically via the following links: http://eurostat.statistics.gr or www.statistics.gr.</p> <p>EXTRASTAT: It is a statistical survey where data are collected by administrative sources. The Customs Authorities collect the relevant statistical data on trade by filling in the Single Administrative Document (SAD). All the transactions with third countries above the amount of 1,000 euros are registered. EXPLANATORY NOTES

International Trade in Goods data of the United Kingdom Under the withdrawal agreement endorsed by the European Parliament on 29 January 2020, the United Kingdom from 1st January 2021 is not part of the European Union's customs and tax territory and trade flows between the United Kingdom and the EU are considered transactions with a Third Country. The imports and exports of the bilateral trade with the United Kingdom are included in the corresponding trade figures with the Third Countries, given that the United Kingdom is now considered a non-EU country.
