EVOLUTION OF TURNOVER OF ENTERPRISES JULY 2023

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sections of the economy, incorporating the most recent data on turnover from Administrative Sources for **July 2023**.

More specifically,

Concerning the enterprises and the activities of the economy as a whole, the turnover in the second quarter 2023 amounted to 110,519,977 thousand euro, recording a decrease of 1.8% in comparison with the second quarter 2022, when the respective turnover was 112,572,779 thousand euro. The biggest decrease in turnover in the second quarter 2023 compared with the second quarter 2022 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 24.7%. The smallest decrease was recorded from the enterprises of the section Information and Communication, per 0.2%, while the biggest increase in turnover was recorded from the enterprises of the section Education, per 33.2% (Table 1).

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in July 2023 amounted to 33,217,171 thousand euro, recording a decrease of 7.2% in comparison with July 2022, when the respective turnover was 35,799,358 thousand euro. The biggest decrease in turnover in July 2023 compared with July 2022 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 57.6%. The smallest decrease was recorded both from the enterprises of the section Water Supply, Sewerage, Waste Management and Remediation Activities and of the section Other Service Activities, per 2.3%, while the biggest increase in turnover was recorded from the enterprises of the section Financial and Insurance Activities, per 111.5% (Table 2).

Note:


Enterprises with single-entry accounting bookkeeping are obliged to submit data to tax authorities on a quarterly basis, while enterprises with double-entry accounting bookkeeping are obliged to submit data on a monthly basis. Therefore, for the total of enterprises, data are available only on a quarterly basis.



METHODOLOGICAL NOTES

Generally

The current announcement provides statistical data on turnover for all enterprises and sections of the economy.

These statistical data have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT, of the reference year 2020.
- Administrative registers of enterprises, of the reference years 2021 and 2022.
- Administrative transactions files (tax, etc) of the reference years 2019, 2020, 2021, 2022 and 2023.

In particular, the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2020.
- The economic activity class for the enterprises that started their activity after the reference year 2020 and have a significant turnover, from administrative registers of enterprises of the reference years 2021 and 2022.
- Income data from administrative transactions files of the reference years 2019, 2020, 2021, 2022 and 2023.

Statistical classifications

For the economic activities, the European statistical classification of economic activities NACE Rev. 2 is used.

Reference Period

July 2023.

Statistical unit

The statistical unit is the legal unit (distinct TIN).

Comparability

The announced statistical data are comparable with the data of the final Statistical Business Register of ELSTAT, of the reference year 2020 (relevant link from the webpage of ELSTAT, where tables and information on the methodology applied are provided <u>Statistical Business Register</u>).
