



**EVOLUTION OF TURNOVER OF ENTERPRISES IN  
ACCOMMODATION AND FOOD SERVICE ACTIVITIES  
AUGUST<sup>1</sup> – SEPTEMBER – 3<sup>rd</sup> QUARTER 2023**

The Hellenic Statistical Authority (ELSTAT) with this sectoral publication, presents the map with the evolution of the turnover of enterprises classified in the **Accommodation and Food and Beverage Service Activities** divisions. These economic activities have been over time in the focus of interest due to the significant weight they bear on the Greek economy as a whole, but also due to their extensive dispersion, with a significant presence in all regional units and a significant contribution to the respective local economies of Greece, often associated with the tourist product of the country.

The current publication is part of the announcements published by ELSTAT ([link](#)), since April 2020, incorporating the most recent data on turnover from Administrative Sources for **August, September and 3<sup>rd</sup> quarter 2023**.

In particular, ELSTAT announces data on a monthly and quarterly basis and at the regional unit country-level of analysis, for the turnover of enterprises classified in the divisions Accommodation and Food and Beverage Service Activities (divisions 55 and 56 of the NACE Rev.2 classification) for the period 2019-2023.

The published data can highlight, at a detailed local level, the current evolution in the performance, in terms of turnover, of enterprises having activity in key classes of the tourism sector and thus provide quick and highly relevant information on the evolution of the tourist product of Greece.

Specifically,

For the total of enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), the turnover in the third quarter 2023 amounted to 5,537,560,411 euro, recording an increase of 5.6% in comparison with the third quarter 2022, when the respective turnover was 5,243,904,629 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of the third quarter 2023 compared to the third quarter of 2022 was recorded in the Regional Unit Chalkidiki (18.8%) and the smallest increase (1.1%) was recorded in the Regional Unit Rodos, while the biggest decrease was recorded in the Regional Unit Mykonos (15.9%) (Table 1).

For the total of enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), the turnover in the third quarter 2023 amounted to 3,469,132,482 euro, recording an increase of 5.3% in comparison with the third quarter 2022, when the respective turnover was 3,293,041,525 euro. For the enterprises of the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of the third quarter 2023 compared to the third quarter of 2022 was recorded in the Regional Unit Zakynthos (19.1%) and the smallest increase (0.2%) was recorded in the Regional Unit Magnissia, while the biggest decrease was recorded in the Regional Unit Mykonos (3.3%) (Table 2).

For the enterprises in **Accommodation Activities** (division 55 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2023 amounted to 1,308,709,014 euro, recording an increase of 11.8% in comparison with September 2022, when the respective turnover was 1,171,099,826 euro (Table 3).

For the enterprises in **Food and Beverage Service Activities** (division 56 of NACE Rev.2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2023 amounted to 249,689,684 euro, recording an increase of 9.4% in comparison with September 2022, when the respective turnover was 228,281,412 euro (Table 3).

In total, for the enterprises in **Accommodation and Food and Beverage Service Activities** (divisions 55 and 56 of NACE Rev. 2 classification), **obliged to double-entry bookkeeping**, for which data are available on a monthly basis, the turnover in September 2023 amounted to 1,558,398,698 euro, recording an increase of 11.4% in comparison with September 2022, when the respective turnover was 1,399,381,239 euro. For the Regional Units with a contribution to the total turnover of the year 2022 greater than 1.0% (Table 5), the biggest increase in the turnover of September 2023 compared to September 2022 was recorded in the Regional Unit Chalkidiki (32.8%) and the smallest increase (4.0%) was recorded in the Regional Unit Messinia (Table 4).





**Graph 1:** Turnover (in thousand €) of the total of enterprises in the Accommodation Activities (division 55 of NACE Rev. 2 classification)





**Generally** The statistical data presented in this announcement have been compiled on the basis of the linking and processing of primary data from the following sources:

- The final Statistical Business Register of ELSTAT of the reference year 2020.
- Administrative registers of enterprises, of the reference years 2021 and 2022.
- Administrative transactions files (tax etc) of the reference years 2019, 2020, 2021, 2022 and 2023.


In particular the following primary data have been used per source:

- Active enterprises and the economic activity class from the final Statistical Business Register of the reference year 2020.
- The economic activity class for the enterprises that started their activity after the reference year 2020 and have a significant turnover, from administrative registers of enterprises of the reference years 2021 and 2022.
- Income data from administrative transaction files of the years 2019, 2020, 2021, 2022 and 2023.

It is noted that the geographical classification of enterprises is based on the location of the enterprise's headquarters.

**Statistical classifications** For the economic activities the European statistical classification of economic activities NACE Rev.2 is used.

**Reference Period** August, September and 3<sup>rd</sup> quarter 2023.

**Statistical unit** The statistical unit is the legal unit (distinct Tax Identification Numbers (TIN)).
