


EVOLUTION OF TURNOVER OF ENTERPRISES DECEMBER, 4TH QUARTER 2023 ANNUAL DATA 2023

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of turnover of enterprises in all sectors of the economy, incorporating the most recent data on turnover from Administrative Sources for **December and 4th Quarter 2023**.

For the enterprises and the activities of the economy as a whole, the turnover in 2023 amounted to 447,422,094 thousand euro, recording a decrease of 2.9% in comparison with 2022, when the respective turnover was 460,915,313 thousand euro (Graph 1, Table 1).

In 2023 compared with 2022, a decrease was recorded in turnover of the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 45.2% and the enterprises of the section Manufacturing, per 8.5%, while the biggest increase was recorded from the enterprises of the section Education, per 23.5% and the enterprises of the section Construction, per 16.7% (Table 1).

The biggest decrease in turnover in the fourth quarter 2023 compared with the fourth quarter 2022 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 55.4%, while the biggest increase was recorded from the enterprises of the section Education, per 13.6% (Table 2).

For the enterprises of the economy as a whole, obliged to double-entry accounting bookkeeping, for which data are available on a monthly basis, the turnover in December 2023 amounted to 34,688,378 thousand euro, recording a decrease of 13.4% in comparison with December 2022, when the respective turnover was 40,071,423 thousand euro. The biggest decrease in turnover in December 2023 compared with December 2022 was recorded from the enterprises of the section Electricity, Gas, Steam and Air Conditioning Supply, per 68.1%, while the biggest increase was recorded from the enterprises of the section Financial and Insurance Activities, per 32.0% (Table 3). **Table 1.** Annual Turnover (in thousand €), from Administrative Sources, for the Total of Enterprises in the Greek Economy (final Statistical Business Register, year 2020), per section of Economic Activity (NACE Rev. 2)











Income data from administrative transactions files of the reference years 2019, 2020, 2021, 2022 and 2023.
