
DATA ON VITAL STATISTICS: 2022

The Hellenic Statistical Authority (ELSTAT) announces data on the evolution of demographic indicators in Greece for 2022. Data refer to vital events such as births, deaths, marriages, and registered partnerships of the population residing in the Greek Territory, during 2022. In this publication, for the first time, statistical data on divorces (irrevocable court decisions and dissolutions of marriage by notarial act) of the years 2018-2022 are announced. The source of all data is the Civil Registry Offices of all Greek Municipal Authorities.

- With respect to the above, the number of live births amounted to 76,095 (39,305 boys and 36,790 girls) recording a decrease of 10.8% in comparison to 85,346 (43,998 boys and 41,348 girls), in 2021. The number of births does not include stillbirths, which in 2022 amounted to 446, recording a decrease of 1.5% compared to the 453 stillbirths in 2021 (Tables 1, 2, 3, 4 and 7).
- In 2022, 140,801 deaths (70,802 men and 69,999 women) were recorded, decreased by 2.2% compared to 143,923 deaths (73,420 men and 70,503 women), in 2021. Infant deaths amounted to 239 in 2022, reducing the infant mortality rate (number of deaths of infants aged less than one year per 1,000 live births) from 3.48 in 2021 to 3.14 in 2022 (Tables 1, 2, 6 and 7).
- Marriages in 2022 amounted to 43,355 (21,381 religious and 21,974 civil marriages) recording an increase of 6.4% in comparison to 40,759 (18,487 religious and 22,272 civil marriages), in 2021. The number of registered partnerships recorded an increase of 13.9% amounting from 11,550 in 2021 to 13,157 in 2022. In this total number of registered partnerships during 2022, 394 between men and 113 between women are included (Table 8).
- Divorces in 2022 amounted to 14,477, recording an increase of 4.0% compared to 2021 (13,921 divorces). As regards the type of divorce, eight out of ten divorces issued in the last five years were by mutual consent. In 2022, among the total number of divorces 11,638 were by mutual consent (80.4%) and 1,906 contested divorces (13.2%) whereas for 933 divorces (6.4%) the type of divorce was not declared. In 2022, most of the divorce decrees concerned persons aged 40-44 years (17.8% men and 20.0% women), followed by persons aged 45 49 (17.6% men and 16.4% women). 65.6% of the divorces issued in 2022 concerned couples that had been married for 10 years or more (9,500 divorces) (Tables 10, 11, 12, 13).
- The ratio of divorces per 100 marriages in 2022 was 33.4 compared to 34.2 in 2021, 41.2 in 2020, 32.1 in 2019 and 32.8 in 2018 (Table 11).










Graph 4. Deaths by age group and sex, for the year 2022



Graph 6. Marriages (religious - civil) and Registered Partnerships, for the years 1992 and 2022




Graph 7. Percentage shares of Marriages and Registered Partnerships, for the years 1991, 2001, 2009, 2014 - 2022








Graph 9. Marriages and Divorces, for the years 2018 - 2022




Graph 10. Divorces by age group of the divorced, for the year 2022




Graph 12. Divorces by type of marriage, for the year 2018 - 2022

EXPLANATORY NOTES

Vital Statistics	The Vital Statistics Survey has been conducted under its current form since 1956. Since May 2013, ELSTAT has access to the electronic registration system of vital events "ARIADNI" of the Ministry of Interior from which the data are derived on a monthly basis. As regards divorces, up to 2017, ELSTAT collected data on final divorce decisions issued by the Courts of First Instance on an annual basis. As of 2018, with the implementation of Law 4509/2017, art. 22, the divorces are registered at the Registry Office where the marriage was registered. To this end, data on divorces are also derived from "ARIADNI" system. As a result, data on divorces from 2018 onwards are not fully comparable with data up to 2017.
Legal Framework	The survey is governed by Law 344/76 concerning the "Registration of vital events" which lays down the obligations of the Civil Register Offices to collect and then to transmit the data, as well as by Law 3832/2010 on the "Greek Statistical System. Establishment of the Hellenic Statistical Authority" as amended. Legislation for divorces:
	 Law 1329/1983 "Implementation of the constitutional principle of equality of men and women in the Civil Code, its introductory law, commercial law and the Code of Civil Procedure, as well as some modernization of the provisions of the Civil Code concerning the family law". Article 1438 - Marriage dissolution with a divorce issued by means of an irrevocable court decision. Article 1439 A.K - Serious impairment of the marital relationship Article 1440 A.K - Spouse missing. Article 1441 A.K - Divorce of mutual consent.
	Article 22 - the possibility of marriage dissolution by written agreement of the spouses, with the presence of attorneys for each of them is introduced. The settlement is concluded with a notarial deed. The Law came into force in 2018.
Coverage	The survey is a census survey, and it covers all births, deaths, marriages, registered partnerships and divorces that take place within the Greek territory and are registered in the Registries system ("ARIADNI").
Geographical	Geographical classification is based on the Nomenclature of Territorial Units for

Classification Statistics (NUTS).

Definitions Infant mortality rate: The ratio of the number of infant deaths under one year of age during the reference year to the number of live births in the same year. The value is expressed per 1,000 live births.

Neonatal mortality rate: The ratio of the number of infant deaths under 28 days of age during the reference year to the number of live births in the same year. The value is expressed per 1,000 live births.

Perinatal mortality rate: The ratio of the number of infant deaths less than 7 days of age (one week) plus stillbirths during the reference year to the number of total births (including stillbirths) in the same year. The value is expressed per 1,000 total births.

Natural population change (natural balance): the difference between births and deaths, without taking into account net migration (immigrants – emigrants).

Methodology The vital statistics data, after having been collected from the "ARIADNI" system, undergo the necessary quality checks, and statistics on births, deaths, marriages, registered partnerships and divorces are compiled on an annual basis. In cases where two types of marriages take place (religious and civil), only the first marriage is recorded. The deaths of migrant-refugees during their attempt to approach European countries are not included. As regards divorces, from 2018 onwards, data are collected via "ARIADNI" system, on divorces by mutual consent (dissolution of marriage by notarial act) and contested divorces (irrevocable court decisions, i.e., which cannot be contested by legal action). The available variables collected are: type of divorce, sex and age of the divorced, duration and type of marriage (religious - civil), Region of usual residence. Data on the reasons of divorce and the party against whom the divorce was issued are no longer available in the "ARIADNI" system. Due to these changes, data on divorces from 2018 onwards are not fully comparable with data up to 2017.

Vital statistics are subject to revision after integration of new data or further clarifications.
